# Welcome to the Assembly

Terry S., Alternate Delegate/Area Chair, opened the Assembly at 8 AM with the Serenity Prayer. Doug D. read the 12 Traditions; Jo G. read the short form of the 12 Concepts. April, the Area 40 Secretary, took the roll. There were 14 districts present with 102 voting members, and 28 visitors for a total of 130 attendees at the 2009 Fall Assembly.

## Orientation to the Assembly- Carole B., Area 40 Delegate

Good morning everyone, my name is Carole B. and I'm an alcoholic. I have the huge honor and pleasure of serving as your Delegate. Recently, I changed home groups and started attending a few other groups in Billings. A GSR said that the reports a the Area Assembly can get a bit boring so I decided to spice up this orientation a bit. Robbie used to tell the GSRs to make service look like fun, because it is. If it isn't fun, I ain't doing it.

I have opted to make this a participation orientation. I have asked some people to help me. Here's what were going to do. I will seek your participation and those who get the correct answer will be given a ticket by my assistants. Some questions have multiple answers. A ticket is available for each correct answer to those questions with multiple answers.

Put your name on the ticket. The tickets will be collected and placed in a hat. Those drawn from the hat will get a prize such as a Grapevine Calendar, a Grapevine, Young People's poster, or other memento.

This is the only time in this Assembly that you can shout from your seat. Terry needs to you go to the mike to speak during the remainder of the Assembly.

Let's get started. First I would like to welcome all the people here for their first Assembly. I would also like to welcome all the first time and returning GSRs. GSR stands for? (General Service Representative). That's right General Service Representative.

We need all those in attendance to register with your DCM. DCM stands for? (District Committee Member) Yes, District Committee Member. Even if you are here as a visitor, please register.

Ken B., West Central Regional Trustee is here with us this weekend. Area 40 – Montana belongs to the West Central Region with 7 other Areas. Name those Areas. (Iowa, Northern Minnesota, Southern Minnesota, Nebraska, North Dakota, South Dakota and Wyoming) As a Trustee, Ken serves on the General Service Board.

We also have a number of Past Delegates here today as well. What are the names of the Past Delegates here today? ( ) I'm glad you know who they are because they are a great resource and have helped me very much over the last few years.

As soon as we get done playing this orientation game, we will have reports from the Area Chairs, DCMs, Area Advisor, Archivist, and Webmaster.

This later this morning, I will give my report of my activities. In April I attended the? (General Service Conference). It was held in New York City but next year it is moving to Rye, New York. You have graciously invited me to come share my experience with you throughout the summer.

Then we will break into committee meetings and workshops. Who can name the committees? (Archives, Corrections, Cooperation with Professional Community, Grapevine, Public Information, Finance, Literature and Treatment) Anyone can attend committee meetings but only committee members can vote within the committee. Each district provides two or more committee members. Each DCM serves on a committee and each district provides a representative to serve on a committee.

Each committee has assigned to review the actions taken by the Conference on the agenda items at the 2009 General Service Conference. If the committee is so inclined, they may bring forth an item for the 2010 General Service Conference as a recommendation for the Assembly to discuss and possibly approve. If such a recommendation is approved, I will forward it to the Conference Coordinator for the Trustees to consider placing on the 2010 Conference.

For those not attending committee meetings, the workshops will be led by Past Delegates Earl and Loren. As I said earlier, the Past Delegates are great resources so enjoy the workshops.

Ken B will share with us and then we will begin the floor assembly. Each Area Chair reports on the committee meeting and may offer a recommendation which is a made and seconded motion. If a recommendation presented, we discuss it.

The voice of each and every member of AA matters. If you have a concern or question, please voice it. If you don't understand what we are trying to accomplish, please ask for clarification. If you are uncertain, it is likely that there is someone else needs clarification. So, by asking a question, you are really helping all of us. If someone has already expressed that opinion, there is not a reason to repeat it. This is why you are here.

This Assembly will loosely follow what procedures? (Robert's Rules of Order)

After receiving each District's registration forms, our Area Secretary, April, will establish the number of voting members present. In order to be a valid vote we must have a quorum. A quorum consists of 2/3 of the voting members being present. If the vote is valid such that a quorum has cast votes, the recommendation will only pass if we have substantial unanimity or a majority vote. In Area 40, we consider what fraction to be the majority vote? (2/3). Yes, 2/3 of the vote is needed to approve a recommendation.

There will also be time for minority opinion after a committee recommendation is voted on. The purpose of minority opinion is to help ensure we have an open discussion on each issue. However, it is best to express your concern or voice during the discussion such that we have all information prior to taking a vote.

The Committee Chairs will also report on items the committee discussed but did not take any action. You will be given an opportunity to ask questions regarding the item.

The GSR and DCM Breakouts are a great place to find out how other groups or districts handle situations. Or place to propose an idea you may have for carrying the message to the still suffering

alcoholic. These are also great places to discuss the 12 Traditions. Ask-it-baskets are in the back of the room for these breakouts so you can pose your question there if you would rather be anonymous.

Tomorrow morning, we will hear reports from the Spring and Fall Roundups, Intergroups represented, and the Regional Forum. We will also hear from Past Delegates Loren and Earl. Then we will continue with committee reports.

If we have time, we will have general sharing. This is the time that Floor Actions could be made if we have something that must be dealt with and is not on the agenda.

By past actions, the Assembly will close at Noon on Sunday. Two things can cause the Assembly to not close at noon – a motion to adjourn during general sharing or a motion to continue past noon if we did not get through our business.

Any questions on the Assembly's procedures?

We'll have the drawing at the break. Thanks for your enthusiasm.

# **Area Committee Member Reports**

# Area Chair/Alternate Delegate- Terry S.

Good morning, Area 40!

Welcome to the second assembly of the 2009-2010 Area 40 rotation. Now, in Spring 2009, virtually all of us were in new positions, and we learned together. This time, many of us are "old veterans," although most of us "old veterans" are in our second assembly in our current positions. All of us, new and old alike, get the privilege of working together to assure that the hand of AA will be there wherever and whenever a suffering alcoholic reaches out for our help.

First of all, let me give you the dates for upcoming Area Assemblies (our coming attractions). The Spring 2010 assembly dates are at the bottom of page 5 on our Agenda for this Assembly — April 10/11, 2010. Please remember the A.A. meeting on Friday night, like the one last night, will be on April 9, 2010 at 7:30 p.m. in this room. The 2010 Fall Assembly will be September 11-12. For 2011, the Spring Assembly will be April 9-10 and the Fall Assembly will be September 17-18, moved later into September to avoid conflicts with the 2011 West Central Regional Forum, in Iowa on September 10-11. This report will be in the minutes of this Assembly, so let me mention some other dates you may want to remember. July 1-4, 2010, the International Convention occurs in San Antonio, Texas — registration opened for the International Convention on the 1<sup>st</sup> of this month, and I understand they have resolved the initial problems with on-line registration. Also in 2010, the West Central Regional AA Service Conference will be in Iowa on March 5-7, at the Holiday Inn in Dubuque. Later next year, there will be a special WCRF in Rapid City, South Dakota, on Nov. 12-14, addressing Native American experience in AA, and AA experience with Native American members and prospects. In 2011 the WCRAASC is in Northern Minnesota, and then, in 2012, it is scheduled to be here, in Montana. We have an agenda item about that service conference, to commence our preparation to select a site and begin the planning and preparation.

Part of my job is to educate trusted servants throughout the Area on placing items on the agenda for the Area Assembly as well as the General Service Conference. Under our Area Policy and Procedures, you've gotta get your agenda items, in writing, with the background material, to me by February 1, 2010. Do not expect to get an item on the agenda next spring if you miss that deadline. There just isn't any extra time to be late.

Our room rates for this Assembly are 69.99 for one person in a standard room, \$79.99 for two persons, 89.99 for three persons, and so forth, with a 3% tax added. Our group reservation number is #GA0032, but most of folks at the front desk know that is the rate for folks attending this Assembly. If you have any problems, talk to me if the front desk can't take care of it for you.

Since the Spring Assembly I have visited business meetings in districts 41 and 61, participated in 2 Area Committee telephone conferences and attended the West Central Regional Forum in St. Cloud, Minnesota. We'll have a report later about that conference, but let me just say it is another of those service experiences that you will not want to miss. Our Area Committee telephone conferences this fall have been an experiment, and Sharon, our Triangle Editor, has completed a survey about how the participants feel so far. We'll continue to explore the use of technology for between assembly communications, and perhaps someone will present an agenda item about the best practice to follow in another year or two. Communication—transparency—doing our best to assure that every member of the Fellowship in Area 40 can find out what is going on—is vital to our recovery and to our unity, as well as to our service.

District 21 apparently has a new DCM, Joe G., and appears to be losing a couple of groups that are asking to become part of District 51. There has been some consultation with other folks in Area 40, and I hope we will find out the status of that matter perhaps this weekend. Ultimately, since each group is autonomous, the groups have every right to change their district affiliations.

We have a great agenda for this assembly, consisting mainly of local items, and otherwise consisting of our committees telling us what they see as important from the General Service Conference this Spring. My role is not to participate in the discussion but to keep things functional and on time. You all have the jobs of sharing your comments, questions, and concerns. If somebody else has already shared what you were going to share, please don't repeat. If you have a question that has not been asked or a comment that is new, then please do go to the mike and share. BEFORE we get to the floor assembly, while our committees are meeting, if you are not a voting member of any committee, please feel free to attend the workshops in this big room, chaired by 2 of our past delegates. Or, if you are interested in any particular local items, or the status of items from this Spring's GSC, or if you have some thoughts about a particular aspect of service, please do attend the meeting of the committee in which those items will be addressed. This is our assembly, yours and mine. Our GSC is the collective conscience of our Fellowship, and the General Service Office is our GSO. Share your thoughts, your feelings and your ideas, so that we can continue to improve our ability to offer our recovery program to any and all alcoholics who might want it.

As Carole mentioned, our West Central Regional Trustee, Ken B., will be sharing with us this afternoon, before we commence our committee reports to the floor. Ken follows Chuck B., who did a wonderful job for us, and Ken is carrying on in the same fashion, in his own style, and also doing very fine work for the Fellowship. Thanks, Ken.

In order for all to share and to get through the myriad of business we have before us. Each Area Committee Chair and DCM has 5 minutes for their reports, discussion or comments from the floor are given three minutes to share.

DCM's I have put attendance sheets for each district on the tables by your nameplate, please have those filled out and hand them in to me by the first break which is at 9:30. I use the count from these sheets to determine a quorum for voting purposes. Voting members are DCM's or their alternate, GSR's or their alternate, and most Area Committee Chairs and Officers.

I have been busy updating Area 40's group information at GSO through a website called New Vision. I have registration forms for new groups; the same forms can also be used to update group information as well. A note of clarification, all the information with asterisks next to it is necessary to properly register or update any group. Omission of any of this information results in the system rejecting the entry. GSO did not publish meeting directories this year after all, I do still need to update all group and group contact information, regardless. If you have any questions, please come up and see me.

All those giving reports may e-mail your report to me. If you choose to submit your report in hard copy, I will need two copies. In addition, I will need the minutes from all the committee meetings and breakout sessions being held later today. E-mail is more efficient and my preference but hard copies will suit. Remember, two copies...

Recommendations from committees to come to the floor in the spring assembly were:

Archives/ Structure Committee recommends that Area 40 fund the Archivist to attend the 2009 National AA Archives Workshop in Woodland Hills, CA (not to exceed \$1500) to make a bid that Area 40 host the 2011 National AA Archives Workshop,

Vote: 96 For; 6 Opposed. Recommendation Passed. Minority Opinion was heard.

Corrections/International Conventions and Regional Forums : Area 40 Corrections Committee requests a Local Forum from the General Service Office to be held in the spring of 2011 in Great Falls, MT.

Vote: 65 For; 23 Against. Recommendation Passed.

### Area Treasurer-Linda B.

Hello and welcome to everyone! Our purpose this weekend is to participate in the business of our area and support the service structure in carrying the message of Alcoholics Anonymous. This is the time where your voice is heard. Please come to the microphone and ask questions.

This weekend the finance committee is tasked with two agenda items:

- 1. Review the agenda items from this year's General Service Conference and report back to this assembly.
- 2. Prepare and propose a draft budget for 2010. This assembly will discuss and vote on this recommendation this weekend.

As treasurer, along with the finance committee, my job is that of overseer of Area 40 finances, keeping accurate records, collecting contributions, pay expenses, and most importantly, reporting to the groups the current financial picture of Area 40. Firstly, I want to thank the spring assembly participants for their 7<sup>th</sup> Tradition contributions of \$1,214.77. This was commendable and surprising in that this was the largest amount received from any assembly. Once again, the power of the purse has spoken.

Each DCM has a packet this morning on their table. Each group in each district that made contributions to Area 40 has a letter to share with their home groups. This letter is to thank the groups for their contributions and continued support of the structure and services we perform in Area 40. 94 groups, 2 districts, and one individual have contributed funds this year totaling \$20,754.74. Check to see that these contributions match up with what your groups have contributed this year. Any discrepancies can be reported to me. It would be invaluable to include all new group information and your group service number with your contribution to insure proper accounting of the monies. There are many contributions still being sent to different addresses. Please update your mailing information. The address for Area Treasurer is PO Box 21577, Billings MT 59104. There are address labels on the back table by the Coffee can.

There are financial reports for everyone to have a copy of. Along with these reports, there is a budget worksheet. All of these figures will be discussed and reviewed this weekend. Some of the financial highlights are a checkbook balance of \$28,531.99. Of that there is \$10,813 for prudent reserve and \$2,073 in the archivist account. That leaves an operating balance of \$15,646. Income to date through September 13<sup>th</sup> is \$22,910 with expenses of \$17,250 leaving us with a net gain of \$5,660. Your 7<sup>th</sup> Traditions contributions have been and are supporting our expenses this year. While we are supporting our current expenses, we are not on target for supporting the 2009 budget of \$30,939. Plus, we increased that budget by \$1,500 this spring with voting to fund the Archivist to attend the Archives Convention and bid to host the 2011 Archives Convention in Montana. The annual budget we passed for 2009 is now \$32,439. As you can see in the financial reports, actual expenses are significantly different than the projected budget. In the reports you can see we're not spending our budgeted monies in most of our committees. Our 2009 budget isn't based on actual expenses; it's what our collective vote was to provide and support Area 40 services in carrying on our 12t Step work. There will be estimated expenses of \$7000 for the remainder of this year, so realistically we will be having expenses of about \$25,000 this year compared to the \$32,349 budget that was projected.

If, we as a fellowship deem the services are essential and necessary in Area 40 and vote to support those services, collectively we need to increase our 7<sup>th</sup> Tradition contributions also. If the expenses this year

were close to the projected budget, we would be using our prudent reserve to pay for expenses. Our area has in the past proven that when a call for money is necessary, the groups respond. Are we as a fellowship setting a budget we are willing to support through our contributions? There may be agenda items passed this weekend that will further impact the budget for next year. Is it time to trim our budget, to estimate our expenses in equal proportion to our contributions and set a budget accordingly? These are the questions I pose to this voting assembly to discuss. I'm sure that there will be thoughtful discussion and that we will come to an informed decision in passing the 2010 budget.

# **Triangle Editor- Sharon S.**

Hi everybody. My name is Sharon S.; I am an alcoholic and your Triangle editor.

I've had a great time doing the 6 issues of the Triangle thus far this year. I slacked after the May-June issue and found myself doing catch up in a hurry for the July-August issue, which became the August issue! I appreciate all the support and articles I've received from the Area officers and committee chairs, DCM's, GSR's, and A.A. members. The participation has been great. So, thanks everyone. Those who haven't contributed yet, I'll be trying to put a little structure into the remaining issues, with focus on a particular area of service now that we have all had a little time to settle in to our positions.

Groups (and individuals) are encouraged to subscribe to the Triangle, for \$10 a year. By past motion, groups receive the Triangle whether they subscribe or not. Currently, 84 groups, or about 30%, have current subscriptions. There are 16 paid individual subscriptions. I mail approximately 300 copies. They go to all groups with a valid address, the DCM's, the Area Committee, and West Central Region Delegates, the West Central Region Trustee and individuals with a current subscription. There are currently 23 groups on the list with invalid addresses which I have not been able to resolve

I continue to work with the DCM's to keep the mailing list as up to date as possible. I have given each a current list of groups for Triangle mailing in hopes that any updates or changes can be made this weekend and the lists handed back before you leave. If you want to take them back to your next district meeting, that would be great. You can mail the updates to me. I'll email a copy of the list to you in case that works out to be easier for you.

I have subscription forms if you want to subscribe or your group wants to renew its subscription.

At the spring assembly, I voiced my desire to be sure that the Triangle meets your needs. I did put together a little inventory and included it in the August Triangle. Thank you for taking the time to help the Triangle "take its inventory". The Archives/Area 40 Structure & Policy committee will be reviewing the results.

I've worked with Linda to put together a budget request for 2010 for the Triangle. First of all, if I publish 2 more issues of the Triangle, I will go over budget for 2009 by about \$400. I don't have the details of the 2009 budget, so cannot identify exactly why this happened. There were several things that may not have been anticipated: postage increases, quarterly National Change of Address (NCOA) checking on all bulk mail, and a new printer. My budget for 2010 includes the actual expenses from this year plus a slight increase for postage. The biggest part of the budget is to upgrade the outdated software and a provision to replace the computer if necessary.

I put "extra" Triangles out on the back table, help yourselves. There's also a binder of recent issues, if you'd like to peruse.

I'm pretty excited to be registered for the International next year and hope to include some stories in the Triangle to encourage others to join us. Do you have a good International experience that you'd like to share? I would love to have it, please talk to me sometime this weekend!

This is really is a great job that you have trusted me with. Thank you for allowing me to serve!

I would like to ask all of you to remember the Grapevine and the fine resources it has especially when working with newcomers or perhaps not so newcomers that would benefit from the Grapevine. Books such as "Voices of Long-Term Sobriety", "Beginners' Book: Getting and Staying Sober in AA", Audio tapes such as Spiritual Awakenings, Emotional Sobriety, Attitude Adjustment are some of the online resources that cover topics including sponsorship, working with wet drunks, service work, the twelve steps, and a litany of other very helpful items. Therefore, A.A. is more than a set of principles; it is a society of alcoholics in action. We must carry the message, else we ourselves can wither and those who haven't been given the truth may die." This paragraph, written by Bill W. in 1951, is the first paragraph of our service manual. I thought these were words of wisdom worthy of sharing as we begin another Area Assembly.

The summer seemed to fly by, even though I did not have any invitations to lug my incredible literature stash hither and yon. Just a reminder that I would love to participate in any event in which you think I could be of service. Please invite me! I did participate in one of the Area 40 Conference calls, and intended to participate in the other, but forgot about it until it was over. If only good intentions paved the way to somewhere other than . . . well, you get the idea.

I did not place a literature order prior to this assembly for a few reasons. First, after contacting Julio E., the new Literature Coordinator at the GSO, I found out that it would be unlikely that the new service manuals would be printed in time for me to receive them before the Fall Assembly. I have a few of the 2008-2009 service manuals left for the low price of \$2.50. They are located on the table near the literature display. In addition, because I did not place an order, I did not get any new Literature Catalogs. I have placed copies of the new Order Form, which reflects the new prices, near the service manuals in the back. The 2009-2010 Catalogs are available on the AA Website for viewing, downloading and saving, or printing.

I have set up Area 40's Literature Display at the back of the room. Please take a moment this weekend to browse the display which contains much of the material available to you through the General Service Office. The books and audio-visual materials are for display only and not for sale. However, you may help yourself to a pamphlet or two, and I strongly encourage you to pick up several regular and birthday contribution envelopes!

Area 40 – Public Information (PI) Report

The majority of what I have been doing since the Spring assembly has been working on the 1-888 number.

There was much discussion in late spring about why were not using the online contact system and still relying on outdated lists. This was due to two main reasons. The first was that our webmaster was still working on the online portion of the system and secondly we did not have a very high percentage of districts that had entered their contact information online.

Since that time however I am very excited to report to the Area Assembly that in early August the online contact system that connects one Alcoholic to another, and insures that we can reach the hand that is

reaching out to us in a more efficient and assured manner, went live. Thank you Alex our Webmaster for all you did to make this possible and to all the districts that entered their contact information and to AnswerNet that had to upgrade their computers to allow it to happen.

If you are a district that has entered your contact information online about how this will not only help people get in contact with AA in your district but will also go a long way in support of our three legacies - Unity.

There have also been many emails going back and forth; (about 100 received and 60 or so sent) on the service but three that I think bear repeating here at the assembly:

- 1. I know we are getting many calls for information in our district but the bill from AnswerNet is not reflecting it
- . AnswerNet is not billing us separately for many of the calls for meeting information but relying on the base charge they bill us on a monthly basis.
  - 2. I heard we are getting charged \$84 a month more than we were originally told by AnswerNet for the Service.

We are now getting charged \$84.05 a month to have the 1-888 number listed in the yellow pages. This is what Dex charges AnswerNet and they just pass this charge on to us and are not making anything off of it.

3. Why can't we insert Al-Anon contact numbers in the online entry system?

What was passed by this Assembly was to implement and maintain an AA statewide answering service. In order to include Al-Anon it would have to be submitted as an agenda item to the assembly, make it through committee and be passed by the Assembly. Of course someone could also try a floor action to liven things up a bit on Sunday morning.

Things that are coming up for me is that I will be headed to District 71 in October to do a PI/1-888 workshop and to District 11 in November to do the same.

I think the first thing that is on everyone's mind concerning Treatment is "When are we going to get to go back to MCDC in Butte?" I received an email from Dave Peshek, the Administrator of MCDC on August 19th. He wrote "Thank you for your inquiry. At this time, all outside providers of service to MCDC are still on hold. A new policy has been drafted to address how we utilize outside providers as well as guidelines for them to meet. At this time, the policy has yet to get final approval. Once

the policy has that final approval, all previous providers of service will be contacted by letter with a copy of the policy and offered the opportunity to come back to MCDC provided they are able and willing to comply with the policy. Thank you for inquiring and wanting to pursue providing AA to our patients. We will be in touch once things are finalized." I am hoping that we will resume meetings by the end of the year.

In June I received an email from Janine Barr, who is the coordinator for BTGWW whose primary purpose is to serve as a clearing house for all BTG contacts in the United States. To find a contact, just go to <a href="https://docs.pt/btgww.org">btgww.org</a> and you can request a contact or central office. BTGWW also puts out a newsletter and conducts an annual workshop. There is also a resource library. Copies of the newsletter are available in the back of the room.

The Treatment Committee is compiling a list of Treatment Centers, both in- and out-patient in their respective districts. I have also asked for the names of Bridging The Gap Chairs. At this time I am hearing from Districts 11, 51, 81 and 93 on a regular basis. I very much appreciate the contacts and feedback. Mary C-M, the BTG coordinator, for eastern Montana has been working hard to get contacts for folks coming out of Watch East. We have had many discussions about who's district different cities fall in as it can be hard to figure out by comparing the Map of the Area and the map of Montana.

I was disappointed that I was invited to only one event this summer. Unfortunately it was in the very eastern part of Montana and I would have had to take 2 days off work to be there so I had to regretfully decline.

My husband and I are registered for the International Convention in San Antonio, TX. It is my fondest wish that everyone could go. The International Conventions are most inspiring and an opportunity for further service.

## **District 11**

My name is Colby D; I am an Alcoholic, DCM District 11;

Activity in District 11 has not been without challenges and opportunity. District 11 has experienced steady and consistent participation at the regular monthly district business meetings, with 7-9 GSR's in attendance. This participation equates to approximately 40% of the Groups registered in the Billings area. All committee chairs are filled and working hard to add volunteers. In the coming months the District has plans to hold a Hotline Workshop, on "How to take 12<sup>th</sup> step phone calls and requests", this will be a potluck event and all members are welcome especially those who are on the contact phone list.

Currently the PI/CPC committee has had the opportunity to present several informational sessions in the local community arenas specializing in addiction and alcohol abuse. Tumbleweed has requested volunteers to present topics and discussion on what "AA is and what AA isn't". These presentations were received well and we have been asked to do these again as requested. The PI/CPC committee took on the task this summer of providing meeting lists and schedules at local hotels and campground facilities. The Billings Crisis Center has inquired of local members to make a meeting available to them, no action has been taken by the District but consideration will be presented at the next district meeting.

The Corrections Committee is working to ensure literature is made available to the local prison and city jail institutions through the use of "Pink Can Funds" instead requesting the District to fund these requests. This has been met with mixed consideration; opponents of the "Pink Can Fund" contend this is a violation of the traditions and could potentially cause some confusion at local groups regarding 7<sup>th</sup> Tradition contributions. Local groups continue to take and make meetings available to both the men's and women's correctional facilities, attendance and participation are good.

The Treatment Facility Committee ensures meetings are conducted twice a week at the psych center from the local group pool. The groups are selected from the hat each month for the upcoming month, thus ensuring rotation and diversity within the AA community.

The Archives Committee is actively scheduling and conducting interviews with AA members with 20 years sobriety or more in order to capture their story of recovery on magnetic media as well as an opportunity to get other relevant historical information about AA in our district.

The Alanon Committee has established a local telephone number for the district and is also assembling a mailing to local church professionals for information regarding the AFG.

The Grapevine Committee is encouraging support throughout the district for participation in our meeting in print and access to the digital archives. Groups have been given registration and subscription information forms.

Billings will be hosting the 2010 Spring Roundup, May 14-16, 2010 at the Crown Plaza; Johnny B. will be providing a full report at the 2009 Fall Assembly.

Currently, the District is experiencing a cash short fall due to reimbursing South Central Montana Inter-Group for previously paid Area 40 Hotline expenses. As a result of this action the District commissioned an Ad Hoc committee to review the District's operating expenses and budget to better understand what it's immediate cash needs are and provide accountability to the Fellowship. The Ad Hoc Committee recommended that the DCM present its' findings to the local groups with emphasis on letting groups be aware that Hotline expenses are the responsibility of the District not Inter-Group and the need for groups to revisit their contributions to these two entities in proportion to the overall operating expenses of the district. Several groups have responded in kind. Recently contributions have increased, although the district continues to be under it prudent reserve requirements. We trust that through our collective efforts to carry the message to the still suffering alcoholic the needed funds will be present.

Most groups report meetings are well attended or are growing.

We have had one "hibernating" meeting get going again on Rocky Boy in Box Elder. They have three or four (3 or 4) regular members plus "road tripping" visitors every week. So we are now up to nine (9) groups in our District and three (3) meetings that are not affiliated with a group. There are 25 AA meetings held each week.

The former Director of Hi-Line Recovery in Havre approached the District to hold an AA meeting in their facility. The Wednesday Noon Open Meeting of Alcoholics Anonymous started the first of July. Hi-Line Recovery averages between 30 - 40 clients. We hope to reach some of them. After we pay rent, we buy Big Books for the Center to give to their clients.

After attending our functions for the last three years, the two meetings in Phillips County have had a group conscious and have expressed a desire to change back to being a part of District 51. Over 20 years ago they were convinced, by a retiring judge who moved to Malta from Wolf Point, to change Districts from 51 to 21. After years of many miles driving east, they have decided to drive not-so-far west. We did not know the protocol for changing Districts so it did not get on this Assembly's agenda in time. If they continue to feel the way they do now, you will see that change request on the spring agenda. District 51 has voted, yes, to their request.

Upcoming events in District 51 include the annual Havre AA mini-conference which will be held September 25-27 at the HRDC building. That is next weekend. It is the most economical conference held in the Area. Pre-registration is \$20.00 and there are flyers here at the Assembly. Pre-registration ends this Sunday, the 20<sup>th</sup>. This is the first time ever that our District has been able to financially support a CPC luncheon. Changing over to AnswerNet has helped our District tremendously. We now have the funds to do more 5<sup>th</sup> Tradition work. I do not know much about what the CPC committee has planned. I do know it will be

a soup and sandwich luncheon that is free to professionals but AA and Alanon members are charged. They plan to show videos from GSO that are available on-line, and that they will have a couple ten (10) minutes speakers from AA members who got sober through the intervention and help from their employers.

And for the first time in years, our Delegate is coming to give the report. The past DCM tried to arrange for the Delegate's report but people in the District explicitly expressed "no." Maybe because Carole lived in Havre early in her sobriety they have finally been okay with hearing the report. She is coming to our October District Meeting on the 18th.

And there is talk of holding a Corrections Workshop this winter to try and get more people signed up to take the meeting into the Detention Center. I believe we are down to one (1) consistent member and only four (4) AA members total have been approved.

All in all, District 51 is a great place to live with active AA in all of the three legacies: recovery, unity, and service. Thank you for allowing me to serve.

# **District 61**

My name is Tom D, I'm glad I'm an alcoholic and I don't care who knows it. It's great to be at another Area Assembly, and to see a lot of familiar faces, to recognize that I actually know the names of a respectable fraction of those faces, and to see some new faces from around Area 40 and especially from District 61. Just like in our meetings, the newcomers and first-timers at this Assembly are the future and hope of AA, so welcome. If it looks a little confusing, grab hold of somebody who's been here a few times and ask for help – it will be useful, friendly and freely given.

It's been a great year for District 61, and it isn't my fault. We came into the beginning of the year with a great amount of momentum for which I am grateful to our immediate past DCM, Tim M. We've kept up a good deal of that momentum primarily thanks to the hard work of Anne B., our Alternate DCM, Rolf S., our Secretary, and Bob R., our treasurer. We started out the year with preparations for our third annual Corrections and Treatment Workshop, which is turning out to be one of the most useful things we do. The workshop was held in April with, I believe, over 100 participants, distributed about 70% to alcoholics who paid for lunch and most of whom worked during the workshop at one job or another, and about 30% professionals who, I genuinely believe, walked out of the workshop convinced of one significant fact: AA works. When those professionals include a District Judge, the County Sheriff and several ranking Helena police Department officials, as well as a great number of working corrections and treatment professionals, all of whom have seen some of us at our very worst, that is an accomplishment.

Perhaps the biggest moment at this year's Workshop was when all of the alcoholics in the room who were WATCH alumni were asked to stand. The District Judge who had committed nearly all of them to the program was visibly shaken and moved. This workshop – and we're getting started on planning for next spring's now – has done two things to carry AA's message in the Helena Area which I think are significant: first, it is allowing an increasingly large number of people newer in AA and therefore a lot closer in time to the corrections treatment that got them there to go into the institutions and convincingly carry the message that there is hope for long term recovery after the enforced treatment is over. A number of the secured institutions into which we send volunteers have become much more relaxed and trusting, and have relaxed the sobriety and recency of adjudication requirements substantially. Second, it has provided a number of professionals to hear our sobriety stories and to understand how important, if often unthanked, their contributions have been and continue to be. Another major benefit of this project has been that probably forty or more members of the District 61 recovery community participated in making this workshop activity work, and brought the enthusiasm and energy back to their home groups, to other service work, and to participation in the

greater AA. I'd like all the GSR's and other folks from District 61 who have worked and are continuing to work on this project to stand up for a minute, so the rest of Area 40 can see how big this thing really is. More mundane stuff: We have over 30 registered groups in District 61, with an average of 24 GSR's attending district meeting. There are over 100 groups or meetings up and running: if you live in Helena and have the time, you can attend 21 or more AA meetings a week. Our AA groups present a real smorgasbord of choices to the new comers – we have men's meetings, women's meetings, discussion meetings, call-up meetings, step study meetings, traditions meetings: we even now have a small group which meets once a month just before the District meeting to read and discuss the Concepts. We had a small but successful GSR School this summer, and plans are actively underway for the 55<sup>th</sup> Annual Attitude of Gratitude. We're starting to gear up to host the National Archives Conference during the next rotation, depending upon whether they decide to hold it in Montana, and we are considering hosting the Fall Roundup that same fall. We started out the year with too much money, but that resolved itself, as it usually does.

All of our service committees chairs are occupied and we're working hard to grow that new leadership in the understanding that none of us ever takes on an organized service job with full knowledge of what it entails. I think one of the great things about AA is that about the time we get to understanding a service job, it's time to turn it over to someone else, ideally with some organization and some information about what your successor is getting into.

It is an honor and a privilege to play whatever role it is that a DCM plays – I hope I'll have it figured out by the end of the rotation – with the level and depth of support I've received from our committee chairs, GSR's and District Officers. It's a good time to be sober, and to be carrying the message to the still suffering alcoholics: there are still plenty of them out there. Thanks for letting me be of service.

## **Delegate's Report**

Good Afternoon,

My name is Carole B. and I'm an alcoholic. I have the honor of serving as your Panel 59 Delegate. I am very glad to be with you again.

From this morning's reports, you know that typically the reports of the Area Officers, Chairs, and DCMs provide information regarding the activities on behalf of AA since we last met in April. This morning I want to theme my report around a word and I would like you to consider a question throughout this weekend.

The West Central Regional Forum was held in St. Cloud Minnesota September 11-13, 2009. I have a friend that lives in Minneapolis so I got to see her before and after the Forum. She mentioned to me that her word for the year is abundance. My sponsor taught me to look up words and abundance is an extremely plentiful or over-sufficient quantity or supply. Thus my word for this report is abundance.

Sunday night my friend had a cook out and I met a member of the Central Pacific Group. He asked me why I thought our membership had leveled out. I gave him my opinion but it has left me thinking. My question – what more can we do for the still suffering alcoholic? I would also like you to consider what are we doing to assure AA's future?

The week following the Spring Assembly, I headed to New York for the General Service Conference. I must say, it was a rather tough week made much more easy by the support of Area 40. The cards and letters you sent me helped me more than you could possibly imagine. Abundance.

Throughout that week we looked at ways we could help carry the message of Alcoholics Anonymous. By attending the West Central Service Conference, the Pre-Assemblies, and the Spring Assembly, I arrived in New York very well prepared. Abundance.

The theme of the Conference was "Our Commitment to Carry A.A.'s Message – Enthusiasm and Gratitude in Action." We were eased into it on Sunday and then hit the ground running on Monday. I am assigned to the Public Information Conference Committee. We had much work to do and we were asked by the PI Staff Member to come prepared. Everyone on my committee came very well prepared. Abundance.

Monday and Tuesday consisted of committee meetings, area highlights, presentations, a general sharing session, and a trip to GSO. Staff members escorted conference members to GSO. My escort, Valerie O,

made the train ride and walk to the office very enjoyable and informative. Valerie has worked for GSO for over 17 years and recently was named the Publications Director. Abundance.

GSO is located at 475 Riverside Drive very near the Hudson River and Columbia University. I had been to GSO twice before and knew the building was called the Interchurch Center. I did not know that the building is owned by the Rockefeller Foundation and leases the space to AA and others non-profit entities at a significantly reduced rate.

On Wednesday, we held the workshops, selected Bob H. as the Region's nominee for Trustee-at-large U.S., and then elected the Southeast Regional Trustee, the East Central Regional Trustee, and Trustee-at-large U.S. Page 75 of the Final Conference Report lists the newly elected Trustees and a short biography. Our Trustees are fine trusted servants. Abundance.

Then the Committee reports began. Since our assemblies are based on the committee system of the General Service Conference, I felt very much at home with the process. However, it seemed like there was lobbying and a bit of unrest among some of the Delegates and Trustees. We had agreed to a process on Sunday and then it was asked for blind ballots to be available. This began a much too long discussion of why they were needed and unfortunately, set the tone for the remainder of the Conference. Bill said and I quote "we shall always be threatened by menacing forces within and certainly in the world of great peril in which we live today, by menacing forces with out. So the prime problem of AA is how to survive then grow and prosper." Unquote. What more can we do for the still suffering alcoholic?

For the remainder of the week, we stayed late and got there early, but it didn't seem like a big deal to put in long hours. We approved many recommendations, which I think will help us carry the message to the still suffering alcoholic.

If you turn to page 6 of the Conference report, you will find the Advisory Actions or approved recommendations made by the standing committees. After the Conference, I put together a document available at <a href="www.aamontana.org">www.aamontana.org</a>. This lists all the agenda items, the action taken by the committee, and the action taken by the Conference.

- The workshops for the 2010 Conference will be taking the Conference's inventory.
- The CPC video directed to professionals was approved.
- The pamphlet "Sure Beats Sitting in a Cell" will be revised.
- The Trustees will gather information from the Fellowship regarding literature profits vs. contributions. (More about this later)
- Those not attending the 2010 International Convention can view the opening ceremony in an Internet broadcast.
- "AA for the Native North American" was approved.
- The Young People's Poster and Young People's Video were approved.
- The membership survey will be conducted in 2010.
- The revised video Hope was approved.

The Finance Committee asked the Trustee's committee on Finance to:

"Gather input from the Fellowship on the following for review by the 2010 Conference Committee on Finance: 1) If we continue to use literature profits to fund services, should there be a limit? 2) If there is a limit how do we continue to pay for services if there is a shortfall in contributions?"

I think this is along the lines with my trip to Glendive in my new car. My question was how much over the speed limit can I go without being stopped? The answer is 10 miles per hour and I was breaking the law. By the way, your money is in good hands. Linda would not pay the ticket.

John T., Area 63 Delegate said it best at the Regional Forum. I paraphrase; if we don't like literature prices going up and we don't like using literature profits for AA services, send GSO money. The prudent reserve has a cap and when we reach that cap, the AAWS Board is forced to lower literature prices. In my reports to your districts, I proposed contributing so much that they can give newcomer the Big Book for free. Abundance.

I'm anxious to hear from the Fellowship of Area 40 what they think of these questions posed. At the July General Service Board meeting, the Trustees Finance Committee has asked the 2010 Conference to discuss additional ways to communicate with the Fellowship. I am anxious to hear the ideas of Area 40.

The Conference ended with the farewell talks of the rotating Trustees. Then after a stop at FedEx and Toys-R-Us, I headed to the airport for home. I returned from the Conference tired and grateful that my home district was my first report. I got a chance to recharge my batteries a bit.

Over the summer, I have given 12 reports and have one scheduled in October. It was great to be with you. I pulled into the camp where I was to give my report to District 93 and 25-30 people were having an AA meeting. It was pouring rain and they had the meeting with umbrellas in hand. At the Lower Yellowstone Soberfest, I gave my report for District 23 and got to hear the best Alanon talk I have ever heard. I ate a rib-eye steak bigger than my head at my report in District 71. You have given me a great summer. Abundance

It is such a pleasure to be out visiting you and seeing what I can do to help you help the still suffering alcoholic.

As I mentioned earlier, last weekend I was at the West Central Regional Forum. It was the best Forum that I have ever been too. It has got me thinking about the future of Alcoholics Anonymous, taking action, and I have a suggestion for you.

Ward E., our Chairman of the Board, was asked what he believes are AA's current challenges. He answered: 1. Carrying the message on new media; 2. AA & religion; and 3. Maintaining our singleness of purpose. He said we have to find a way to reach young people using new media. He also said that with his background, it is very clear to him that AA is not a religion but the courts will continue to challenge this.

Then Phyllis H., our General Manager, was asked the same question. Her reply was Unity, Anonymity, and Sponsorship.

Ward being Class A (non-alcoholic) Trustee was asked how he learned about our Traditions and Concepts. He said Class A's are assigned a 1728 sponsor. This person takes the Class A Trustee through the Steps, Traditions, and Concepts. Ward stated that the 12 Steps are the most spiritual action he has ever taken. (Ward is the President of General Theological Seminary in New York.). The 12 steps multiplied by the 12 Traditions and then multiplied by the 12 Concepts equals 1728. Want your life to

get 12 times better? Take the Steps. Want your life to get 144 times better? Practice the Traditions. Want your life to get 1728 times better? Follow the Concepts. Abundance!

Why not have playshops (not work) on 1728? Districts could gather speakers to share their experience, strength, and hope on the steps, traditions, and concepts. Colby D., DCM for District 11, has information a 1728 Playshop format. We have a wealth of resources – Terry, Andrew, and the Past Delegates I'm sure are more than willing to help you put on such an event. I'd be honored to help.

I have an abundant life because of the Fellowship of people like you, God, and sponsorship. I'd like to close with a couple quotes from AA Comes of Age.

"A.A.'s Twelfth Step, carrying the message, is the basic service that our fellowship gives; it is our principal aim and the main reason for our existence." – Page 139

"For in AA the whole is truly greater than the sum of all its parts. The infusing power of the group, of our Fellowship, draws something more out of each of us than any of us by himself can supply. Each of us in turn draws out of the spiritual reservoir of our Fellowship the added courage and will which makes each one the stronger and our Fellowship the greater." — Page 277

# Workshop: Practicing These Principles In All Our Service Affairs-Loren B.

Loren, past Delegate Panel 51, gave an informative workshop at which 38 were in attendance. The workshop began with an interactive orientation to service for those who are new to AA, new to Service or new to the Assembly. The discussion covered such topics as what service really means; what principles guide our actions, what a panel is. After the orienting /discussion and question period participants broke up into groups to consider and discuss the questions from the Traditions checklist and the Concepts checklist.

## Workshop: This We Owe to AA's Future-Earl F.

Earl, past Delegate Panel 53, gave an interesting workshop, starting out with providing information on current AA membership numbers (1.2 million), comparing that figure to the number of estimated alcoholics in the world. Stating that approximately 4% of the world's population is alcoholic and .07% people in the world are in AA. Why aren't more of those still suffering from alcoholism in these rooms? Participants then broke up into groups to discuss questions. Here are the questions Earl asked us to discuss:

- 1. What are ways we can increase or improve communications between us (me, the group, and the fellowship) and the still suffering alcoholic?
- 2. How to make our fellowship more attractive to the still-suffering alcoholic?
- 3. With new technology available, how do we keep it simple?

A good series of discussions flowed from these questions, with some good concrete suggestions (e.g., make sure people know where to find meetings, including local law enforcement) and use technology as a support, but not a substitute for face-to-face talk and a cup of coffee.

# **Sharing from West Central Regional Trustee- Ken B.**

# **DCM Breakout Session**

Nineteen people participated in the DCM Breakout, sharing experience, strength and hope on the following questions:

Question: What are ways to generate ideas for more people to attend and participate in district meetings and the area assembly?

Responses: Invite people; reminder calls; email agenda; follow up with absentees; sponsorship; get to group business meetings; attend individual district committee meetings for encouragement and express gratitude; go to all meetings in the district; encourage and invite people to serve; share rooms at assembly; remind people to reserve rooms in Lewistown (at 1<sup>st</sup> district meeting after assembly)

Question: What activities does your district do to foster and grow participation and service?

Responses: Luncheon with panels, professionals, and AA; "meet your district" workshop; general service versus social activities, different jobs for different people

Question: How effective have Traditions Workshops been in your district?

Responses: Location and food affect participation; invite Area Committee Chair; call them something else (Living with the Traditions; Traditions in Personal Relationships, Sex and the 9<sup>th</sup> Tradition)

Question: How or what can be done to involve or encourage non-participating groups to participate in district meetings and area assembly?

Responses: Directly invite these groups; invite nonparticipating groups (especially ones with other experience and opinions) seeking their different or unique perspective; put something controversial (money is a good topic) on the agenda; no coercion; communicate caring; have fun; car pool; take district meetings to remote areas of district

Question: What are persons doing as DCM to visit other groups in their district?

Responses: Road trips; share information; ad hoc committee about what district does, money; letter to groups asking what they need from the district committee; treasurer sends thank you notes for contributions (contributions have doubled); move district meetings to other venues; call groups, ask them to host district meeting; including Intergroup in district activities; liaison between intergroup and district; invites and calls and trying to be of service to the groups; road trips to meetings (introduce self at meeting as DCM with offer to answer questions after meeting)

Question: How much does a DCM need to defend or protect district chairs; how much management is needed? Are DCM's AA police?

Responses: Reach out, ask how to be of service (rather than show up or resign); when you stick your head above the crowd, get ready to have a shot taken; communication is important; came to AA to take, remained to give; when critical, walk a mile in their shoes, that way if they become angry you're a mile away and they have no shoes!

# **GSR Breakout Session**

The GSR's had a lively Ask-it-basket session, sharing experience, strength and hope on the following questions:

#### Question:

What are we doing as a group to get people from treatment facilities to visit our meetings and to encourage members to use restraint of pen and tongue when negative opinions and attitudes about treatment exist?

## **Responses:**

Take meetings to pre-release and treatment facilities

Sponsorship, shake the new person's hand

Specific people chair meetings with specific topics, call on treatment center people

#### Question:

Who takes charge and says something if a group or district officer or committee person isn't showing up?

## **Responses:**

Group conscience to have 2 members talk to the person; ask "what can we do to help?"

Policy: miss 3 in a row and you are done, DCM makes the call

Policy: miss 3 meetings (not showing up or giving a report), will call; if no legitimate reason the person is dismissed

# Question:

Meeting uses non-conference approved literature in spite of group conscience

### **Responses:**

Have a group inventory

Start a new group

# Question:

## <u>Literature – Lori F.</u>

My thanks to my committee, represented by Nick D., DCM-12, Neil T., Alt. DCM-31, Mary M., DR-91 and Deb C.., DR-93. Thanks also to Lee from Dist.41, Bill from Dist. 61 and Dan from Dist.51 for their participation. Our first session consisted of our only agenda item:

**A.** Review the items on the 2009 GSC Agenda in Literature and the action or inaction upon each item. Five of the ten GCS Agenda items resulted in Advisory Actions:

- The pamphlet revision "A.A. for the Native North American" was approved.
- The Trustee's Literature Committee will review the pamphlet "Questions and Answers on Sponsorship" and eliminate or revise outmoded ethnic, cultural and vocational references.
- A Special Needs recovery pamphlet will be developed with stories solicited from members who are blind, deaf, wheelchair bound, etc.
- A sentence will be added to the pamphlet "A Newcomer Asks," encouraging newcomers to obtain and study the Big Book, *Alcoholics Anonymous*.
- The title of the pamphlet "44 Questions" will be changed to "Frequently Asked Questions About A.A."

Two of the ten items became additional considerations, meaning that they were discussed in committee but no action was taken or recommendations made:

- A request to publish a booklet consisting of stories from members living in remote communities, and;
- A request to publish a second volume of *Daily Reflections*

Three of the ten items resulted in recommendations from the Literature Committee, but did not result in Conference Advisory Actions:

- The recommended pamphlet revision "The A.A. Member Medications and Other Drugs" was not approved by the Conference.
- The committee recommended an update of the existing video/DVD "Your General Service Office, the Grapevine, and the General Service Structure," including an episode for both GSR and DCM. This was not approved by the Conference.
- The committee recommended that the Trustee's Literature Committee develop a questionnaire
  to gather input from the fellowship on whether a need exists to develop literature addressing
  spirituality, and agnostics or atheists/nonbelievers in A.A., and present a summary of the
  responses to the 2010 GSC. This was not approved by the Conference.

Some of our committees' thoughts and questions during this review are as follows:

- Concern expressed about Special Needs pamphlet "What is a Special Need?"
- Is A.A. publishing too many "differences" pamphlets? Maybe some pamphlets are needed to address specific issues.
- Are we asking the literature to do our job for us?
- Do we need to be "politically correct?"
- Many suffer from "terminal uniqueness" and the loss of our singleness of purpose could kill us.
- Are we being prudent with our funds, considering that AA does not appear to be growing? Is it time to look at doing something different?
- One person would like to see more of our literature address the meditation aspects of the program.

Looking back at the sense of our Literature Committee from the Spring Assembly, we noted that we were in agreement with the Conference six times.

### No discussion.

In the afternoon session, our committee discussed Area 40's policy on the Lending Library. Lori shared the following background:

As you may know, we have a lending library which consists of most of the audio and video cassettes available from GSO. This policy was established at the Fall 2002 Assembly as follows:

"Fall 2002 it was agreed that the literature committee create a lending library consisting of the video and audio tapes that are currently in the Area 40 Literature display. A simple checkout form and list of the Titles Available will be created by the 2003-2004 Literature Chair. Shipping cost, when applicable, will be paid for by the group or district checking items out."

## The Area 40 Guidelines state:

"G7.5 The Literature Committee will have a lending library consisting of the video and audio tapes that are currently in the Area 40 Literature display. A simple checkout form and list of titles available will be made available to the Area. Shipping cost, when applicable, will be paid by the group or district checking them out."

### and also

"G7.4 The Literature Committee will have available one (1) copy of all A.A. literature from the G.S.O. for viewing."

Our Area 40 Literature display is pretty representative of the literature available, but is not complete. There are many items in the catalog that we do not have, but, focusing on audio and video, the items we have in audio and video cassette form are listed on the attached (revised) check out form. We also have some CDs and DVDs (recently purchased) for our display. The literature chair from two rotations ago reports that she got no requests to borrow from the library. Last rotation there was at least one request. I have had no requests to date.

### No discussion.

The committee discussed possible reason for the lack of borrowing, including lack of publicity (groups/districts aren't aware of), lack of interest (groups/districts own items themselves or have no use for), and contents of library are obsolete (VHS and Cassette Tapes instead of DVDs and CDs). The committee then discussed whether Area 40 should continue to maintain the library. The consensus was no, but that if it was kept, it should be updated to DVDs and CDs. Other thoughts were that this service would be better handled locally by groups or districts, and that much of what's available would be something a member may want to keep, not borrow.

Based on our discussion, the Area 40 Literature Committee respectfully requests the Area Chair to place the following on the agenda for the 2010 Area 40 Spring Assembly:

"Consider eliminating the Lending Library of audio and video cassettes currently maintained by the Area 40 Literature Committee Chair and depositing the existing tapes into the Area 40 Archives."

In addition, background material will be submitted to the Area Chair prior to February 1, 2010.

### **VIII. Public Information**

A. Consider 2008 annual report from the trustees' Committee on Public Information

regarding GSO's A.A. Website.

- By unanimous vote the committee accepted the report submitted by the Trustees' Committee on Public Information.
- The committee reviewed the 2008 Annual Report from the trustees' Committee

on Public Information regarding G.S.O.'s A.A. Web Site.

B. Consider a request to add the text "Provide initial motivation" to the section "What

A.A. does NOT do" in the pamphlet "A.A. at a Glance."

- Comments from the committee were:
  - o Do we provide initial motivation when we sign cards?
  - o Attraction vs. Promotion
  - o This makes this pamphlet consistent with other AA literature so we should do it.

By unanimous vote the committee felt this should be done.

- The Committee requested that the Trustees' Public Information Committee consider placing the full text of the section "What A.A. Does Not Do" from the service piece "Information on Alcoholics Anonymous," into the "What A.A. Does Not Do" section of the "A.A. at a Glance" flyer.
- C. Review a rough draft of the updated text and graphics of the pamphlet "A Message to Teenagers...," which utilizes selected text and graphics from the current "Too Young?" pamphlet.
  - We reviewed it and felt the more we can relate to teenagers the better.
- The Conference approved the updated pamphlet, "A Message to Teenagers," containing selected text and graphics from the current "Too Young?" pamphlet, be approved with minor changes.
- D. Consider draft wall poster for young people with information about Alcoholics Anonymous.
  - Comments from the committee were:
    - o Felt the poster was "Cheesy".
    - o Concern that young people would not relate to it.

The committee unanimously agreed that the poster needed to go back to the drawing board and that young people should be brought in to work on it.

- The Conference approved the wall poster for young people with information about Alcoholics Anonymous be approved with minor changes.
- E. Consider a request "to develop a generic A.A. poster or posters for places such as hospitals, places of employment, doctors' offices, etc."
  - Comments from the committee were:
    - o This is promotion.
    - One member commented that Drinking and Driving posters did not stop him from doing it, (He has six DUI's)...

The committees vote was split;

3 - No, 1 - Yes, 1 - Abstained.

- The committee took no action noting that there was not a widely expressed need.
- F. Public Service Announcements (P.S.A.s):
- 1. Review current television public service announcements for relevance and usefulness.
  - The committee unanimously agreed with the recommendations
  - The committee reviewed the current television P.S.A.s and suggested that none be retired.
- 2. Assess the need for a new television public service announcement.
  - The committee unanimously agreed with the recommendations
- The Conference approved the recommendation that new A.A. television public service announcement (P.S.A.) be developed for review by the 2010 Conference Committee on Public Information, at a cost not to exceed \$40,000, and that full faces of actors portraying A.A. members not be shown in this P.S.A. (This was voted down and then reconsidered.)

Note: The committee suggested that older alcoholics and alcoholics with special needs be portrayed in this P.S.A.

- 3. Review information on centralized distribution, tracking and evaluation of the 2008 television P.S.A., "I Thought."
  - Reviewed the report on "I Thought" and also unanimously felt it was fine.
  - The committee reviewed information on centralized distribution, tracking and evaluation of the 2008 A.A. television public service announcement "I Thought."
- Review revised draft script of "Combination Radio P.S.A.s on CD," and consider recording revised script at a cost not to exceed \$20,000.
  - By unanimous vote they also agreed with item
  - The Conference approved the recommendation the revised script for "Combination Radio P.S.A.s on CD," omitting P.S.A. #15, be approved with minor changes, and recorded at a cost not to exceed \$20,000.

- The committee requested that the script be included in the packaging of the "Combination Radio P.S.A.s on CD."
- G. Consider draft of the "A.A. Videos for Young People Project."
  - Although we did not get to see this video we did hear that Carole our Delegate did and heard her comments that they were all good but one was outstanding. The committee unanimously voiced their approval of this project.
  - The Conference approved the four selected A.A. Videos for Young People be approved with minor changes.
  - The Conference approved the recommendation that the videos, "A.A. Rap With Us" and "Young People and A.A.," be discontinued.
  - The Committee requested that the A.A. Videos for Young People Project continue, and that video submissions be encouraged from young people in the Fellowship, especially from Spanish-speaking members.
  - The committee requested that the trustees' Public Information Committee
    consider distribution options in addition to DVD for the A.A. Videos for Young
    People, e.g., placement on G.S.O.'s A.A. Web site.

The Assembly was shown the young person's video "25 and Under- In the House". Our Regional Trustee, Ken B, commented to the Assembly on this video. Ken thought this was a great video and voted for it at the Conference, he now wishes that maybe he hadn't mainly because of the music. The music used in the background of the video is readily identifiable and he thinks that perhaps there could be an implication of affiliation to the music, its origins, and its message.

Someone asked if it was legal to use that music on the video for AA? We were reassured that permission to use the music was obtained.

- H. Consider draft 2010 Alcoholic Anonymous Membership Survey Questionnaire.
  - The committee unanimously agreed that the survey questionnaire was fine the way it is.
  - The Conference approved draft 2010 Membership Survey Questionnaire.
  - The Committee requested that the Trustees' Public Information Committee consider the purpose, usefulness, frequency and methodology of the A.A.
     Membership Survey.

No discussion.

- I. Consider the need to clarify the importance of not breaking the anonymity of living
   A.A. members in memorial announcements when one of our Fellowship dies.
  - The committee unanimously agreed that this is out of the scope of A.A.
  - The Committee requested that the Trustees' Public Information Committee develop test on the importance of not breaking the anonymity of living A.A. members in memorial announcements when one of our Fellowship dies. This test, intended for inclusion in the pamphlet "Understanding Anonymity," is requested to be brought back to the 2010 Conference Committee on Public Information.
- J. Discuss suggestion that Public Information committees "explore the use of A.A.
  Grapevine and LaVina in their endeavors."
  - Suggestions from the committee were:

District PI committees should be encouraged to buy subscriptions to the GV and La Viña and distribute them in Doctors' offices, auto dealerships, banks, hair salons, ...anywhere people have to wait and might pick one up.

- The Committee briefly discussed.
- K. Review contents of Kit and Workbook.
  - The committee unanimously agreed that the content of the workbook is fine the way it is.
  - The committee reviewed the contents of the Public Information Kit and Workbook and requested that the pamphlets "Too Young?" and "A.A. for the Older Alcoholic – Never Too Late" be included.

No discussion.

### **Treatment/Agenda- Paula H.**

The meeting was opened with the Serenity Prayer. The Treatment Committee welcomed it's new voting member, Kevin S from District 71. Thanks to April for her work in District 71. The meeting was very well attended! I really appreciate the interest and input of the 18 people who came. Thank you to Jo G from Helena for taking the minutes!

The committee has two responsibilities, Treatment and Agenda.

#### Treatment

There were no Area 40 items to discuss.

A) Review the items on the 2009 GSC Agenda in Treatment and the action or inaction upon each item.

The committee reviewed each item. No action was required. See p 8 of the 2009 Final Report for more in-depth information of those items approved.

The revised video, "Hope: Alcoholics Anonymous was approved.

The treatment committee's scope was expanded to include service to Special Needs/Accessibilities and the name of the committee was changed to Treatment Facilities/Special Needs/ Accessibilities. There was discussion in our committee about what Special Needs are and how Round Ups, Districts and groups can provide assistance.

See p 59 for more in-depth information on the recommendations by the Conference Treatment Committee.

Additional information on carrying AA's message to treatment facilities with out-patient programs be developed using shared experience. This information will be included in the Treatment Facilities Workbook and Guidelines. The committee also suggested staff continue to gather shared area experience and that the trustees' Committee continue to explore ways to carry the AA message to treatment professionals and patients in out-patient treatment settings. Districts in Montana are already working with out-patient treatment centers.

Additional uses of the AA Grapevine and La Vina in Treatment Facilities endeavors or that groups be encouraged to adopt a treatment facility or center for the purpose of providing subscriptions and/or back issues of the AA Grapevine.

It was suggested that the video "Hope" and the AA Grapevine as well as uses/examples of "Local Experiences" be included in the Treatment Kit.

We discussed Bridging The Gap. It is a contact program in both Corrections and Treatment. Sometimes both committees serve the same facility so cooperation is needed to avoid duplication and confusion. Tel-a-Med is available to bring meetings to remote locations. Ask Tom D of Helena for more information.

The Helena Treatment Committee is in the process of producing a policy and procedure manual. Paula has a BTG made up in 1996 by the Area Treatment Committee she will pass on. Much of the information was taken from the Treatment Workbook.

### No discussion.

### Agenda

### A) Area 40 Item

The committee unanimously recommended the implementation of a standardized format for submission of Agenda Items to Area 40, including the following header items, to facilitate intent, benefits, funding, background, and reasoning for proposed change: "(1)Describe Your Proposal; (2) List the primary Benefits to the Area; (3) Estimate of funding required; (4) Additional Background; (5) How did the Proposed Change come to be; (6) Why should the change be made; (7) Final Comment." District 12 did a great job using their proposed format to submit this agenda item. The committee was very impressed.

### **Discussion**:

Brenda: Is there a place on the format for the names of submitters? Is there a place on the format to enter the resolution of the agenda item?

**Answer: No** 

Andrew W.: This sounds as if your committee would like for this to be adopted by the Assembly. Is this correct? Please clarify if this is meant to be mandatory or merely suggested.

Paula: Our committee feels it is more of a suggestion.

Billie Jo: I think the streamlining of our agenda item proposals would be wonderful.

Jewel Lea: As a new person, I see this as a great tool for explaining the proposal.

Coming out of committee I thought this was to be a motion to adopt this new way to submit agenda items.

Rich K.: Items coming out of committees would they have to do this too?

Andrew W.: As currently worded, nothing is required for anyone.

Carole B. Items from committees are not agenda items but made and seconded motions.

Lori F.: I love this idea and I am going to use this format to submit a Literature agenda item for the Spring Assembly.

Nick D: Our thought when submitting this was for this to become a definite Policy and Procedures item for use when proposing agenda items. Not kinda-sorta but concretely. There are so many proposals where it is hard to figure out what it is and why is it being proposed.

### **BREAK FOR DINNER**

Paula H.: The Agenda committee would like to make the recommendation that Area 40 implement the standard format (described above) as the procedure for submitting agenda items to the Area Assembly.

Voted. Motion passed, unanimously.

B) Review the items on the 2009 GSC Agenda in Treatment and the action or inaction upon each item.

As always, it was interesting to note how our area voted on items compared to the General Service Conference.

The committee reviewed each item. No action was required. See p 6 of the 2009 Final Report for more in-depth information of those items approved.

The Conference approved the theme for the 2010 General Service Conference "Practicing AA's Principles--the Pathway to Unity." and the presentation/discussion topics. The workshop topic will be "Discuss the General Service Conference Agenda Selection Process."

The committee reviewed the General Service Conference Evaluation Form and made no changes.

For more information on how the process works see p 35, "Conference", and p 36, "Cooperation with the Professional Community/Treatment Facilities."

# No discussion.

We ended the meeting with a great discussion about getting committee members to meetings. Food, Area Treatment Workshop, reminders a few days before the meeting, giving committee members a job at the meeting, getting new members if the current ones are not fulfilling their duties, and job descriptions were some of the suggestions.

# **Archives**

**Item A.** Consider budgeting the \$1000.00 per year to the Archives Committee for defraying reasonable and proper expenses of the Archivist for travel and display of Area Archives at AA functions (including group/district/regional events) within Area 40, limited to three (3) activities per year on a first come first serve basis by requesting group/district on a rotating basis.

The committee felt the \$1000.00 was too much and after input from the Archivist, the figure of \$500 was more realistic. Also to prevent multiple trips to the same District in the same year, the word 'group' would be dropped from the agenda item. For the purpose of clarification, the phrase "excluding Round Ups" would be added to the agenda item, because by past action, they are intended to be self supporting. It was also decided the item was vague in how requests for the Archivist and the rotation of visits was to be handled. So, the Archives Committee recommends:

The Archives Committee recommends budgeting \$500 per year to the Archivist for defraying the reasonable and proper expenses of the archivist for travel and display of Area Archives at AA functions (including district/regional events) within Area 40, excluding Area Round Ups, which by past action are intended to be self-supporting. Fulfillment of requests is limited to availability of funds and the archivist.

### **Discussion:**

Linda B: What about the Archivist's budget of \$ 2700.00? Other chairs travel and they only get \$250.00, why should Archivist get more?

Gerry R: The \$2700.00 is money earmarked for Archives maintenance.

Tim H: \$500. is the amount our committee felt would cover the Archivist's travel.

Linda B: Are there any other items that will impact our budget? Let's keep this in mind, .the budget is about to be presented.

Tim H: this is the only thing affecting the budget that our committee is considering.

Lori F: How many requests does the Archivist get to travel?

Gerry R: None this year, in the past years it has been approximately four or so.

Scott W: I support the idea for the Archives to go out to the Districts. Why is this coming from the Archives committee is this a mistake?

Tim H.: Yes, it should read to the Archivist.

Leo Mc: It was supposed to help those districts or groups that cannot afford to fully fund a visit by the Archivist.

Vote: 89 For; 12 Against. Motion Passed.

**Minority Opinion:** 

Billie Jo: Last fall we set a budget, this spring we expanded it for the Archivist; now again we adjust it? I am against it.

Richard L: I love AA history, I believe the reason I voted against it is that we have always had the Archives at functions before and never needed this extra travel budget, why do we need it now all of a sudden?

Rich K: I voted against it. We will have a new budget next year, I don't see why it can't be included in the 2010 budget.

Tim H: What we are discussing is going into the 2010 budget.

**Item B.** Review the items on the 2009 GSC Agenda in Archive and the action or inaction upon each item.

The committee took no action.

# **Area 40 Structures and Policy**

**Item A.** Consider modifying the Area 40 election procedure to require all nominations for Area Standing Committee Chairs and for the Triangle Editor be made by the District Committee Members (or the alternate in the absence of that DCM), with each district making not more than one nomination for a particular position.

The committee felt this would be too limiting, and could, in fact, reduce the pool of qualified candidates. It was also felt that it could pose a dilemma for DCM's if, at the Assembly, more than one person in their district decided to stand for the same position.

The committee took no action.

### No discussion.

**Item B.** Consider changing Paragraph G10.12 of the Area Policy and Procedures Manual to read, "The Triangle Editor must be computer literate with knowledge of word processing software. If necessary, the Area 40 will provide the Editor with a computer, printer, scanner and all software necessary to produce the Triangle."

The committee felt the word "must" was too exclusive. The committee discussed the need for suggested, repeat "suggested" job qualifications. The Area 40 Policy and Procedures Manual lists the job duties but does not mention any suggested qualifications.

The committee took no action.

### **Discussion:**

What is computer literate and who judges this?

Glenn: I don't understand what is meant by computer literate, the editor should have the skills to put out the Triangle.

**Item C.** Consider changing the last sentence in Paragraph G11.4 of the Area Policy and Procedure Manual to read, "The Secretary must be computer literate with knowledge of word processing software."

The committee felt the word "must" was too exclusive. The committee discussed the need for suggested, repeat "suggested" job qualifications. The Area 40 Policy and Procedures Manual lists the job duties but does not mention any suggested qualifications.

The committee took no action.

### No discussion.

**Item D.** Consider adding a guideline to the Area Secretary at G11 of the Area Policy and Procedure Manual to read, "The Secretary will serve as the Area Registrar and be responsible for updating GSO's database, Fellowship New Vision (FNV). As Registrar, the Secretary will update group, district and Area information and work closely with each DCM to assure the Area groups are receiving correspondence from the General Service Office."

The committee felt the word "current" should be added to reflect any future changes for updating the GSO database. Therefore, the committee recommends that we add a guideline to the Area Policy and Procedure Manual:

"The Secretary will serve as the Area Registrar and be responsible for updating GSO's current database, Fellowship New Vision (FNV). As Registrar, the Secretary will update group, district and Area information and work closely with each DCM to assure the Area groups are receiving correspondence from the General Service Office."

Vote: 97 For; 2 Against. Motion passed.

**Minority Opinion:** 

What is the cost for changing the Policies and Procedures manual when the secretary does this already anyway?

Jim B: I'm against it because I don't like to always vote in the majority.

**Item E.** Consider adding a guideline to the Area Chair at G13 of the Area Policy and Procedure Manual to read, "Shall work throughout the rotation with the Area Standing Committee Chairs and the Triangle Editor regarding succession planning for the next rotation and with the Chairs and Editor will seek out persons interested in knowledgeable to stand for election in the next rotation.

The committee felt this would be redundant and should already be taking place.

The committee took no action.

No discussion.

**Item F.** Consider adding a line item for pre-assemblies to the Area 40 budget to defray the expenses of Area Officers and Chairs for participation in three (3) pre-assemblies each spring, one in each generalized portion of the Area—Eastern, Central and Western Montana—either face to face or by teleconference (per the host district's preference for each pre-assembly each year, keeping in mind expenses), with the districts each portion conferring and deciding whether to hold such a pre-assembly and, if it will be held, which district will host it.

The committee felt that with no dollar amount specified in the agenda item, they took no action.

### No discussion.

# **Corrections/International Conventions-Regional Forums**

A. Review the items on the 2009 GSC Agenda in Corrections and the action or inaction upon each item.

### We reviewed each item and felt we needed to take no action these were the items:

- . Consider alternatives to biennial mailing to corrections professionals, focusing on those that may be more effective and fiscally prudent
- . The Committee's suggested:
- . That the automatic biennial mailing begun by additional consideration to the Conference Committee on Corrections in 1999 be suspended indefinitely
- . That the American Correctional Association Directory of Adult and Juvenile Correction

  Departments, Institutions, Agencies, and Probation and Parole continue to be purchased on
  a biennial basis and the contact information therein be sent to the relevant area corrections
  committee chair.
- . Consider updating the pamphlet "It Sure Beats Sitting in a Cell."
- . The Conference approved the recommendation that the Trustees' Committee on Corrections undertake a revision of the pamphlet "It Sure Beats Sitting in a Cell" which will take into consideration:

- . More stories of recovery from alcoholism through the principles of Alcoholics

  Anonymous, drawn from Sharing From Behind the Walls, Box 4-5-9, or other available sources
- . Less use of outdated and directive language (such as that used in the section on H.A.L.T.
- . Including photographs that reflect current times.

and that a draft pamphlet or a progress report be brought back to the 2010 Conference Committee on Corrections.

. The Conference approved the recommendation that the photo on page 18 of the pamphlet, "It Sure Beats Sitting in a Cell," which shows an inmate smoking a hand-rolled cigarette, be replaced with a photo of the current edition of the Big Book, Alcoholics Anonymous, in future reprints, as well as in any revision.

Note: The above items originally came out of committee as additional considerations. The Conference sent it back to committee and these became Advisory Actions.

- 1 . That the list of contents be corrected to indicate that both the Corrections Correspondence Service flyer for the outside A.A. member (F-26) and the Corrections Correspondence request form for inmates (CCS-2) are included in the Kit.

- . That the Spanish-language and the French-language Corrections Kit contents be updated to match as closely as possible the English-language Kit. The committee heard a report from the Publications director that A.A. in Prison: Inmate to Inmate will be completed in Spanish by fall of 2009, and the DVD A.A. in Correctional Facilities will be available in a compilation of all three languages by the end of 2009.
- . That a copy of the booklet A.A. in Prison: Inmate to Inmate (in the appropriate language) be included in the Kits.
- . That the list of Corrections Kit Contents be placed on G.S.O.'s A.A. Web site in the Corrections 'bucket' with the appropriate links to each service piece, pamphlet or book, where available.

- . Consider a broadcast of the 2010 International Convention Opening Flag Ceremony similar to the encrypted, anonymity-protected, delayed extranet broadcast of the 2005 International Convention Opening Flag Ceremony.
- . An encrypted, anonymity-protected Internet broadcast of the 2010 International Convention Opening Flag Ceremony be approved.

- . Discuss ways to encourage interest in Regional and Local Forums.
- . Be enthusiastic in announcing the Forum in advance, and reporting on it afterwards.
- . Write an article about the Forum for a local newsletter or Web site.
- . Participation is key—get people involved in the planning of the Forum, as greeters, hospitality, registration, etc.
- . Encourage all segments of the Fellowship to attend, including those who speak other languages.
- . Seek ways to prevent conflicts with other local events, such as sharing weekend A.A. event schedules through a central office or intergroup.
- . Let members know that Local Forums can be requested by any A.A. entity; the request does not need to come through the general service structure.

B. Consider responses to the passed recommendation, at the Spring 2009 Area 40 Assembly, that the Corrections Committee request a Local Forum on Corrections from the General Service Office to be held in the spring of 2011 in Great Falls, and that any district wanting to place a bid for location as well as suggest theme(s) other than Corrections for this Local Forum may submit same to our Area Chair by July 1, 2009.

We considered the responses and made a decision to take a new plan of action.

C. Consider including Miles City as a second location along with Great Falls for a 2 day Local Forum event for Spring 2011.

There was discussion.

The Corrections/International Convention and Regional Forum Committee recommends that a Forum request be submitted to GSO for Area 40 to host a Local Forum, one day in Great Falls, one day in Miles City for the Spring of 2011.

Discussion:

Geoff: How did you come up with those two cities?

Mary S: the recommendation was passed in the spring for Great Falls, then Dist 31 put forth an agenda item that it be Great Falls and Miles City.

Linda B: Do you have local groups willing to set up the venue for the forum?

Mary S: Yes, we have groups in both places willing to organize this event.

Lance: I don't know why Miles City was suggested but it is a good place. we had better attendance at pre assembly than Helena.

Paula H: Is this forum repeated or is it two different forums?

Mary S: I believe it is repeated. Eric: are there any costs to Area 40?

Mary S: this is on GSO's dime.

Gary: I was on the committee the last time it was split and the forum is the same (repeated) in each place.

Andrew W: I love a road trip. How is GSO staff getting from Great Falls to Miles City?

Mary S: We thought that you would drive them.

Scott W: We have done a lot of homework on this and it is all covered.

Lori F: Do I understand this correctly that if we don't pass this motion that we will still have the forum but it will only be in great Falls?

Billie Jo: If we get the Archives workshop to come here will this conflict with the forum?

Answer: No it will be a different time.

Rebecca: we talked about cost of the forum and decided that the 7<sup>th</sup> Tradition can defray any costs we might incur.

Joe H: Let's not have a registration fee, we made enough with 7<sup>th</sup> Tradition in Great Falls last time we had a forum.

Scott W: The forum request form does allow a registration fee but let's not exercise this option. We only need to cover the cost of the hall, flyers, and a hospitality room.

Jewel Lea: The expense would come from districts 31 and 41, I think this would be a boon to a remote area such as Miles City and eastern Montana.

Question: I thought GSO would cover the whole cost of the local forum.?

Answer: That is not how it is written. It will pay for GSO representatives to travel and for all the materials they use. The local AA community is responsible for the venue.

Vote. 91 For, 2 Against. Motion passed. No minority opinion.

D. Discuss how Area 40 should begin preparing for the 2012 West Central Regional AA Service Conference (what deadline for districts to submit requests to host, how to research the appropriate guidelines, etc., and who will be responsible for early planning and preparation). There was discussion in the committee. We decided to begin by finding a place to hold it.

The Conference/ International Conventions and Regional? Forum Committee request that any district wishing to submit a bid for the upcoming West Central Regional Service Conference which will be held on March 2,3 and 4<sup>th</sup> of 2012, be sent to the Area Chair by February 1, 2010. Bids will then be reviewed at the 2010 Spring Assembly.

Upon sharing this on the floor with assembly, some ideas came out to help any districts wanting to submit a bid. The West Central Regional Planning Guide will be posted on the aa-montana.org web site as well as helpful criteria to put together a bid. Any other pertinent information like past Area 40 minutes regarding the last WCRSC which was held in Bozeman in 2001 can be used as reference.

### **Discussion:**

Linda B: I did the bid package for Billings, it might be useful to hear necessary requirements now so that districts can realistically entertain the idea of hosting the WCRAASC.

Mary S: A bid city would need an airport, hotels, restaurants, and public transportation or car rentals available.

Lori F: How big is the bid package? Can it be put on the Area 40 AA website?

Mary S: The planning guide? Yes I can put it on the website.

Libbie L: is there a formal base packet to fill out separate from the planning guide?

Mary S: There is no form per se, but there are very clear directions. Plus we have resources from others that have done this before.

Gerry R: As the Archivist I was sent a request for a previous bid package to use as an example, If there is a form I didn't see one. If there is a form, please get it to me we need our archival stuff to be as complete as possible.

Sharon S: I don't recall a form but the guide is very clear.

Joe H: The last conference was in Bozeman. Our Delegate will get correspondence from GSO.

Mary S: We have the guide, it is very specific and will be useful in writing out a bid.

Andrew W: Bozeman was a blast! It happens only once every 8 years in Montana. The districts should go for it!

Loren B: I was Delegate during Bozeman, I just want to say go for it don't let the lack of a form concern you. Start now to get your bid in.

# **CPC/ Trustees- Virginia R.**

In attendance were all 4 voting members: Donna from District 21, Marylor from District 81, BilliJo from District 51, and Duane from District 42. We also had Paul from Whitefish and Kelly from Bozeman and were visited by past-delegate, Andrew in the afternoon.

We reviewed the background information from the General Service Conference. It was recommended at the Conference that the video segment directed to professionals in the employment/Human Relations field to be streamed on GSO's AA website. There are already videos prepared for the medical and correctional professions.

We were also interested in ideas brought forward about how to utilize the Grapevine in CPC work. Suggestions included adopting a professional and taking them a single magazine or a subscription, "losing" a Grapevine in your doctor or lawyer's office and inviting Grapevine reps to participate in local CPC presentations.

We talked about what our district CPC committees have been working on. One district drafted a letter for professionals about how AA can be of service to them. One caveat they discussed is how not to make the particular professional think we were insinuating that they themselves needed our help.

Also included in our discussion was how to include people in CPC work who are not computer-literate.

Finally, we reviewed a power-point presentation available from GSO that is a self-contained AA information talk for professionals.

### No discussion.

#### **Trustees Committee**

We talked about the fact that there are generally 21 class A and class B trustees serving at any given time. At present, we have 3 vacancies. We were wondering why they weren't replaced. It seems that there is sufficient work to be done among the 21 so why aren't there alternate trustees, much as there are alternate delegates? We learned that those responsible for replacing these 3 trustees opted not to do so. In the Service Manual, there is a rather vague method in place to replace vacancies but we thought we could come up with something more specific. As a result, a motion was made, seconded and voted upon unanimously by our committee that Area 40 consider recommending that the General Service Board develop guidelines for contingency plans when the number of serving trustees drops below 19.

### Discussion:

Kevin M: Is there already a plan in place or are we making one?

Virginia: This plan is just more specific than what is already in place.

Rich K: Why the number 19? When does the floor become inoperative?

Virginia: We felt 19 was a good number. The work load is huge for these trustees so we figured with only two vacancies the work would not stop or suffer too much neglect.

Jim: It seems the Service Board chooses to use the number 18 as the time to replace vacancies so I would like to use 18.

Tom D: What are we being asked to do?

Billie Jo: 19 is 10% that is a significant shortage.

Andrew W: It seems as this a made and seconded motion to submit an agenda item to the conference.

Glenn: I have no idea what a trustee is and how this is ran. Should we be doing this?

Ken B: This is just basically asking if the fellowship has thoughts on how we vote for and replace our Trustees. As it is now we have no trigger to mandate the filling of slots. The board has bylaws governing this process so basically, anything put forth would be a recommendation to the board to rewrite its bylaws.

Loren B: this is like a black hole, this is what happens when things are not put on an agenda. if we put stuff on the agenda we can research it. Let's do that- it might be prudent.

Linda B: is the reason for not filling Trustee vacancies a fiscal one?

Virginia: No.

Paul L: I am on this committee, it seems as the number of Trustees goes down, the amount of work per person goes up. It can get overwhelming, we decided to recommend this so that all issues receive attention and work does not suffer.

Tim H: I think this a good idea but I go into fear when we consider a floor action without using the agenda process first.

Ken B: The standard work load for a Trustee is being on 3 committees. Two people are on 4 committees, and one person is on 7 committees.

Connie R: We might need to pause, this all sounds reasonable but should we rush into this?

Tom D: It seems we need a Point of Order to table this issue. This will give us time to study the background material and form a better proposal.

I move to table this motion from the CPC committee.

Motion seconded.

Joe H; I am addressing the motion to table the recommendation, this means that if it is tabled it will not go to GSO until two years from now.

Vote on motion to table the committee's recommendation. 29 For; 57 Against.

Call for Question.

Scott W: My experience about items going forth is that it is best to have a solution to present. For Class A and B Trustees, we would be asking GSO to rewrite their voting process, can we hammer out a viable solution to offer with our suggestion in 15 minutes?

Question: Is this even <u>our</u> job, to tell the Trustees to get more Trustees; to basically tell them how to do their job?

Joe H: Question.

Lloyd: Second

Vote to stop discussion. 84 For; 5 against. motion to stop discussion passed.

Vote for the recommendation from the committee. 40 For; 51 Against. Motion failed.

Minority opinion:

Tim M: What I heard is that this is a shot over the bow to get these guys to fill these vacancies. the Trustees are overworked.

Glenn: The trustees topic is not clear, if we had guidelines it would be more clear.

Carol: I believe we need something in place to bring in Trustees when vacancies occur.

# Finance-Linda B.

Serenity prayer. Linda: Two items: Reviewing items, benefits and liabilities spiritual and practical of funding AA through the contributions of the Fellowship. They have asked to gather input from the Fellowship. If we continue to use some literature profits, what's the limit? As of a couple of days ago, there's some background on that issue. Trustees are asking for input. Is there a deadline for input? Don't see one. Last time there was a very short turnaround on getting information back.

Attach: Report of the Subcommittee on Self Support January 28, 2007. Perceptions: We versus them, misinformation being perpetuated. Terry: Need to talk to each District and groups, put in, and get back to us, by the end of the year. Try to get it back by the end of the year. Jenn: Would be helpful to have a uniform survey tool to get a uniform kind of answer. Carole: Came back from the Forum feeling uplifted. Came back from the service conference feeling down, there needs to be somewhat of a movement for talking about it in meetings that we need to make sure that AA is here in 20 years. Doing our part. The unity is not there so much in Billings. May talk at District, but not becoming unified as a district, a WE program. Too much WE and THEM. Needs to be WE as a whole. Money, albeit important is just a tool, it will come if it is an informed group conscience. In presenting back to the general body of area 40. Linda: Questions have to be the main part, that's what they are asking: Should there be a limit? We need to put something on paper. We are funded by our voluntary contributions. Would like to strike the word "voluntary". We have voted to have these services, but we don't pony up.

Bettie: AAs are not welcoming of rules or coercion. That's what voluntary says. To throw out voluntary throws out a principle. Jennifer: Want a minority opinion. We already lost our Directory, what's next. Feel like there can be social pressure not to adhere to this proposal, need to allow comment, maybe interesting things will come out of there.

\$13 million dollar issue here with literature sales. Could see limiting lit contributions to 2009 levels. Personally could see shooting for ideal is to be fully self supporting. Go to three groups, a ton of newcomers, not so much 7<sup>th</sup> tradition generation. Also go to a big 7<sup>th</sup> tradition meeting it exceeds his funds by 2 or 3x. Feel bad about that, but also acknowledge his fresh from treatment folks. Need the profit from literature to carry on the work they do. Only concrete suggestion is We suggest we limit contributions to X level, or X dollar amount.

Linda, Have a goal, a percentage to work toward.

Terry: Like that, but there is a business here with employees, with fixed employees. The second question is if we put a limit, what are we going to cut, How spiritual is that? Are we willing to be responsible for cutting vital services and fire people:

Carole: Are we really getting the message out, if our membership has leveled out? How do we recruit and maintain reach and attract keep good members? It's a unity thing.

Doug: Encouraged by District 11, poster going around for support. Little bullet points – your 7<sup>th</sup> tradition supports these services.

Jennifer: Feel like the money is secondary to reaching out – at regional forum mentioned that treatment is no longer such a source, maybe we need to reach out more actively get back to our roots of spending time with new people and getting them involved.

Carole: Hit the nail on the head.

Terry: Input, each group would do their own thing – self support statement is all we are able to do at this time. Before we can answer the question, need the time to get the new people in, before we start skashing the service structure. Feel both ways, listen to people who are hostile to outreach materials, it isn't either or, how do we get people to meetings? Then reach out to people in meetings. Need to figure out better ways to reach out. The answer to question 1 is who goes.

Doug: For a bean counter the reality is if the money isn't there, things get cut. The upside is that when the numbers are there, we hire more people, do more things. Disagree, feel there should be a limit.

Undisciplined in a lot of ways, but disciplined in a bean counter way. In favor of putting a limit. Need to be working toward a goal, to be fully self supporting.

Carole: Area 63 proposed agenda items, ended up as background item, to be fully self supporting by 2020. Then the question is, what happens when you're not? What do we do with the resentment if GSO takes action to adhere to this?

Terry: A procedural question: Break at noon:

Linda: Let's get that birthday contribution going,

Jennifer: If our primary purpose is carrying the message to the still suffering alcoholic, how do I explain to a newcomer that we are putting money first?

Betty: The practical should always be in support of the spiritual. Like numbers too, but that's the practical thing. How do we use that to support the spiritual. "Back to Basics" book, research on how early members brought in members. He suggests a four week 12 step immersion, get people who are willing to share, work with the newcomers, take them through all 12 in 4 weeks, going to try this with her home group in Butte.,, There are a lot of pre-release members there. Where did it switch from us to calling the newcomer, to them calling us? People couldn't stay sober with once a week contact. Carole" Propose those 1728 workshops Steps/Traditions/Concepts, traditions how we play well together, concepts, how we survive. Have changed a lot how she sponsors, call them a lot when they disappear. Continue to reach out.

Linda: Second one: Discussion of different ways to communicate with the fellowship, advisory action #8. Terry: I hope we never step over a drunk to adhere to a Tradition, Paul C.

# Finance ...(cont)...... Room 328

Linda: Good discussion this morning, tell Area that we are going to draft a questionnaire to send out to the District 72 groups, send it with our Delegate as Background information for the Spring.

Terry: Put a deadline of Election Day of November 2<sup>nd</sup> for submission groups. Send in q questions to Linda by September 27, next Sunday, meet at the roundup in Bozeman to finalize the questionnaire. Response time, is November 2<sup>nd</sup>.

Conference approved recommendation of ways to communicate the 7<sup>th</sup> tradition. Birthday plan, etc. Linda – what if we had an Area 40 blog? Who would oversee the content?

Jennifer: Security is a real problem with web sites/social networking sites.

Terry:

Linda: Q? Do you feel that literature sales is a form of contribution?

Discussion:

Tom D: If literature is sold to us even at 25% increase this is still cheaper than any other literature we can buy. What else will we spend profits from literature sales on if not the fellowship? Sue: When is that survey form available and where?

Linda B: We are coming up with a draft on October 4<sup>th</sup> or 5<sup>th</sup>. We will then put it out via email.

Last page of packet in Financials, budget worksheet: The \$1500 archivist training is not yet included in the budget, voted in at Spring Assembly. added to the \$3939, brings us to \$32,504. 2010, Spring and Fall Assembly, don't know of any different pricing, Spring \$4,465, under by \$540. Leave it alone, in case price rises. Need funds to cover travel to Special Forum in Rapid, Terry contributing funds from his travel. We are leaving budget the same for GSO \$700 to New York. Carole used \$479. May need to go in early next year, leave as is.\$844 travel bills for Carole, reduced Roundup budget to \$250, since in Billings, then goes to Butte. Maybe send the Area PI person to the Special Forum in Rapid. One year budget, need to mention that for the future, to be clear. Terry is looking at a \$500 area chair budget. Archives \$3780. Archivist training \$1500, does he have to go next year 2010 too? Why? To report on it, another \$1500, or leave it at \$0? Need to hear back from him. Archives chair, All chair positions have been at \$250,

including preassemblies. Everything is under spent, but leave it there, so there's not a perception that there is no travel funds. PI Chair has only spent \$65. Lori, purchasing literature, to restock \$545, leaving travel at \$250. Carole, suggest just leaving it there. Jennifer: Suggest the PI and CPC chairs be considered for travel to the Native Forum in SD. Put on the Spring Assembly agenda, note that it wasn't on the budget because not passed. Linda Secretary: \$50, not much postage and paper. Leave as is. Treasurer, went over this time, probably not next time. Leave as is. Webmaster, upped to \$170 for increased costs. Triangle costs:\$2400 for 8 issues. \$1500 for software updating and new computer if needed. Postage is going up again in 2010. Suggest as \$1,000 could be achieved with a netbook and large screen to plug in. As functional as a full size.

At \$29,969, based on our expenses. Total income \$28, 673 in 2008. Brings it in line with our contributions. Actual \$22,910 for 2007.

Linda B: Gerry do you have to go to the 2010 Archivist Workshop in order to receive seed money for 2011 Workshop should we win the bid to host it?

Gerry R: I do not have to go to receive the seed money. If we win the bid I might go for one day maybe...

Linda B: so we don't know.

Gerry R: Yes.

Tim M: the basic rate is \$50/ mo plus \$84.05. The basic rate for publishing phone numbers is \$55/mo plus \$84.05.

Paula H: If we changed the hotline budget to \$1600. there would be no cushion, we need to raise the budget to \$1800. to have the cushion to cover the districts that might not be able to pay for the phone service.

Vote on the 2010 Budget. 87 For; 5 Against.

Minority opinion:

Colby D: Our estimated income is less than our estimated expenditure – this is not prudent.

Carleen L: What do we need to add to the Prudent reserve? Is that included in the \$773.25 shortfall? Linda B. No.

Also, if you remember, we tried to get the word out that anyone with less than 6 months sobriety would get free registration, 56 people took us up on that offer. It was great to see so many newcomers when we did the sobriety countdown. Out of the 625 registered, there were 444 from AA, 101 from Al-Anon, 51 double winners, 15 from Alateen, and 14 guests. People came from 112 different cities, from 13 different states. Judging from the smiles, laughter and tears from everyone, this was an experience that will not be soon forgotten. The round up committee was an incredible example of what a little co-operation between

members of Al-Anon and AA can accomplish together backed by some willingness to be of service to others. It taught us a lot about our "real" singleness of purpose.

After all the seed money was returned to the District 81 groups, and the seed money was sent to Bozeman, we had a surplus of about \$3000. We sent \$1000. to GSO, split another \$1000. out to all the Area 40 Districts, and put the rest in the District 81 checking account.

We hope that Bozeman is as blessed as we were with their Round Up this fall, and thank you all for helping to make our Round Up experience so rich and rewarding.

# **Flathead Valley Intergroup**

Hello from the Flathead Valley Intergroup. We represent the AA groups throughout District 91. Our monthly newsletter and business meeting minutes are mailed to groups from Elmo to Eureka, and any other who request it. Each group in the valley is entitled to one representative to Intergroup.

We continue to provide the answering service and meeting schedules to help carry the message of AA and let people know where AA meetings are, and why we are here. The answering service continues to field 50-100 calls per month, providing meeting information or connecting the caller with a recovering alcoholic. We update our meeting schedules about every 3 months and our website is updated weekly with meeting changes and event updates.
