Welcome to the Assembly

Terry S., Alternate Delegate/Area Chair, opened the Assembly at 8 AM. The Serenity Prayer was led by Dan from Dist 71; Jeannie, Dist 41, read the 12 Traditions; and Grant, Dist. 81, read the short form of the 12 Concepts.

<u>Roll Call</u> was taken by April, the Area 40 Secretary. There were 14 of 14 districts present with 112 voting members, and 30 visitors for a total of 145 attendees at the 2010 Spring Assembly.

Orientation to the Assembly- Carole B., Area 40 Delegate

Good morning! My name is Carole B. and I am an alcoholic. It is my honor to serve you as your Delegate to the 59th General Service Conference. We are here today to obtain the conscience of Area 40 regarding items on the General Service Conference Agenda and some Area specific items. Our goal, as always, is to help the still suffering alcoholic so that when anyone, anywhere reaches out for help, AA is there.

Would everyone who is here for his or her first Assembly please stand up? Thank you for being willing to serve AA. The spirit of rotation has always served AA well. Just like when a new woman comes to my home group; my energy and enthusiasm increase when I see someone new fired up for AA service.

Each DCM has a signup sheet and we would ask that everyone – especially General Service Representatives (GSR's) sign up. If you don't sign up with your DCM, you will not be considered a voting member. Also, non-voting members are asked to sign up so we have an idea how many people attended this assembly. Each DCM will turn the signup sheet into our Area Secretary, April.

Lori, our literature chair, has AA Service Manuals for sale. If you would please take yours out. Page S25 discusses the Group and GSR, page 31 the district and DCM, S44 the Area Committee and S48 the Delegate.

The Service Structure is shown in a great diagram on page S16. There are 93 Delegate Areas and each is shown on page S90 and S91. Page S54 describes the Annual Conference, for which we will be discussing the 60th Conference's agenda.

AA business is conducted using substantial unanimity or 2/3 vote. As such, we are mostly in agreement when an agenda item is approved. Recently, an item on the General Service Board Agenda failed lacking 2/3 vote. The item was routine in nature but the minority expressed their opinion, a change was made to the motion, and the motion passed. Or, more simply, this is a way for a bunch of disagreeable people like me to find a way to agree.

Our Area Chair, Terry S, compiled the agenda you have before you. For this Assembly, we will discuss items on the General Service Conference Agenda and Area 40 specific items.

But what do we do first? Well, the Area Committee, District Committee Members, and non-voting Area Committee members will give their reports. Then the individual committees will meet. As stated in Area 40's Policy and Procedure Manual, we utilize the committee system similar to that of the General Service Conference. At my first Assembly, we did not utilize the committee system and I think we spent most of Saturday figuring out which side of the room was to be non-smoking.

Each committee consists of two DCM's, two District representatives and is chaired by the respective Committee Chair with a couple of exceptions. The Area Treasurer chairs finance and the committee consists of the Delegate, Area Chair, a DCM and a District Representative. Literature has one DCM and three District Representatives. Anyone can attend the committee meetings. If Area 40 specific items are voted on in the committee, only committee members vote. If the item is approved by the committee, it comes to the Assembly Floor as a made and seconded motion.

The Assembly has the opportunity to discuss and vote on the motion. This will require substantial unanimity. I can't express adequately how important the minority opinion is to the Fellowship. As stated in Chapter 7 of the Service Manual – occasionally, a well reasoned minority opinion can result in another vote reversing the first decision. If it seems like you have an opinion different from what you are hearing, it is your obligation as a member of Alcoholics Anonymous to speak up. Preferably, you would do this before the vote but please don't stay silent when minority opinion is called for.

However, most of the items we will discuss this weekend will be that of the General Service Conference Agenda – items affecting AA as a whole. Each committee will discuss the items of their committee and the respective Area Committee Chair will give a report. The Assembly will have the opportunity to ask questions or make comments regarding the agenda items. Comments and questions are limited to 3 minutes and if someone has expressed your opinion from the mike, there is no need to repeat it. However, please share your thoughts with us. Everyone's opinion counts – it is your obligation to speak up.

I will be asking our Area Chair, Terry for a sense of the Area on many issues. This will give me an idea how the Area feels about these issues when it is time for me to vote at the Conference. However, many of the items will not come out of the Conference Committee in the same form they are on the agenda. But I will have an idea how the Area feels and will pray for guidance.

If you don't attend a committee meeting, Past Delegates Scott W. and Mark S will lead workshops. These workshops are very useful to the GSR's. Bob and Mark are very knowledgeable and have a wealth of experience to share.

After the Committee Meetings and Workshops, I will give my report and take questions. Then we will plunge into the discussion of the Agenda items, which are presented by the Area Committee Chairs.

This evening, we will conduct breakout sessions for GSRs and DCMs. These sessions are opportunities to learn from your counterparts in other groups or districts. These sessions will be lead by Scott W. and Mark S. In the back of the room, there are ask-it baskets. You can place your question in the respective basket for discussion during the breakout sessions.

Tomorrow morning there will be reports from the Roundups held around the State. Intergroups represented here today will also have an opportunity to give a report. Then Scott and Mark will provide

Past Delegate sharing followed by more discussion of the agenda items. If time permits, general sharing happen. The Area's Policy and Procedure Manual states: that the Assembly shall end at Noon on Sunday.

Assemblies, like life, are much more fun for me when I am actively participating. I encourage you to participate and have fun!

Area Committee Member Reports

Area Chair/Alternate Delegate- Terry S.

I'm Terry and I am an alcoholic. Good morning, Area 40! It's my privilege and pleasure to serve as your Area Chair, and welcome to the third assembly of the 2009-2010 Area 40 rotation.

This fall, on September 18-19, 2010, we will be back here for the fourth and final Assembly of this rotation. I mention that first because all of us currently serving in elected rotating positions on the Area Committee — District Committee Members, Area Standing Committee Chairs and Area Officers (including the Triangle Editor) — have in common a job to do before the Fall Assembly. We have to encourage our replacements to step up! We are tasked with finding other members of our Fellowship here in Area 40, who we think are ready, willing and able to serve, and invite them to show up and stand up at our Fall Assembly to accept the positions that we will be vacating. Robbie S. liked to say that we "grow" our service leaders. The time is NOW to get to work on that task.

Looking further ahead, next year, in the first year of the 2011-12 rotation, our spring 2011 Assembly is here in Lewistown on the weekend of April 9-10, and the Fall Assembly is also here on the weekend of September 17-18. For each assembly — this Fall and next year — there will be a Friday night A.A. meeting, like the one we had last night, at 7:30 p.m. in this room.

After our Fall Assembly, there will be there will be a special Forum in our West Central Region, in Rapid City, South Dakota, on Nov. 12-14, addressing Native American experience in AA, and AA experience with Native American members and prospects. Next year, the 2011 West Central Regional AA Service Conf. will be Northern Minnesota, March 3-6, up in the vicinity of Brainerd, and the West Central Regional Forum will be in Davenport, Iowa, September 9-11.

In 2012, the West Central Regional Service Conference will be here, in Montana, in Area 40, in a host district we will be selecting during this Assembly, so we can commence the planning and preparation.

Just a reminder, under our Area Policy and Procedures, you've gotta get your agenda items for the Fall Assembly to me, in writing, with background material, by July 1, 2011. Don't be late — I have a tight time line and can't help you if you miss that deadline.

Our room rates for this Assembly are 69.99 for one person in a standard room, \$79.99 for two persons, 89.99 for three persons, and so forth, before the tax is added. The folks at the front desk know the rate for A.A. registrants. If you have any problems, talk to me if the front desk can't take care of it for you.

Since last fall's Assembly, I have visited 7 of our 14 districts, for workshops, luncheons, listening sessions, panel presentations, a district inventory, business meetings and preassemblies. I will try to visit, or visit again, all of the rest of our districts before the end of this rotation, if not before the Fall Assembly. DCMs let me know if there is a particular date, event or service subject that works for your districts, please.

We have made good use of Area Committee telephone conferences to address various service topics or concerns without travel expenses. I expect we will continue to do so as it becomes necessary. With the general economic downturn in society generally, our Area has been very responsible and responsive, it seems to me, being good stewards of our Area 40 resources. Our delegate continues to emphasize how important communication—transparency—doing our best to assure that every member of our Fellowship in Area 40 can find out what is going on—is to our recovery and to our unity, as well as to our service. Communication doesn't always require travel; it can be done by telephone, email and snail mail, so we all stay in the loop together.

We have a huge agenda for this assembly, which includes 58 GSC agenda items and 9 Area 40 agenda items. As most of you already know from past assemblies, my role is not to participate in the discussion but to facilitate it. You all have the jobs of sharing your comments, questions, and concerns. If you have a question that has not been asked or a comment that is new, then please do go to the mike and share. If somebody else has already expressed your group's view, you will still be expressing your group's informed group conscience with your vote and with your hand in the air when Carole asks for a sense of the Area on a GSC item. I'm not trying to shut anybody up, but we do need to get our work done here.

BEFORE we get to the floor assembly, while our committees are meeting, if you are not a voting member of any committee, you are still welcome to attend any of our committee meetings, or you can attend the workshops in this big room, chaired by 2 of our past delegates. Our GSC is the collective conscience of our Fellowship, and our delegate is our voice at the conference. Here, in our committee meetings, in the workshops and breakouts and on the floor of this Assembly, please share your thoughts, your feelings and your ideas. Just as we have to participate in our recovery program in order to recover, we have to participate in our service process if we are going to serve.

Thank you so much for the honor and the opportunity to serve as your Area Chair and Alternate Delegate. It's a remarkable experience.

Area Secretary- April A.

Hello everyone, my name is April; I am the Area 40 secretary and an alcoholic. It is good to see everyone again.

I have a few procedural announcements:

In order to get through all the business we have before us. Each Area Committee Chair and DCM is given 5 minutes for their reports; discussion, comments, and sharing from the floor are given three minutes.

DCM's I have put attendance sheets for each district on the tables by your nameplate, please have those filled out and hand them in to me by the first break which is at 9:45. I use the count from these sheets to determine a quorum for voting purposes. Voting members are Area Committee Chairs and Officers, DCM's or their alternate, and GSR's or their alternate.

I have been busy updating Area 40's group information at GSO through the website New Vision. There are group update forms available for the asking. GSO is publishing meeting directories this year. My deadline to enter new information is May 7^{th,} April 23rd if you send hard copies to GSO. I also update group information all year long; please send any changes to me on the forms provided. If you have any questions, please come up and see me.

All those giving reports may e-mail your report to me. If you choose to submit your report in hard copy, I will need two copies. In addition, I will need the minutes from all the committee meetings and breakout sessions being held later today. E-mail is most efficient for getting this information to me.

Recommendations from committees to come to the floor in the fall assembly were:

The Agenda committee would like to make the recommendation that Area 40 implement the standard format as the procedure for submitting agenda items to the Area Assembly.

Voted. Motion passed, unanimously.

The Archives Committee recommends budgeting \$500 per year to the Archivist for defraying the reasonable and proper expenses of the archivist for travel and display of Area Archives at AA functions (including district/regional events) within Area 40, excluding Area Round Ups, which by past action are intended to be self-supporting. Fulfillment of requests is limited to availability of funds and the archivist.

Vote: 89 For; 12 Against. Motion Passed.

Area 40 Structures and Policy committee recommends that we add the guideline to the Area Policy and Procedure Manual:

"The Secretary will serve as the Area Registrar and be responsible for updating GSO's current database, Fellowship New Vision (FNV). As Registrar, the Secretary will update group, district and Area information and work closely with each DCM to assure the Area groups are receiving correspondence from the General Service Office."

Vote: 97 For; 2 Against. Motion passed.

The Corrections/International Convention and Regional Forum Committee recommends that a Forum request be submitted to GSO for Area 40 to host a Local Forum, one day in Great Falls, one day in Miles City for the Spring of 2011.

Vote. 91 For, 2 Against. Motion passed.

Finance Committee: Outlined the 2010 proposed budget.

Vote on the 2010 Budget. 87 For; 5 Against.

Area Treasurer-Linda B.

Hello, everyone. My name is Linda and I am an alcoholic. I have the privilege of serving as your Area Treasurer. Our task this weekend will be to review, discuss, and consider three agenda items for the upcoming General Service Conference. We have been on the road in Area 40 last November and December gathering input about literature profits and our voluntary contributions in their relationship to our spiritual principle of self-support. The process has presented many differing opinions, yet the facts are that our fellowship relies on literature profits to help fund our services to the fellowship. Does this violate our own principle of self-support? We will be discussing this again this weekend. In the February 2010 quarterly report from the General Service Office total contributions from A.A. groups and members for 2009 was:

\$6,296,710

And literature profits were: \$8,244,374

Interest income \$ 1,187

Total Income \$14,542,271

Total GSO Expenses \$13,253,623

Net Income for 2009 \$ 1,288,648

Also, in the quarterly report, total non-A.A. purchases of literature were 30.6% of total units sold in 2009. This percentage was much higher than normal, owing to a large order purchased from Hazelton; estimating that the Hazelton order represented two to three years inventory for them. In 2008, non-A.A. purchases represented 20% of the total units distributed. Are literature profits bought from within the fellowship considered contributions? Research points out that Bill's own writings are inconsistent on this topic. In some places he is clear that absolutely no funding from outside sources should be used to support AA and then, in other places he defines literature sales as contributions, even though a significant percentage of literature sales are to entities outside AA. By the very nature of our first agenda item on Finance, we have much to discuss. Awareness, thoughtful consideration and discussion will be our input for Carole, our delegate, to carry to the conference this year.

There will be two items to consider on the agenda:

- 1. Replace pie charts with different wording
- 2. Consider adding 7th Tradition stories to "Where money and spirituality mix".

Lastly, on the agenda, we look for additional ways to communicate with the Fellowship on self-support. Does your group treasurer share the financial view of more than just its group? Are financial reports from our area and the general service office given at group business meetings?

Now about Area 40 finances. There were highlights of the 2009 yearend financial report in the Triangle this year. I have brought copies of the final year end for groups to take to their home group members. Please share this information. There was total income (all voluntary contributions) of \$31,574.75 last year. Operating expenses for the year were \$29,451.12. With income of \$110 and expenses of \$360.29 in the Archivist account, this leaves a profit of \$1,873.34 for the year 2009. Area 40 has demonstrated the principle of self-support very well. Thank you for supporting our service structure in Area 40.

For 2010, we have established a budget of \$31,232.25. As of April 7th, the balance in the check book is \$24,703.76. The prudent reserve is set at \$10,410.75 and there is \$979.78 in the restricted Archivist account. This leaves an operating balance of \$13,313.23. Year to date income is \$8,806.47. Area expenses this year are \$8,822.39. Your contributions are showing great support to Area 40. Both contributions and expenses for the year are at 28% of the projected budget. There is an Area 40 agenda item that may increase the budget by\$1,500, if passed and adjustments may have to be made to the budget total and to the prudent reserve. Please see me later if you have any additional questions or comments. Please take only one copy of each report. If there aren't enough, they will be on our area website for download. A point of housekeeping: Send your area contributions to Area 40 Inc., PO Box 21577, Billings MT 59104. Triangle subscriptions should go to Sharon S, the Triangle editor and contributions to the Pink Can should be sent to the Corrections chair, Mary S. All addresses are available on our area website and are printed in the Triangle. And lastly, thank you for allowing me to serve you and Area 40.

Hi everybody. My name is Sharon S; I am an alcoholic and your Triangle editor.

Again, I have to report, I have had a fabulous time with the Triangle. I've been very fortunate to have lots of articles contributed from Area Officers, Committee Chairs, DCM's and A.A. members. I am grateful for all the help and support and especially appreciate the efforts of my proofer (you know, that woman who helps me see my errors and get them fixed!). I also want to thank Alex, our Webmaster. The anonymity protected version of the Triangle is on the Area 40 website within minutes of when I send it. I don't always get it right the first time, but he re-posts it as many times as necessary!

You will have noticed that the Triangle is arriving in your mailbox under a new cover. New postal regulations effective in October increased the mail preparation costs. The mailing service I am using helped me look at options and we decided to use the envelope. I hope you like it!

Groups (and individuals) are encouraged to subscribe to the Triangle, for \$10 a year. By past motion, groups receive the Triangle whether they subscribe or not. Currently, 96 groups, or about 35% of the groups, have subscribed. There are 16 paid individual subscriptions. I send copies to all groups with a valid address, non registered groups or meetings who have asked to be added to the list, the DCM's, the Area Committee, West Central Region Delegates and Trustee, other WCR newsletters, and individuals with a current subscription. I have been mailing approximately 300 copies. There are currently about 30 groups with invalid addresses.

The Triangle is the Area's newsletter, just one of the ways for committees, groups and officers to communicate with each other and to help us to better carry AA's message to those who need it. We are using National Change of Address files from the post office to check our addresses and I also use "return service requested" to receive notification of undeliverable mail. I try to communicate with the group contact and/or the DCM when I have invalid addresses so we can get them corrected. The post office is getting more precise about addresses, so please be sure the address you give us is deliverable! DCM's, I've placed a mailing list on your table. It includes any recent Triangle returns and identifies groups with invalid addresses. I appreciate anything you can do to help get correct addresses and would appreciate you sending me a copy of any changes you send to April (or GSO) for Fellowship New Vision and the directory updates!

I have subscription forms if you want to subscribe or your group wants to renew its subscription.

I put "extra" Triangles out on the back table, please help yourselves.

The next time I give this report will be the fall election assembly. I know it seems like a long way away, but time flies for me (this gets worse as I age!), so I want to ask you now to think about the fall election assembly and whether you will be willing to serve as the Triangle Editor. I might not see many of you until September, so I will try to be talking to people this weekend to see who is interested. If I miss you and you are curious or know someone who might be interested, please be sure to talk to me before the weekend is over! This is a really great job and I'm sure anyone who serves will, as I have, gain far more than is given!

District 61 also takes AA meetings into Elkhorn Treatment Center, Boyd Andrew and MIP classes. Dee has contacted, Our Place, a mental health resource center, to see if the members of the district can be of service there. District 61 will hold their 4th Annual Treatment/Correction Workshop next Saturday, April 17. I look forward to being there.

District 72 – June K has been dedicated to recruiting folks to go into MCDC the 1st Friday of every month.

District 81 – Has a new Treatment Chair, Mary Ellen D. The District is taking meetings to the Providence Center twice a month, to Teen Recovery every Tuesday night and to MCDC on the 4th Friday of each month. She contacted Turning Point outpatient treatment center, who refused our services. Mary Ellen has formed a committee to carry out the treatment work of the District. Her goal is to have chairs for each of the centers the district takes meetings into and is recruiting treatment chairs from each group in the District since a different group is responsible for the meetings each month. District 93 – Barry L is recruiting folks to go into MCDC with Missoula. That district is also bringing meetings into Montana Addiction Services in Hamilton four times a week!

This is a striking and almost unbelievable fact about Alcoholics Anonymous."

And finally, here's a quote from former Class A Trustee and Chairman of the Board Leonard B's "story," told at a service conference I attended: "One of us is not smarter than all of us." I will add — "not even if the 'one of us' is me!"

Delegate's Report

My name is Carole B. and I am an alcoholic. I have the honor of serving as your delegate. This has by far is the most difficult report I have had to write. I firmly believe that Alcoholics Anonymous is currently saving my life by serving you.

On February 22, 2010, my big sister, friend, and biggest fan was killed by a drunk driver who ran a red light at 70 miles per hour. She had just come from Office Depot where she purchased a printer cartridge so I could finish printing the General Service Conference background materials. You have walked me through all of it. You have encouraged me to go on even when I really don't want to. Many of you have asked what you can do. Well, for me, you've been there. However, I think there is a bit more we all can do.

What we can do is continue to serve Alcoholics Anonymous; continue to reach out to newcomers, to those yet to come, to those about to leave, and the professional community including corrections professionals. We've yet to scratch the surface in helping those who desperately need AA.

I thank you from the bottom of my heart for what you do and what you will continue to do to help alcoholics like me. In particular, I would like recognize those who participated in the panel discussion on April 9 at the Nexus Treatment Center. I suspect there are a few suffering alcoholics at the center.

My activities from the Fall Assembly until now have been:

I got to attend the General Service Board Weekend because I am the chair of the Conference Committee on Public Information. This was a fantastic experience. I believe we are in very capable hands with our Board. The Board frequently asks the question "What does the Fellowship think?" when making the tough decisions and finical considerations.

Also, while during the Board weekend, I heard about the good work of one of our own. Prior to the earthquake in Haiti, a sober member from Bozeman was working for the Catholic Relief Services. She saw alcoholism affecting the lives of the people in Haiti and she needed a meeting. Having trouble finding a meeting, she got connected to Ken C., the South Florida Delegate. Ken called the Southeast Regional Trustee, El N. who put him in contact with Trustee-at-large U.S., Don M. They were at the October Board weekend and the International Committee had just finished talking about how to help the still suffering alcoholics in Haiti.

It turned out that there was a French speaking meeting in Port-au-Prince but most Haitians speak Creole. A few pamphlets are now being translated into Creole and I hope to hear at the General Service Conference, that AA has begun to reach the still suffering alcoholics of Haiti.

I bring this up because it is a classic example of reaching out to the still suffering alcoholic. This one of many reasons why need a General Service Office.

The West Central Region will host an Additional Forum in November with a theme of Singleness of Purpose: Carrying our Message to the Native American. While at the Pre-Assembly in Elmo, a sober member of the Elmo Group who happens to be Native American was offended by Native Americans being singled out. I don't know if the theme is helpful or divisive.

The Big Book says "the Realm of the Spirit is broad, roomy, all inclusive, never exclusive or forbidding to those who earnestly seek." How does singling out an ethnic group fit with the First Tradition? How do remarks made about other groups affect unity? Do terms we use such as sponsorship lines cause divisions within AA? Am I making every effort to assure when anyone, anywhere reaches out for help that the hand of AA is there?

I bring this up because based on my recent personal experience, it is very clear to me that we can do more.

The International Convention is July 1-4 in San Antonio, TX. I was honored to submit 13 names to chair or speak at a meeting. Nine of those people have been asked to participate. Ken B., our Trustee, asked me to participate in the West Central Region meeting.

Speaking of Ken, he continues to conduct conference calls (note to self – next call is Sunday night). The calls are very helpful in discussing the happenings at GSO and at the General Service Board level.

On Thursday, I will fly to New York for a couple days of playing and to attend the General Service Conference. Sharon, our Triangle Editor, has made labels for you to take if you wish to send me a card or letter while I'm there.

Our workshop at this year's conference will be taking the inventory of the General Service Conference. Inventory has been very necessary for my spiritual growth and I suspect it is also true of the Conference. It is probably time for Area 40 to take its inventory again since the last time was in the early 90s. District

91 just completed their inventory as did the Traditions group in Billings. Perhaps your District or Group can disclose damaged or unsalable goods to be rid of promptly.

For the Area, maybe it's time to look at the number of Assemblies we conduct, their location, how we utilize our Delegate and Area Committee Chairs? What more can we do to help the still suffering alcoholic?

The committee did this and asked the Archivist to give the status report to the Assembly Which he did. Things are coming into place for the Workshop.

Discussion: (reverts back to Area 40 Agenda item for Archives) Cory: I thought that we heard the last time that someone will pick up the banner and the seed money and that we don't need to send anyone.

Ken: When I came here I didn't know anything about Archives, maybe the new people in AA don't have the same reverence for Archives as there used to be. Maybe we should spend the money around here.

Carleen: I have been given good advice, never miss an opportunity to "sell" your product. We need to "sell" the people at the 2011 workshop on coming to Montana, the Archivist needs to go to accomplish this so the event will be self supporting.

Lori: I feel churlish saying all this and having to make a decision against funding his trip. I feel we should.

Andy: These are good reasons to go. We kinda put in the work and got the bid, now it might be a slap in the face for our Archivist not to show up to receive the banner and seed money. I think we could.

Nick D: I would feel better if the money would be earmarked to ABSOLUTELY be repaid to Area 40 for this trip.

I would like to make a friendly amendment to the committee's motion. That everything above the \$1500. seed money be put in Area 40's coffers.

Seconded.

The Archives committee accepts the friendly amendment.

Carla: If we don't make enough money how will we get reimbursed for the Archivist travel?

Tim H: Good question, there is no guarantee that we will make enough to cover both the seed money and be self supporting.

Gerry: I don't have any information about whether the proceeds are enough to defray costs. I have only heard of one workshop in the recent past that was not self supporting.

Paul G: What is the benefit of having this library? Why are we keeping these books locked up? Maybe some groups can use them.

A: The committee thought that maybe the funds used for this library could be better used for other services and for getting stuff into the Archives.

Rich K: I don't think these materials are the proper materials for archives.

Gerry R; I wanted to keep some outmoded media as the Archives sometimes has requests for these materials.

Paula H: I wonder if it is appropriate for these outmoded media be stored in the Archives and converted to a newer media format.

Vote: 87 For; 12 Opposed (66 is quorum) motion passed. No minority opinion.

<u>Corrections/International Conventions-Regional Forums:</u>

A. Review Progress Report from Trustees' Committee on Corrections on revising pamphlet "It Sure Beats Sitting in a Cell."

We reviewed the report and the committee was satisfied with the revisions to the pamphlet.

Discussion from Area 40 Committee:

The subcommittee met 4 times and felt the pamphlet could be strengthened. The fellowship has issued a call for submissions which will be accepted until June 15, 2010.

Clear emphasis of AA suggested 12 step recovery programs in both non narrative portions and in selected stories, as well as positive effects on alcoholics who have contact with the fellowship, both behind the walls and after release.

More stories that emphasis sponsorship, corrections correspondence and pre-release contact, also to represent the fellowship in gender ethnicity, culture and faiths. The fellowship is encouraged to supply feedback. Some outdated language like the groovy and an image of a guy rolling a cigarette taken out.

No discussion.

a. Review progress report from the trustees' Committee on Corrections on signing sponsorship agreements and legally binding documents.

We reviewed the report and our committee was satisfied with the progress so far.

In our committee we discussed:

"Deciding to participate in Corrections 12 step work is an important individual decision. AA members should carefully read all paperwork required by correctional facilities and fully understand regulations prior to commencing such work."

Background being quite extensive, the committee has made adjustments in pamphlets, AA guidelines and workbook to include wording that strongly urge the fellowship to be aware that they are still obliged to follow the rules of each institution they are involved with to share the message of AA.

If a member has a problem with signing a document that states they will follow all rules and regulations than they ought to not enter the institution and carry the message there. As this has become an issue of sorts and really not everywhere at this time it is something we do need to address and be prepared for in the future.

<u>2012 West Central Regional AA Service Conference Committee Bid District 81</u>

It would be an honor and a privilege for District 81 to host the 2012 West Central Regional Service Conference in Missoula. District 81 has been blossoming in service and has the active fellowship required to enthusiastically support a successful conference.

- In April of 2009 we hosted a successful Spring Roundup with over 650 people in attendance. It was self-supporting, received great reviews, and was thoroughly enjoyed by those in attendance.
- Missoula has not hosted a regional event, such as a service conference, and we would be honored to host our very first regional event.

- Missoula is home to an International Airport with service provided by Delta/Sky West, Northwest Airlines, United Airlines, Alaska Airlines/Horizon Air and Allegiant Air.
 Complimentary shuttle service is available to and from hotels.
- The proposed conference hotel, the Hilton Garden Inn, has 22,000 square feet of conference space and a block of 120 rooms available for as low as \$89 per night.
- There are 10 hotels within walking distance of the conference facility with rooms available for as low as \$65 a night.
- There is a wide variety of restaurants within walking distance of the conference facility providing options for every budget and taste.
- Known as the "Garden City", Missoula is one of Montana's most culturally diverse cities, with a beautiful landscape which will be sure to entertain all who care to venture outdoors. There is easy access to recreational areas for hiking or skiing, including riverfront trails and the historic "M" trail which overlooks the city.

WCRAASC 2010 Bid from District 11

District 11 appreciates your consideration of our proposal and we look forward to hosting this important Alcoholics Anonymous event in Billings.

There is a onetime set up fee of \$1500.00 for the conference room and additional breakout session rooms. The main conference room will be appropriately equipped with audio/video equipment. In addition, the facility has sufficient rooms for the breakout sessions. Should a weather event preclude normal attendance at the conference, the room set up fee has been confirmed with a minimum booking of 50 sleeping rooms for both Friday and Saturday nights.

Neil: There is a famous battlefield close to Billings, and there is fine fishing.

Tim: We all traveled to far regions of MN and NB and made it there with no problems. Missoula is close to Kalispell.

Connie: Has the WCRAASC been held in either of these cities before?

A: No.

Linda: Who hosts the Spring Round Up that year?

Scott W: 2012 Spring is in Kalispell, and Fall is Missoula

Sandy: The West Central Region (WCR) consists of Montana and states east of us.

Bud: We want visitors to see beauty not refineries and smog.

Carleen: Can someone talk about what Missoula thought about putting on both events in the same year?

Andrew: Missoula (Dist 81) thought about it and decided we could do it. The two events are very different. Missoula has never hosted a regional event, we have enthusiasm and a number of young people involved in service work so we could make it work no problem.

Finance:

I want to thank Jennifer for the excellent note taking. There were 5 voting members present and 11 other AA members sitting in at the Finance committee. We met for both the breakout sessions for our discussion.

- A. Review input from the Fellowship gathered by the trustees' Finance Committee on the following:
 - 1. If we continue to use literature profits to partially fund services, should there be a limit?
 - 2. If there is a limit, how do we continue to pay for services if there is a shortfall in contributions?

Our committee came to the consensus 4-1 that we should strive to be self-supporting through our voluntary contributions; that we should strive for perfection, not must. We need to be careful in changing the status quo by requiring perfection or nothing. We must see where we have gotten off track and a new approach of being pro-active must be our individual responsibility. All members of AA shoulder this responsibility. We are always trying not to use literature profits, we talk about it, and we even make some progress. How do we keep an informed group conscience? It is by talking, sharing, and then taking action. We need to focus on how to increase contributions, so that literature profits would be a moot point. In 2009, there were voluntary contributions of approximately \$6,300,000. If each person would double what they contributed, we would be within \$5000 of meeting GSO expenses. Another way to not rely on literature profits is by utilizing the "Birthday Plan". We would then be self-supporting through our own contributions.

There was discussion about cutting expenses, from the bottom-up, as shown in our inverted triangle. All organizations in these economic times are dealing with cut-backs. Let's think about what is best for AA as a whole, the bigger picture. We need to reflect some more, give and take, and live within our means. Our budgets continue to grow and our contributions are not matching that. Is it time to take inventory and rein our expenses in? Being mindful, it is us, recovering alkies that keep asking for services to the fellowship. If we can vote for more services, we can also vote to cut spending. The power of the purse would then carry weight in our financial responsibility.

There was also approval for setting limits on using literature profits, but how the application of this is another agenda item. Does the fellowship feel that literature profits bought from AA sources are a form of contribution? While it is not a voluntary contribution, do we AA's feel that monies generated by ourselves is an acceptable form of income.

As you can see, there was much reviewing done. There were 23 areas and 1 past delegate that gathered input on this agenda item. More will be revealed.

Discussion:

Colby D: Since GSO is a model organization for other GSOs' and those GSOs are self supporting why isn't our GSO self supporting?

Carole B: The Irish GSO is self supporting; in fact it sends money OUT to help the groups. I'm not sure how this is.

Nick D: Do not limit the amount of literature profits used to support GSO.

Geoff: Does Ireland have Pink Can funds? This might be robbing groups of 7th tradition money.

Connie R: I'm the Archivist's Old Lady. 20% of our literature profits come from Hazelton if we limit using literature profits lets use the money that comes from others

Linda B: A lot of money comes from outside sales.

Lori F: If we don't have the money, then we should curtail events and things. It's concerning that we ask for more and more money and expect the money to appear. I think we should move towards

Amelia: I use a book from Hazelton, I got it in treatment.

Tim H.: If we have more profits in literature what will we use it on? Will we lower the cost of the literature? How low?

Bill: If we all gave more than one dollar we wouldn't be having this discussion.

Sam B: Does GSO have an emergency fund? Do we have to sell to outside entities to be considered non-profit?

A: Yes.

Peg: we need to challenge the fellowship; the GSRs should get the background material on this and inspire others to put more in the basket.

Rich K: Should we limit the amount of financial support to GSO from literature sales? Yes, 50%. We can phase in higher limits over a period of years. Maybe we can vote to adjust the trigger for replenishing GSO's emergency fund so that the fellowship has time to respond with their support before profits from literature are used.

Carole B: We have the power of the purse already; If we don't want to use literature profits then we need to contribute more money so we don't have to.

My group needs to add \$100/month to our 7th tradition to give to GSO. We should eliminate the Pink Can and have the districts buy literature for correctional facilities.

Dave: Sell other books! There are many good books by AA's that are not conference approved, Hazelton is selling them and making money on them (we aren't). AAWS could be making more money.

Linda B: Use the Birthday envelopes, let's pony up! Use them.

#1 above: In favor of no limit

#2 above: NA

B. "Self-support: Where Money and Spirituality

1. Consider request to replace the "pie charts" on page 12 with text such as: Each group is autonomous and its informed conscience should determine the contribution amounts to the following entities: District, Area, GSO and intergroup/central offices, if one services your district.

Adding the text was unanimously approved. Don't remove the charts, though. Pie charts are a helpful source of examples, especially to newcomers. Many people are visual and are drawn to the example. The pie charts are not set in stone, they are only suggestions. Our friend from Area10, Colorado, suggested that having the pie chart watermarked with the word "EXAMPLE" would allow for each group to make their own choices in their splits.

DCM Breakout Session-

8:30/10:00 DCM Breakout – Led by Past Delegate Mark S.: Ask-it-basket and sharing

Mark: Have been a DCM, probably come up with some of your problems, others have solved it. Any problems to

Dale D31: Not a problem per se, but three towns don't have active AA groups. Batted it around how to get something started up – Baker, Broadus and Ekalaka. Any ideas?

Mark. Sponsee in Elkins Arkansas, he put up posters in stores in town. Meetings at 8 at the Fire Hall. They didn't show up, but he kept going, So Mark showed up to keep him company. Then someone else started. So then they 12 stepped a guy, then there were three, then it

took off. Persistence is what it takes. Have to commute to another town. Not easy. Chances are, be yourself for awhile.'

Dale: Tried that method, didn't really work. Went two months, all told 3 people in 6 months. Another group from Miles City goes to Baker. But they are the only ones there. Maybe go once a month to those towns, see what works.

Jennifer: Knowlton meeting was a once a month, worked well.

Anne: Bridging the gap program is really important

Matt: Jail meetings? That could be good.

Mark: SPECIAL FORUM: It is by request, for a special purpose.

What can we do to promote Unity?

Anne: Everyone listen to me, we'll get along fine.

Jerry: In Shelby, go to other meetings in the District. Carpool around, to the different towns, get to visit in the car to and from.

Mark: What do we do about meeting openers using prescribed marijuana shortly before the meeting?

Dan: the No Name group in Missoula had an opener he had some sobriety, but he was smoking Marijuana, they suggested that maybe it would be better if someone else opened up the meeting.

Matt: Get three or four people to talk to them and say you don't appreciate it.

Mark: Pills prescribed can get pretty high too.

Nick: A meeting describes what sobriety is, the traditions say it is an outside issue. It's not our job.

Anne: Don't have to kick them out – just not put in service.

Doug – are they trusted servants?

Mark: Something like 10,000 people getting medical marijuana certificates

Dale: We depend a lot on group conscience, let it rule on this. Group conscience, yes, can come in and listen. Know about pain, wouldn't even think about it, and know the high would lead to a better high. The legal kind at least ask for them to come to the meeting straight.

Sam: Sober times come in to play here. What's legal and what's not – when you're not, booze is illegal. How are you going to know if they're impaired all the time? Consistency and sobriety time are more important.

We have always been self policing. We throw not our kind out by example. Demonstrate contented sobriety – what it is. People should be welcome at our group, maybe not give service positions. We have a duty and responsibility to not let an outside issue infiltrate and

take over our meetings. When we teach the message we were taught to carry from our books and literature we can stay on point.

Dan: Slippery slope here. We have trusted servant guidelines. Have to have two years of sobriety for positions. We do that to protect AA from people who are using, but also to protect them. Two separate things – 1) Is it OK to smoke dope and go to meetings 2) is it OK to have a service position and smoke dope. Experience is can't use anything and control it. Hate to chase someone off by not being compassionate. Wait to hear the right thing.

Mark: Keep the door open to them; just don't put them in a service position.

Doug: We have the pamphlet – the AA member and other drugs – down the line we are going to have to address this issue in the pamphlet. Give it to these people, for them to figure it out.

Sam: Knew a guy who went to the doctor, been depressed for a long time – told the doctor he was sober, and the doctor said he would make some different choices about prescriptions. A place to start – educating doctors – CPC.

Mark: Other topics:

Dan: An interesting situation going on in D81. A member is separated from his partner; she has a restraining order out on him. Volatile situation going on for over a year. He brings his personal life to the meetings, makes threats, super-disruptive to meetings. We're really having a tough time with this. Almost a fight between him and someone else outside a meeting. He was outside screaming obscenities. There was a kid's camp going on at the same time. Offensive. At least four people approached, wanting District to intervene. What are the options? Have a group take him aside, and say it's causing problems, making ladies afraid to come to meetings. Or the meetings could get restraining orders — don't know what to do. Need your help.

: Had a situation like this in Texas. We create our own black eyes by allowing poor behavior. Told Bobby that the cops would be called if he didn't cut it out. Had to draw a line in the sand about what was acceptable.

Doug: Home group had someone show up and get threatening physical violence. Group got a restraining order against her. There are other meetings she could go to.

Eric: Victor group had a situation between two people – someone was stating religious views – people got out the Traditions and said you can't kick someone out because of this reason. Might not work in this situation.

Doug: As a DCM, it keeps coming back to the home group.

Anne: A guy brought a gun to the meeting; they called the cops and had him taken away. Another guy stalked the meeting on a loud scooter driving up and down, screaming obscenities, he ended up killing himself.

Dan: He has a sponsor, it's driving them nuts. Ladies quit going. It's more than disruptive.

Using rage like he used to use alcohol.

Andrew: Been around long enough to see a lot of things like this. Got to be dealt with in the meeting.

Jennifer: In San Francisco, we had "Al Pacino from Hollywood" who was very misogynistic and violent. We had a business meeting and created two service positions - guys who would sit on either side of "Al", and if he got disruptive, immediately escort him out of the meeting. it worked well.

Nick: Pretty black and white – disruptive, call the police. Don't care about hurting their feelings. Been at lots of meetings where cops were called. Can't make idle threats, have to follow through. If nothing changes, nothing changes.

Jerry: Some of these people are mentally ill, not simply alcoholics. There was a guy who didn't feel welcome, quit coming, killed himself. Everyone feels bad about something like that, but we are not psychologists. Lead them to a psychologist.

Jennifer: My District is asking – what are other groups doing about the Special Topic conference? Possibly thinking

Mark: SD has remote communities for Native population who aren't coming to town for meetings.

Rock: Went through treatment three years ago in Great Falls: There was a Native meeting then, Disbanded, but could put them in touch.

GSR Breakout Session-

Meeting openers are using prescribed marijuana shortly before the meeting. What can/should the group do about this?

- Experience-individual decided, while it is an "outside issue", that it wasn't right to chair a meeting when using the drug.
- Experience-some of us don't have any experience with this, some of us have the experience of being clear of all substance.
- Be honest with use with sponsor.
- Mind is altered when using.
- Home group is autonomous and will decide how to deal with such issues.
- The 3rd tradition says that the only requirement for membership is a desire to stop drinking.
- The home group has a right to determine the length of sobriety necessary to chair meetings.

What is a forum? Why special?

- A non-alcoholic Trustee thought it would be nice to bring the General Service Office (GSO) to us, thus the Regional Forum. The regional forum brings the flavor and taste of GSO to us. Friday through Sunday, the General manager of the GSO, someone from the AAWS Board and the Grapevine, et cetera, come to us to share with us about what they do and answer our questions.
- We get to facilitate the local forum in our area and GSO brings 2 people to answer questions. It is nice to know what the GSO does, what we are doing and what we are spending our money on.
- Special no answers.

What can I do to promote unity?

- Self support creates greater unity.
- Business meeting participation helps unity.
- Use of a sponsor and the inventory process.
- Speaking to people directly rather than talking to others about issues and/or problems.
- Caravan to meetings-the meeting before and after help.
- Socialize with other members in many different ways.
- Traditions meeting as a group for a common understanding of the traditions and unity.
- Remember we are all the same on the same playing field as alcoholics!
- Definition of Unity the state of being one; oneness of mind, concord, harmony, or agreement; (in literature and art) a relation of all the parts or elements of a work constituting a harmonious whole and producing a single general effect.
- Experience- starting with a desire for serenity grew into service to home group and the many components to unity which create a very satisfying life.
- Bonds between us within our pain or others' pain.
- Participate in Roundups and other events outside of the comfort zone.
- Share with others, especially newer people, how we carry the message.
- Allow diversity; practice acceptance; give a thorough welcome to visitors.
- Encouragement (sponsorship) to attend Area Assembly, Roundups, Conventions, speaker events.
- Practice unity on the home group, and then take it out on the road. Help each other grow.
- Our home group alternates chairs with home group members and newcomers from a treatment center.
- Unity keeps a group of people alive.

- We put the unity in community.
- Speak with someone I don't know and introduce myself to others.
- Smile at people even if I don't like them.
- Talk to people who I wouldn't normally talk to.
- Old timers are participating in activities which makes it more valuable to newer people.
- Take the action and don't wait for others to reach out or talk.
- Let others live so I can live.
- Personal accountability, practice principles in all of my affairs, avoid "promotion of self by character assassination of others".
- Lead by example and talk less.

The DCM talks about her personal life in her report; the Alternate DCM doesn't run the meeting very well; the Secretary hasn't provided minutes for 3 months. HELP!?

- Ask them what I can do to help.
- Remember it is no "us" versus "them".
- Hold officers accountable to their positions; ask questions pertinent to service position duties and responsibilities.
- Take our own inventory.
- "Sponsor" into service position by outgoing officer guidance and information; don't leave your successor high and dry!
- Practice treating others with dignity and respect.
- Eliminate gossip.
- Service work shows me how it works and my judgments.
- If I see a problem or bring up a problem, I identify a solution.
- Ask for help for the judgments, practice the spiritual axiom.

Other than using a time, what are some techniques for getting people to shorten their sharing?

- Put in the opening statement about 3 minute share and ask that people NOT share a 2nd time before others have shared.
- Chairperson may tactfully deal with long shares, "Thank you for sharing" and move on.
- Six months of sobriety suggested before chairing a meeting, to deal with long shares.

• Importance of letting everyone share in some meetings with at least an opportunity to say their name and that they are alcoholic.

Round Up Reports:

2009 Fall Round Up:

As your trusted 2009 Fall Roundup chair, it is my privilege to report that the event appears to have been a big success based upon:

- a large amount of unsolicited positive feedback and praise received by myself and other members of the committee from members of both fellowships as well as our distinguished out of town speaker guests.
- b) the unanimous positive reaction of the Roundup Committee at our wrap-up meeting yesterday, Oct. 16th and
- c) The committee's ability to hand you this check in the amount of \$4,768 which, by the way, is net of \$1,500 in seed money already passed along to the Chair of the 2010 Billings Spring Roundup.

Many thanks to the volunteers who helped to make this event a successful one as well as the dedicated group of Roundup Committee Chairs who made my job much easier than I had anticipated it would be....those trusted servants are, and I apologize for missing anyone in this list:

Betsey, Cathy, Chris, Frank, Gerry, Guthrie, Jeff, Joe, Katie, KC, Kelly, Loren, and Nancy

The Roundup had 410 registrants, comprised of 276 AA's, 73 Alanon's, 37 Double Winners and 24 who chose to not be classified. Based upon comments made by Roundup Committee members and others, the event will likely be remembered for the following reasons, listed in priority starting with the point most consistently mentioned:

- 1. <u>Overall Quality of Experience by those in attendance</u> comments included: "great event", "fun", "well organized", "incredible", "smooth", "one of the best Roundup's ever"!
- 2. <u>The Venue</u>: many people have specifically mentioned how impressed they were with the level of guest service by motel staff, food, facility, etc.
- 3. Occupancy limitation and the fact that we had to turn people away; the Grantree management-imposed limitation for folks seated theatre style in the ballroom for the Saturday night event was 398. We began the event Friday morning with approximately 300 pre-registered people and by the end of Friday night's activities 100 more had registered at the door, putting us beyond capacity at that point. A difficult decision was made by members of the committee who were present (with proposed emergency remedies considered) to close the event for further walk-up registration and an announcement was made to the 300 people in attendance at the Friday night speaker event to pass the word "back home" to friends and family that the event was officially closed to anyone who had not pre-registered.

We will never know how many people in total would have come between those who caught wind of the closure prior to coming and those who showed up on Saturday (perhaps about 30 or so?) only to be lovingly turned away and how much of a problem the overflow would have been and what effect it would have had on those who did indeed pre-register well in advance. I stayed at the front desk (along with other brave and willing volunteers ③) for the majority of the time Saturday and personally apologized and consoled those who were affected, most of whom were understanding and supportive. Nevertheless it was an awkward situation that will certainly be remembered, anticipated and planned for by the next District 72 Roundup Committee. Initial suggestions include:

- a) plenty of pre-planning for video feed to other rooms in the Grantree, which was considered and researched to some degree this time too but never ended up happening for various reasons. this is my fault and I take full responsibility for not accomplishing some level of video feed in advance and I do believe that with ample amount of time spent researching and planning in the future that SOME amount of additional people (beyond 398) would be able to attend future Roundups at the Grantree but at the same time I strongly suspect that there would nevertheless still likely end up being a capacity cutoff situation that would need to be planned for in advance as best as possible.....even with video feed planning and preparation, strong wording on the Registration Flyer should be considered as to the potential that the event could fill-up at the last minute and the committee should creatively shoot for getting our valued members statewide to pre-register vs. jumping in the car at last minute...
- 4. <u>Great Alanon emphasis in the event</u> many commented on how great it was to have so much Alanon stuff and how nice it was to have AA and Alanon so integrated.
- 5. <u>Location Grantree vs. MSU</u>: overwhelming feedback (both solicited and unsolicited) from those who have attended Bozeman Roundups in previous years at the MSU venue has been that the Grantree was much better.
- 6. <u>Babysitter Service</u>: a number of people commented on how they wish there had been a baby sitter service. This was discussed in the planning of the Roundup and the decision was made to not offer babysitting service but it should go on record that it was one of the more frequently mentioned things.

Other suggestions/observations/matters of business that came up in our Wrap-up committee meeting:

- Put out-of-town speakers on panels and discussions elsewhere in the Program throughout the
 weekend for us to enjoy and benefit from as well as for them to have more involvement and to
 feel more "a part of".
- Need actual hospitality room (with snacks) and not just in the atrium we did have an extra room right by Registration Desk and could have used it.
- The amount of panels and discussions was good "a busy Roundup is a good Roundup".

Intergroup Reports:

Greetings from the Flathead Valley Intergroup

The Flathead Valley Intergroup represents AA groups throughout District 91. Our monthly newsletter and business meeting minutes are mailed to groups from Elmo to Eureka and to any others that request it. Each group in the valley is entitled to one representative to Intergroup. Following the monthly business meeting we hold a valley- wide birthday celebration where any attendee may receive a commemorative sobriety medallion, usually presented by their sponsor. We generally have 10 to 20 celebrants with anywhere from one- day- at- a- time to 30+ years being given out.

We continue to provide the answering service and meeting lists to help carry the message and let folks know where AA meetings are and why we are here. The answering service continues to field 50 to 100 calls per month, either providing meeting information or connecting the caller with a recovering alcoholic. Fortunately, we're still able to effectively make direct contact between the alcoholic in need and one in recovery. Our hotline committee is in the process of updating the call lists to ensure that the answering service has a willing recipient with a real phone. We update our meeting schedules about every 4 months and the website is updated weekly or whenever changes and additions become known. Our website still generates over 150 hits per month and continues to provide information about upcoming events and up to date meeting changes. We've recently appointed a new web committee and expect excellent things from them.

Our annual campout will again be at the Emery Bay Group Camp Sites on the east shore of Hungry Horse Reservoir. It will be held over the weekend of 6-8 of August. Speakers meetings, excellent meals and discussion meetings will fill the weekend along with swimming, hiking, and general lazing about. We provide the meat for the meals and subsidize rental of the spaces for that event.

Our entertainment committee has organized a speaker meeting and potluck or other special event each month during the winter. The two or three potlucks and music nights that we had this year were well attended. Food seems to help generate attendance.

As usual, our corner of the state has a batch of campouts coming up and those will be posted on the website. We'd encourage any of you to come join us in the great out of doors. We do campouts and potlucks really very well in the Flathead Valley, thanks to a whole lot of folks who've traded their booze and drugs for food and sobriety. We absolutely insist on enjoying life and our Flathead Valley intergroup is dedicated to helping with that endeavor in service and sobriety.

WCRAASC Report:

My name is Eric, alcoholic, and here are some of the highlights of the West Central Regional AA Service Conference held in Dubuque, Iowa on March 5th to the 7th 2010. I made it to Dubuque with minutes to spare on Friday due to a powerless flight delay in Chicago. We opened with the Serenity Prayer at 7pm and two guys with the same name "Mike" did the readings and Rick C. who MCd this Conference referred to them as the M&M guys but he couldn't decide which one was "plain" or "peanut". Next up was General Session 1 on the topic of "What is the difference between general service and service in general" presented by Area 63, South Dakota. Two ladies from the Area shared and one was a sponsor and the other was her sponsee and we all felt a little sorry for the sponsee because she had to ride over with her sponsor in the car. Both felt that there really was no difference and that both kinds of service make us o.k. We then met the Delegates from the Region and delved into the discussion of the General Service Conference Agenda items part 1. So here we go! CORRECTIONS: Item B got some play time on the report from the Trustees Committee on Corrections on signing sponsorship agreements and legally binding documents. Most of this had to do with the "Federal Report Rape Discloser" in our jails and prisons and the 5th Step. The best solution I heard was wait until the sponsee is out of jail to do the 5th step. FINANCE: Items A & C on self support was a horse that was beaten and killed every which way you and I can think of and some I had never thought of. Whatever your opinion was I am sure it was expressed. One suggestion I heard was to bring up the 7th Tradition as a topic at your meetings and if you come out alive your higher power was working! PUBLIC INFORMATION: Item B on PSA's and there usefulness was discussed in great length and it was stated that approximately 1% of our fellowship use's these to get in the rooms of AA. But that 1% is 20,000 people and in treatment they told me that an alcoholic who is drinking affects 29 people around them so you do the math. Also discussed was the use of full faces of actors portraying AA members and "Anonymity in a Digital Age". More air time was spent on these and "Facebook" came up and it was not your friend! Report & Charter: Item A came in to play about producing the AA Service Manual every other year and in years not produced publish the AA Directories. So bottom line I came away with after extended air time is that we need to keep our Group info up to date so visitors and the still suffering alcoholic can find us and you will hear about the

Service Manual costs later. Sunday morning we heard from our West Central Regional Trustee Ken B. and our last General Session titled "General Service Conference Agenda Selection Process-Communication-The Key to an Informed Decision". We closed the Conference with the Responsibility Statement. One thing I forgot to mention was what a great speaker we had Saturday night and the hospitality was awesome! We really have our work cut out for us when this Conference comes to what should have been Missoula, MT in 2012 and I would hope all of us would be of service to the AA member and their families as well as continued service in some capacity be it opening meetings, sponsorship, District, Area, National, or World service so that we are available for those who have not found us yet. 2. Discuss request to include information about AA. Grapevine.

Committee was in favor of this. Groups cannot contribute to the Grapevine. Income comes solely from subscriptions and purchases of materials.

3. Consider request to add Seventh Tradition stories.

The committee would be in favor stories that follow the dollar and how that money is used in spiritual principles and how it serves our primary purpose. Where does the dollar go in the 7th Tradition basket, what is the purpose of giving funds outside the group. Our primary purpose is not to pay for coffee; it's in carrying our message to the still suffering alcoholic.

No Discussion.

C. Discuss additional ways to communicate with the Fellowship about self-support.

We went on the road in Area 40, asking for sharing. It generated groups to return home and bring up the topic at their business meetings. Give out the information, share it, and exchange ideas. The communication must come back from the groups to their GSR's and up and down the triangle. Sponsorship is a vital way of communicating about self-support. Self-support is not just money in the basket; it's in the actions we take, it's in the time we give, it's that hotline call or that jail meeting. A member said, "I donate to Habitat for Humanity but have no voice, I contribute to AA with money in the 7th tradition basket, I give time, love, and service to AA, and I have a voice. The results become my experience, strength, and hope.

Discussion:

Carole B: What do you, Area 40, think is effective?

Paula H: In my home group we have had several meetings with the topic of 7th tradition and contributions have picked up. For years now we have been able to send more than recommended to GSO.

Cindy: after making a contribution, I got a letter from GSO soliciting future contributions. Maybe we can do that at Area or District?

Laurie: Our group got a letter from GSO saying they had not received any contributions from our group this past year. Maybe we need to model different behavior, we could make birthday envelopes available and inform everyone about the birthday contribution program.

Geoff: Some people have nothing to give, so if you have a few extra dollars try to put some in for the ones that can't.

Tim H: We can do a better job of spreading the word about what the 7th tradition is needed for and what GSO, Area, and District does for us.

Tim: I had to ride a bike to meetings for a while so the money I saved on gas I put in the basket. Ride a bike!

Carole: For the birthday envelopes, if you want the contribution to be attributed to your home group, you don't HAVE to know your group number. just write the name of your home group and they can pull up your group number at GSO.

Loren B: When the Big Book price was raised from \$6 to \$8 I recall hearing that GSO needed money, I think that the trigger for literature help too quickly. We also need to be better at informing our Area, District, and groups that GSO needs money.

Lastly, our delegate has asked that I share a little about the ONLINE CONTRIBUTIONS. This will be operational in May. You will be asked questions your contribution. It will allow you to designate your group name with the city and state. Check it out. This is another electronic media tool for making our contributions. Jim H: I am really embarrassed that the magazines are not equal. We have a magazine that looks like it has a lot of advertizing when it really doesn't. This magazine (GV) doesn't need to be pretty. We need to focus on getting the GV and La Vina into correctional facilities.

Pat: I think maybe we could do birthday contributions to the GV for their birthday, or just contributions in general.

Sandy: I am passionate about the GV, I've subscribed for years. I buy it for the stories- not the pictures. Maybe we could try printing the GV and La Vina like instruction books do where one side is English and the other side is Spanish.

Rich: The Grapevine is a company and cannot accept donations.

SOA: Opposed.

1. Discussion:

BilliJo: I think that the GV helped me stay isolated and emotionally retarded in AA.

Connie R: I was at the WCRAASC in Bmjidge, MN the financial solvency of the GV was being discussed then. We need to remember the spiritual reason for the GV and not focus so much on the money part.

Nick D: How upside down is the GV? I think to decide on this issue of limit we need to know the amount of loss we are talking about.

Terry S: There is an estimated loss of \$250 in 2010.

Gerry R: I subscribe to the GV and the digital archives of the GV. I would be happy to contribute to the GV if it were possible. GSO and AAWS both take contributions why not GV too?

Dan: When I am on my ranch and 70 miles away from the closest meeting, I need the GV.

Carleen: I love that here is always someone who says that something might be a bad thing, but it (GV) saves lives. BilliJo I am glad you had it to hide behind, it kept you around long enough to get better. I subscribe to the GV but I don't read it.

Policy and Admissions

Items A and B: These items dealt with replacing delegates with their alternates and visitors to the conference and were considered regular business and not discussed at length.

No discussion

Item C: This item given a cursory review.

No discussion

Item D: This item discussed the process of taking an inventory of the General Service Conference, and was discussed at length. While the idea of the inventory was interesting, the concern was how would it be implemented and what would be done with the inventory was discussed.

No discussion

Item E. This item concerns the process of Minority appeal process and was discussed at length and in general the idea that a process would be standardized and used only as a last resort was a minimum request.

No discussion

Literature – Lori F.

The Literature committee was represented by Nick D., DCM-12, Neil T., DCM-31, Mary M., DR-91 and Deb C., DR-93. I would like to thank Mark V. from District 72 for helping me take notes. We also had seven other A.A.s sit in on and participate in our meeting. The meeting was opened with the Serenity Prayer, followed by discussion of the agenda.

- A. Review the revised draft pamphlet "The A.A. Member Medications and Other Drugs."
 - Revision was proposed by Area 20 Northern Illinois in December 2006.
 - Pamphlet revision to include current experience became GSC Advisory Action in 2007
 - 2009 Recommendation to approve revised pamphlet failed.
 - 2009 Floor action to return pamphlet to Trustee's Literature Committee (TLC) for additional discussion was approved.
 - Current draft contains new introduction; had additional review by AA members who are also physicians.
 - Pamphlet is only available to Conference Literature Committee member at this time, so we had no material to review.

No discussion

- B. Review the revised draft pamphlet "Questions and Answers on Sponsorship."
 - Pamphlet revision stemmed from a request from Area 54 Northeast Ohio.
 - Became a 2009 Advisory Action for the TLC to conduct a thorough review and look to eliminate or revise outmoded ethnic, cultural and vocational references.
 - Pamphlet was last revised in 2005.
 - Pamphlet is only available to Conference Literature Committee member at this time, so we had no material to review.

No discussion

- C. Consider developing Conference-approved literature which focuses on spirituality that includes stories from atheists and agnostics who are successfully sober in Alcoholics Anonymous.
 - Result of several requests from several areas over the past 20 years+.
 - Reasons for requests include: many people are put off by what they perceive to be the religious
 nature of AA and this may create a barrier; although an outside issue, some courts have ruled
 that AA is a religion; some atheists feel pressured to conform to a belief in a higher power.

- Currently, many of our pamphlets and other pieces of literature contain some explanation of the spiritual nature of the program, but there is not a single piece of literature which consolidates this information.
- A recommendation in 2009 for the TLC to develop a questionnaire to gather input on whether there is a need to develop this type of literature failed.
- The agenda item was the result of a 2009 Floor Action to recommit, which passed.

The committee was split on whether AAWS should develop literature of this type. Some felt that we are becoming more divided, that AA is not in the business of defining God, and that we have plenty of literature addressing this issue. Others pointed out that Bill W. wrote about being sympathetic to people of no faith and that we should try to be as inclusive as possible. Sense of the committee was narrowly opposed to this item by a vote of 3-2.

Discussion: Mark: I was in the committee, I'm in favor of it. It was hard for me to hear any mention of God. I now realize that AA does not define God or a Higher Power.

Carla: ditto. We are inclusive, we are viewed as having religious overtones- maybe because of the Lord's Prayer.

Peg: Maybe it is because of the Lord's Prayer.

Nick D: The Big Book is plain, it is a God of our own understanding as in Bill's Story. Maybe we should decide if the Lord's Prayer is appropriate or not.

SOA: Split

- D. Consider request to change a sentence regarding closed meetings in the pamphlet "Frequently Asked Questions About AA."
 - Item was proposed by Area 29 Maryland.
 - Under the section titled "What is a closed meeting," the first sentence currently reads: "A closed meeting is limited to members of the local A.A. group, or visiting members from other groups."

 The proposal is to change this to: "A closed meeting is limited to members of A.A."
 - The reason for the proposed change is that it is thought that the existing wording misleads the reader to believe that if one is not a home group member, one cannot attend a closed A.A. meeting, and that the language is not consistent with the Third Tradition.

The committee agreed that the existing wording was vague and could be simplified, but was not in favor of the proposed change. The sense of the committee was unanimously opposed to the change as written, but would like to note that it would have been in favor of a change as follows: "A closed meeting is limited to those with a desire to stop drinking."

No discussion SOA: Opposed

- E. Consider request to update the pamphlet "A.A. and the Armed Services" with new stories reflecting more recent experience.
 - Item proposed by Area 75 Southern Wisconsin (original proposal was to develop a new pamphlet for military veterans suffering from alcoholism).
 - Reason is that veterans often feel a sense of hopelessness and abandonment by the military as
 they face life after active service and that the current pamphlet speaks to an entirely different
 population.

• The TLC took no action on the request as presented but instead is asking the conference to consider revising the current pamphlet.

The committee agreed that process of identification was important for the newcomer, and that it would be better to revise the current pamphlet than to produce a new one. Some of the issues in the background material, such as PTSD, were considered to be outside issues by some. It was also mentioned that the current pamphlet, like some others, divides us rather than promotes unity. The sense of the committee was 4-1 in favor of the revision.

No discussion

SOA: For

- F. Consider request to review the booklet "Living Sober."
 - Proposed by the Wednesday Night Living Sober Group of AA in San Francisco, CA.
 - Reasons: It is thought that the relevance could be enhanced with some updating for instance there are no references to the internet or social networking sites, but it contains quaint, outdated references, such as to "ham radio."
 - Booklet has not been revised since its publication in 1975 with the exception of an addition of an appendix containing sections of the pamphlet "The A.A. Member – Medications and Other Drugs."
 - Estimated cost for limited review and creation of a draft manuscript is up to \$2,500.

The committee was split on the need for updating. Some thought updating was unnecessary – we don't update the Big Book because of outdated language. Others pointed out that we rely on attraction in our message. Still others thought we should totally revamp or eliminate the booklet. Several questioned the cost estimate and thought it would surely cost more than \$2,500. The sense of the committee was opposed to the update by a vote of 3-2.

Discussion:

Jennifer W: to add "Living Sober" was a critical tool for my recovery, I hope it doesn't become so dated it becomes obsolete.

SOA: For

- G. Consider request to define the editorial responsibility of G.S.O.'s Publications Department.
 - Proposed by Area 76 Wyoming
 - Requested wording is as follows: "Editorial responsibilities of the Publications Department of the General Service Office be limited to the following in pamphlets and literature where not otherwise specifically addressed by other Advisory Actions:
 - Update financial and publication data that change on an annual basis;
 - Revise dates that require periodic updating;
 - Correct typographical and spelling errors;
 - Maintain any accurate indexing, pagination, and cross-referencing."
 - Reason for request is that a clarification of delegated authority is needed as the Publications
 Department has not been given clear direction on editorial latitude. This has resulted in
 controversial changes that did not go through the conference approval process and later had to
 be changed.
 - The TLC noted that the request as presented may limit and not cover all responsibilities commonly undertaken by the Publications Department.
 - In the opinion of John H. (member of the Publications Department) this wording is broad enough to apply to all literature in addition to the Service Manual.

The committee agreed that the job description for the Publications Department should be clear and specific, and that this wording does the job of establishing boundaries. A concern that this essentially makes the department nothing more than proof readers was expressed. The sense of the committee was unanimously in favor of this item.

No discussion

SOA: For

- H. Consider request that the video "Your General Service Office, the Grapevine and the General Service Structure" be revised and updated.
 - Requested by Area 29 Maryland
 - Reasons are: the anonymity protection is inadequate; video should have updated pamphlet covers and the 4th Edition Big Book; GSR, DCM and General Service Board are not covered.
 - Estimated cost for revision is \$40,000.
 - Total distribution in 2009 was 60 copies.

The committee agreed that it did not seem fiscally responsible to update this video, with additional comments being that personal contact is better than using a video and we have plenty of other resources to use, i.e. the Service Manual. The sense of the committee was unanimously opposed to updating this video.

Discussion:

Paula H: Do you have any sense of distribution from early years? Was it always unpopular? A: I have no early distribution figures.

SOA: Opposed

- I. Consider request to develop a book on the history of "early pioneer women in A.A."
 - Proposal from Area 36 Southern Minnesota
 - There is no Conference Approved literature of this kind other than a few Grapevine articles in the Digital Archives. GSO Archives was able to provide a document "History and Resources of Women in AA" all non-conference-approved literature.
 - Estimated writer's fee is \$150,000 \$200,000.

The committee was split on this idea. While most thought the cost was too high, several were attracted to the idea of this book, stating our history is important and this may help attract more women. A compilation of existing literature/articles may be less costly. The sense of the committee was opposed by a vote of 3-2.

No discussion SOA: Opposed

Area 40 Agenda Item for PI:

1. Review and report the status of the Area 40 888 number.

Status of the Area 40 Hotline number 1-888-607-2000

Since the Fall Assembly I have visited District 71, (Butte/Anaconda/Dillon), District 11, (Billings), and District 41, (Great Falls), concerning Public Information in General and the Area Hotline Number in specific. Probably the biggest area of concern that was voice during my visits was about the Area Hotline number not being in many of the phonebooks throughout the state. In mid December Area 40 entered into contracts through AnswerNet to be in the following Dex yellow pages;

- Billings, Bozeman, Butte, Miles City, Glasgow, Great Falls Main, Great Falls Valley, Helena, Lewistown, and Missoula. I am also happy to report that I received the new Dex directory for the Helena area on last Thursday and the Hotline Number was in it!
- Kalispell is not listed in a Dex directory because Qwest does not do business in this area. I have spoken to the DCM and to Larry L. a member of the Intergroup up there to get this number in the CenturyTel directory that does service that area. Alida W. a member of the Kalispell Intergroup attended the Spring Assembly and has agreed to work with their Answering Service, and if necessary CenturyTel, to get the number that is listed in their director transfer to the Area 40 Hotline number.

The reason we will only be listed in the Yellow Pages of the Dex directories is because the 1-888-607-2000 number is not owned by QWest but by AnswerNet so it can only be in the Dex yellow pages.

It is also my understanding that the dates the above books are published varies but once the new books for 2010 come out the number will be in them. The cost to be in the Dex directories was budgeted for 2010 but AnswerNet required a \$175.00 processing fee for the year and the entire year paid in advance for a total of \$1195.00.

We also signed contracts to be in the following Co-op directories around the state for a total yearly cost of \$636.00 that was not budgeted for in 2010 because when we were doing the budget at the Fall Assembly we were told it would cost far greater than the amount we eventually got them to agree on;

The 2009 year end budget showed that we had a deficit of \$2100.44 was due to the 2010 expenses for being in the directories was paid in 2009. This will result in the 2010 budget not reflecting these expenses. Our Area Treasurer Linda has also asked me to remind you that this service is saving your districts allot of money. It is not only the right thing to do, but our responsibility to contribute more to Area 40 to pay for this service.

As of the end of April 5th we have 508 contacts in the Area 40 Hotline database with all district represented except 21, 23 and 42. The online meeting information has also been updated within the last year for all districts except Districts 21, and 42. This is a vast improvement from the paper lists that AnswerNet was using which in some cases were 5 years old.

Since I reported at the Fall Assembly until the end of March of this year our invoices reflect that AnswerNet has received 354 calls for 228 minutes and made 33 patch calls, (A patch call is when someone requests to be connected to a member of AA and actually is). The total costs to districts during this time period was \$134.50 and to Area 40 of \$330.00 for a combined total of \$464.50.

Some districts have voiced concerns that the total call number seems low. In talking with AnswerNet about this I was told that they do not bill us for many of the calls for just meeting information. In order to track all calls they would need to bill us an additional amount of \$65.00 a month to pay for the labor cost to do so.

I was also asked why we needed to pay the base rate to Dex to be in the yellow pages for 2009 even though we were not in many of the directories yet. What I was told by AnswerNet is that this is Dex's billing policy and that AnswerNet just passes on their charges to us without making anything from it.

I would also like to take this opportunity to remind the fellowship that this service is only as good as we make it. There have been some concerns voiced in my rotation about some bumps along the way with the service AnswerNet is providing us. On the reverse side of this I was informed recently that it took AnswerNet fifteen tries before they could connect with someone to talk to the person who wanted to reach another Alcoholic. So please if you make the commitment to put your name as a contact make sure you are available at the times and days you say you are. If you are a district PI and/or Answering Service chair please keep the call database current. Also notify any organizations in your districts that we cooperate with, (Hospitals, Mental Health facilities, Law enforcement, Newspapers etc.), about the 1-888-607-2000 number so they will update their material to reflect it.

In closing on behave of all the still suffering Alcoholics reaching out for help, Thanks to all the members who have volunteered their time, efforts and talents, especially Alex our webmaster, to create and to update the online meeting information and contact lists, and to be contacts when someone needs our help. We are all truly better off because of it. Please keep up this very worthwhile effort!

April 11, 2010 Recommendation by the Public Information Committee at the Spring 2010 Assembly

That the current process of having districts pay for the calls billed to each district be discontinued and the following process adopted.

The Area 40 PI chair will forward the itemized bill received from AnswerNet to the Area 40 treasurer for payment up to the amount of \$250.00 a month. In the event the monthly itemized total amount is over \$250.00 the Area 40 PI chair will bill each district on a prorated basis. (Example: If the total bill is 300.00 and district 11 has 30% of the billable calls that month they would owe 15.00, ((300 - 250.00) * .3 = 15.00).

Nick D: I need clarification on this will this allow us to send money to Area directly to cover the cost of these calls?

Tim: At this time each district is billed individually this is cumbersome for Answernet and for the districts.

Area 40 Agenda Item for Agenda

In September of 2008, Brooke C, Panel 58 Delegate from Wyoming submitted a proposal on behalf of the Area. "That the General Service Conference re-instate the Conference Committee on Agenda's duties and responsibilities to be once again consistent with The A.A. Service Manual, which reads: 'Reviews and approves the overall format and content of the agenda for the annual Conference meeting, has the year-round job of communicating with GSO on subjects for the Conference agenda and theme.'" (p S60, CONFERENCE COMMITTEES, Agenda) Three other Areas (67, SE Texas, 35 N Minnesota and 62 SC) support this proposal.

It seems that somewhere along the line from 1973 to 1983 things changed, and since 1983 the trustees' Conference Committee sets the agenda instead of the Agenda Committee. There is no record how or when the change was made. However on page S56 of the Service Manual, under Sources of Agenda Items, the last paragraph reads: "Whatever its origin, any agenda item follows the same path to the Conference agenda: The A.A. Staff studies it in the light of previous Conference actions, then passes it on to the trustees' Conference Committee or the appropriate Conference committee....."

After discussion, the committee recommends that an Ad Hoc committee be formed to study the process and bring the process and the Service Manual in line. Thank you for allowing me to serve,
