#### **AREA 40 SPRING ASSEMBLY**

#### **APRIL 14-15, 2012**

<u>Sharon S. opened the assembly</u> with the Serenity Prayer at 8 am on Saturday, April 14, 2012. Heidi from District 72 read the 12 Traditions and Virginia from District 71 read the 12 Concepts.

<u>Roll call</u> was taken by Linda B. There were 108 voting members and 32 visitors for a total of 140 in attendance at this assembly. All officers and standing committee chairs were present. District 12 Alt DCM Nick D. stood in for Sandy A. and District 72 Alt DCM Nick G. stood in for Catherine J.

#### Actions Passed at the Fall 2011 Assembly

The Area 40 Corrections Committee recommends that the Pink Can Fund Program become one of the defined responsibilities of the Corrections Committee.

Motion passes. For 77 Against 5

The Area 40 Corrections Committee recommends that the Pink Can fund be used to supply AA literature to alcoholics who are detained in a facility as the result of a law enforcement action. The detaining facility must be located in the geographic boundaries of Area 40. All requests for literature must come through the district in which the detaining facility resides.

Motion passes. For 64 Against 18

The PI Committee recommended that the Archives Committee review the sections of the Area 40 Policy and Procedures Manual that refer to the Web site to resolve inconsistencies or inaccuracies so that the Policy and Procedures manual can be updated.

The motion passed. For 67 Against 15

The Area 40 Finance Committee recommends the 2012 Budget.

Motion passes. The vote was 82 votes For with none opposed.

The updates for Fellowship New Vision and accurate information for each group in Area 40 has to be submitted no later than May 1st to the records department of the General Service Office. There are only 4 out of 14 districts that have submitted their updated paperwork to me. If your group has changes, please see your DCM and get that information recorded on the group update sheets that were mailed out to them early in February. All group information now will need to be mailed, faxed, or emailed to the records department. I have group update forms available. If you have your update sheets completed, I can take them this weekend and still get the information inputted into the Fellowship New Vision Database. As always, thank you for allowing me to serve as your area secretary. Linda B.

#### Area Chair/Alternate Delegate Report-Sharon S.

As a part of experimenting with some changes to the Agenda for the Assembly, I omitted presenting my report. I was reminded that it would be appropriate to submit a report in some form, so I am submitting this report for inclusion in the minutes. I am also emailing it to the Area Committee and will have it available at the Finance Committee, should they wish to review it.

In reviewing the detailed notes from the inventory taken at the Fall Assembly, I noticed that there were many comments about the agenda. Since we didn't include any plans to take action on the inventory, I visited with other committee members and past delegates and have made some changes in the agenda. The most significant change is moving the standing committee chair and non-voting member reports to their respective committees and the DCM reports to later in the morning. I am hoping this helps sustain some of the Saturday morning energy that you all bring to the meeting. I also provided a little more time during the day for questions and answers. Please take a few minutes and answer the questions on the evaluation form before you leave on Sunday. We want to know what worked and what didn't and any suggestions or comments you have.

Thank you for sending me to the West Central Region Service Conference and the preassemblies in Laurel and Boulder. Although I planned to attend the preassembly in Corvallis, road conditions around Bozeman were not good because of one of our famous spring storms. Reluctantly, I decided not to try to drive on the icy roads. I knew the preassembly was in good hands.

I think Terry S. is doing a commendable job as our Delegate. He is very well informed on the agenda items and has given us (AA members in Area 40) many opportunities to study, question, and discuss the General Service Conference agenda items. I am confident we will send him to the Conference with a well-informed sense of our Area. Also, Terry has done a really good job at communicating with me, as Alternate Delegate. He has also used the Audio Conference option to keep in touch with the Area Committee between assemblies. We had Audio Conferences in October and January. The Area Committee does not make decisions on these calls, which are an opportunity to maintain contact and communication in between Assemblies. We did discuss the Triangle and its status in the January calls. The Triangle Editor is responsible for publication of eight editions annually and because only 5 of the 8 issues were published in 2011, we had to have a difficult conversation. A plan was suggested, and 3 issues have been published this year, as scheduled. My goal is to submit an article for each of the remaining 5 issues and I know the Triangle Editor would appreciate articles from other members also.

The next 3 assemblies have been scheduled (the next Area Chair will schedule 2014 and 2015):

- Fall 2012 Assembly September 22 23
- Spring 2013 Assembly April 6 7
- Fall 2013 Assembly September 21 22

The deadline for agenda items for the Fall Assembly is July 1. If you plan to submit an agenda item for that assembly, I would be delighted to help your home group with the process of preparing an agenda

item. The suggested flow of information is outlined in the Policy & Procedures (page 22). Since this flow includes the group and the district, embarking on this process this month is a good idea. Also, the fall assembly is an election assembly and I encourage everyone to consider who will be serving your group, your district, our area. Please think about:

- your own strengths and abilities, family and work commitments and where you could make a commitment to serve AA;
- your current service position look around you and encourage those who might be qualified to take over your service position; let them know what is required;
- our current trusted servants and what makes them successful and who among the fellowship might be able to follow;
- reading Concept IX and Bill W.'s "Leadership in A.A.: Ever a Vital Need" article.

# Group Contributions as a Percentage of Budget



#### **ORIENTATION TO THE ASSEMBLY-TERRY S.**

My name is Terry S. and I am an alcoholic. You have given me the gift of serving as your Panel 61, Area 40 Delegate to the General Service Conference, last year and this year, and I am very grateful.

Our Area Chair, Sharon S., has prepared the agenda for this assembly, and will chair the assembly. We loosely follow Robert's Rules of order, and Sharon is the final authority on any points of procedure. Everyone who is attending their first Area Assembly, please stand up? Thank you! Welcome! We've been waiting for you. A.A. survives and thrives on newcomers. That is every bit as true in service as it is in recovery. We ask that you do two things. First, please participate! Service is not a spectator sport. Second, keep coming back! There's work to be done, and we need your help. My job now is to give you a brief orientation to this assembly.

As soon as I finish this orientation, we are starting our committee meetings. Pages 3-10 of the Area 40 Spring Assembly Agenda list the agenda items each committee will consider. Here in Area 40 we use a committee system based on the committee system at the General Service Conference. Each of our standing service committees will meet in separate rooms. Feel free to attend any of the committee meetings. If you prefer, you can attend the Workshops that will be held in this room while the standing committees are meeting. The committee meetings are led by the Area Committee chairs except for the Finance Committee, which is led by the Area Treasurer. Each committee discusses the items on the agenda for that committee. Many of the items are the agenda items for the 62 General Service Conference, which will convene in Rye, New York, next weekend, and run through the following week. The rest of the agenda items are Area 40 specific items. Each committee will discuss their agenda items, for both Area 40 and the General Service Conference. Most of our Committees have secondary assignments, doubling up on categories of agenda items.

On each item, the voting members of the Committee will decide whether to recommend an action by our Assembly, make a comment about the item, or to take no action. Although only the actual committee members vote, anyone can attend the meeting and participate in the discussion of the agenda items. For those of us who are not in the committee meetings, two of our past delegates, Andrew Ware and Mark Sullivan will lead workshops here in this room. The times and topics are in your agendas, as are the rooms in which the various committees will meet.

Every Assembly we invite two of our past delegates to participate in the Assembly, in one or two workshops, in breakout sessions and in sharing. We are blessed in Area 40 to have a stellar group of past delegates who have retained their love of and enthusiasm for Alcoholics Anonymous. We can all always learn from them.

At 11:00 a.m. we will reconvene in this room for brief reports for our DCMs about what has been happening in their districts. At 12:00 we break for lunch, and at 1:30 the committee meetings resume in the same rooms, and there will be a "Breakout" session in this room, led by Mark and Andrew, on "What is on your mind and heart?" Again, you can attend any of the committee meetings or the breakout session.

I'll be giving the delegate's report at 2:30, in this room. Then, after a coffee break, at 3:30 we will convene a floor session, in this room, of the entire Assembly, to hear the reports of our committees, and any recommendations or comments they have on the agenda items. After discussion on any recommendations, we will probably vote on them. In order to be a valid vote we must have a quorum (two-thirds of the voting members present). By past action, a valid vote with two-thirds of the votes cast in favor of an action passes. There will also be time for minority opinions after a vote on a committee recommendation. Minority opinions help ensure that we have an open discussion on each issue and that no voice is squelched in the process.

For all of us, new or veteran, please participate. Take part in the discussions. If you are confused, then ask questions. Ask the people around you. Go to the microphones and ask. We are seeking clarity and consensus, but it takes a full discussion to get there. In the interest of saving time, if someone else has already expressed your view, it is not necessary to repeat it. If nobody has expressed your view, get up and go to a microphone and share it with us. An informed group conscience requires voicing of all views about the item.

After a coffee break, the curtain will divide this big room into two rooms, and there will be a G.S.R. breakout at one end, and a D.C.M. breakout at the other end, chaired by Andrew and Mark. You don't have to be a D.C.M. or G.S.R. to participate in one of the breakouts. It is a chance for everyone who wants to be there to ask questions, share in discussion and get answers about service-related topics.

We will resume on Sunday morning, and conclude our business, usually by noon. Finally, a reminder to get things started: please, GSRs, sign in with your DCM. DCMs, turn the completed sign in sheets to the Area Secretary, Linda B. This will enable us to determine how many voting members are present and to determine the number of votes required for a quorum, which is two-thirds of all voting members.

Thank you all for being here. Let's have fun and get the work of Area 40 done! This fall, we will be electing our new trusted servants for the next two year rotation. Please be thinking about whether it is time for you to stand for a position on the Area Committee. We need all of you to participate, and welcome your willingness to do so. Thank you for my sobriety, and for this opportunity to serve.

#### **WORKSHOPS**

Workshops were led by Andrew W. and Mark S. in the Sapphire Room at 8:45 and 10:00. The topics discussed were: "Change-Essential to A.A.'s Growth" and "Safety in A.A.: Our Common Welfare".

#### **DCM REPORTS**

District 11- Brandon M. gave highlights about District 11, but didn't submit any written report.

<u>District 12</u>- Thank you to Nick D. for his service in stepping up as Alternate DCM for District 12 at the last minute.

District 12 has currently has 34 meetings in 8 towns and is financially sound and retains no debt. We continue have four committees, Grapevine Rep, Daniel M., PI & CPC, Steve O., Treatment & Corrections, Cheryl D., Literature, Nick G.

District 12's Annual Mid-Winter Social was held Feb. 18th in Joliet at their community center with the district providing ham and turkey, with attendees providing a delicious assortment of side dishes. Our speaker that evening was Area 40 delegate Terry S, who shared his experience, strength and hope. Our gratitude to the many that attended and continue to attend this successful and joyous event every year.

A pre-assembly was held in Laurel on March 25th with several of Area 40 committee chairs, Delegate Terry S., Chair/Alt Delegate, Sharon S., and several of the Area 40 Committee Chairs in attendance.

The upcoming Annual Fireman's Point Campout has been set for August 17-19, 2012 at Fireman's Point, one half mile south of Columbus on Hwy 78. The campout has evolved to 2 nights and 3 days. Friday night kicks off the event with a potluck and speaker to follow at 7 pm. The SOB (Sober Old Bikers) Poker run will happen on Saturday, August 18th with a meeting on the river at the half-way point, ending again at Fireman's Point. A BBQ Saturday night with Chef Dave R., grill master, will prepare the meat provided by the district. At 7 pm, Rodney M. will share his story of what life was like, what happened and what his life is like for him now. The evening will conclude with toasted marshmallows, tall tales and resentment burning. Tentative plans for Sunday include District 11 providing a delicious breakfast followed by Area 40 delegate report from Terry S. Camping is free, with no utility hookups. <u>District 21</u>- Our district is perhaps the most challenged district in Area 40. A round trip drive from one group to next is two to four hours. Unfortunately, we see our fellow groups infrequently and our district meetings are poorly attended as a result.

Our summer event, Wild West Soberfest, is situated on the Missouri River as it flows into Fort Peck Lake (Montana's largest body of water) and is scheduled for August 24-26. We are honored to have Sharon <u>S.</u>, Libbie <u>L.</u>, and Lori <u>F.</u> joining us. Of course, we will have speakers and campfire meetings. Our featured event, as far as some of are concerned, will be a marshmallow roast and sing-a-long with the kids. We

are not a glum lot. All food is provided. If you haven't visited our neck of the woods, this is a great opportunity.

The Sheriff of Valley County has invited us to bring meetings into the jail, as 97% of the inmates have alcohol and/or drug related problems. Valley County's new jail, unlike the old jail, offers a safe place for visitors to meet with inmates. This is facilitated by a glass wall, where we meet in pods. We are not able to meet in the same area without being separated by the wall. It causes some frustration as an us-them atmosphere is set up.

The Glasgow group has ten meetings per week and they average between five to 15 members per meeting. Currently there are some newcomers. They are adding new interest among the "old timers" and we seem to have more treats that usual. Many of us have mysteriously gained weight over the past months.

Wolf Point, Poplar and Plentywood continue to struggle to stay vibrant. There are few newcomers and membership is down; however Plentywood has added a third meeting. In sum total our district has 17 meetings a week. In some ways we are encouraged by the number of weeks—we now have the highest number of meetings, to date. Laura S. DCM

#### <u>District 23</u>- District 23 DCM Report to Area 40 Spring Assembly 4-14-12

Greetings All. Since the fall assembly, my travels have taken me to meetings in Bismarck, ND and Billings and Laurel, MT including the most recent WCRAASC and the North Dakota Area Fall Round-up and Assembly in Bismarck. Not to mention, events at the Savage Community Center on Halloween, New Year's Eve and the most recent St. Patrick's Day Soberfest.

The WCRAASC was my first service conference and I am glad I attended. At the District level, we have had (2) District meetings, at the Halloween event and the most recent St. Patrick's Day Soberfest. At the later, among other business, we voted to pay the entire amount of the Area Hotline Invoice, rather than just our percentage above Area's share. Our District's bank account is historically low, but the expenditure was worth it.

It is my opinion that we must be conscience of what we spend our funds on and put it up to a scrutiny comparing how such expenditure will help us carry the message. I agree with Carole B., Area Advisor, when she talks about this subject and how important it is, especially in times of frugal budgets, to put any expenditure to this test.

I got my first call from Answer Net, while I was in Billings for the WCRAASC. I was eating dinner at Denny's on March 3 and my cell phone rang. Answer Net was displayed on the caller ID, along with their number. It took twice for them to connect, as the first time I answered I said hello but to no avail. Anyway, they called back right away, advised that the caller was looking for a meeting in Sidney and eventually patched him through. We spoke and I asked if I could call him back (so as not to rack up the Answer Net bill). He consented, I called him back. We talked about the meeting location in Sidney going on that night. He was at the right place, just looking at a different building of the Church. As we talked,

he found the place. Following up, he was welcomed into the meeting, has since come back to other meetings, done service work and made contacts/friends in the program. A success story!

Concerning groups/meetings, in addition to the three registered groups-Monday Noon-Sidney; Welcome Home-Sidney, Life Again-Glendive; we have three unregistered groups: 12 to Life-Glendive; Fairview Big Book Study-Fairview; and the Circle group. Also, a member in Sidney, has been holding a Monday 7pm meeting, smoker friendly, in his home since April 9th. More to be revealed here. Lastly, there is a non-affiliated Sober Life Young Persons NA-AA Group-Sidney. With all these meetings/groups, one may have to get in the car (or truck) and attend a meeting at different times of the day, but one can make at least one meeting a day in the District. All of the meetings are reported to have good attendance.

As far as my plans, I have taken recovery road trips to attend meetings throughout District 23, the State, in addition to Round-Ups and meetings around the State/Country. We have held roving District Meetings. I launched District 23 DCM Ramblings, my newsletter on April 11th. Still in the process are: filling all District Committees, registering the unregistered meetings and re-developing Workshops cosponsored by District 21 and 23. By God's grace, I am still willing and able to do whatever else comes my way as I "trudge the road of happy destiny" in my recovery efforts, ever keeping in mind--Rule 62-"Don't Take Yourself So Damn Seriously"."

Since our district spans across such a large geographical area we see less attendance from some of the smaller towns, although we do have regular attendance from several GSRs who travel over an hour to reach us every month. Our service commitments include: meetings to MCDC in Butte on the 4th Friday of each month; meetings to the Providence Mental Health Center two times per month; weekly meetings in our correctional facilities; and, weekly meetings to the Teen Recovery Center.

The committee meets monthly and will increase in frequency as October approaches. Daycare will be available at the Round-Up—so parents are welcome to bring their families. He did a great job of establishing a line of communication, gathering volunteers who met the specific requirements to enter the jail and organizing a system that will ensure AA meetings are in the jails and literature is available for inmates.

In the last few months I have received several calls from community organizations that are requesting AA literature and inquiring about having an AA meeting held at their treatment center. I think this is an exciting compliment to AA—indicating that we are attracting people by example and following the Traditions as they have been taught to us. Because of these calls and the work of a dedicated P.I. Chair, AA schedules and pamphlets have been distributed to many more areas of our District where a potential alcoholic-in-need may find them. #### **Questions and Answers**

 I have been told in A.A. that I get to choose a higher power of my own understanding. I wonder why throughout the Big Book, God is referred to as He. Could we change He and/or God to Higher Power?

By past action, we won't be changing any of the first 164 pages, the Realm of the Spirit is roomy, we should just read it as it is written, we all get to choose a higher power of our own understanding, don't change the Big Book to fit you-change yourself to fit the Big Book.

- 2. As a GSR, how do I get the information and/or decisions generated by each committee (as well as background information) back to my group and how much, if any, of this information is sent on to the General Service Office.
  - Of The ususal process is that the background information is first passed from the Delegate to the DCM's, committee chairs and officers. It is the responsibility of the DCM to see that groups know that all information is available for their group and can be duplicated. The DCM is the link between the district and also between the groups and the area committee. The service manual also gives much information about how information flows between all entities.
- 3. Is it a good idea to have an NA. presence at an A.A. Roundup?

Use the literature and use the traditions to guide us. The General Service office Desk can be asked to give information on shared experiences, we should believe in separations of the two fellowships by

carrying our own message and don't convolute the two separate entities, this is a violation of our tradition of affliation, keep them separate

#### **Workshops**

Andrew W. and Mark S. led workshops on 3 topics. "Change-Essential to A. A.'s Growth", "Safety in A.A.: Our Common Welfare", and "What's on your hearts and minds?" Here are highlights on the workshops.

Topic #1: It was brought up at the preassembly that changing the 11th Tradition would require a 75% positive response from all the groups worldwide, but what would it take to change that rule and then change the Tradition?

• That rule is part of a resolution that was put forth by Bill W. and adopted by the General Service Conference in 1955. You can read this resolution on page S105 in the Service Manual. It is highly unlikely that will be changed.

Topic #2: What is the deal with anonymity for AA's on Facebook?

- Will Facebook (FB) allow AA to have a non-interactive page? If so, then I think that's okay.
- What about personal anonymity in and FB?
- What would be the impact on AA if I broke my own anonymity at the FB level?
- If I go out again, I can create a black-eye for AA. The people I work with need to know that I don't drink but not that I'm in AA (unless they ask). I don't represent AA.
- There is one committee position that requires breaking our anonymity: CPC chair. Makes me nervous as a teacher in a small community.
- Telling someone one-on-one is not breaking a Tradition. It's a personal choice who we tell we are in AA. It's only breaking a tradition if it is at the level of press, radio and films.
- I came into AA thinking I was keeping a secret (that I was in AA). Over time, people I work with and interact with have found out that who I am and that I'm in AA. It's no longer a secret.
- What about people posting pictures of fellow AA members at AA events on FB? We need to tell them it's not okay.
- I don't go out to break my anonymity, but I'll do it if it will help someone. In my work I overheard some medical professionals that they couldn't schedule someone after 9 AM because they would be drunk. I let them know I could be a resource as a sober AA member.

Topic #3: How do we encourage our groups, our sponsees, and our friends to be more self-supporting?

- How can we encourage participation? It's more than just money. I don't want someone to just drop money in the basket and leave. We used to use the circle and triangle. We would tell people that if you want all of recovery, you need all three sides of the triangle. The financial contribution is just part of it. If you drop a \$5 in the basket, don't crumple it up let other people see it.
- We can bring up the 7th Tradition as a topic in our meetings.
- My experience with the 7th Tradition is that that it is one of the key ones that sold me on AA. They weren't looking for money from outsiders. They weren't trying to sell me into a program. The sacrifice is important. Am I making a sacrifice for AA?
- At our last preassembly in Corvallis, we asked what are the services that groups get from GSO for their contributions? Similarly, what do our groups get from district for their contributions? Should district PI folks be getting public service announcements (PSA's) and taking them to local TV stations?
- You can view the PSA's right online. They are really good.
- Are the PSA's being played in Missoula? I see Al-Anon spots but not AA ones.
- I complained to my sponsor that "so-and-so" wasn't putting anything in the basket. My sponsor suggested that I put contribute for "so-and-so."

#### Delegate Report- Terry S.

My name is Terry, and I'm an alcoholic. It's my pleasure and privilege to serve as your Area 40 Panel 61 delegate to the General Service Conference of Alcoholics Anonymous in the U.S. and Canada. Since the 2011 Fall Assembly I have participated in the 2011 Fall Roundup in District 61 last October, the 2011 Attitude of Gratitude in District 61 last November, an Area Committee telephone conference in January of this year, District 12's Mid-Winter Social this February, the West Central Regional A.A. Service Conference in District 11 and PreAssemblies in Districts 12 and 61 this March, and a PreAssembly in District 93 this month, plus a couple ofgroup events in between. But what I want to share with you today is what's happening in A.A., across the USA and Canada, and here in Area 40.

Let's talk about numbers. I came to A.A. in 1995, and I was in very sorry shape. The members of my first home group, the West End Group in Billings, were faced with a whole bunch of us new guys and new gals in the Fall of 1995, and most of us were in very sorry shape. Those of us who made our meetings (and even shared in them), made coffee or washed cups and ashtrays, and started to take the steps, we stuck around. Others of us new guys and gals didn't do those things, and got struck drunk, and disappeared for a while, coming back in worse shape, or maybe never making it back at all. Overall, our group was growing a little bit. After I moved to Helena in March 1996, both my first Helena home group, the We Care Group, and my current Helena home group, the Free for Lunch Group, also were both growing a little bit. Overall, from 1995 through 2012, A.A. was growing a little bit in the United States and Canada, although there have been some increases and decreases instead of steady, slow growth.

In 1995, our membership was 1,251,148 in the USA and Canada. Estimating that 1 out of 10 people in the USA and Canada probably is alcoholic, there were, in 1995, 29,563,200 alcoholics in the USA and Canada, so there were slightly less than 24 active alcoholics (23.6) for every member of our Fellowship in the USA and Canada. We have grown a little bit since 1995, but by a little bit I mean that while we have more members in 2012 than we did in 1995, we aren't keeping up with the rate of growth in the total number of alcoholics in the USA and Canada. At the beginning of 2012, there were 1,423,468d members of A.A. in the United States and Canada. There were 34,747,321 active alcoholics in those two countries, for just more than 24 drunks still out there drinking and causing trouble, for themselves and others (24.4). So the folks in the USA and Canada are making new drunks faster than the existing drunks are dying.

The number of active alcohols is growing at a faster rate than the rate at which they come to A.A. and get sober and stay in our Fellowship. We are not goindg to run out of drunks anytime soon. So, how can we do better? Well, we can look carefully at how we are attracting new members. Are we letting them know, without becoming promoters, where to find us and what we do and don't do? Are we still taking panels into schools? Are we still taking meetings into correctional and treatment facilities? Is there a list of contacts for calls to our 866 number looking for someone to talk to in your town? Do the members of the Fellowship in your town go out on Twelfth Step calls when they get the chance? Are they actively seeking those chances? Are there contacts lists of members of the Fellowship in your community who are willing to go and meet the folks coming to your town out of correctional and treatment facilities all across our Area, and willing to take those new folks to a meeting the first day they are there? Are there AA literature racks around your community, in the hospitals and schools and cop shops as well as correctional and treatment facilities, and are they still filled with AA literature? Is your local or district meeting list on those racks, and in your meeting rooms, and maybe even in your local newspaper? How many open meetings and closed meetings do you have each week? How many people come to district each month? How many of your groups do splits? Do you greet the newcomers who show up at your meetings, and talk with them before and after meetings? Do you shake their hands, get their phone numbers, take them out for coffee? Do you offer to take them through the Book? When you do get the chance to take them through the Book, do you do it? Is it awesome for you? Does it improve your life and your attitude? I only ask because those things happen for me, and I sure hope they happen for you, too. Either our Fellowship grows, or we shrivel up and start dying. There is no middle way for that one. Are we making sure the hand of A.A. is always there when any drunk, anywhere in Area 40, reaches out for help with his orner alcoholism?

Right now, folks, Area 40 shares a common problem with the GSO, AAWS and AA Grapevine. In Area 40, since at least 2004 or so, we have had a lot of money in our Area bank account, over and above our prudent reserve. That happened back at least four full rotations ago, because we had too little money in the Area bank account, and it looked like we might be headed back to the bad old days when we had to pass the hat at the end of each Area Assembly, to try and get enough money to pay the facilities and coffee charges for the Assembly. The word went out, across Area 40, that the Area needed more money, to do the things that we decided we wanted Area to do, by voting to do them and approving a budget for doing them. And the money came in! The old-timers, the elder statesmen, always tell us that every

time Area 40 has needed more money, to support our primary purpose, to make sure the hand of A.A. is there whenever any alcoholic anywhere in Area 40 reaches out for help with his or her alcoholism, when there is a genuine need, the groups in Area 40 send in the contributions to meet that need. They responded so well that in early 2005, we had more than \$26,000.00 in our bank account, more than double our prudent reserve, before a new Area Treasurer got out the word that we no longer needed the increased contributions requested..

Since then, we have not had to be self-supporting through our own contributions, because we had this cushion in the bank. Until now. As Lori F., our Treasurer, told you this morning, we have spent the last of that surplus. Unless our splits and individual contributions cover ourbudget of more than \$35,000.00 carrying our message, we won't be able to do all the things thatwe decided last Fall we were going to do in 2012. We're kinda out of practice at self-supporthere at the Area 40 level, because we haven't had to do that for quite a few years. We sometimeshave done it, we weren't spending down that cushion every one of these years, but we've reliedupon it enough that it is now gone.

Funny thing – the financial projections for both AA World Services, Inc. ("GSO") and A.A. Grapevine, Inc. suggest that our operating corporations are looking at the same kind of asituation. For those of you who don't know (and there probably are some here today), down atthe bottom of that inverted triangle, that starts at the top with the groups, and then moves downto the districts, and down to the Areas, and then down to the General Service Conference, andthen down to three corporations. The first is the General Service Board, Inc., the corporation that has overall management responsibilities for all of the support activities for our service work andfor all of our publications, Public Service Announcements and so forth. The GSB is responsiblefor carrying out our policies and moving our projects forward. And it is also responsible, overall, for our two operating corporations, AA World Services, Inc., and A.A. Grapevine, Inc. We have just under 100 employees working for those two corporations, in the General Service Office and the Grapevine Office, and most of those employees are members of the Fellowship. All three ofour corporate boards have Trustees, both Class A non-alcoholic trustees who are "friends of Bill"recruited by A.A., and Class B alcoholic trustees, selected and approved by A.A. Each yearslates of directors for all three corporations are selected (and currently approved by the GeneralService Conference). Those slates typically include non-Trustee positions, filled by long timemembers of our Fellowship who have both the A.A. service experience and the requisiteadditional experience and skills to do good jobs in those director positions. We also hireconsultants, as needed, and use outside entities for various defined tasks. We bank our money, instead of keeping it in bags in the corporate offices, for one very easy example. We use deliveryservices, both the U.S. Mail and others, to get our correspondence and our literature delivered. In all these tasks, our Boards of Directors are responsible to our Conference and our Fellowship forkeeping the operations on-task and successful. The day to day operations of our corporations arein the hands of their employees, under the direction of the General Manager of GSO, Phyllis H., and the Publisher/Executive Director of Grapevine, Amy B.For many years not every year, but a majority of years, and most all of the recent years, the contributions received from our groups and our members have not covered all of our functional service expenses. We have made up that difference, which recently amounts tomillions of dollars every year, with literature profits. So, for a very different reason, the service structure at and below the Conference has not had to rely entirely

upon the voluntary financia lparticipation – in this instance, the contributions – of the members of this Fellowship. We've gotten out of practice being self-supporting here, too, just as we have in Area 40.

The draft projections for 2013 and 2014 show deficits in all of our literature. Grapevinewas in the black in 2011 (at least from the unaudited results, which folks at Grapevine are tellingme will stand up on audit), and is projected to be in the black again in 2012, and is running ahead of projections so far. But in 2013 and 2014, the draft projections show it back in the red, for \$178,000 in 2013 and \$320,000 in 2014. AAWS, which I believe has always, since before World War II, made money, is projecting a loss of \$265,000 in 2013 and a loss of \$721,00 in 2014. When we add our other magazine, La Viña, which is published as a service piece and always loses money, our net losses for 2013 are projected at \$552,200 and for 2014 at \$1,153,100.

We are NOT on the verge of bankruptcy. We are not in danger of going under. The projections for 2013 and 2014 do not include any projected revenue from ebooks and emagazines and such. These are based on "standing" pat projections where expenses exceed revenues. These are "worst case" projections. Even with these worst case projections, we would still have better than 9 months of expenses covered with our remaining prudent reserve at the end of 2014.

We don't need to be selling pencils on street corners to keep our corporations in business. But we can be pretty sure that we are on the verge of being forced to be self-supporting through our own contributions. And we are out of practice at doing that, at the General Service level, just like at the Area 40 level. We can do it, if we step up to the plate and make larger contributions. And if we do that and are self-supporting at the General Service level, then we will no longer have to raise the prices of the Big Book to support our service expenses and keep our prudent reserve at the level we prefer. And that is a challenge, but it is also a wonderful opportunity for spiritual growth. Here in Area 40, we are once again looking at how to use our web site to make more information available faster across the Area. We already do this to provide contact info for our toll free number answering service, so they can contact volunteer members of our Fellowship, and ask them to call (or to be patched in with and then call) someone who called in looking for an A.A. contact. We have two agenda items for our PI Committee to consider: First, should we expand the use our Area 40 website with a secure repository for Bridging the Gap Temporary Contact (BTG) information from each district in Area 40? Each district would keep its own contact info current, and BTG coordinators would be able to access the information for all districts, to find contacts for folks coming out to our districts across from various facilities.

Second, should we form an ad hoc committee and look at what other kinds of secure information we can protect with passwords and make easily accessible as needed – like background material for our Assembly agenda items or Corrections Temporary Contact information? We'll see what Paula H.'s Area 40 Literature committee does with these items, in their web site oversight capacity.

We also have a new and different approach to replacing Area officers who resign or become unable to serve. Last year, we decided that any Area Officer might have to take over as Delegate if the Delegate and the Alternate were both injured in the same car crash and unavailable. We do sometimes travel together, you know! This year, an alternative proposal has a "worst case scenario" option for temporary

coverage selected through the let the Area Committee until the next Assembly, when we can all decide who should step up and serve.

We'll see what Joe H.'s Area 40 Archives committee thinks about that. Joe's committee also has to decide what to do about some inconsistencies in our current policies and procedures. We have Web Site oversight by both the Public Information Committee and the Delegate. One or the other might be better than both. We also have requirements for our secretary and our treasurer to be able to use computers (the secretary has to be able to use the GSO member database software, and the treasurer has to use electronic spreadsheets and financial software). Yet we also have, by past action, said that neither the secretary nor the treasurer has to use a computer if he or she doesn't want to. We can't have it both ways, folks.

We live in interesting times. Sometimes it's really hard for us to trust the process. The General Service Conference has a request from the General Service Board to give a "thumbs up" to the GSB developing a plan to restructure AAGV Inc. "corporate and governance structure, while retaining the Grapevine's independent voice." There are no details about this plan, except that it might "address the separate corporate existence of AAGV Inc."

At last year's 61st GSC, we adopted an Advisory Action that the A.A. GV Board, in consultation with the A.A.W.S. Board and under the guidance of the GSB Chairman, continue to investigate what efficiencies and objectives can be accomplished by combining services and sharing resources, being mindful of Concept XI, while still maintaining editorial and corporate independence. 61st GSC 2011 Final Report, p. 7 ("Grapevine"), Advisory Action No. 8. If we are going to "address the separate corporate existence of AAGV Inc.," we better be mindful of Concept XI. The by-laws of the General Service Board, The AA Service Manual (2011-2012 Ed.), "Appendix E," p. S112, state, "The General Service Board shall be guided by the spirit of the Twelve Concepts of Alcoholics Anonymous . . . ."

AAGV Inc. appears to have ended up in the black in 2011, and is projected to be in the black in 2012. Why then are we receiving this very unusual request, which comes directly to the Conference without going through a Conference Committee, and has no background material? I'll want to know what your informed group conscience says about this item. We have a Finance Committee General Service Conference agenda item to increase the maximum member contribution per year from \$3,000.00 to \$15,000.00, and raise the maximum bequest in a member's will from \$3,000.00 to \$75,000.00. The background material is, to say the least, odd and unclear, but the only real problem here may be Bill's concern that "He who pays the piper calls the tune." Two individual \$15,000.00 contributions will match or exceed the 2010 contribution of our entire Area.

We have new literature in development, and a new Hispanic PSA, with distribution, tracking and evaluation proposed that will adding up to \$40,000.00 to the production costs of that video. Do we trust the Committee process? Do we trust it enough that if the Conference Literature Committee wants to go forward on the "broad range of spiritual experience including atheists and agnostics" pamphlet, are we okay with awaiting the draft pamphlet before deciding anew whether we approve of that inclusion, when the Conference will probably get to the read the stories included? Do we trust it enough to rely

upon the Conference PI Committee if it recommends going forward with "Tengo Esperanza" distribution, tracking and evaluation?

Just in case there is something to vote on at the Conference, I really need to know how Area 40 feels about these General Service Conference agenda items and the rest of the General Service Conference Agenda items, too. My Conference Committee assignment is Treatment/Special Needs/Accessibilities. I think that this Committee, kinda like Corrections, will be similar this year to how it was last year. We really like Treatment and Corrections work! We get lots of prospects from corrections and treatment programs out there in flat land. We don't fight as much about Treatment and Corrections, cuz it's all about those prospects, and helping them find us and try us out. If only we could agree as easily upon things more removed from direct work with other alcoholics, like pamphlets, videos, finance and AAGV!

I'll be flying out to New York on Saturday, April 21, and flying back on Sunday, April 29. Sharon S., our Area Chair, has the address, and I welcome your cards and letters. Your phone calls, text messages and emails are also welcome. I am participating in the General Service Conference as your delegate, so please keep in touch! When I return, I look forward to sharing with you about what happened at the conference.

Right now I have confirmed dates to present reports on the General Service Conference to all but 3 of our 14 districts, and will be visiting with the last 3 soon. My first Conference Delegate report will be at the Spring Roundup in Kalispell, on May 5, 2012. One more thing, Area 40 – if you ever get the chance to stand for delegate, do it. If your job permits it, your family is okay with it, your sponsor approves it, and you feel in your heart that you are ready, willing and able to do it, STAND UP FOR CONSIDERATION! It will stretch you, inspire you, scare you, infuriate you and show you things about yourself and about A.A. that will sometimes lift you up and other times break your heart. This service position is almost as amazing as working with another alcoholic. If you get the chance, you really must offer to take this ride.

Thank you, Area 40, from the bottom of my heart, for this opportunity to serve. I don't have to do this service work. I get to do this service. I try always to tell you that it is an honor and a privilege to be one of your trusted servants because that is the bottom line truth here. For a guy who came to A.A. from being a homeless rummy residing in the nut house, this is pretty good work if you can get it, and you gave it to me. Thank you so much, Area 40, for my life. #### Agenda- Spring Assembly Area 40-CPC

A. Review the Area 40 CPC Chair Spring 2012 Assembly Report Committee took about an hour discussing CPC in Area 40 and the projects being launched as well as reviewing the CPC Assembly report.

#### **General Service Conference CPC**

A1. Discuss report on replacing the current AA CPC DVD with a new compilation DVD that includes existing print material.

Consensus of the committee was that it would be a convenient way to get information to professionals. We already use a DVD in the information packet sent out currently. This would eliminate the need to send all the pamphlets with it. Information is also available on-line through the aa.org website. The sense of the Area is that they are in favor of this.

#### A2. Review draft product of replacement DVD

Consensus of the committee is that the committee will review the draft copy. The cost (\$1350) seems reasonable. Keep in mind the concerns of the trustees regarding limited material and technology changes.

B Consider adding the phrase "nonalcoholics may attend as observers" to the Singleness of Purpose statement in CPC literature.

Committee was split as to whether this was a necessary change. Most of our discussion involved recognizing the audience for these pamphlets and who will be using this information. Is the information we want to relay for the professionals themselves, non-alcoholics, or possible alcoholics?

#### C. Review contents of kit and workbook

Consensus of the committee is that the changes seem appropriate and that any help or guidance is helpful. Our workbook should be up to date and accurate as well as full of ideas to spread the message of AA.

#### **General Service Conference -Trustees**

- A. Review resumes of the candidates for and slates of trustees and officers of the General Service Board of AA Inc.
- 1. West Central Regional Trustee
- 2. Western Canada Regional Trustee

Consensus of the committee is that Andrew W be the candidate selected as trustee for the West Central Region. We took some time discussing the number and role of Trustees and reviewed the election process. Nothing to be approved; the trustees will be elected at the General Service Conference.

- B. Review slate of directors of AA World Services Inc.
- C. Review slate of directors of AA Grapevine Inc.

Consensus of committee is that the conference should act appropriately in their approval of the slate of directors. We discussed the all or nothing approach for approving slates and the pros and cons of that action.

D. Review report from the trustees Nominating Committee on the impact of the Conference Disapproving a Recommended State

Consensus of the committee is that we would recommend that the committee on Trustees would look for all potential methods to follow up on this issue. We need to take special care to uncover unexpected repercussions of our actions. We need to comply with laws and protect ourselves from ourselves. Remember that it is not Trustees vs. the Conference vs. the Grapevine vs. AAWS; it is AA carrying the message to the still suffering alcoholic. We should not look for a quick fix because there was an issue with this process. We don't want the good to be the enemy of the best, and we don't want division in the branches of our leadership.

#### TreatmentFacilities/Agenda- Coby D.

Good morning my name is Colby D. and I am an Alcoholic. It is an honor and privilege to serve and report as your Area 40 Treatment Chair. It is good to see you all here; I hope since our last gathering together your lives, families and home groups have been filled with enthusiasm and His spirit of Love and Service.

Since the Fall Assembly I have been busy fielding requests for contact information to assist those leaving treatment facilities around Montana, Arizona and Idaho helping them to get in touch with A.A. in their home town. There has been a great deal of activity request for BTG coming from and to the Missoula, Butte and Helena areas. Thank you DCM's, BTG contact liaisons for taking my calls and accepting the opportunity to be of service to others. I was able to conduct a workshop regarding BTG at this past years "Attitude of Gratitude" in Helena, thank you Anne B. for making the invitation and facilitating such a great opportunity to foster communication and action to help gain a better understanding on being an effective treatment volunteer member in your local district when the calls, cards and requests come in for your service to others. This happens all too often resulting in bad or negative press that we receive when the treatment facilities get calls from former patients and

ask how the contact went and it is reported that no one contacted them. This response is all too common and continues to propagate those negative opinions surrounding our fellowship.

An action item was created and is on are Area 40 agenda for your consideration. We believe it is a step in the right direction but its final effectiveness still relies on us as individual members and trusted servants for implementation and effectiveness. The meeting was opened with introductions and delineating composition of the voting members of the committee. A brief overview of the voting process and use of "Roberts' Rules of Order" was provided by the committee chair to be observed. The committee body was informed that Terry S., delegate for Area 40 is a sitting member at the General Service Conference – Committee on Treatment /Special Needs Accessibilities.

A review of the activities concerning the Area 40 Treatment Chair was provided and discussed with the final report to be included as part of the presentation at the Assembly Floor .

#### Treatment Committee/ Special Needs/ Accessibilities - GSC

A. Discuss trustees' progress report on the review of the video Hope: Alcoholics Anonymous

Trustees reported in a letter dated 1/29/2012 that nothing in the script would limit the usefulness of the current video. It was also felt that the concerns over particular lines of script that when taken out of context might misrepresent our Traditions were fine when viewed in the context of the surrounding script. Those in attendance also concurred with the Trustees findings and recommendations.

Committee Findings/Recommendations/Discussions:

B. Discuss a suggestion to develop a pamphlet for the alcoholic with mental illness.

The committee and those in attendance expressed concern about the creation of another pamphlet. It was expressed that perhaps those concerns for the creation of another pamphlet should be viewed as a review of the current material pamphlets by members of the fellowship whom are practicing physicians or psychiatrists, psychologists whom are more qualified in this medical issue and have them review the content for effectiveness. A practitioner in attendance at our meeting indicated that the current pamphlet "The AA Member- Medications and other drugs" in content and context adequately represent and communicate that members affected by mental illness should be and are directed to obtain medical advice by a licensed professional. It was also stated that as individual members we should be reminded that those in the medical professions are indispensable and our friends, and should be sought out accordingly by individuals on a personal basis and choice. The sense of the area is that we should not develop another new pamphlet.

C. Review contents of Treatment Committee Kit and Workbook.

Contents of the treatment committee Kit and workbook were not reviewed as these revisions or proposed changes are to be reviewed by the appropriate trustee's committee and implemented and may or may not be forwarded for further review and discussion during the GSC.

Some general changes include Treatment Committee Kit (previously treatment facilities) and "Treatment Committee Workbook"; kit content lists have been updated to reflect suggested language changes.

D. Review Contents of Special Needs/Accessibilities Kit and Workbook.

Added to the kit in 2011 is the conference approved pamphlet "AA For the Alcoholic with Special Needs (P-83), currently this workbook is being printed in Spanish and French, left to the committee to determine in 2012 whether the Special Needs kit should also be printed in Spanish and French currently only in English.

No further discussion or recommendations were conducted with regard to the Treatment Committee – GSC.

#### Agenda - GSC

A. Review suggestions for the theme of the 2013 GSC.

The list of the suggested themes was distributed to the committee for review; the list included 53 theme suggestions. Those in attendance were asked to review the list and submit 3 as their choice.

There was no recommendation or consensus. Of those suggestions submitted, suggestion 24 & 30 received multiple recommendations.

B. Determine the inventory questions listed in the "Inventory Plan," which were approved by the 2011 G.S.C., that will be discussed each year for the 2013, 2014 and 2015 G.S.C.

The committee made no recommendations but to accept as presented, noting there are 44 questions for consideration for the inventory process. The General Service committee will disseminate, dertermine, and divide these questions for each of the three years for discussion. This is what we asked the committee to do. Look forward to the upcoming inventory process.

C. Consider reducing the number of presentation/discussion topics for the 2013 General Service Conference to allow scheduling for the Conference Inventory process approved by the 2011 G.S.C.

The committee only commented in light our recent experience at the Area that devoting adequate time to the inventory process is important and that consideration to limit the number of presentations should be considered so as to maximize the time necessary to explore and discuss the inventory questions thoroughly.

D. Review suggestions for presentation/discussion topic ideas for the 2013 G.S.C.

The committee was provided a list of the suggested presentation/discussion topics which totaled 69 suggested items. The Committee compiled the following list:

The committee reached no consensus of the Presentation/ Discussion items but noted that item 21 received multiple considerations.

E: Review the General Service Conference Evaluation Form.

Background material was shared with all members in attendance. The committee discussed briefly that the evaluation form is a useful tool for evaluating the overall effectiveness of any event and that useful and helpful comments are always welcomed to improve the experience or processes. The committee did notice that the form is quite lengthy, 11 pages, and suggested that may be an electronic version be made available which may help collate and capture comments more quickly.

Following the lunch recess the committee reconvened at 1:30 pm to openly discuss and develop actionable items that each on the committee could commit to improvement at their home group and district

The following helpful suggestions were discussed to improve the overall effectiveness of the BTG: can be done at all levels, (institutions, district, home group and sponsorship)

BTG volunteers should be well informed and familiar with AA, (suggested reading 'What AA Is and Is not");

BTG contact members should be introduced to facility staff and remain consistent and accountable to the process and facility. Should there be an occasion that an individual is unable to fulfill a commitment identifying and introducing the suitable replacement in advance is recommended, thereby reducing confusion, both to the facility and potential prospects.

Follow-up upon return with facility personnel from an absence.

Bring contact cards and meeting schedules to the facility on a regular basis;

Follow-up with both the contact and prospect when permissible to ensure the contact was made;

Maintain accurate and current contact information regarding contacts communicate often and make the changes when necessary;

Offer to do a presentation for staff only to familiarize them with both AA and the BTG program;

Build relations with professional providers and treatment facility staff, these go a long way in keeping us and our presence involved within the facility;

Focus your individual work on your experience with applying the 12 Steps of A.A. in your life first, then offer the pamphlets and other AA related literature to increase understanding and facilitate Q &A, build the relationship first around the importance of twelfth step work;

The meeting was opened with the Serenity Prayer, followed by discussion of the agenda. Discussion began with the General Service Conference Agenda as follows:

- A. Consider suggestion to increase the Conference Delegate fee.
- This item was submitted by a past Delegate and former Conference Finance Committee Chair from Area 26.
- The requested fee started at \$100 and had gone up at random intervals over the years, with the last increase being from \$800 to \$1,200 in 2005.
- 58 Areas sent in contributions above the minimum requested in 2011, the average additional contribution being \$2,275.

Discussion ranged from what the actual cost of the conference is (~\$5,800/delegate) to suggestions about ways to cut costs from the conference as opposed to asking for more money. A portion of group contributions goes to fund the conference (12-14%). Sending group contributions from Area to GSO seems to take away the power of the purse. It would be better to encourage groups to contribute more to GSO. The sense of the committee was unanimously opposed (5-0).

- B. Review the current \$3,000 dollar limit on annual contribution and one-time bequests.
- Request from a GSR.
- Would like the annual contribution limit raised to \$15,000 and the one-time bequest limit raised to \$75,000.

We discussed the seemingly rambling letter from the GSR which was the total of the background material provided for this item. Of great concern was the last sentence included in the letter which stated that if AA somehow ended up with too much money, we could "donate" it. It was pointed out that in 2010 the groups of Area 40 gave just under \$30,000 to GSO. It would take only 2 people

donating the suggested maximum of \$15,000 to remove the poser of the purse from Area 40. There is no limit on the amount that a group can contribute and it was suggested that the group baskets may be the most appropriate venue to make large contributions that then can be sent on to other service entities. The sense of the committee was unanimously opposed (5-0) to raising the contribution limits at this time. Comments from the floor of the assembly were that it diminishes the "Power of the Purse", it's anonymous if it's in the basket, area concensus is opposed

- C. Review proposed Self-Support Kit.
- This item is the result of a request from the Conference Finance Committee that the trustee's Finance Committee develop a draft Self-Support Kit to be brought to the 2012 Conference Finance Committee for review.

The committee had many questions regarding this kit – Who gets this kit? Registered Treasurers? By request? In GSR Kit? This will be much more expensive to mail than the smaller service piece, F-19. Was expense considered when choosing what to include? It was mentioned that AA wants to invest in educating groups about self support. Getting this Kit into the right hands will be a challenge. The sense of the committee was narrowly in favor (3-2) of production of the kit.

- D. Review draft document of self-support/financial talking points to be used by the Fellowship.
- This item is also the result of a request from the Conference Finance Committee that the trustee's Finance Committee prepare a simple document of Self-Support/Financial talking points to be used by the Fellowship, made available on GSO's website, in the GSR and DCM Packets and in the Self-Support Kit.
- The resulting list consists of 15 Talking Points and 6 Additional Thoughts/Questions.

The Committee briefly discussed the list and where it would appear. All of the items seem worthy of discussion by the fellowship. No vote was taken, but the committee had no problem with the list of Talking Points.

- E. Review information concerning General Service Office/A.A. Grapevine Financial Projections for the years 2013 and 2014.
- In 2011, both AAWS and Grapevine operated in the black; La Viña operated in the red.
- The 2012 budget projects AAWS and Grapevine to continue in the black and La Viña to continue in the red.
- Projections for 2013 and 2014 show all three entities in the red for a total of -\$552,200 in 2013 and -\$1,153,100 in 2014.
- The background stresses that these figures are basically worst case scenarios, based on very little growth and flat sales. They do not consider any sales from the recent conversions of literature and magazines to e-formats.

We discussed these figures in light of publishing on the whole (not just in AA) moving toward digital formats. While there likely always will be paper format books and magazines, we may not be able to rely on literature sales to make up the difference between group contributions and expenditures. We need to ask if we are far too dependent on literature sales. This was a review item so no sense of the committee was taken.

- F. Consider a review of continuing financial commitment to La Viña per the 2001 General Service Conference Advisory Action that "La Viña continue to be published by the A.A. Grapevine and supported by the General Services Board as a service to the Fellowship."
- La Viña has lost money since its inception in 1995 for a total of \$1,410,279 or about \$82,958/year. Peak subscriptions were 10,979 in 2007; last year they were 8,982.
- La Viña started as a five year experiment, at the end of which the Conference voted to continue it as a service to the fellowship. This was reaffirmed in 2010, and also recommended that La Viña achieve spiritual parity with the Grapevine, thus adding more costs to production.
- There is currently a GSB Ad Hoc Committee re-evaluating the commitment to continue publication.

The committee was dismayed at the losses being incurred by La Viña. It was mentioned that there is a Spanish language magazine produced in Mexico that is self supporting. Perhaps we could purchase this in here for use in Spanish language communities. Other suggestions were to put a Spanish Language story in the Grapevine as was done in the past. The sense of the committee was unanimously in favor (5-0) of discontinuing production of La Viña.

Time was allotted for the Triangle Editor, Lee T., to give his report to the committee (attached). It was decided that Lee would reduce the report to some highlights for Lori to read during the floor assembly.

#### AREA 40 NEWSLETTER CHAIR 'TRIANGLE' EDITOR'S REPORT

April 14, 2012

During the past month I have been working with as many as possible of the 14 DCM's for Area 40 to reconcile group contact information. This has also included correlating records with the New Vision and Area 40 AA Web site. Not only is it a requirement of the position to attempt to get all active groups throughout the Area 40 a copy of our newsletter, it provides another opportunity to help our Area Secretary and the DCM's to update and reconcile their District's group records. Last fall I started with an attempt to reconcile through information provided on our Web site. Without current New Vision records this was the approach I used. Our Area secretary, Linda and I sat down last fall with the updated New Vision records and began what turns out to be quite a task to get the information up to date. Without the help of each and every group, and the information collection efforts at each District level this becomes a nearly impossible task. Last fall I had three of the 14 Districts attempt to work with me on these efforts. During the past month I have had response from (as of last night) a total of five of the 14 Districts. There were two that have just received their information today because they did not participate in one of the three pre-assemblies organized during the past month. From the expense angle associated -with the Triangle these reconciliation efforts save money by not having related costs from the return of incorrect addressed newsletters. This is a bit more than the usual wrong address costs because it allows us to maintain anonymity protection. Just for the record, the cost of my efforts to attempt a one on one meeting to work the details and explain the efforts at each pre-assembly are not covered under the Area expenses. I showed up at two of these events on my own dime and to one of them in conjunction with my home District, the rest of the in-town contacts and visits were in sync my company's work schedule. I had hoped to get a greater response, and certainly am in agreement with the Area Secretary to please return these forms to me with the yellow shaded areas completed by the end of this Assembly. If you are having trouble getting all the information about the groups just try to complete as much as possible, and we will continue to work on getting this informationprogress not perfection, right!

Costs of each publication are running about \$370 to \$420. This breaks down to about two dollars per issue or \$16 per year for each group and individual. The efforts during these past six months have proved that there are quite a number of groups that could be receiving the Triangle, but they are not because of incorrect or changed group information. As GSRs rotate positions, move, or there are changes in the group a consideration for updating the Area (in particular the Triangle) should be observed. What is *your* group doing to keep Area informed? A contribution level was reached of about 8.3 percent of the potential groups in February (that was 25 groups that had offered the nominal \$10 per year). During this past month this level has

rose a few percentages because some DCMs have been contacting the groups in their Districts, updating the contact information,

and letting these groups know about this method of contributing to the Area fund in direct relation to a service that is provided: the Area 40 newsletter. What is going on in your District and home group concerning group information updates and Area contributions? What about group contributions to the Triangle, in particular? Obviously \$10 per year is a bargain.

Through past actions, and traditional fare the Triangle helps continue unity and provides some useful information concerning and throughout the State, Region, and General Service. The timeliness of these past few issues has perpetuated knowledge concerning the West Central AA Service Conference, pre-assemblies, Agenda items we are discussing this weekend, and awareness of other various upcoming events and contact information for all these levels. This ability mainly happens in the mailed edition. While there is an on line version, many efforts to protect anonymity diminish the ability of this resource to carry this information.

As part of the inventory process we started last fall there will be a time during this assembly to answer questions concerning the value of the Triangle especially as it relates to its reputation as one of the more costly services Area provides. How important is the Triangle to our Districts and groups? Is it a valuable tool providing unity throughout the Area, the West Central Region, and perhaps all of A. A.? Does it ultimately aid in our efforts to carry the message? If so, can this be accomplished with just an on-line edition?

There was a point last fall when the lack of group participation and my personal life obstacles distracted me from my primary objective: carrying the message through publication of the Triangle. For this I have editorially apologized, and would like to take this time to continue that apology to the fellowship and in particular this Area Assembly. You are the ones that trusted in me and voted me into the position. While the discussions about my ability to continue were conducted through teleconferences, emails, and telephone calls I realized that this was AA in action. Through the amazing concern and helpfulness of this panel of trusted servants I am thoroughly convinced that, one more time, my life was saved. Thanks to everyone involved, and especially my higher power I am even more committed to greater efforts towards maximum service to this position.

In reviewing the current Area financial bottom line, I don't know how we would have made it if the final issues in 2011 had been published. Certainly, this would have cut into our prudent reserve. I am sure that, along with the treasurer's request of contribution to the Area somewhere around a 75 percent increase during the upcoming months that the publication expenses for the Triangle are of paramount concern. It is in hopes that our inventory process puts us in a place to examine these costs and determine the real value of this newsletter to the fellowship.

Thank you for your continued trust and for allowing me to be a part of providing this service.

The committee then reviewed the Treasurer's report, which consisted of the highlights shown at the beginning of the assembly and the handout which detailed the budgeted vs. actual expenditures to date. Lori has filed Form 990 online with the IRS, and also the annual report with the Montana Secretary of State. Monthly financial emails are being sent to the entire Area Committee, including non-voting officers; the Triangle contains the most recent financial statement released prior to publication; and the monthly statements now appear on the Area 40 Website (thanks to Alex M.). Concern was expressed that we are behind on group contributions at a time when we need an increase of 75% over last year to meet our budget and maintain prudent reserve. There are some line item amounts in the budget which are set by past action and cannot be changed without a vote of the assembly. All are encouraged to share travel and other expenses where possible. While we strongly encourage groups to support the requested services at the Area level, we also looked at ways to reduce spending. Respectfully submitted, Lori F., Area 40 Treasurer

The committee unanimously decided to bring the following recommendation to the floor of the assembly:

"The Finance Committee recommends that starting in 2012, Area 40 send only the requested contribution for the General Service Conference delegate fee."

There was much floor discussion on this reccommendation. Some comments are:

Go home and talk to your groups, when there is a need for money, it usually is met, trust our treasurer and the state of our financial picture. Discussion ceased and the vote was called for. Motion passes with 75-For and 15-Against

Minority opinion: There wasn't a specific dollar amount, we haven't gone to our groups to discuss increase or decrease of our delegate fee, this looks like we are attacking our budget in the wrong place, we voted last fall to approve this amount, we aren't being self supporting, let's give our area a chance to show self support. After minoriity voice, reccommendation stands.

Attendees introduced themselves.

Grapevine – Area 40 Gary gave an overview of his activities; he's working hard.

#### Grapevine - GSC

A. Consider proposal of A.A. Grapevine 's Audio Strategy.

Consider making it so people will be able to record stories over the phone. Stories would be edited and put out in audio and/or print. Okay to go and sense of area is in favor

B. List of suggested GV book topics for 2013 and later

Gary read proposed list. The books are composed of stories published in the GV. Okay.

C. "Sunset" proposal for GV items

Discontinue items which "no longer seem useful." Phase out all cassettes, most CDs, some books, and selected other products. Sunseted products would be available in at least one format, so they are not really going away entirely. The committee was okay with this proposal. The sense of the area was unanimously in favor of putting to rest outdated material and that it would still have availability in one format or another.

D. Consider incorporating service responsibilities and duties of the service positions "Grapevine Representative" into the Service responsibilities and duties of the GSR.

It's hard enough as it is to perform the duties of the GSR – harder still to get them to do more work." "This item seems to go with the other one which may be aimed at merging the two corporations." "Our group doesn't have a GVR – if it is formally included in the GSR's responsibilities, it might stand a better

chance of getting done." "If we are supposed to promote the GV, how does that work with attraction rather than promotion?" "How can Area and District tell our group that we have to do this?" "What are we doing with the GV, why do we have to promote it anyway? Why this continual push of magazine sales? Is the GV for the fellowship and to carry the message or not?" "Our group doesn't want to have too many service positions given to one person – more service jobs mean more opportunities to get involved, especially for newcomers." NOT Okay.

E. Updating GV Workbook. Okay.

#### Policy/Admissions – GSC

- A. Approve request for two members from the General Service Board of India to attend the 62<sup>nd</sup> General Service Conference as observers. Good to go.
- B. Review dates of the 2015 GSC. Okay.
- C. Consider modifying procedure for the submission of Concept V minority appeals to the General Service Conference.

Place deadline at 10 days before the conference for submitting an appeal and related background materials, schedule them during the opening session, treat appeal as made and seconded motion. Conference then free to fashion an appropriate response. "There are other processes and this is for when those other processes are used and exhausted." "This just puts a process in place if needed – this rarely comes up." Okay

D. Read policy and guidelines regarding the use of personal electronic devices at the General Service Conference. It's okay.

Motion from General Serive Board to the 62<sup>nd</sup> General Service Conference

A. The General Service Conference supports the General Service Board development of a plan to restructure the current Alcoholics AnonymousGrapevine, Inc. corporate and governance structure, while retaining the Grapevine's independent editorial voice. The plan may, among other things, address the separate corporate existence of Alcoholics Anonynous Grapevine, Inc. and address as well issues of governance and operations. The plan will be designed to increase unity, better reach and connect the Grapevine to the borader Fellowship while addressing financial stability. The plan will be susbmitted to the 63<sup>rd</sup> General Service Conference for approvoal prior to implementation.

Gary read Concept XI – Bill was visionary and addressed the reasons why it would not serve the fellowship well if the GV were to be managed by GSB. Some speakers felt like this is premature. We projected loss in 2011 and then actually made a small profit. We need more information. Seems like the GV is making plans to cut items that aren't making money and they have cut expenses. The GSB must be really busy with AA business – how are they going to find the time to do the GV stuff too? Not Okay.

There was lengthy discussion on the assembly floor. The concensus is that we should decline to consider this idea, it's in direct opposition to Concept 11, it circumvented the process committee system, there is no background information and this is not an idea that will promote unity of our fellowship, this seems to be another attack on the Grapevine, the Grapevine Board with consultation continues to recttify the inefficiences within their separate corporation. This was not generated by the conference, more information, there are no bad guys here, we each love the fellowship, this is not a conspiracy, let's be open-minded and place principles before personalities. Let's keep all things transparent, sounds like the service board is operating on fear, let's use our conference inventory and put it into effectiveness, let's play together and don't over-react. We need to address problems and don't be afraid to talk about the tough issues

Carla T. read p. 231 of As Bill Sees It, which speaks to the fact that in the future, we will make mistakes. If we do, we have the ability to make corrections, too.

All decisions are unanimous. The concensus of the assembly is to not consider this proposal.

Area 40 Spring 2012 Public Information Report

C. Review the Area Webmaster Spring 2012 Assembly Report.

The Webmaster reported that he had made only minor adjustments to the functionality of the website since the last Assembly, and that the website was functioning well.

D. Consider all business pertaining to the Web site operated by Area 40

Inc.

1. Consider use of the Area 40 website as secure repository for the collection of Bridging the Gap Temporary Contact (BTG) information from each district in Area 40. Each DCM or District designee would input the temporary contact information for their District. Each DCM or designee would be responsible for maintaining and updating current information. In order for the list to be complete and functional, it is suggested that each person signing up as a BTG contact would list their full name, mailing address, city, state, zip code, sober date, gender, age range, phone number and email. However, it would be up to each person signing up on the list whether or not to use his or her full name. First nameand last initial are sufficient to make a contact. Since the website is a protected site, passwords for the functioning of editing, and viewing contact information will be restricted to the DCM, or district designee and the Area 40 web master.

After discussion with the web master and among the committee, the committee recommends that Area 40 use the Area 40 website as secure repository for the collection of Bridging the Gap Temporary Contact (BTG) information from each district in Area 40.

Bridging the Gap nees more attention that can address issues with newcomers from falling between the cracks when coming to A.A. Will this have SSL protection?, the treatment center in Helena eliminated their Bridging the Gap because it's not effective; we need to figure out how to make it function effectively, the website is a great tool, let's us it. Let's help treatment centers get ahold of us. Now we need to do our part. After floor discussion the motion passes with 87-For and 10-Against.

Minority opinion: Didn't want to see addresses on the list, there was too much information on the contact list.

There was a vote to reconsider from Terry. It was seconded. The vote to reconsider failed and motion passes as is.

2. Consider forming an ad hoc committee, including the webmaster as a member, to consider ways to place Area background material and other material, such as contact information for Bridging the Gap and Temporary Contact participants, on our Area web site in secure locations.

After discussion with the webmaster and among the committee, the committee recommends that Area 40 form an ad hoc committee, including the webmaster as a member, to consider ways to place Area background material and other material on the Area web site in secure locations that can be accessed by members.

The motion passes with 87- For and 3- Against. No minority opinion

3. Consider centralized distribution, tracking and evaluation of the proposed Hispanic video P.S.A., "Tengo Esperanza," at a cost not to exceed \$40,000, as an addition to the work of local Public Information committees.

The committee did not agree to the expense at this time.

4. Review current video P.S.A.s for relevance and usefulness.

The committee had reviewed the PSAs individually prior to Assembly and found them to be relevant.

5. Consider production of new video P.S.A.s.

The committee did not agree to the expense at this time as the current PSAs are in need of revision.

the purpose of providing information about A.A. to the public; this presence would serve as an informational resource only, with no interpersonal communication capabilities.

There was much discussion and concern about establishing a presence on Facebook. Issues such as anonymity and affiliation with advertisers were discussed. As there had been no communication with Facebook about the conditions of establishing a presence, more information needs to be forthcoming before our concerns can be addressed.. The committee referred to the "A.A. Guidelines" on the Internet.

There needs to be more exploration with Like & Join, Anonymity breaks. This is a social media site that reaches lots of people, put the PSA videos on the facebook page. The committee was not in favor of establishing a presence on Facebook at this time. The sense of the area was not in favor, also.

E. Discuss requests related to adding language referring to current media to Tradition Eleven.

The committee discussed the procedure and expense of changing a Tradition. It was thought that the procedure in "A Resolution," PP 105-106 of the AA Service Manual (2011-2012 Ed) needed to be changed to make a change in the Traditions feasible.

D. Consider removing inconsistencies in Area Secretary and Area Treasurer Guidelines and Qualifications. These inconsistencies were created as a result of the action passed at the Spring 2011 Assembly to include qualifications for Area service positions. Qualifications were accepted for these

positions which require the Area Secretary to use GSO member database software (Q11.3 In addition to the computer requirements defined in the general section this position also requires the ability to use the GSO member database software) and the Area Treasurer to use electronic spreadsheets and financial software (Q12.4 In addition to the computer requirements defined in the general section this position also requires the ability to use electronic spreadsheets and financial software), but the ad hoc committee failed to delete conflicting language in the Guidelines stating that it is not a requirement to be computer literate or to use a computer for these positions. Statements to be removed:

G11.4 ... If the Secretary does not want to use a computer, it will not be required. .... It

is not a requirement to be computer literate to hold the position of Area Secretary.

G12.4 ... If the Treasurer does not want to use a computer, it will not be required.

.... It is not a requirement to be computer literate to hold the position of Area Treasurer.

Very little discussion, committee generally favored this and felt that computer skills are important for these positions in today's world. (committee voted unanimously)

The Archives Committee Recommends deleting wording of G 11.4 "...if the Secretary does not want to use a computer, it will not be required...it is not a requirement to be computer literate to hold the position of Area Secretary." And G 12.4 ""...if the Treasurer does not want to use a computer, it will not be required...it is not a requirement to be computer literate to hold the position of Area Treasurer."

We cannot, nor should we, turn back the clock." And so, while A.A.'s message of hope and recovery never wavers, just how that message is delivered continues to evolve in today's digital world.

Revised AA and Medications pamphlet out, New Special Needs pamphlet is out. I have the new special needs workbook on display.

# **Literature 2012 Spring Assembly**

All committee members were present. Jim B DR 51, Joe L DR 42, Bob T DR 61, Jay T DCM 93. Thank you Jeff from Missoula for taking notes for the Literature committee and Susan from Billings for attending our committee break out.

A. Review the Area 40 Literature Chair Spring 2012 Assembly Report. Committee reviewed and made changes to add ebooks to the report.

#### Literature - GSC

A. Discuss progress report from the trustees' Committee on Literature on the development of literature which focuses on spirituality that includes stories form atheists and agnostics who are sober in Alcoholics Anonymous.

The committee reviewed and discussed the progress report.

200 stories were read by the subcommittee appointed by the Chair of 'the trustees' Committee on Literature. It was agreed that 46 stories would be re-read out the 200 and the subcommittee would try to indicate what they perceived the authors "spiritual orientation." Final reading resulted in 23 stories that met the general criteria.

23 unedited stories and draft introduction will be sent to the 2012 Conference Committee on Literature. This is not to be considered a draft pamphlet.

B. Consider the draft of the revised "A.A. and the Armed Services" pamphlet.

The draft pamphlet is not available to the committee at the Area level. There was a new subtitle submitted by a retired Marine Sgt Major: "None Left Behind" instead of "We don't leave anybody behind" that will be considered at the 2012 Conference.

Our committee discussed and all agreed with the new subtitle consideration.

C. Consider the final draft of the revised Living Sober booklet.

The draft is not available to the committee at the Area level.

D. Discuss a suggestion for revision of the pamphlet "Circle of Love and Service.

Our Committee discussed and reviewed pamphlet and all agree that a revision is warranted to the pamphlet. Some changes noted:

- -There is an asterisk to nowhere.
- -Reference to page 5, to what?
- -Take out or change Good GSR and Good DCM to Active GSR and Active DCM.
- -change www. Alcoholics-anonymous.org to www.aa,org to reflect current address.
- -update entire design to current pamphlets.

It was noted by our committee that everything in the pamphlet can be found in the service manual. What is the demand for this pamphlet?

E. Discuss a request to add text from the dust jacket of the Third Edition of the Big Book, Alcoholics Anonymous, to the dust jacket of the Fourth Edition of the Big Book.

The committee thoughtfully discussed and concluded that this was not necessary. We did not feel that many people take notice of the dust jacket anyway and did not find the change in the Fourth Edition negative. All opposed.

F. Consider a request to add the A.A. Preamble to the front inside pages of the Big Book, Alcoholics Anonymous.

We also had this agenda item at the Spring and Fall 2011 Assembly. It had gone before the 61st General Service Conference and did not receive 2/3 majority vote. The vote was 65 for/ 66 against. Area 29, Maryland feels the vote too close and should be re-considered:

-there would be no additional cost to the Big Book per publications department at GSO

- -the Big Book is often the first literature a new comer reads and the Preamble state who and what we are.
- -it would keep the AA preamble the way it was written and presented in the Grapevine 1947
- -it would provide everything to conduct a meeting.
- -may be the only piece of literature available to someone.

Area 43, New Hampshire stated that now that the Traditions and Concepts are included in appendices that the Big Book has become closer to a complete manual for AA.

The committee considered and discussed this at length. Our committee was split 2 for / 3 opposed. Those opposed stated that it is in a lot of other literature and already in the Big Book, the Forward to the First Addition. One committee member could go either way

G. Consider a request to add the short form of the Twelve Concepts for World Service to As Bill Sees It. From Area 71, District 9

Bill W. references the concepts in the introduction of As Bill Sees it and refers to them on 13 pages within the book. They believe because the 12 Steps and the 12 Traditions are in the back of the book, that would be the logical place for the 12 Concepts. Then all three of our legacies would be there.

The committee considered and thoughtfully discussed this agenda item. We were split 2 for / 3 opposed.

Comments: one of the opposed members of the committee was that because the concepts are mentioned in ABSI that maybe it would prompt people to look at other literature to research the concepts. One member wanted to consider stopping the agenda item. When were the steps and traditions put in? How many copies are still available before new printing

#### Corrections/Intn'l-Regional Forums-Terry H.

Hi, My name is TerryH., and I am an alcoholic. Gratefully serving as your Area 40 Corrections Chair.

Thank you to my Standing committee, the district corrections chairs and other interested parties who attended our Corrections Committee meeting. I really appreciated everyone's lively participation.

Our first order of business was to review the Spring Assembly Corrections Report.

There are no AA meetings being held in MSP. There have been no meetings for almost 10 months. MSP requires an administrative sponsor and the CD counselor who sponsored AA resigned and has not been replaced. It has been a painfully slow process to get back in and to make contact with the new Warden. Many of us are very frustrated and both Lee G and I are getting your phone calls and agree that it is taking too long! Lee G. along with his sponsor, Tom. I. have been using what is called the Four step process for setting up or re-establishing meetings. So far there has been no response from the new

Warden. Our next communication will be much more direct. We want to be able to have a meeting with the Warden. What we are hoping for is more access, more meetings and less red tape. At the Women's Prison you have to go through orientation and once approved your name goes on a list. It doesn't matter who shows up to bring the meeting as long as they are on the approved list. There is no administrative sponsor and it works fine.

Next was the pink Can report and I appreciate the suggestion or directive to be referring facilities back to the district Corrections Chair or DCM to request literature from the Pink Can since that was Last Fall Assembly's decision. AA members are still referring Correctional or Treatment Centers to contact me for literature.

There are copies of the Pink Can Fund financial report back by the coffee.

We started the year with \$3355.45. We have had contributions of \$191.57. We have distributed \$845.60 worth of literature this year. Our current balance is \$2645.42

# <u>Under International Conventions/Regional Forums-Area 40</u>

A. We reviewed the 2012 WCRAASC Committee Spring Assembly Report.

## Corrections-GSC

A. We considered the revisions being made to the the pamphlet "It sure beats sitting In a Cell".

We did not have a copy of the revised draft to review. It was the sense of the committee that the pamphlet is very outdated and should be revised.

B. We considered the revisions to the pamphlet "A message to Corrections Professionals".

It was the sense of the committee that these revisions should be made to this pamphlet.

C. We considered the possible remake of the 1987 video "It sure beats sitting in a Cell.

It was the sense of the committee that a remake of the video is not a prudent use of AA's \$ or time. There are 998 members serving as committee chairs and 1534 active AA groups in correctional facilities. There were only 188 of these videos distributed in 2011 and about 1000 in the last 10 years. That is distribution, not even utilization. The cost involved would be \$60,000-\$75,000.

D. The contents of the Corrections kit and workbook were reviewed.

A. We discussed ways to encourage interest in Regional Forum.

This is still progress from the way information was given to Delegate's in the past!

2. How do you deal with having a vital committee chair vacant for several months, then it is filled by someone who is resistant to support and chooses to pursue activities outside the scope of his/her position rather than the work in the position description.

DCM shares his own experience and explain the guidelines

DCM shares his experience and advocates one-on-one human contact. Person made amends and indicated she would change her behavior but resigned two months later.

Be open and honest with people

Our biggest responsibility is electing trusted servants and picking the best possible to serve

Better election process, have people know them.

Past-DCM shares his experience and so sometimes it just works itself out. As DCM you can just tell them what needs to be done and be a source of guidance. Sometimes even when it looks bleakest it might mean it gets better soon!

3. How are the relationships in Districts with Intergroups and do they play nice with one another?

Past-DCM shares that Intergroup used to come to his meetings and they had a good relationship.

DCM shares that they have a good relationship with Intergroup, they share a meeting space and the Intergroup Chair comes to most District meetings. They have good communication with one another.

DCM shares that he didn't feel welcome as a DCM at the Intergroup meetings in his District. But, they have improved their relationship, have established communication, have an Intergroup Rep who attends the District meetings, and they are coordinating on the schedule upkeep.

Cooperation has increased to the point that it is hard for him to believe their relationship was ever negative!

Even though they may not be a "large, metropolitan area" Intergroup definitely provides a service in his District.

Alt-DCM indicates he was met with hostility when he would do group visits but when he showed them how he was trying to report accurate information and establish a relationship he was met with cooperation.

4. What is the hierarchy of leadership in your District? Does Alt DCM always become DCM?

DCM- "No". You never know what may happen.

District 61 Alt-DCM automatically becomes DCM.

One District saw the DCM become the Alt to help positions and support.

District 12—"I don't think we've ever had an alternate"!

This was the same for another DCM.

Alt-DCM has suggested having Alt-DCM rotate into DCM in her district because it provides good training for a big position.

DCM advocates for training and grooming of new leaders.

The pamphlet "The AA Group" speaks to rotation—not circulation. It brings fresh blood and fresh ideas.

Send newly elected GSR/DCM to Area rather than just throwing them in to their first Assembly.

Practice, study and ask people with experience for help

GSR School, DCM School and Mock Assemblies

5. Which Districts have voting members that are GSRs—and which Districts have GSRs and Committee Chairs as voting members?

Just GSRs: 2

**GSRs and Committee Chairs: 7** 

Anybody Who Shows Up: 1

DCM-They have GSRs vote only. Saw a big dip in attendance, considered allowing Chairs to vote = hot button issue and shot down. But—attendance was up!

Contention = Attendance!

Discussion versus Vote: The vote you only have one. But, with discussion you can collect votes if people agree with your point-of-view.

Voting to reconsider and allowing the minority opinion to speak is helpful.

6. We have a chair person in our district who introduces himself as an addict. I see this as a problem when he identifies himself as an addict when representing AA at institutions. What should I do?

DCM-We've discussed this and determined it in contrast of our Traditions.

This DCM advocates asking him if he is an alcoholic.

Past-DCM- Love and tolerance is our code.

Also, 30-40 days ago they didn't know what they were. A treatment center gave them a label and they identify with that.

We can ask them off to the side what they identify as and have that discussion in private.

This isn't Feelings Anonymous—have the discussion.

As far as he can tell our literature doesn't say we must identify ourselves as alcoholics.

Have the discussion with the effort of not annihilating anyone.

Addict versus alcoholic versus over-eater

Find out the difference and pursue

Telling your district you have an addict chair person might increase attendance! (joking comment)

The Doctor's Opinion: "he was working this man and trying to fix his alcoholic addiction".

It's up to us not to abuse anyone at anytime.

They can die—we can direct them to where they need to be.

Is saying alcoholic/addict in a meeting a violation of 12th Tradition because it creates dis-unity?

Not every place, especially in rural areas, have meetings beyond AA: NA, etc.

Totally agrees alcohol is primary focus but in rural MT there may not be other choices.

Kids are using everything these days.

Guy takes meetings into the jail and doesn't care who shares about what because that's there only place for help.

Past-Delegate: One of the toughest things he had to do was talk to groups about adhering to the Traditions when they may be doing other stuff.

Just talk to them—share the importance of the Traditions. Cannot force anyone to do anything. This is a part of our job duties.

Focus on the steps and recovery elements.

If you don't have NA—addicts can start it.

I truly consider myself blessed to be counted among you.

Since my last report, I negotiated my way through a busy fall in Helena, which led to a much quieter winter. However, spring "service season" is now upon us and things, as they always do, will again pick up.

Last fall, Area 40 hosted the 15th National AA Archives Workshop, in Helena. I have a separate report on this event which I will give later. For now, however, I feel it important to mention two additions to the Area 40 Archives that came as a result of this event. Vicky B., a past delegate from Arizona, presented me with a picture of Past Area 40, Panel 14 Delegate, Judy M. sitting with Bill Wilson at the 1965 General Service Conference. <u>2012 Spring NAAAW Report</u>- The 15th National AA Archives Workshop was held in Helena, September 22nd through the 25th, 2011. In all regards but one, the event was a smashing success, and those who attended thoroughly enjoyed themselves. Several of the long-time participants remarked to me personally that it was one of the best they had ever attended.

Topics ranged from practical to the historical and everything in between, with a blend of presenters that included GSO Archivist Michelle Mirza, Stepping Stones Director Annah Perch, AA historians and Archivists from around the nation, along with a few of our home-grown Fellowship who capably proved that we could hang with the rest of them. One of the presenters, past West Central Region Trustee, Carl B. remarked to me on a few occasions how pleased he was with the turnout and with how well the entire region was being represented to the rest of the AA's from around the country.

Attendance ended up at 144, with 84 of those being travelers from out-of-state, leaving in-state participation at 60. As promised, the visitors came from every corner of the U.S. as well as a few from Canada. While we had hoped for more participation from the Area 40 Fellowship, those who came did a tremendous job of welcoming our visitors. We were able to pass on \$1,000.00 to the 16th NAAAW in Cocoa Beach this fall. This was \$500.00 less than what was passed on to us from Macon, Georgia. The Florida contingent was quite content to accept it however, and they assured us that their Area had already presented them with a significant amount of seed money for their event, and all was well.

During the event, I'm proud to announce, our Area Webmaster Alex M. was voted in as the official NAAAW Webmaster, and is currently involved in helping them develop a website they've always dreamed about. Congratulations Alex! And thank you again for all your hard work on our event.
