Area 40 Statewide Hotline # 1-888-607-2000 Overview and Guide Presented at the 56th Annual Attitude of Gratitude November 13th, 2010

History;

- At the fall 2006 Area 40 Assembly the Public Information Committee made a recommendation that an ad-hoc committee be created to look into the feasibility of Area 40 creating a statewide toll free Hotline and they would report back for consideration at the 2007 Spring Assembly. This recommendation passed.
- At the Spring Area Assembly the Public Information Committee made the following recommendation:
 - Implement as soon as possible an Area 40 800 number, utilizing the services and contract from Answernet, Contract to be a month to month agreement, with a maximum, possible expenditure of \$1,000.00 per month to Area 40. The Area 40 Public Information Chair will make reports regarding utilization and expense at each Area Assembly.
- Discussion was held.
- Vote was taken and the recommendation passed 96 for with 7 opposed. A minority opinion stating that "calling for the question" happened when there were still people wanting to comment. This stopped discussion. A voting member for the recommendation got up and requested a reconsideration of the vote. A vote on whether to reconsider was taken and it failed with 23 for reconsideration and 70 opposing reconsideration.
- Motion to implement the 800# passed.
- At the Spring 2010 Area Assembly the Public Information Committee made the following recommendation:
 - The Area 40 PI chair will forward the itemized bill received from AnswerNet to the Area 40 treasurer for payment up to the amount of \$250.00 a month. In the event the monthly itemized total amount is over \$250.00 the Area 40 PI chair will bill each district on a prorated basis. (Example: If the total bill is \$300.00 and district 11 has 30% of the billable calls that month they would owe \$15.00, (\$300 \$250.00) * .3 = \$15.00).
- This was discussed by the full assembly, voted on and passed.

Note: The question was asked by the Area Treasure in November of 2010 if this amount includes the base rate that Area already was paying and it does not.

How the system works;

- Districts that are using the system are electing an Answering Service Chair. The main responsibilities of this positions are;
 - Coordinate the gathering of AA contacts in the district. I will explain how one might go about this further down.
 - o Enter the contacts into the online AA site and keep the list current.
 - Act as the contact to receive the monthly bill for your district in the event the amount of the itemized calls goes above the \$250.00 amount and your districts gets billed for its' prorated portion of it and make sure your districts portion is sent to AnswerNet for payment.
 - Act as the liaison to the AA contacts in your district, AnswerNet and the Area PI chair.
 - Any other duties that the district deems necessary to help this tool carry the message in your district and throughout Area 40.
- · To get copies of the signup sheet;
 - Go to www.aa-montana.org
 - o Click on area business, (upper left of screen)
 - Click on Articles and Documents
 - Scroll down to Other Documents
 - Select Hotline Signup Sheet and print it
- Pass these sheets out to GSR's to have them collect AA Answering service contacts from the
 groups. Once they are returned to the Answering Service chair you are ready to enter the
 names and numbers into the system. Contact our Area 40 Webmaster Alex M. alexmar@mt.net
 to get your login ID and password. Once you have them go to

http://www.aamontana.org/800/login.asp. You will be presented with the following screen.




- When you successfully enter your Username and password that you received from the Area 40
 webmaster you will be presented with a screen that allows you enter the information you have
 gathered from the paper signup sheets and update any information for your district.
- Now when someone calls the Answering Service the information will be available to the Answering Service. See the main contact screen below of what the Answering Service sees to locate an AA contact;



 The Answering Service asks the caller what city they are looking for an AA contact from. The service then selects from the list of available cities. If a city is not listed because there are currently no contacts available, they use the map presented to locate the closest city that does have contacts and select it. The Answering Service is presented a random list of names from the city they selected and they
select males for male callers and females for female callers and they begin calling until they can
successfully connect the caller through to an AA member.



 Maps are also available via the website if the caller or AA member needs directions to pick up the caller to take them to a meeting.



Costs

- Area is charge a base monthly rate of \$55.00 for the service.
- Area also pays \$1020.00 a year to be listed in the Dex yellow pages and for the current Co-Op phone books we are listed in \$636.00 a year for a total yearly cost of \$1656.00.
- We also get charged .50 cents per minute for calls that are patched through. Area pays up to \$250.00 a month for these itemized calls, (Calls for just meeting information are not billed to this amount). Any amount over the \$250.00 monthly total is billed to the districts on a prorated basis. (Example: If the total bill is \$300.00 and district 11 has 30% of the billable calls that month they would owe \$15.00, ((\$300 \$250.00) * .3 = \$15.00).

Note: Many districts have written procedures that ask for the caller's number once they are connected so they can call the caller back and minimize the amount of this charge. It should also be noted that to cover the additional cost of the Hotline to Area, groups are encouraged to increase their contributions to Area.

How is the system working?

- There were some growing pains when the system first came up with billing and contact information but these have been worked out. District 91 went so far as to report at the Fall Assembly of 2009 that the Answering Service is no longer the "Hot topic" at their district meetings anymore.
- There were concerns that we were not listed in phonebooks and we are now in the yellow pages of 10 Dex directories and 9 Co-Op directories.
- District 61, as of November 2010, is still using a Qwest local number so their old number can be published in the white pages and they have calls received forwarded to the 1-888-607-2000 number. In the timeframe, October 2009 - November 2010, there were 1084 calls forwarded to the Area Hotline from District 61's local number.

Additional benefits;

- Lower Costs to districts for their Hotlines, (District 61 has reported their monthly fees were more than cut in half and District 51 reported they were able to go to the WCRSC in Casper WY due to the cost savings from it).
- A much larger availability of contacts, (As of April of 2010 we had 508 contacts from 10 Districts).
- A more automated approach is available so it is easier to keep information current.

What the Area Hotline System is not

One point that has caused some districts, and individuals, concerns is the per minute charge that is incurred when a call is received by someone wanting to talk to a member of Alcoholic Anonymous. To avoid excessive billing, as was mentioned in the Costs section, it has been suggested that if the caller needs or wants to speak at length that you get their phone number and call them back to avoid the per minute charge. The concern arises in that the person who called may not be willing to do this.

In response to these concerns if needs to be noted that the Hotline number was not intended to be a crisis line or a suicide prevention line. District 11 has went so far as to state in their Hotline guidelines that if you think the caller is in trouble, i.e. DT's convulsions, are threatening suicide or threatening to harm themselves or some else that you should call 911. We on a whole as members of Alcoholics Anonymous are not trained nor qualified to handle calls such as these. As for the case that someone wants to talk at length and is unwilling to give out their number or meet you in person along with another member of AA I would defer to page 96 in the Big Book "We find it a waste of time to keep chasing a man who cannot or will not work with you. If you leave such a person alone, he may soon become convinced that he cannot recover by himself. To spend too much time on any one situation is to deny some other alcoholic an opportunity to live and be happy.", and as anyone who has attended an AA business meeting will tell you there are multiple other worthwhile places where our financial contributions can be directed to help the still suffering Alcoholic who is reaching out for help.

- It is a prudent use of your District's funds to make the initial call as short as possible (to avoid the .50 cents per minute charges) by asking the caller for their name and number so you may call them back directly. *
- Before returning the call, you can dial *67 to prevent your number from appearing on their caller ID.
- 3. Call them back immediately.
- 4. Ask for and talk only to the person that called (avoid breaking their anonymity).
- 5. Give your first name only and state you are a member of Alcoholics Anonymous.
- 6. Identify the needs of the caller (AA information, ride to a meeting, etc...).
- 7. Determine the willingness of the person to do something about their condition.
- 8. Suggest taking action today, i.e. arrange to take them to a meeting today.
- It is recommended that you do not give out your phone number until the person gets to a meeting. If you are willing, leave your number and encourage them to call. DO NOT GIVE OUT ANYONE ELSE'S NUMBER.

10. You may face different circumstances:

- a. If they want to go to a meeting, offer to meet them or offer a ride; whichever you chose. Be sure to bring someone else along if you are offering a ride.
- Be patient, kind, compassionate and LISTEN. SHARE freely of your experience, especially your feelings of loneliness, hopelessness, and confusion before coming to AA.
- c. Explain the three-fold aspect of the disease (physical, mental and spiritual), stressing that it is progressive and fatal. Discuss what AA has to offer for their recovery, SHARE your EXPERIENCE, STRENGTH and HOPE.
- d. If they are too drunk to talk, offer to call them later or ask them to call when they are sober and able to communicate.
- e. If you think they are in trouble, i.e, DT's, convulsions, are threatening suicide or threatening to harm themselves or someone else, call 911. Don't Panic.
- If they want another Twelve Step Program, refer to them to that resource directly if you are able.
- g. If the person is a relative or friend of an alcoholic, suggest they contact Al-Anon. *
- h. If the caller wants speakers for schools, clubs, etc.., request their contact information to provide for the Hotline Liaison. The Liaison has the numbers to reach the Cooperation with the Professional Community and Public Information Chair (CPC/PI). Let them know that someone will be in touch with them shortly. Call the Liaison immediately to make this request.
- If you cannot handle a call, let them know someone else will be contacting them. Then call your sponsor or an AA friend for help.
- j. If the caller is from another area or district, talk to them, and if necessary refer them to local meetings or answering services in their area or back to the answering service who may have those resources.

LEADERSHIP - FALL ASSEMBLY PRESENTATION 2014

Look at Bill W.'s "Leadership in A.A.: Ever a Vital Need," published in the *Grapevine* in 1959 and incorporated into both Chapter Six, "The Delegate" in the A.A. Service Manual and in the Concept IX essay, both in *A.A. Service Manual Combined with Twelve Concepts for World Service*. In A.A., leading is by example, by participation. It's not "talking the talk," it's "walking the walk."

I've had opportunities to serve in A.A.'s general service structure at various levels. My experience with leadership in formal service work seems to me to follow a natural progression that I'm going to share with you in five simple phrases, five actions in service.

The first phrase is often heard at regular A.A. meetings, because recovery begins with this action. I want to suggest that unity, and service, and leadership (in all three of our legacies) all begin with this action.

1. SUIT UP!

"Suit up" can refer to the whole ball of wax, "participation," but it also can refer to very first aspect of participation – preparation. "Suit up" means getting dressed appropriately for where I am going and what I am going to do. In the military it meant more than just get into uniform, it referred to all the things we carried – all the gear we might need. When stepping onto the runner of a chopper and climbing aboard, it is recommended that I wear and carry everything that I might need – that we all wear and carry everything that any of us might need.

"Suit up" applies at work, at play and in A.A. "Suit up" is to do the ground work necessary for participation. "Suit up" is doing the preparation necessary to participate fully in the mission, in the Assembly, in the picnic – in whatever it might be.

We had opportunities to do that before this Assembly. We had chances to get copies of the agenda and read them. We had chances to digest the background material and talk it over with our home groups, sponsors, sponsees, service friends and mentors. We had chances to do some independent reading and research. In A.A., before we make any decisions and take any action, it is always a good idea to consult widely. To get ready is to "suit up."

In A.A. suiting up also can include prayer at the beginning of the ground work and prayer throughout doing the ground work. It can include reading Bill's leadership essay again, for a reminder to listen carefully to those who disagree with me and truly consider what they are saying before responding. Suiting up can also include inventory and consultation with others about some of my first reactions to stuff AND suit up should include that last minute note to myself to LEAVE OUT the snarky insults that would fit so well into my comments.

That's my snapshot of suiting up – coming out of my experience. Your view will be slightly different, because it comes out of your experience. But our experience includes what others have shared with us, so your experience and mine will have some elements in common. Once we have "suited up," it is time for us to take the next service action.

2. SHOW UP!

A.A. depends upon OUR participation. One alcoholic sharing with another is at the heart of A.A. – in sponsorship and all of our A.A. meetings: on or off our A.A. schedules, in business or group conscience meetings all over the inverted pyramid, in workshops and roundups and other celebrations or gatherings, large or small. To be a part of any of it or all of it requires that we "show up." To "show up" without "suiting up" makes it harder to get anything done. We have to keep inventing the wheel over and over again.

But all the prep in the world doesn't matter if I'm not at the meeting. I can't contribute to the group conscience by telepathy or mind control. I have to "show up." It's difficult to be part of the "we" this weekend, by an out of body experience. We have far more sophisticated ways to participate than we have ever had before, but, one way or another, you just gotta "show up."

I know I am preaching to the choir on this one, because you're all here. However much prep you have been willing and able to do, you have taken the trouble to be here for this assembly. And since we are here, our leaders are us, are here -- "suiting up" and "showing up."

Who will grapple with the questions arising this weekend? We will. Who will elect our next rotation of trusted servants this weekend? We will. Who will be building an informed group conscience on Agenda items? We will. Who sees the new ideas – approaches – concerns that appear here? We do.

WE DO - THE ONES THAT "SHOW UP."

All the folks who provided us with input before we got here have shared this Area 40 process of assemblage. All the folks who find out from us afterwards what happened here and provide feedback will have shared this Area 40 process of assemblage. But the decision-making happens here and the feedback comes out of what happens here at the assemblage.

And often – not always, often – there are very little drama and very little conflict. One of the ways I notice service leadership in action is in how our leaders respond to questions, comments or even attacks.

"That's a good question."

"I'm glad you brought that up."

"Valid point."

"Thanks for sharing."

"Showing up" also can mean that we do remember and do affirm, here at this Assembly or at any other service gathering, that A.A. is inclusive. Every participant brings to the table their own experience, their own recovery, their own troubles and shortcomings and their own concerns about the best action to take on the current item, consistent with offering A.A. recovery to the still suffering alcoholic. We need to welcome everyone who does "show up."

Even very prideful or angry people can be absolutely right while the peaceful and loving voice can be totally wrong. I need to listen to the message instead of judging the messenger. Even when I feel like the messenger is judging me. Even at the end of a long day and evening, and especially when I am restless, irritable and discontent!

I need to remember to ask my Higher Power, "Keep my mind open about the item we are considering. Save me from becoming angry or afraid. Help me recognize that this, too, is a sick person. Let me be of service. AND help me be willing to take another fresh look, in light of what I hear next, at this issue we are discussing." Now it's time. I've come here, and as ready as I can be. Now what?

3. SPEAK UP!

When something is being discussed and there is a question that nags at me, a suggestion about what else needs to be covered, an idea a simpler way to address the matter, and nobody else has said it at the mike. That's when it is up to you and up to me to get up and go over to Mr. Microphone, who is our friend, and "speak up."

We've "suited up" and we've "shown up." That unsuspected inner resource which we presently identify with our own conceptions of a Power greater than ourselves is ready to help us grasp what direction our deliberation is going, and what else could be important to know in making the decision. None of that can be of any use to the group conscience unless we, each and every one of us, musters our courage and takes part – participates – "speaks up."

Maybe I'm afraid I won't say it right and you'll misunderstand or dislike me. Maybe I'm worried about how many times I've already been to the mike. Maybe I'm hesitant to say something that disagrees with most of the voices so far. Those are the times when I need to "speak up" and share anyway! A group conscience needs all the voices, not just the brave ones, the loud ones, the really good talking ones, or the respected ones. We need all the voices.

We don't know yet what voices will manifest the will of our Higher Power on the agenda items and elections here. Our group conscience will be shaped by our sharing during this Assembly. Our leaders "speak up." The voices don't have to come from the front table. The voices often come from the floor of the Assembly. But we will only hear the voices of those who "speak up."

And don't wait, holding back your killer argument for the minority report. Share it NOW, so we can have all the information available for the initial decision. This isn't about winning, it's about reaching a group consensus, a group conscience. Our traditions are very, very clear – in our group conscience we can find the will of a loving God expressed. Our leaders, our trusted servants, help us get there, but it is in the group conscience that we can find it. So, after we "suit up" and after we "show up," participation in the group conscience occurs when we "speak up." We need that participation. We need to "speak up."

So now we're done, right? Not quite. My next suggestion is truly appropriate for an election assembly. When the time comes for folks to offer to serve in a position, for our Area Chair to form an ad hoc committee, or when some other project we have approved needs volunteers, it's time for another leadership action.

4. STEP UP.

Let's not be sitting and thinking, "It would really be good for Judy or Joe or somebody else to serve in that position, they would grow so much." We have done the prep, and we have come to the gathering and participated in the decision. I want to suggest that we also have some obligation to "step up" and offer to serve in implementing the decision. Let's not let somebody else do it for us, whether it's a new person who is still figuring out what is happening, or it's one of the usual suspects ready and willing to take on yet another service job. "Step up."

Be a part of the action on the item, as well as part of the decision making about the item. Participate. Bill said it clearly: "True leadership, we find, depends upon able example" [Twelve Steps and Twelve Traditions, Step Twelve, p. 124, stopping before "and not upon vain displays of power or glory"] If you have the experience for the job, if you have the time for the job, if you haven't already done the job and haven't already gotten a job for next rotation, say a quick prayer for the willingness and then "step up" and ask for the chance to do the job. Lead by example, by action. If you are not sure, talk to one of the old hands about what is involved and find out. Do not wait to be asked, "step up." It is an experience that you really should not miss, believe it or not. A.A. can save your life, and A.A. service can change that new life for the better!

5.

So that must be it, huh? Go back to No. 1 and start over again next time? Not quite. It's true that chances to be of service, in recovery, in the Fellowship, and in the outside world, never really end. But formal general service work does eventually end. And when it does, the person who is rotating on has two choices, as Bill so bluntly described them. Elder statesman or bleeding deacon. Bill describes what motivates bleeding deacons in one point in: "We have seen that we were prodded by unreasonable fears or anxieties into making a life business of winning . . . what we thought was leadership." [Twelve Steps and Twelve Traditions, Step Twelve, p. 123, omitting "fame, money, and".]

You know, most of us have done enough bleeding over the years so that we might be willing to sit back and wait to see what happens. We might be able truly to rotate, to let others take their turn at leading. Bill underscored the virtues of rotation – "And we need not depend overmuch on inspired leaders. Because our active leadership of service can be truly rotating, we enjoy a kind of democracy rarely possible elsewhere." [*The Language of the Heart*, p. 78]

It was my pleasure and my privilege to serve a rotation as an Area 40 delegate. It really did change my life, and I wouldn't have missed it for the world. I've heard that other Areas have trouble with a lack of past delegates, and those Areas try various ways to keep their past delegates involved. In Area 40, we are blessed with trusted servants who are now continuing in the formal service structure below the Conference level, down in the deeps of the inverted pyramid, one as a Regional Trustee and another as a Non-Trustee Director.

We also have a former Area 40 member of our Fellowship who now works at GSO. Closer to home, we have a past delegate serving as our Area Archivist. We invite two past delegates to each and every assembly,

and as far as I've seen, we always have two who are willing to come here and to participate. Clearly, in Area 40, not everyone who rotates on from delegate is rotating away from general service.

But there comes a time, or perhaps several times for some of us, when we do rotate away from general service, at whatever level we have been doing it. When that time comes, there is a final leadership task we face, as we step down and open up service positions for new trusted servants. It is really pretty simple. My last suggestion, No. 5? SHUT UP. It's time for other voices. If you need my experience, strength and hope, you will let me know. For now, though, thanks for your kind attention, and thanks for the gifts of sobriety. If there's time now for sharing – questions and comments – I look forward to hearing them. It's my time to "shut up."

AREA CHAIR/ALT DELEGATE GERRY R POST REPORT

I would like to express my most sincere gratitude to the outgoing committee for two years of dedicated service. It has been a joy and a blessing to work with each of you. My gratitude also extends to all who guided me along my service path throughout these many years.

As we move forward, I encourage you all to step up and support our new slate of trusted servants. They each face the daunting task of quickly learning a new position while stepping forward as a leader, often in an area in which they have little practical experience. Please take to heart the lesson that we learned over the course of this last Assembly – We can do together what we could not do separately.

Perhaps the best lesson that I have learned in my time with you all is, that the point of service is not to win a position, it is to be helpful, and to grow in recovery as we serve. I wish you all many, many opportunities to serve and a world of growth. God Bless.

SECRETARY REPORT MARY M

DCM's: I need your attendance sheets that are on your tables back to me no later than noon today and preferably by the first break. I use the count from these sheets to determine a quorum for voting purposes. Voting members are DCM's or their alternate, GSR's or their alternate, and most Area Committee Chairs and Officers. Also please have visitors sign in from your district.

I have placed ballot slips on all the tables to be used for elections for the next rotation. And I have placed Fellowship New Vision print outs of the active groups on your tables. We made the reminder to the assembly that this presentation is still available.

Finance – GSC

A. Review the results of all Finance committee items considered, reviewed, and discussed at the 2014 GSC.

A. Review suggested area contribution for delegate expense for the Conference.

The Area 40 Finance Committee felt that the \$1600 amount seems adequate and that we agree to pay that fee. We also discussed that groups and individual should fund GSO completely so we wouldn't have to rely on the Areas to help fund their delegate. This fee can help remove barriers to delegate going to GSC from Areas that can't fund. We also discussed the cost comparison of having the conference in Rye/Westchester vs Manhattan/NYC. It would interest us to see if moving all of the equipment and staff to Rye is truly cost efficient. (Area 40 Spring Assembly 2014 GSC Finance Agenda)

The committee reviewed the suggested area contribution for delegate expense for the Conference and after a lengthy discussion felt an increase was not necessary at this time.

(Additional Considerations page 64, 64th GSC Final Report)

B. Review Self-Support Packet.

The Area 40 Finance Committee reviewed the Self-Support packet. This included its contents and the planned change to the printing on the Self-Support Green card. This change would add "Gratitude expressed through contributions reaches the still-suffering alcoholic" to the next print batch which is scheduled. (Not a voting item) We also discussed some of the items in the packet and felt it was important to mention that the pie charts in the Self-Support Where Money and Spirituality Mix pamphlet are only a suggestion. (Area 40 Spring Assembly 2014 GSC Finance Agenda)

The committee reviewed the Self-Support packet and suggests that the following changes, as the Self-Support Card (F-42) are being updated by the AAWS Finance Committee:

After the Business meeting Intergroup hosts a monthly Birthday Meeting at 8:00pm to celebrate valley wide sobriety accomplishments followed by cake and fellowship. Intergroup has 16 Chair positions which are filled. All current Chairs are very passionate, dedicated and active people in sobriety within the Flathead Valley willing to carry the message to the still suffering alcoholic.

Intergroup provides the AA meeting schedules for the entire Flathead Valley from Eureka all the way to Elmo Montana. The schedules are also available via our website which is aa-kalispell.org. The schedules are printed quarterly or printed if needed.

Our website in June had 1,217 visitors, July had 1,447 visitors and in August the website had 1,531 visitors. Our website also posts any open service positions available on a District and Intergroup level as well as AA related flyers for any Flathead Valley events. Intergroup also has a Northwest Montana AA Hotline which is (406) 257-7185, in which for the month of July 3, 2014 through July 31, 2014 there were 30 inbound calls and 2 outbound calls.

On July 26, 2014, Intergroup amended and approved our By Laws in which our three trustee's/Steering Committee were able to review and advise Intergroup of their recommendations to the revision of the By Laws to better reflect our service positions and roles currently. Intergroup hosts 13 Valley wide events yearly some of which include: Annual Campout at Emery Bay in Hungry Horse which was held August 1- 3rd, in which we had two speakers from WA State, about 10 groups represented and about 100 people in attendance. Annual Halloween Event, Annual Thanksgiving Event, Annual New Year's Eve through New Year's Day Alcathon, St. Patrick's Event, Annual Spring Fling BBQ.

As a side note our Intergroup is following 6 of the 7 requirements out of the Services Manual S41.

Bob had a sponsor that was very service orientated 30 years ago. Bob loves carrying the message into physic wards and jails. He was Delegate panel 62, 1992-1993. He talked about early days at Area Assembly. It was a rodeo in the past. Went to WCRSSC as Alt Delegate and saw how others did things. I was introduced into the committee system at regional forum. I learned that a chair does not get involved in discussion but just chairs the assembly. We decided where round ups would be. Robbie S re-wrote the agenda that Bob and Joe wrote for the committee system and it passed. The Pendleton jacket that Libbie got yesterday started with me, then passed on to Mark, Robbie, Eric and so on. What troubles me at election assembly is the lack of people that stand for positions. We need to change that. Be there when people show up and welcome them. I did a workshop in Kev, Ukraine and there was only Intergroup-no service. So I am grateful for our service.

DELEGATES REPORT SHARON S (9:00 - 9:40 am)

My name is Sharon S. and I am an alcoholic. It is my honor and responsibility to serve as your delegate to the 63rd and 64th General Service Conference. I'm inclined to have served, but, like you, I have 3 more months before I rotate on from this service position you have trusted me with and from which I have gained so much.

Thanks to the committee for such a great job these two years. Gerry and I had some hurt feelings at the beginning, but amends were made and I think we worked well together, Gerry has done a great job as Area Chair. Libbie has been a fabulous Treasurer, and Mary as Secretary, the registrar part of that job is huge and she has done such a great job at getting and keeping the Area 40 committee and group information updated in FNV, which is so important for communication between GSO and the groups. The standing committee was fabulous, thanks to them and the work the districts and groups did in pre-assemblies and at the Spring Assembly, I went to the Conference both years, confident that I understood the agenda items. I may have been afraid, lacking self-confidence and worried about how I looked, but I knew the material! And, thanks to our great Webmaster Alex. He has always been so responsive and patient. Sometimes he had to undo things I asked him to do more than once!

Thank you Bob and Earl for your sharing. You reminded me of parts of my own story. I got to Alcoholics Anonymous in utterly hopeless condition. I don't know that I looked that bad, as I am pretty good at looking good, but I was hopeless in a deep dark way, deep inside of my heart. Page 52 describes that pretty well; and I thought the problem was my childhood and the people in my life. No wonder I was depressed, that always happens when I depend on people or situations outside of myself to make me ok! I was having problems with my daughter, a teenager who was having problems at school and with friendships. We went to a family counsellor who spoke to each of individually and then together, then said to me, "she is going to okay, do you want to come back?' A year later I was finally able to be honest with him about my drinking and he suggested I go to an A.A. meeting. He knew where it was and what time it was and enough to give me an idea about what AA was. I'm pretty sure the AA's in that community were doing their job, they had reached out to that professional and told him where to send a woman like me! So that group of women in that first AA meeting shared their stories with me and I knew that they knew; I also had a feeling that they had found something, so I came back. They gave me a service position and let me join their group (I was afraid to ask); they, and others, kept inviting me back and into the middle of AA. I didn't have to drink and eventually I worked the steps. I had a spiritual experience as a result; actually, I keep having these experiences! Like being allowed to serve as your delegate. It's been a long, slow process for me, but I am so grateful. I am especially grateful for the sponsor who, from the beginning, exemplified our three legacies. She rarely tells me what to do, like getting a service position. She just invited me along with her, doing these things.

On to my delegate's report. Thanks to the districts who hosted delegate's reports and thanks to those of you who were able to attend one. After next weekend, I will have personally visited all of the districts to report on the conference. This really is the best part of this service position, spending time with you and AA members in your districts. I am not going to give my entire conference report —The committees have reviewed their items and reported committee discussions and recommendations. I will cover a few of the agenda items toward the end of the report.

Although the agenda for 64th annual General Service Conference was not heavy, it was full. The members of the conference disagreed on many things. Several committee recommendations received majority votes, but failed to achieve substantial unanimity. I think this is a reflection of what is going on in our fellowship and that we have lots to think about and discuss as it relates to how we can reach out to other alcoholics and offer them the solution we have found here.

The General Service Board met in August and decided a few things:

- Literature price increase and decrease in shipping charges
- Long term decision to keep G.S.O. in NYC
- Authorized a draw down of up to \$1.3m from the Reserve Fund to move forward with a remodel of the 11th floor of the Interchurch building to better use the space available and share it with the Grapevine

The AAWS Board met last weekend. Yesterday I received an email from Bill N., the Board Chairperson. I was already here, so too late to make copies, but I will be forwarding it to the DCM's who will share it with their groups. The AAWS Board had a strategic planning session and wants the fellowship to know they have realized that "depending on literature profits to make up the shortfall of contributions is not a sustainable model to remain self-supporting". In addition to communication about the numbers, they will strive to communicate the value of the 7th Tradition and will be including '7th Tradition stories' in the Grapevine, Box 4-5-9 and contribution acknowledgements. If you have a 7th Tradition story to share, please send it to the address provided in the memo.

Registration for the International Convention July 2-5 in Atlanta opened September 3. I am registered and hope to see you there.

Other AAWS information. Hopefully, many of you have visited the new website, aa.org. If you have not, I invite you to do so. The find AA Near You is designed to fit the needs of AA communities with Intergroups or Central Offices. I have requested in a few different ways that Area 40 be handled differently and that the Area 40 hotline and web page be the first response. I invite you to comment also, if you have not already.

The theme for the 65th General Service Conference is "Celebrating 80 Years of Recovery, Unity and Service — The Foundation for Our Future" ... please consider using this theme at your local AA events, too! Discussion topics were also set for the conference and, hopefully, these provide food for thought for your local AA events, too, and will stimulate conversations in groups about how we can continue and improve carrying the message of AA to alcoholics who still suffer:

- Diversity in A.A. Our Heritage of Inclusion
- Safety and Respect Practicing the Principles Begins in our Home Group
- Safeguarding our Traditions through the Evolution of Technology
- Inventory

A few things from the General Service Conference:

Significant actions:

The conference passed with overwhelming support "Many Paths to Spirituality" which went on sale the first of August. The very good news is that this pamphlet is such a good example of the year-round conference process and the committee process. This pamphlet started in 2009 as an area request for a video on the topic. In the 5 years since, each conference worked on the project and A.A.W.S. and the trustees worked on it year-round. There has been much disagreement whether we should have a pamphlet, but substantial unanimity always called for some literature. Then we struggled about what it should say; many drafts were sent back to trustees' for more work. Most of us think this pamphlet is very good, but not perfect. I dislike one sentence [Today I can even recite the Lord's Prayer without feeling guilty since it was pointed out to me in "How it works" that I have to any length to get sober] as I think it implies that "How it works" says we have to say the Lord's Prayer to get sober; I believe "How it works" is talking about the steps and that it is not necessary to say the Lord's Prayer in order to get or stay sober! There were attempts to wordsmith it from the floor, but as is often the case, we

couldn't come up with changes that really worked in context with the story and that we agreed on so, in the end, we approved the pamphlet with very close to a unanimous vote, and I voted in favor.

We have conducted the triennial survey, with four Area 40 groups participating. The results have been turned in and we'll see the 2014 Membership Survey pamphlet when Libbie comes back from the Conference.

The controversial "Alcoholism at Large" section of the Grapevine will continue to be published. The members of AA are very divided on this issue. A majority of conference members wanted it removed, but not substantial unanimity. I suspect that future conferences will be discussing this and hopefully will be able to create a solution that meets the needs of everyone.

The Conference also discussed the request to create a pamphlet for alcoholics with mental illness and took no action. This was a very emotional topic and we spent a long time hearing lots of stories. Again, the conference was divided, with a majority of members voting for the pamphlet, but not a substantial unanimity. In the end, I voted against it because as I listened to the appeals to do something I came to believe that a pamphlet is not going to solve this issue. It is one of those things that, as a fellowship, we need to be having some more conversations about starting in our home group and finding out how we can reach out the hand of AA to those who come to our meetings and may have trouble hearing and/or understanding us; reaching over that barrier to offer what we have been given.

I've mentioned these actions/no actions because I expect they will come to future conferences in some way or other ... and we have work to do on issues on which we are divided. I think this starts, one alcoholic working with another, communicating with each other (listening) to each other; with our home groups discussing these things and attempting to find experience or ideas that will help us carry the message to people we may be missing or failing to reach out to in a way that they can understand.

So, in closing, please talk with each other in the language of the heart and ask what we can do to help the alcoholic who still suffers, then in the way of those who passed before, take the action!

Thanks for your cards, letters, cards, emails, and prayers at the conference. I appreciate you so much and am honored to be trusted to serve you. I will do my best to show up and finish out this rotation in the next three months!

ARCHIVES/AREA 40 STRUCTURE & POLICY – KIRA A (10:50 - 11:00 am)

Archives Chair Report

I'm Kira A and I'm an alcoholic. Thank you for letting me be your Area 40 archives chair for the 2013 - 2014 rotation. It truly is a privilege to have the opportunity to serve Alcoholics Anonymous in this capacity.

During this rotation I gave myself a project to work on. I set out to interview old-timers in AA, not for their personal stories, but rather to make record of the general atmosphere of Alcoholics Anonymous in Montana at the time they started their sobriety. Each interview was highly structured, with identical questions being asked of each interviewee. All interviews were taped and some were also transcribed. I was able to interview people in Helena, Bozeman, Missoula and St. Ignatius.

The end result of the project was to be a conglomeration of all the responses to each question, assembled together to see how they compared and contrasted. The question *How were young people treated and what was considered young?* would be followed by each interviewee's answer. Each response was unique, showing a variety of perceptions and experiences in AA as it was twenty or forty years ago.

I have brought a sample of this project with me, something tangible to show what I have been doing as your archives chair. This booklet has the responses from interviews done in Helena. It's about 50 pages and I can get it to anyone who would like it, either in paper form or via email. Last names are present so it is confidential.

There was much discussion from the floor on what to do about the open webmaster position due to Alex M being elected Area Chair / Alt Delegate.

CONFERENCE ADVISORY ACTIONS OF THE 64TH GENERAL SERVICE CONFERENCE

The following recommendations were approved by the 64TH General Service Conference and the General Service Board:

Grapevine

No recommendations.

Policy/Admissions

It was recommended that:

- 18. Jennie Herd, alternate delegate, Area 85, Northwest Ontario, be seated as a Conference member at the 64th General Service Conference because Ken Baker, Panel 63 delegate for Area 85 is unable to attend.
- 19. Jim Stone, delegate, Area 1, Alabama/Northwest Florida, be seated as a Conference member at the 64th General Service Conference because Craig Miller, Panel 63 delegate for Area 1 is unable to attend.
- 20. Joyce Saunders, alternate delegate, Area 83, Eastern Ontario, be seated as a Conference member at the 64th General Service Conference because Mel Caterine, Panel 63 delegate for Area 83 is unable to attend.
- 21. The 67th General Service Conference be held April 23-29, 2017, since these dates do not conflict with any significant holidays or hotel availability.
- 22. During a two-year trial period the General Service Conference include one day of electronic voting on all nonelection votes, on the Thursday of the 2015 General Service Conference and on the Friday of the 2016 General Service Conference, and that the trustees' Committee on the General Service Conference provide a report from data gathered from the 2015 and 2016 General Service Conferences, evaluating electronic voting to the 2017 Conference Committee on Policy/Admissions for consideration.

FLOOR ACTIONS THAT DID NOT RESULT IN CONFERENCE ADVISORY ACTIONS

To add a single line item to the General Fund budget for La Viña. (Not approved)

The 64th General Service Conference reaffirm the right of decision of the Grapevine Board to making formatting decisions for the A.A. Grapevine and La Viña magazines noting:

- a. That right is already exercised by publication of La Viña in color and
- b. The 2010 Advisory Action recommended a beginning point in bringing La Viña on spiritual parity with the A.A. Grapevine. (**Not approved**)

The Conference consider the use of the circle and triangle on Conference-approved literature as a historical reminder of A.A.'s Three Legacies of Recovery, Unity and Service.

(Conference voted not to consider)

A.A. Grapevine discontinue publishing the "Alcoholism at Large" section of The Grapevine **Magazine.** (Not approved)

Additional Considerations

Conference Committee on Grapevine

The committee reviewed the 2014 Grapevine Office Report on Audio Strategy and requested that an updated status and financial report on the project, including practices, financials, metrics and plans for the future, be provided to the 2015 Conference Committee on the Grapevine. The committee reviewed the A.A. Grapevine Board's suggestion that a new business plan is required for La Viña and requested that a new business plan be developed for La Viña and be brought back to the 2015 Conference Committee on A.A. Grapevine for review.

Conference Committee on Policy/Admissions

The committee discussed the 2008 Conference Advisory Action regarding responsibility for site selection of the General Service Conference and took no action. The committee considered that the current hotel site-selection process by the General Service Office management is appropriate. The committee suggested that, in the spirit of clear communication, reports describing the hotel site-selection process of all future General Service Conferences be provided to the Conference Committee on Policy/Admissions for their information.

RECOMMENDATIONS THAT DID NOT RESULT IN CONFERENCE ADVISORY ACTIONS

Conference Committee on the A.A. Grapevine

The committee discussed a request "to reaffirm the Right of Decision of the A.A. Grapevine Board to make formatting decisions for the A.A. Grapevine and La Viña magazines." The committee acknowledged that Grapevine and La Viña are valuable Twelfth-Step tools. The committee recommended that the A.A. Grapevine Board have the ability to exercise their right of decision for all formatting decisions in producing Grapevine and La Viña noting that this recommendation removes all formatting restrictions on Grapevine and La Viña.

Area Corrections Chair Report

There is a lot of activity going on in the Corrections world these days. Teresa from Kalispell represented Area 40 at the recent Bridging The Gap conference in Kansas City. Clement, who is on the Corrections Desk at GSO was there along with the BTG Archives person. I had asked her several questions to explore with people at the conference and she came back with lots of shared experience from other areas.

The June Montana State Prison conference was cancelled due to a mix-up with their staff, but we identified another staff sponsor and the conference has been rescheduled for November 8th. I got confirmation yesterday that our application has been accepted and the conference is a go. We have 25 inmates and 25 outside AA's cleared to attend.

The volunteer orientation scheduled for this weekend was canceled due to lack of applicants. The next orientation is scheduled for January 17th, 2015. We hope to have a large group of AA's attend to increase the number of eligible volunteers on the list. Please announce this in your groups and districts. We'll get the website updated ASAP so folks can download an application and cover letter.

Montana State Prison continues to hold weekly meetings on both the Low Security Side and at the Work Dorm. Meetings remain unavailable on the High Security Side. We currently have 40 AA volunteers having lost a few recently. We have had 4 Bridging the Gap contacts at MSP since the last Assembly and 6 inmates have been connected to outside sponsors by mail. If you are willing to sponsor inmates through the mail, please let me know. We have missed several meetings recently at the prison so I'm working with the volunteers and district Corrections Chairs to ensure that every possible meeting at MSP has a volunteer. But we could use some more folks to go through the orientation and get added to the list.

Things are going well at the Women's prison. They are having our 3rd annual AA 12 step retreat the third weekend in Oct. They need speakers for the monthly Saturday night speaker meeting but they don't' have any travel money to reimburse people. Men or woman can do it but they must complete an orientation. Orientations are held quarterly and good for a year. Unfortunately it is on a Tuesday night from 7 to 9. Still if anyone around the state wants to get a carload to come down to the next orientation and doesn't need compensation they could definitely use them as speakers. Anytime they were in town on a Tuesday or Saturday night they would be able to participate in the regular meetings too! Anyone interested should contact Moe V. at 647-5444.

Meetings continue to be held at the Riverside Facility for adolescent females in Boulder supported by the women in Districts 61, 71 and 72. Weekly (at least) meetings continue to be held at WATCh West-Warm Springs, WATCh East-Glendive, Cascade County Regional Prison-Great Falls, Elkhorn Center -Boulder, START at Warm Springs, Crossroads Prison in Shelby and the MAST program in Missoula as well as various pre-release centers across the state. There are currently no meetings at the Pine Hills School for Boys in Miles City or the Dawson County Regional Prison.

The Corrections Correspondence program at the General Service Office continues to look for male AA's who are willing to correspond with incarcerated inmates across the country. Currently there are 90+ inmates nationwide requesting correspondence that are waiting for AAs to respond. If you are interested and willing you can download a Corrections Correspondence pamphlet from the GSO website: http://www.alcoholics-anonymous.org/lang/en/catalog.cfm?origpage=254&product=111.

Since the last Area Assembly the Pink Can Fund has received \$2,911.70 in contributions from 6 groups and districts, including a \$1,500 donation from the Butte Round-up committee. We have purchased \$2,245.80 in AA literature that has been distributed to 9 different facilities. The current Area Pink Can Fund balance is \$1,396.99 but I will be making another large purchase by the end of the month before literature prices go up again and to avoid the shipping charge. Please make checks out to: AREA 40 INC. Do not make checks out to the Pink Can Fund. The bank won't accept them.

I attended a Service Workshop in District 72 this summer, but travel has been light besides that. I'm still available for workshops throughout the rest of the year, so please don't hesitate to call. I would still recommend that Round-up committees add a Corrections/Treatment and a PI/CPC workshop to their traditional schedules. It's a great chance to expose more AA's to these service opportunities and to answer questions about what they are all about.

I want to thank my committee for all their work and support these past two years. We got a lot done. I want to extend a special thanks to Karla B, DCM for District 61 for being willing to serve as the committee secretary. She has done a great job.

I want to thank Area 40 for the honor to serve as your Area Corrections Chair the past two years. It has been a privilege to do this work. Hopefully we have been able to carry the message to a few more men and woman behind the walls who would not otherwise have access to the life-saving and life-giving message of Alcoholics Anonymous. I am so grateful for this opportunity. It will be a highlight of my sobriety. Thank you for allowing me to serve,

Review Area Assembly and give Chair report

BTG conference in Kansas City was attended by Teresa from District 91, who represented Area 40. Some of the things she learned include:

- Follow-up loop needs to be more expedient and have a quicker turnaround time
- BTG for Area 40 falls under Corrections AND Treatment
- Sounds like it is working pretty well throughout the Area with a few gaps
- BTG coordinators have access to the database in the Area website
- Contact information remains the same, but the person rotates every 2 yrs
- There are trainings available for AA and facilities about BTG

MSP mini conference has been rescheduled for Nov 8 and it is ready to go. 25 AA's are approved to attend.

MSP Volunteer Orientation was scheduled for today, cancelled due to low numbers of applications. Next one is Jan 17, 2015.

- Will ask Terrie at MSP how many people are required to hold an orientation
- 40 people on the list currently, but it needs to be updated and increased

Meetings are weekly on the Low Side and Work Dorm, but none on the High Security Side currently.

- Only 1 person is needed hold a meeting so we need a minimum of two each week, one for the Low Side and one for the Work Dorm

WSP holds orientation Tuesdays 7-9 pm

- Looking for volunteers
- Holding 3rd annual 12 step workshop weekend, the 3rd weekend of October

Meetings being taken in all state facilities around Area, except Pine Hills and Dawson Regional Prison.

Corrections Correspondence Service needs at least 90 male AA's throughout the country who are willing to correspond with inmates requesting an AA to write to them. You can use your District or group address if you don't want to use your home address. You will be matched up with inmates from across the country, not inmates located locally or regionally.

Pink Can contributions \$2911.70 from 6 groups and Districts

- Purchased \$2245.80 in AA literature, distributed to 9 facilities
- Balance currently is \$1396.99, will make another large purchase by the end of the month to beat the literature price increases.
- Bank account set up through Area 40 Inc, not as the Pink Can Fund.

Kevin, from District 72 share a flyer for Corrections Service Opportunities he developed. It lists all the options that district AA's have to get involved and carry the AA message into facilities.

Lee recommended that we have a workshop from Area Chairs at RoundUps or other conferences. It's a great way to get more people involved in this part of service.

Reviewed Guidelines for Area Trusted Servants for Corrections Chair, Corrections Committee. Most questions were about the Pink Can Fund. Lee said his job was to implement the Pink Can the way it is laid out in the Area 40 Policies and Procedures rather than debate whether he agreed or disagreed with it. The way the Pink Can is set up groups and districts can be autonomous in their choice of whether to have a Pink Can or not.

Reviewed the results of GSC Advisory Action Items discussed for Corrections and Int'l Conventions and Forums. The 2025 International Convention is going to be held in Vancouver, British Columbia. Plans are already underway for the 2035 International Convention, which will be AA's 100 birthday.
