Saturday, September 10, 2022

The Assembly was opened with the Serenity Prayer at 8:00 am by Area 40 Chair/Alternate Delegate Kacie N. The Twelve Traditions and the Twelve Concepts were read.

Orientation to the Assembly

Good morning everyone. I am Connie and I am an alcoholic. I have the privilege and honor of serving Area 40 as Panel 71 Delegate to the General Service Conference. What a thrill to be standing here, looking out at all of you here in person and The virtual attendees. Many of you have been on this journey with me and have definitely been a part of creating the life I get to enjoy today. My heart overflows with gratitude.

Will everyone who is attending their first Area Assembly, please stand. Those who are attending virtually please raise your hand if this is your first time? Welcome!

First timers please keep standing and keep your hand raised. Would all those who have never attended a live Area Assembly please stand. First timers look around, you will notice that you are not the only ones here for your first LIVE assembly. I'm doing this to help you see that you are not alone in this process. Just like attending our first AA meeting, everyone here had their first time attending Area. Don't be afraid to ask questions

General Service work is part of the Recovery triangle that affords us the opportunity to "have a fellowship grow up about you." I encourage you to find someone who has attended an Area Assembly before, and ask them to be your Area buddy. I was able to sit by someone who knew what was going on at my first Assembly and it helped to ease my fears when they gladly answered many of my questions. It helps to remember that we are all here to help each other help the still suffering alcoholic. Please have a seat and lower your hands.

Will all DCMs please stand? Thank you for your willingness to take your service work to another level and for the example that you all set in your respective districts that General Service work is not a do-it-once-and-you're-done deal. After our secretary, Lisa, does roll call, we will ask DCMs to complete the sign in sheet for their districts. Those voting members that are attending virtually should let Alex M know that they are a voting member. GSRs and District DCMs are the only voting members of the district. Alternate GSRs will only have a vote if their GSR is not present and Alternate DCMs only if their DCM is not here. DCM's please identify

your District Reps who will be sitting in on the Area Standing Committee meeting. District Reps who are appointed to a committee have a vote in that committee meeting only but not out in the general assembly, unless they are also a GSR.

DCMs please give their signup sheets to Lisa by the first break today. The collected information helps to establish a quorum, which is two-thirds of the eligible voters counted from these sheets. With very few exceptions, everything we vote on here is decided by what we call "substantial unanimity". What that means is that, as long as we have a quorum (two-thirds of the registered voters) any item we vote on must receive two thirds of the counted vote in order to pass. (Kacie will explain this more thoroughly as we take our votes)

This is an election assembly, Paul L, Area Advisor, will be conducting the elections. Before the 1st break, Paul will go thru the list of eligible individuals for Delegate to see who is willing to stand. This will offer you an opportunity to hear their service history. During the break and lunch, take the time to talk to those individuals. From the same list, our Area Chair, Treasurer and Secretary maybe selected. To help you make your decision, please take the time to visit with those individuals willing to stand. Paul will explain what the 3rd legacy voting procedure is when we return from lunch and begin the elections. The Delegate, Area Chair/Alternate Delegate, Treasurer and Secretary will be voted on using the 3rd legacy voting procedure and the Area Standing Committee Chairs are elected by simple majority.

Our job this weekend is to conduct the business of Area 40 and elect the new Area 40 Officers and Standing Committee Chairs. Those who are willing to stand are making a commitment to Area 40 to be available to attend Area Assembly twice a year an, provide the support to districts and district committee chairs.

Kacie, our Area Chair/Alt Delegate will be facilitating the assembly according to a loose interpretation of Roberts Rule of Order, an interpretation that she will explain as she goes, and of which, she has the final say. In other words, when it comes time to decide if we're done talking about something, "Kacie makes the call."

Kacie has prepared this weekend's agenda and has decided the order in which we will conduct our business. We will soon start to hear reports from our Area Officers, Area Chairs and DCMs. At 9:15 we will stop the reports and collect the names of those individuals willing to stand for Delegate. We will take a break and the Standing Committees will go to their respective breakout rooms. Anyone can attend the committee meetings, but remember, only the appointed DCMs and District Reps are eligible to vote in committee. If you prefer not to attend a committee meeting, Mark S, Panel 44 Past Area 40 Delegate will be doing a workshop titled "Right of Decision – Trusting our Trusted Servants" in this room while the committees are in session. After the committee breakouts and workshops conclude, we will break for lunch. After lunch we will begin elections.

When we begin business, we will address the Area 40 items. During the Standing Committee meetings an item may come to the floor to be voted on by the entire Assembly. The item will come to the floor in the form of a Recommendation, which is considered a made and seconded motion.

Kacie will facilitate discussion on all items. There will be 3 microphones; two here on the assembly floor and the 3rd for virtual comments. If you wish to speak please get in line behind the mike or virtually please raise your hand. Introduce yourself with your name, your district and your service position. You will have 3 minutes to express your opinion. Once your 3 minutes has been reached Lisa will let you know with the clang of the cow bell. (Ask Lisa to ring it.) If Kacie feels that the comments are becoming repetitive, she may stop the discussion. Votes taken on Area 40 items will require that we have a quorum of eligible voters. For an item to pass it must have a two thirds majority of the votes cast. As a voting member, please be here on time so that we can be sure to have a quorum.

At 8:30 tonight, GSRs can attend a breakout session here in the Mansfield Room and DCMs in the Russel Room. This is a good time for everyone to bring any questions, concerns or share solutions along with experience, strength and hope. There are baskets in the back of the room where you can put in questions for either session. Virtual attendees can submit your questions to Alex and he will get them to the Mark or myself. After the breakouts... Get ready for some fun.

One friendly piece of advice I have for everyone attending.....be an active participant. Take part in the discussions, PLEASE ask questions if you are unsure of something, you may not be the only one with that question. Every action that you take to be a part of our Area 40 Assembly ensures AA, as a whole, will remain a viable service to the still suffering alcoholic. Your full participation in this side of the triangle will indeed offer you "an experience you must not miss."

Motions from the Spring 2022 Area 40 Assembly

The Literature Committee presented a Recommendation that the Area 40 delegate forward the following proposed agenda item to the conference coordinator to be placed on the agenda of the

seventy third General service conference: That no further changes to be made to any of Bill W's writings. 48 IN FAVOR/50 OPPOSED. MOTION FAILED.

The Finance Committee presented a Recommendation that Area 40 provide a hybrid option for the Fall 2022 assembly utilizing the current appointed tech volunteers, at the one-time expense of no more than \$3,500.00. By July 1st the current tech team will develop a job description, a proposed action plan, and an estimated budget line item using the experience that was developed from the Spring 2022 assembly. 86 IN FAVOR/9 OPPOSED. MOTION PASSED.

After minority opinion was heard, a Motion to Reconsider was made and seconded. 22 IN FAVOR/62 OPPOSED. MOTION TO RECONSIDER FAILED.

The Public Information Committee presented two Recommendations:

A. That the Triangle newsletter be digital-only, eliminate printed copies, and require a minimum of four newsletter publications per year with additional publications to be the discretion of the Triangle Editor. 71 IN FAVOR/22 OPPOSED. MOTION PASSED.

After minority opinion was heard, a Motion to Reconsider was made and seconded. 38 IN FAVOR/47 OPPOSED. MOTION TO RECONSIDER FAILED.

- B. That Area 40 adopt the following job description for the Hotline Chair:
 - 1. The Hotline Chair will prepare a written and oral report of Hotline Chair activities for the Area Assembly.
 - 2. The Hotline Chair will keep the Area, Districts, Groups, and individual A.A. members informed about the Hotline and what function it serves to effectively reach the alcoholic who still suffers.
 - 3. The Hotline Chairperson will maintain a contact list of all District Hotline Chairs, and those Chairs will be the points of contact for all Hotline-related matters for their Districts.
 - 4. The Hotline Chairperson will distribute monthly or quarterly reports to the District Hotline Chairs. Those reports should inform the Districts how many calls their District received during that time period.
 - 5. The Hotline Chairperson will maintain contact with the Answering Service and monitor the call history to ensure accuracy.
 - 6. The Hotline Chairperson is responsible for monitoring all calls for the Area. If a call is missed in a particular District, the Hotline Chairperson is responsible for contacting that District Hotline Chair in a timely manner, with the contact information of the individual who tried to call. The District Hotline Chair is then responsible for having an A.A. member in that District return the call.

7. For the Hotline Chairperson's rotation duration and years of sobriety, the standard Area 40 Policies and Procedures would apply.

89 IN FAVOR/1 OPPOSED. MOTION PASSED. Minority opinion was invited but not offered.

Motions from the Fall 2022 Area 40 Assembly

The Archives Committee presented three Recommendations:

1. MOTION: Update the Bridging the Gap (BTG) and Alternate BTG Chairperson job descriptions to reflect necessary qualifications and current practices.

The additions ought to include:

To section G17.1 of policies and procedures manual, add the verbiage:

- Written and oral communication skills.
- Organizational skills for leading committee meetings, coordinating workshops, and keeping good records that will be provided to district BTG chairs and the Area Archivist.
- Access to a computer with internet connectivity and the ability to readily monitor correspondence with volunteers and facilities.
- Knowledge of computer software and videotelephony software, such as word-processing programs and Zoom, and the ability to use email.

To Q17.1A:

• Since the Alt BTG Chair acquires familiarity with BTG Chair duties to implement them as needed in the event that the BTG Chair resigns or becomes unable to serve, a candidate for Alt BTG Chair should also meet the qualifications for the BTG Chair as described above/

MOTION PASSED.

2. MOTION: That Area 40 creates a 4-5 member technology/AV team led by two co-chair people. Full job description including rotation and voting status will be brought to the Spring 2023 Assembly for approval. Funding amounts will be decided with annual budget approval.

78 IN FAVOR/3 OPPOSED. MOTION PASSED. After minority opinion was heard, no Motion

to Reconsider was made.

3. MOTION: That Area 40 discontinues the Area 40 Triangle and the Area 40 Triangle Editor position.

68 IN FAVOR/10 OPPOSED. MOTION PASSED. After minority opinion was heard, a Motion to Reconsider was made and seconded. 13 IN FAVOR/62 OPPOSED. MOTION TO RECONSIDER FAILED.

The Public Information Committee presented two Recommendations:

1. MOTION: Area 40 PI Committee recommends that Area 40 discontinue the use of all Northern Directory Publishing (MDP) phone directories.

82 IN FAVOR/0 OPPOSED. MOTION PASSED.

2. MOTION: Area 40 PI Committee recommends that the Area 40 Chair create an Ad-Hoc Committee to determine if Area 40 should adopt more detailed guidelines for the Area 40 website and, if so, to recommend to the Area such guidelines no later than the 2024 Fall Assembly.

80 IN FAVOR/0 OPPOSED. MOTION PASSED.

The Treatment Committee presented one Recommendation:

MOTION: That Area 40 fund the Bridging the Gap Chairperson to attend the National Bridging the Gap Workshop Weekend (BTGWW) held September 30th to October 2nd, 2022.

82 IN FAVOR/0 OPPOSED. MOTION PASSED.

The Finance Committee presented one Recommendation:

MOTION: To approve the Area 40 Budget for 2023.

78 IN FAVOR/0 OPPOSED. MOTION PASSED.

The Literature Committee presented one Recommendation:

MOTION: We reviewed the job description for the Area 40 Literature Chair and saw that it was necessary to change Item G7.4 We added the word current to it. It would now read: The

Literature Committee will have available one (1) copy of all current literature from the G.S.O. for viewing.

70 IN FAVOR/0 OPPOSED. MOTION PASSED.

The following floor motion was made and seconded by Susan, GSR, Bigfork By The Bay Group, District 91:

MOTION: Create a separate Area 40 Hotline standing committee and include it in the DCM and District Rep assignments for each rotation.

72 IN FAVOR/3 OPPOSED. MOTION PASSED. After minority opinion was heard, a Motion to Reconsider was made and seconded. 39 IN FAVOR/22 OPPOSED/7 ABSTAINED. MOTION TO RECONSIDER FAILED.

Financial Highlights

Area Chair Report

Good morning, Area 40! I'm Kacie, an alcoholic, and your Area Chair and Alternate Delegate.

As I struggle to wrap my head around the fact that this is already the final Assembly of this rotation, I hear a familiar voice saying, "You're not done yet, there's still four months left!" It's easy to feel like this is it. After this weekend, the job is done. By this afternoon someone else will be elected to this position and I'm off the hook. Time to kick back and relax. When really this is the perfect time to kick it up a notch.

I've been taught in AA to leave things better than I find them. Sometimes the challenge with that is that the way some things are found is already pretty dang great. For instance, I follow in well tread footsteps of a fantastic Area Chair. So, it will be a genuine challenge to find ways to leave this service position better than I found it, but that doesn't have to stop me from trying. Maybe we can all try this together? We can hold each other accountable and share ideas and suggestions on how to rotate on leaving our current position better than we found it. Saturday, November 12th, we'll be holding a Rotation Workshop and Service Transition Zoom meeting. We can check in with each other then to see how things are going.

In the Spring I shared that I had intentions of hosting a "How to Write an Agenda Item" workshop. Sometimes I have to say stuff out loud to you people so that I actually follow through. Happily, that worked, and in June two successful workshops were had. The monthly Concept Study that was started last Fall is also the result of sharing an intention out loud and I'm happy to report that it is still going strong. We may even finish by the end of this rotation. If you're interested in participating, let me know!

A few weeks ago, in a meeting after the meeting with some very new newcomers, I was reminded about what really matters. I was reminded why we do all of this...Assemblies, Concept Studies, Policy changes, reports, committees, agendas...every single thing is to make it easier for the me or the you who isn't here yet to get here. It's so AA is easier to find, so Professionals are better informed, so someone leaving treatment has a hand to grab onto to get here, so the incarcerated have literature available, and so much more. A single person can't make all that possible. It takes all of us doing our part, showing up, being willing, and doing our best. What we do here this weekend is not just to keep AA going, it's to make it better.

Serving as the Area Chair has been the most challenging service position I've ever held. I love service. I love what it's done for my life. I love what I've seen it do for others. But I'd be hiding the warts if I didn't say that I wanted to give up a few times over the last two years. My mettle was tested and I'm not sure I passed. I took things personally. I got frustrated and sometimes angry. I didn't walk through every situation with the grace I wished I would have. But thanks to patient listeners, experience sharers, humor, and stern compassion I did walk through it. And I learned...again...that I'm not doing this by myself. And I don't have to do it perfect. And that it's not about me. I'm just taking my turn at carrying a bit of the responsibility that comes with receiving the gift of sobriety in AA. This is the very least I can offer as repayment for what I've been given. It was my turn for this job and it's almost time to take a turn at something new. It's going to take a lot of turns to come close to paying off my debt to AA and to you.

While it has been challenging, being your Area Chair is also one of the most rewarding things I've experienced in sobriety. It's right up there with sponsorship and really great first step meetings. Thank you. Thank you for doing this work when I was still drinking and for paving the way for me to make it here. Thank you for trusting me. Thank you for loving me through my flaws and mistakes. And thank you so very much for my beautiful sober life.

DCM Reports

District 11 DCM Report

Hi ya'll. It has been an action packed summer over in District 11. We are months away from wrapping up this rotation, and it seems a shame because I, for one, finally know what I am doing and yet my successor has already been chosen. I'm not sure what will be next for myself, but I will continue to show up and do the next right thing. God is ultimately running things, and one thing I've learned while serving as your humble DCM is I do not get to control the results.

I'm excited to announce a scholarship program started in district 11 to help new & smaller groups send their GSR to Area Assembly. The GSRs have spoken, and many of them prefer to attend in person. Since our district has an excess above our prudent reserve, we followed the precedence of other districts and there are 3 dist 11 GSRs here tonight who might not have been able to afford it otherwise.

Campouts and potlucks abounded throughout the summer. Homegroups and sponsorship families put together campouts, as well as the official Intergroup Cooney Campout. Our Delegate came to District 11 for her report. We thought to throw a BBQ potluck this year, and over 30 people stayed to hear the report. A member of District 12 provided the BBQ. For the first time in recent history, District 11 did not provide the breakfast at 12's Fireman's Point report. That was an unfortunate miscommunication, I spent a couple weeks to get nowhere and finally had to call and say we couldn't do it. That was a hard call to make.

Some homegroups made a conscious effort to bring unity by putting on potlucks over the summer and planning large parties in the future. 644 is planning a birthday celebration next year, not officially a jamboree but the term fits, and has already begun planning. Westend has decided to have an annual event called Westend Weekend, and the first one will be the Big Book Comes Alive on Oct. 28-29.

Covid changed everything in our Corrections Committee. It has been a struggle getting meetings back into our correctional facilities. We elected a new chair over the summer, and meetings are now being brought into YCDF and the Women's Prison & half-way house. We are still trying to get enough volunteers for the men's half-way house. There are a number of issues that we are patiently trying to work through.

PI/CPC is one committee over district 11. It has been a hot potato. A couple years ago, we voted in a program without a clear plan on executing it. Unfortunately getting it off the ground has been rocky. Once our budget comes out in October, GSRs will ask their groups if the expense and effort is worth the cost. We will talk about traditions and concepts, which say special workers may do the work but only if it is really deemed necessary by the fellowship.

We had two group inventories over the summer, at Westend and 644 Group. As current DCM, I was looking forward to all the changes I thought I could help bring to my homegroup of Westend. Well, the group had different ideas. Although I chaired the ad hoc committee to follow up on the inventory, after a few meetings I resigned after realizing that my ego was way out of whack—I was trying to lead Westend where it didn't want to go. What I wanted wasn't what they wanted, and I had no idea how to help with what they wanted. So I resigned, and the ad hoc committee is doing very well without me.

I can fill you in on 644 Group. They are having a workshop to help openers and chairpeople. Also from the 644 Group, on November 19 there will be a Sponsorship Workshop. A couple friends from Great Falls will join our own district secretary for an afternoon talking about sponsorship. Questions from the audience are encouraged, & there will be food.

Overall, groups in District 11 are doing well and looking to strengthen the traditions among themselves. We have discussed printing costs, explored the idea of going digital, followed in the footsteps of other Montana districts and offered to scholarship eager GSRs and help them better serve their homegroups. We invited our Delegate both years of this rotation, and people were grateful for the opportunity to hear first hand what going to GSO was really like. Workshop: Right of Decision – Trusting Our Trusted Servants

Conducted by Mark S., Panel 44 Delegate

Election Orientation and Delegate Nominations

Area Advisor Paul L. provided an orientation in preparation for the election of Area 40's officers and chairs during the next rotation.

AREA 40 ELECTION ORIENTATION FALL 2022

Howdy, I'm an alcoholic and my name is Paul. I am the current Area 40 Advisor. According to the 2022 Spring Revision of the Area 40 Policy and Procedures, on page 5; my duty today is to "conduct the election of Area 40 committee members." for the 2023-2024 service rotation. The Area 40 committee members that will be elected today are the Delegate, Area Chair, Secretary, Treasurer and all of the rotating committee chairs.

In order to do this we need to look at how our Policies and Procedures for Area 40 tell us who is eligible to serve as a Delegate and as the Area Chair who also serves as the Alternate Delegate for Area 40. It also states the suggested recommendations for the Area Secretary and Treasurer. The Policy and Procedures further tells us the specific voting procedure that we will use for electing our Area Delegate, Area Chair/Alternate Delegate, the Secretary and the Treasurer. This procedure is the *Third Legacy Procedure*.

After electing these four officers we will then elect our eight rotating committee chairs. These positions are voted on by a simple majority. I will ask eligible voters to raise their hands and the vote counters will count the hands raised and report the number to myself and the secretary. We will ask the candidates to step out of the room during voting.

The *Area 40 Service Guidelines and Qualifications* for Area 40 Trusted Servants are described on pages 8 and 9 in the P&P. In the pages following are the most current Job Description for each of these positions. Very good information to have when you are trying to decide if you are willing to stand for a position before you pray for guidance.

To get more information about the duties and responsibilities of the Delegate you can go to the A.A. Service Manual where all of Chapter 5 describes what a Delegate does, what their duties and responsibilities are and the qualifications personally they should have. On page 37 of the most recent Service Manual, the red one, there is an excerpt of an article by Bill W. On "Leadership in A.A.: Ever a Vital Need." Bill tells us "Our leaders do not drive by mandate: they lead by example." In effect we are saying to them, "Act for us, but don't boss us...."

The previous chapter in the Service Manual, chapter 4, talks about the Area Committee. It describes the qualifications and duties of members of the Area Committee; the Area Chair, Secretary, Treasurer and the various committee chairs.

So, for being a pretty unstructured lot sometimes bordering on anarchy we do have some structure, guidelines, duties and suggested qualifications. It's not like we just pull names out of a hat, that comes later.

From the 12 & 12 about Tradition 1, on page 131 it talks about how:

On anvils of experience, the structure of our Society was hammered out.

That structure is what is described in the *Area 40 Policies and Procedures* and in *The A.A.*Service Manual.

With all of that being said, the first thing we need to do is review who is eligible to stand for Delegate of Area 40. The qualifications specific for the position of Area Delegate are:

- A minimum of six years of sobriety (it doesn't say six years of recent or continuous sobriety, but I think we know what it means.)
- A candidate for delegate is required to have already served as an Area 40 Committee Member.
- Time available, not only for the week-long Conference meeting in April but for all the efforts needed before and after the Conference.
- The ability to make and take suggestions and criticisms too.
- Experience in chairing a meeting.

Someone who is serving or has served as a DCM, an Area Chair, Secretary or Treasurer, or as a committee chair would most likely meet these qualifications and be eligible to serve as Delegate or Alternate Delegate. Area 40 accepts the qualifications from another area.

The other thing is...You must be present to play (either live or on Zoom.)

We (meaning Mike and ???) have compiled a list of eligible candidates for Delegate that will be placed up on the screen. I will then call out the names to ask if you are willing to serve as a candidate for Delegate for Area 40. That individual would then say: "Why yes, I'd be delighted" or "No, not at this time" and their name will be crossed off the list.

One of the things I would like to pass on, that was pointed out to me, is that if you are considering standing for Area Chair, then you should also stand for Area Delegate. If selected as Area Chair you are also the Alternate Delegate and must be willing and able to step into that position if necessary.

After this list is made I will ask each of the candidates for Delegate to come to one of the microphones on the floor to give their Date of Sobriety and to state their service history. When this is completed we will continue on with our Assembly.

When we return after lunch and after you've had time to look up some of these things I've pointed out in The A.A. Service Manual & the Area 40 Policy and Procedures (which you can access through the aa-montana.org website) we will vote for the next Area 40 Delegate using the Third Legacy Procedure I mentioned earlier.

After the Delegate is elected we will review the list again (sound familiar?) to identify all of the willing candidates for the Area Chair/Alternate Delegate. They will come to the microphone and give their Date of Sobriety and state their service history. We will then have a Third Legacy vote.

For the Secretary and the Treasurer we will ask for individuals who are willing to stand. The suggested length of sobriety for these positions are five years. They may be self-nominated or nominated by a friend. We will ask them to come to the microphone and ask for their Date of Sobriety and their service history. Each of these elections will be performed using the Third Legacy Procedure.

To start out with we need to identify who the voting members are. Voting members of this Assembly are;

- Delegate
- Area Chair/Alternate Delegate
- Area Officers
- District Committee members
- General Service Representatives
- Standing Committee Chairs
- Triangle Editor
- Archivist
- Area Advisor
- Webmaster
- Bridging the Gap Chair
- Hotline Chair

Any person chosen to serve as an Alternate GSR or DCM may be a voting member if the primary GSR or DCM is not able to be present at the Area Assembly.

A quorum of voting members is established at each Area Assembly. A quorum shall be two-thirds of the registered voters. As long as the total votes on any ballot is at least a quorum, two-thirds of the actual votes constitutes substantial unanimity and more than one-half constitutes a simple majority.

This Third Legacy Procedure that I've been talking about is unique to A.A. It is a special type of electoral procedure used primarily for the election of delegates and for regional and at-large trustees at the conference level.

In Area 40 we use the Third Legacy Procedure to also elect the Area Chair/Alternate Delegate, the Secretary, and the Treasurer.

In practice, it has proved highly successful in eliminating the influence of factions or parties that seem to thrive on most political scenes. The railroading of a candidate for election is made difficult, if not impossible, since voters have a wide selection of candidates to choose from. More importantly, a second-place candidate who may be extremely well qualified but without early popular support is encouraged to stay in the balloting rather than withdraw. You can read up on the procedure for voting on pages 110 and 111 in the latest Service Manual or in Chapter One in earlier Service Manuals.

For the Third Legacy Procedure and for the voters in the room we will use a written ballot. Zoom voters will follow a different procedure.

THIRD LEGACY PROCEDURE:

Ballots and pencils will be distributed, you cast your vote and it will be collected by the vote collectors I've chosen that are scattered around the room. Those votes will be brought up to me and I will retrieve the ballots, calling out each recipient which will then be marked on the screen. I will pass the ballot off to the secretary who will verify that I have called out the correct name

and will mark it down on a list of her own. The first candidate to receive two-thirds of the total vote is elected.

If someone receives two-thirds of the total vote, they are elected.

If no candidate receives two-thirds of the total vote on the first ballot then the whole process is repeated for ballot number 2. (We may use different colored paper for the different ballots.)

If no candidate receives two-thirds of the total vote on the 2nd ballot then we will go to a 3rd ballot. For this ballot we drop any candidate that has less than one-fifth of the total votes. We keep the top candidate and all of the other runner-ups. If there is a tie for a runner-up we keep both candidates. If someone receives two-thirds of the total vote, they are elected.

If someone receives two-thirds of the total vote, they are elected.

If no candidate receives two-thirds of the total vote on the 3rd ballot we go to a 4th ballot. For this ballot the candidate with the smallest total is automatically withdrawn, except that the top two candidates remain. If there is a tie for second place all tied second place candidates remain. If someone receives two-thirds of the total vote, they are elected.

If no one is elected on the 4th ballot I would then ask for a motion, and a second to conduct a fifth and final ballot. If this motion passes by a simple majority with a show of hands we will go on to a fifth and final ballot.

If this motion is **defeated**, balloting is over and the choice is made by lot; "going to the hat." This is where the Hat part comes in....

If the motion **passes** we go on to the fifth and final ballot with the same candidates as on the 4th ballot. If someone receives two-thirds of the total vote, they are elected. If no candidate has two-thirds of the vote we immediately "Go to the hat."

After electing these four officers we will than elect our rotating committee chairs. These positions are voted on by a simple majority.

There are 8 standing committee chairs that will be elected at this Assembly. Some of the general qualifications for these positions are (a complete list can be found on p 9 in Area 40 Policies & Procedures); four years of continuous sobriety, interest in providing leadership in Area 40 service structure, sufficient time available to fulfill the responsibilities of of the position and previous service experience as a DCM, GSR, District Officer or Committee Chair or in some other capacity as a member of a committee.

We will vote on them in reverse alphabetical order.

These committees and their alternate assignments are:

TREATMENT FACILITIES / AGENDA
PUBLIC INFORMATION / REPORT & CHARTER / WEBMASTER / HOTLINE
LITERATURE
HOTLINE or TRIANGLE EDITOR
GRAPEVINE / POLICY & ADMISSIONS (GSC)
CORRECTIONS / INTERNATIONAL CONVENTIONS
COOPERATION WITH THE PROFESSIONAL COMMUNITY / TRUSTEES
ARCHIVES / AREA 40 STRUCTURE & POLICY

I will ask who is willing to stand for each of these Area Committee Chair positions. You may self nominate or have a friend nominate you. You will then be asked to come to the microphone and give your date of sobriety and your service history. With a simple majority election I will ask eligible voters to raise their hands and the vote counters will count the hands raised and report the number to myself and the secretary. We will ask the candidates to step out of the room during voting. The winner will be the one with a simple majority of all votes cast, more than fifty percent.

With all of that out of the way.....

- District 81 has housing for their archives at the 4th D Alano Club and they have an active and enthusiastic chair who is modernizing how some of their materials are stored.
- District 61 is working on getting digital media like cassette tapes to thumb drives, etc.
- Reminder the Area 40 Archives repository has room for district archival materials, no districts have taken Earl up on this at this time.

Structure and Policy – Area 40

A. Review Spring 2022 Assembly Evaluation Report:

I thoroughly reviewed this report and the highlights included:

- 41 people filled out the survey
- Of those who participated in the survey: 65% did so in person and the other 35% were Virtual

The survey asked many specific questions related to the new form of assembly: 75% of those who attended in person traveled there with 1 or more people. Respondents who attended in person spent an average of \$350 to attend the assembly. Many reported concerns about aspects of the venue including room cleanliness and maintenance. Those who attended in person were grateful to have done so.

The only concerns of virtual respondents were not being able to see more of the room in the main session and some audio difficulties in breakout, although many were grateful to be able to attend this way and thought that it "went off without a hitch."

B. Consider revising and updating the Area 40 Secretary job description under G11.5 of the Area 40 Policies and Procedures Manual

a. After discussion our committee appreciated the thoroughness of the person who brought this forth. The committee considered if it is within their means to make necessary changes

without bringing something that does not suggest a structural change to the body at large. Take no action as this proposal is something procedural that can just be done between the Archivist and Secretary to reflect the current status quo of the position without consulting this body.

C. Consider revising and updating the Area 40 Bridging the Gap and Alternate Bridging the Gap job descriptions to reflect necessary qualifications and current practices

After careful consideration of the agenda proposal form and a desire to honor the current functionality of Bridging the Gap, the Archives committee recommends the following:

Motion: Update the Bridging the Gap (BTG) and Alternate BTG Chairperson job descriptions to reflect necessary qualifications and current practices. The additions ought to include:

- To section G17.1 of policies and procedures manual, add the verbiage:
 - Written and oral communication skills.
 - Organizational skills for leading committee meetings, coordinating workshops, and keeping good records that will be provided to district BTG chairs and the Area Archivist.
 - Access to a computer with internet connectivity and the ability to readily monitor correspondence with volunteers and facilities.
 - Knowledge of computer software and videotelephony software, such as word-processing programs and Zoom, and the ability to use email.

To Q17.1A:

• Since the Alt BTG Chair acquires familiarity with BTG Chair duties to implement them as needed in the event that the BTG Chair resigns or becomes unable to serve, a candidate for Alt BTG Chair should also meet the qualifications for the BTG Chair as described above.

D. Consider creating a standalone Area 40 Hotline Chair position with its own committee After considering ideas such as the structure and purpose of the committee, should this be a paid position, the effectiveness of the hotline, being able to staff and pay for the committee members, as well as the newness of the Hotline chair position, the Archives committee decided to take no action at this time.

E. Consider creating a formal Area 40 Technology Committee with two Committee Co-Chairs

After considering the following ideas: the need for the tech committee to serve a variety of needs in our area, yet conversely some of the complexities around storage, scheduling and attendance that might arise, the Archives committee decided to bring the following motion forward:

Motion: That Area 40 formally creates a Technology Committee composed of two Co-Chairs and adopts the proposed job description and \$2900 2023 budget.

F. Consider eliminating the Area 40 Triangle and the Area 40 Triangle Editor position The committee considered that the Triangle is a valuable resource to rural groups, etc, especially done well, but that the area has done what it good to make this publication work for several years now and thus proposed:

Motion: That Area 40 discontinues the Area 40 Triangle and the Area 40 Triangle Editor position.

Archivist Report

Good day Area 40,

Two thousand twenty two has been a very interesting year, so far. I was invited to the Area 40 Spring Round-up in Helena and had a wonderful time in person with a lot of old friends, some new friends and a lot of fun and fellowship. It was great to be back among my people once again. A sudden infection and quick surgery kept me from fulfilling an obligation to come to the Founders Day Celebration, here in Gt. Falls with District 41. This was the first one I had miss since I have been Archivist. Hopefully, I will be able to attend next year, if District 41 would like for me to. I was invited to District 72 as a guest of the Archives committee and the Special Events committee to do a workshop about Group Histories and Archival Interviews. It was well attended with several GSR's and District Archive Committee members. I spoke about the interview process and did an abbreviated interview with Eleanor W., who was one of the early members of the "Sixth Chapter" group in Bozeman. She spoke of early members and talked of the fun times and meetings that were held in the little clubhouse out on Huffine Lane. The little clubhouse is no longer there and Huffine lane is no longer out. She shared the names of several of the early members who were involved in the start of AA in Bozeman. Some are still around and have been put on my list to contact for interviews. Eleanor has 38 years of sobriety. It was a fun afternoon and I think everyone left very enthusiastic about archives. Betty M. asked me to conduct the District Elections in District 72 last month. It was an honor to participate in this way and I believe that the trusted servants selected will be good leaders for the AA community of District 72. That is all the traveling that I have done as Area Archivist so far this year. I will be heading to the Round-up in Kalispell in two weekends with a display and to do a presentation.

Speaking of Group Histories, I would like for everyone to visit the Archives table in the back of the meeting room. There is a letters from the Archivist in the mid 80's regarding the possibility of having a history book about early AA in Montana. There is another letter from a Delegate in 1999 to the Area Archivist at that time. This is an endeavor that has been addressed every so often and I am going to touch on it again. We have around three and one-half months left in this rotation. I would like to ask for your assistance in creating group histories for your home groups. Go back to your groups, have coffee with a long-timer who has some knowledge about the early days of your group. Take a few notes or a recording and write out a short story of how your group got started. Share it with other homegroup members and see if there is anything they can add. I'm betting that you will develop a new appreciation for your group. Please make copies for your group members, your District Archives and forward a copy on to me. I will collect and share what I receive at the events I am asked to attend and with anyone who would like to have copies. I don't necessarily want to publish a book, but I would like to have as many histories to share with Area 40 as possible. Let's try to do this before you rotate.

I am happy to say that I have updated the Policy and Procedures document and the Past Actions Document, and don't have to make an amends in this report, although I just finished the past actions a few evenings ago. The repository is serving us very well. There is less construction in the neighborhood and the dust impact has decreased immensely. I have asked Jack, the sound technician with us this weekend, to take an archival tape and try to "clean it up" for us. I am hopeful this will improve the quality of the recording and will give us a resource for retrieving historical interviews that have been damaged or were of poor quality to begin with. This is not a frequent occurrence but it does happen from time to time.

The only document contribution that I have received this year was from Sharon S. I have not been through it completely yet, but a quick glance of the contents showed a lot of documents from the early nineties, some incorporation documents for Area 40, Inc., paperwork for our tax exempt status as well as a complete set of notes from the 2001 West Central Regional Service Conference that was held in Bozeman. Sharon has been a very active trusted servant and leader in Area 40. She served at the district level, was the Area Secretary, Triangle Editor, Area Chair, and a Panel 63 Delegate. She is a wealth of information and has made several contributions to the Archives. I am grateful for her support of the Archives.

This is a very exciting weekend in Area 40 with new servants being selected and new service opportunities. As we discuss rotation this weekend, if you have accumulated documents, electronic or hard copies, that will not be passed to the successors of your position, please don't just toss them. I would be happy to take any materials that are no longer needed or wanted as possible additions to the Archives. Thank you for your consideration.

I would be happy to travel to your Group or District to share some of the history of Area 40. Please contact me with any events or activities that your District has. I am very proud of our Archives collection and would like the opportunity to share it with the fellowship.

Consider creating an Ad-Hoc Committee to determine if Area 40 should adopt more detailed guidelines for the Area 40 website and, if so, to recommend to the Area such guidelines Describe the proposal: This is a proposal that an ad hoc committee be formed in order to determine whether Area 40 should adopt more detailed guidelines for the Area 40 website and, if

so, to recommend to the Area such guidelines as may be appropriate. The ad hoc committee would review any relevant guidance from GSO regarding service structure websites, research guidelines that have been adopted by other Areas and Districts, consider what guidelines it may be appropriate for Area 40 to adopt, and present an agenda item at the Spring 2023 Area Assembly regarding whether Area 40 should adopt more detailed website guidelines and, if so, what guidelines the Area should consider.

- (2) List the proposal benefits: Currently, Area 40's website guidelines do not express an informed group conscience regarding what content should or should not be posted on the Area 40 website. Many other Areas and Districts have published guidelines that assist their trusted servants in determining whether certain material is or is not permissible. Where such guidelines are in use, they are based on the group conscience of the service structure. Without such guidance, the Area 40 Webmaster has to make difficult decisions regarding questions such as whether to post event flyers that arguably sound like fundraising (containing references to a 50/50 raffle or an auction, for example) or whether to post flyers about fellowship-only events (containing no reference to an AA meeting). This proposal does not suggest whether we should or should not post such content. It suggests only that it will benefit the Area to have the answers to those questions come from an informed group conscience.
- (3) Cost Estimate: An ad hoc committee may incur administrative expenses, such as copying fees for a final, written report. This cost is estimated at less than \$30.
- (4) List additional background material(s) included with the proposal: Copies of the existing Area 40 Website Guidelines and several samples of website guidelines currently in use in other Areas and Districts are attached. These are included merely to provide examples and no suggestion is made that Area 40 adopt any or all of the sample guidelines. Whether any of the content in the samples may be appropriate for Area 40 will be a matter for the ad hoc committee to research, consider, and discuss.
- (5) How the proposal originated: It was noticed during this rotation that the Webmaster serves a "gatekeeping" function in terms of the content that is posted on the Area 40 website. While the 12 Traditions provide clear guidance on some content-related questions (no use of last names and no affiliation, for example), other questions arise to which the answers are less clear and on which guidance would be helpful to both the Area and the Webmaster. It will also be helpful to the members of the Area to have clear and consistent guidance on what kinds of events and event flyers can be posted on the Area website.
- (6) Why the proposal should be considered: It is important that limits on the content to be posted on our Area 40 website be rooted in an informed group conscience from the Area. (7) Final comments: Thank you for considering this proposal. Yours in Service, Lisa C., Area 40 Secretary Panel 71

Covid caused delays in all areas of life, including the ability to gather to honor our loved ones who passed. It was a beautiful experience to share that time with my niece who graduated from high school the day before the service, despite having tragically lost her father at such a young age. She is an incredible young woman.

In June, my AA home group moved to a new and wonderful location. We are absolutely blessed with a beautiful and safe space to help carry the message to still suffering alcoholics. The Recovery Group in Billings is now located at 131 Moore Lane. Join us on any one of five nights a week--Monday through Friday.

In July, I attended our annual sponsorship retreat and was grateful to spend a weekend with my sponsor and sisters in sponsorship. The theme was meditation and it was awesome.

In August, I attended the Beartooth Mountain Conference at Luccock Camp outside of Livingston. It was beautiful as always ... with incredible speakers and fellowship.

Just one week later ... on August 14 ... I celebrated 10 years of continuous sobriety. Double digits. An entire decade. That is absolutely unbelievable to me. The fact that a woman like me can stay sober that long is a true testament to the power of this sacred program. Just two days after my sobriety birthday, my promotion at work went into effect. I am unable to keep a job, let alone get promoted, without Alcoholics Anonymous.

It is not lost on me that I've been involved in District and Area Service for more than half the time I've been sober. I hear in meetings that "meeting makers make it." While I do not necessarily disagree with that sentiment, I also know that this alcoholic will not stay sober on meetings alone. I need to be fully engaged in all three sides of the Triangle. Unity, Recovery, and Service. Showing up for service has been the ego-deflating, spiritual sandpaper that I did not know I needed. I encourage all of you to fully participate in service in any way you're able. I find it just requires a little willingness to say YES and show up.

Being your Area 40 Hotline Chair has been one of the more humbling and rewarding service positions I've held. I had no idea what I was getting myself into ... dealing with a telephone hotline during a global pandemic. The call volume was absolutely overwhelming at times. Thankfully there were some incredible district hotline chairs who showed up BIG TIME to help me make sure all those calls were answered. You are my heroes.

The Hotline is active and all calls continue to be answered. The call volume has decreased significantly and is much more manageable than it was in 2020. Please let me know if you have any questions!

I know by now you are sick of me. But there is good news! Someone else will be serving in this position in just a few short months. I wish the very best to all the new Hotline Chairs during this next rotation, both at the District and Area levels. I am here to help you if you want or need my assistance.

Thank you, Area 40 Alcoholics Anonymous, for allowing me to serve and for giving me a big, full, beautiful, sober life.

GSR Breakout (Ask-It Basket and Sharing)

Connie R., Are 40 Delegate, moderated a GSR Breakout Session.

GSR BREAKOUT

Question 1) We have a man stalking newer women, what can we do?

- Don't confront in group pull him aside and talk 1 on 1
- We have a right to go to AA and feel safe
- We need to watch out for the women
- But not all men are predators
- Safety cards available @bookstore (Billings) or at AA.org
- Experienced a group of men took the man aside and spoke to him. Showed that the group were keeping the women safe.
- Safety card can be printed bigger and post at the group

Question 2) Does Pink Can still take contributions?

- Depends on the group. Money goes to district or area. This is a group conscience decision
- What is Pink Can
 - Pink can started in OK. The idea is to drop in spar change to get books into jails and prisons.
- One group collects for jails but also uses it to send books to MCDC.
- Again the groups are autonomous and use the money the way they want.

Question 3) Do you allow non-alcoholics to speak at open meetings?

- Groups are autonomous and make their own decision.
 - Example: some groups have an open meeting with Al Anon allowed to share as long as they share about alcoholism
 - Example: welcomes them to attend but not allowed to share.
 - Maybe a newcomer isn't sure of whether they are alcoholic or not.
 - Example: open meeting has a spiritual leader and Al Anon participates
 - Example: Al Anon attending AA found they identified with AA and joined AA
 - Example: Nursing students—we explained to them that they are visitors, helped them understand anonymity and that they could not share.
- What about use of conference approved literature only?
 - Suggested that look at the material. Does it conflict with the message of AA? Does it show affiliation with other organizations? Most important do no harm to AA
- Use the Blue Card which explains what an open meeting is and what a closed

meeting is.

Question 4) What happens when non-AA literature is red?

- Gives newcomers the mistaken assumption that non-AA literature is AA literature.
- Gives mixed message. Could do harm.
- Spouse works own separate program. They are careful to keep the two programs separate
- Suggested that a group have policies and procedures. Having in writing as a principle, what is the group's format, rules, etc. In a document rather than relying on personalities
- Drugs—small community accepts addicts especially when NA meeting is unavailable.
- Page 77 in Big Book states our primary purpose is to be of maximum service to God and to his people. We can take the suffering by the hand and show them where to get help.
- "Drug is a drug is a drug" can be dangerous to an addict receiving help from AA.

Question 5) Why is the Lord's Prayer OK but have to only use conference approved literature in the meeting.

- Because that is the way it has been done.
- Groups are autonomous and can close any way that they would like to.
- Original groups did not say the Lord's Prayer. When Bill visited a group in CA that was the first time he had heard the meeting close with the Lord's Prayer. Lord's Prayer started on the West Coast.

Question 6) Is it Okay to discuss group conscience issues at a regular meeting (as opposed to a business meeting)?

- AA meeting is 12 step work for the still suffering alcoholic
- Have guidelines for the chair and stick to the process to avoid crossover into other topics.
- Business meetings are for other issues.

Question 6) How often do groups have group conscience meetings, and how long do they last?

- Depends on the group some meet monthly, quarterly or yearly.
- One group's GSR summarized the Agenda items and provided to the groups
- In November there will be an orientation for new service positions on how to write a report; how to provide information to your group.

DCM Breakout (Ask-It Basket & Sharing)

Mike S., Panel 44 Delegate, moderated a DCM Breakout Session. Participant Trevor F. provided the following notes.

(roll call was not taken, as we are not voting)

How do you deal with a vital committee chair left vacant for multiple months?

- District 11: The alternate DCM takes over in this instance. Also, take an active role in going to groups to discuss the opening and asking specific individuals if they are willing to fulfill the position.
- District 72: In some cases, it stays vacant
- District 61: It stays vacant until someone is willing to stand for it.
- District 93: It stays vacant
- District 91: there isn't a continuity when someone finally steps into the position, so it would be helpful to facilitate the outgoing chair to help the DCM understand the position. When the position gets filled, the DCM can offer that person pertinent information.
- District 81: print out the page of the job qualification, duties, and responsibilities and disperse this information to the group.
- District 42: bring qualified people to the district meeting and nominate them or "railroad" them into the position.

What is the relationship between districts and intergroups in Montana?

- Do we *need* intergroups in Montana? Do we have enough groups to make intergroups feasible? Intergroups seem more applicable to major metropolitan areas.
- District 91 has an intergroup. District 11 and District 12 have a joint intergroup.
- District 91 DCM read from the aa website regarding intergroups. They are *not* part of the decision-making process in the AA service organization. In Minneapolis, the intergroup had an office to buy medallions, pamphlets, and books in multiple languages. This office had *paid* staff to facilitate these services.
 - i. There seems to be an adversarial relationship between intergroup and district; not sure what happened in the past or why this is, but it seems to be a dysfunctional relationship that has existed for some time.
 - ii. A former delegate discussed the fact that the flathead intergroup used to have control of most of the service.
- District 11 and District 12 discussed the fact that dysfunction began from circumstances that occurred in the 1990s. This intergroup still has a brick-and-mortar store that is open for only 4 hours on Saturday. There were/are issues with service obligations being met (updating schedules). The people in this intergroup are volunteers.

How long does a group have to be in existence before being listed on the district's schedule?

• District 72: This is the DCM's job to help the group provide the appropriate

forms.

- District 93: Start with the information that you send to New York; this information comes to the delegate.
- District 11: One group needed the group number from New York to qualify for financial purposes. However, they are a group if they say they are a group. No reason to wait.
- District 91: intergroup has a requirement for a group to exist for 6 months before they can be listed on the printed schedule. This ended up being helpful, because a group was created during covid, and they didn't have a legit address. They will put you on the internet meeting list, as this can be updated immediately and doesn't have to go through a printing process.

Why isn't AA growing in AA and Canada?

- There are so many other 12-step programs and treatment facilities.
- Cross-addiction seems to be a factor as well; there are more risks today.
- This seems to be an issue impacting organizations outside of AA as well.
- The breakdown of stigma around mental illness has provided other opportunities to heal.
- Possibility that treatment facilities have helped binge drinks stop in time.

Area 40 Bridging The Gap Committee Mission Statement:

The purpose of the Temporary Contact Program is to "Bridge the Gap" between A.A. meetings in treatment facilities, hospitals, prisons, and jails and the first A.A. meetings upon release in the home community. Volunteer members of Alcoholics Anonymous usually acting in pairs, meet the client or inmate after release and accompany them to their first A.A. meeting. Like all 12th Step work, this is never paid for. It is the goal of Area 40 - Montana Bridging the Gap Committee, Treatment Facilities Committee, and Corrections Committee to make this vital 12th Step work possible statewide.



BTG Chair Report Fall 2022

Greetings Area 40, my name is Jessica W. and I am currently serving as your Area 40 BTG Chair. Since the spring assembly I began with reviewing the General Guidelines for Area 40 Trusted Servants, General Qualifications for Area 40 Trusted Servants, and the Bridging the Gap Chair Duties and Qualifications (Area 40 Policy and Procedures) to prepare to meet with potential Alt. BTG Chair candidates. As announced to our BTG committee and then at the spring assembly, Penny R., regretfully needed to step down as Area 40 Alt. BTG chair after serving for three years. I gratefully connected with three members from across our state. I created a spreadsheet with duties, guidelines, and qualifications from our Policy and Procedures so that I could create an unbiased way to select a candidate to ultimately present to the Treatment Committee. I felt so grateful to all the candidates who were willing to serve Alcoholics Anonymous in this capacity.

After a thoughtful process and after meeting with my candidate face to face, I first submitted my choice to the BTG committee meeting on August 31*. For all who participated, there was a substantial unanimity to submit my choice. This weekend I am excited to submit my choice of BTG Alt. Chair Sean R., to the Treatment Committee for final approval. Sean R. served on our Area BTG Committee (2019-2021) while he served as District 91 BTG. Finance Chair/Treasurer Report

Good morning! My name is Jake and I'm an alcoholic, currently serving as your Area 40 Treasurer.

It was my pleasure to present some Area 40 financial highlights yesterday morning. We are nearing the end of a rotation for most and my hope is that we have learned a lot, but like everything else in AA, you can't fix what you can't change.

Since the Spring Assembly, I have continued to keep Area 40 accounts current and deposit any received contributions. Though I cannot mail an acknowledgment to each contributor, I can look up the records if you want to know your group's donations. A few groups have contacted me for the Bozeman address when their mail was returned to them. This continues to be an issue for some. The forwarding has expired, so expect any contributions not mailed to the current address to be returned.

Please keep your areas informed. The current address will always be on the Area 40 website. If I accomplish nothing else, I would like all contributions to get deposited. Sadly, this address will not be changing anytime in the near future. You are stuck with me. Or are you?

The Area 40 Treasurer's job is primarily a quiet existence. I do not interact directly unless there is an issue. It requires some technical knowledge, a bit of bookkeeping, some organization, and a little time. Please consider the gifts sobriety has provided and step up to serve where and when you are able. Alcoholics generally thrive and you will too.

I hope everyone takes the time to review the latest financial reports. They are always posted monthly to the Area 40 website. We ended August a bit light on income and are gaining momentum on expenses, with a net income of -\$6,034. Our expenses are over budget YTD, however, those figures do include some discretionary spending to support a virtual component of Assembly in the Spring and an increase in the cost of travel expenses. Returning to an in-person assembly will take some calibration to ensure we are back on track from a budget perspective. We are current on our annual rent for the archives storage which runs on a rolling 13-month schedule. As I previously mentioned, our expenses are increasing, and will continue, to go up with our income continuing to hold steady. If the Area is to meet budgeted expenses, contributions will need to continue to keep pace with what services we've asked the Area to provide. However, I would like to note, that we have a substantial cushion of cash on hand and in no way need to be alarmed.

Because of inflation, a dollar in the basket today is only worth 61 cents compared to 20 years ago; 47 cents compared to 30 years ago. This is shocking, more so because when I sobered up, a dollar was worth roughly 42% more than a dollar today and you could smoke in meetings. The

basket is where money and spirituality mix. So, the question is, what is the monetary value of my sobriety? I participate actively in my home group because of my ability to influence how that money is spent. As I can afford to, I do put in a little extra for those who are unable or for the times I am without cash. My homegroup does have a Venmo account which makes our virtual participants able to contribute as well as those who shamefully forgot to bring cash. If we want A.A. to be here for the next generation, we need to keep supporting our 12th-Step work at all levels of service. For the first time, I am aware of, GSO is fully self-supporting. Let's keep it up.

We are deadly serious about our work but we should not forget the levity in it all. Please take it seriously if you are considering stepping up to serve. We need the best possible option for all levels of service.

Service work has played a massive role in keeping me honest, humble, keeps me taking action even when I don't feel like it, and most importantly keeping me glued into the fabric of Alcoholics Anonymous. I am truly grateful for you allowing me to serve and am truly humbled by the experience of serving Area 40 as your Corrections Chair.

I would like to start off by thanking all of the District Chairs, DCMs, and everyone doing corrections work around the Area. I would especially like to give a shout out to Gary E., the Montana State Prison Liaison for all the work he has been doing keeping in contact with the prison and coordinating volunteers to go into the weekly Saturday meeting at the prison. 




Income & Expense vs. Budget (2022 through Sept 1st)





YTD Expenses by Committee/Project









Income YTD - 8/31/2022



- The Area Treasurer is allowed to advance funds for approved travel and lodging expenses to events for Area 40 Representatives.


