Minority opinion: In the spirit of Concept V, after each vote, members who voted on the side that did not prevail are given an opportunity to speak. Not all members may state a minority opinion, who can? d) Reconsideration: A member who voted with the prevailing side may move to reconsider a vote (usually because of a minority opinion). Only a simple majority is required. If the majority votes to reconsider, full debate, pro, and con, is resumed (members are encouraged to limit discussion to new considerations) No action may be reconsidered twice. Not all members may make a motion to reconsider, who can

General guidelines: People wishing to speak line up at the microphones and the chair will call on them in order. Introduce yourself at the microphone (each time you speak): name, service position, district. Each person may speak for 3 minutes (hard stop when the time goes off) Everyone who wishes to speak will have a turn before anyone may speak for a second time Full discussion should take place before the vote. Everyone is entitled to, and should, express their opinion. However, if it has already been stated, it is not necessary to repeat it. Everyone is asked to refrain from clapping when people share, pro and con, in order to NOT discourage those who may have opposing opinions or facts

- -Listen with an open mind, particularly to those who speak on the other side of an issue from you, and remember that the loudest or most repetitive voice is not always right!
- -Tabling a motion: postpones discussion to a later time during the assembly Must be made without comment Requires a second Not debatable Only simple majority to pass

> Assembly Welcome, Saturday Morning- Kacie N

Good morning, everyone! My name is Kacie and I'm an alcoholic. I have the privilege of serving as your Area 40 Montana Delegate. Thank you all so much for being here today.

Would all of you who are attending Assembly for the first time, please stand? Those of you online attending for the first time, please raise your virtual hand.

Welcome! We are so glad to have you here. Look around at the people who are still seated or whose hands are not raised. At one point it was also their first assembly ever. They've been where you are and would be happy to answer any questions you may have. Those of you still seated or without your hand raised, please take time during the weekend to reach out, welcome, and offer your experience to any of our first-time attendees. Please have a seat and lower your hands.

Will all DCMs stand, please? Thank you for your service and for taking on such an important leadership and communication role in the service triangle. I am so grateful you are there to help me communicate from the General Service Office, Board, and Conference at the bottom of the triangle back up to the GSRs and groups at the top of the triangle. After our secretary, Lynne does roll call, we will ask DCMs to complete the sign-in sheet for their districts. Those voting members who are attending virtually should let Alex M know that they are voting members. GSRs and DCMs are the only voting members of the district. Alternate GSRs will only have a vote if their GSR is not present virtually or in person. Alternate DCMs will only have a vote if their DCM is not present virtually or in person. DCMs, please identify your District Reps who have been appointed to be a member of one of the Area Standing Committees. These appointed District Reps are voting members of the Area Standing Committee only and do not have a vote on the floor of the general assembly unless they are also a GSR.

The DCMs will return their sign-in sheets to Lynne by the first break. The information necessary to establish a quorum, which is two-thirds of the eligible voters, is gathered from these sign-in sheets. With very few exceptions, votes taken this weekend are decided by "substantial unanimity." What that means is that as long as we have a quorum (two-thirds of the registered voters) any item we vote on must receive two-thirds of the counted vote in order to pass. Lisa will explain this in more detail as it comes up.

Will all Past Delegates stand, please? Thank you for taking your turn in each service position you've held. Thank you for the sacrifice and service you've given to Area 40 and the AA fellowship as a Delegate. Thank you for being present and leading by example.

Will all past Trustees please stand?

Our responsibility this weekend is to establish and gather the informed group conscience of Area 40 regarding the items on our agenda. Lisa, our Area Chair and Alternate Delegate, will be facilitating the assembly according to a loose interpretation of Robert's Rule of Order, an interpretation that she will explain as she goes, and of which, she has the final say. In other words, when it comes time to decide if we're done talking about something, "Lisa makes the call."

Lisa has prepared this weekend's agenda and has decided the order in which we will conduct our business. Soon we will start to hear reports from our Area Officers, Area Chairs, and DCMs. At 9:15 we will stop the reports, take a short break, and convene Standing Committee meetings in their respective breakout rooms. Anyone can attend the committee meetings, but remember, only the Committee Chair, appointed DCMs, and District Reps are eligible to vote in committee. If you choose not to attend a committee meeting, Past Delegates Sharon S. and Gerry R. will be conducting workshops here in this main room. After the committee breakouts and workshop conclude, we will break for lunch.

This is a special Assembly for two different reasons. One is that we will be conducting an Area Inventory. This is a unique opportunity that does not happen every rotation and you do not have to be a voting member to participate. Everyone has an equal voice during this process. Our Area Advisor, Connie R., will be sharing a more thorough orientation on this process when we return from lunch. The second reason is that this weekend we have the opportunity to elect Area 40's nominee for West Central Regional Trustee. Later this afternoon, I will share a brief description of what a Regional Trustee does and then we will follow the Third Legacy procedure to select our candidate.

This is certain to be a very productive and exciting weekend!

We have a lot of Area 40 business to discuss and vote on this weekend. If during their discussions, a committee decides to bring an item to the floor to be voted on by the entire Assembly, it will come to the floor in the form of a Recommendation, which is considered a made and seconded motion. Lisa will facilitate discussion on all items. There will be 3 microphones: two here on the assembly floor and the 3rd for virtual comments. If you wish to speak, please get in line behind the mic or raise your hand. You will have 3 minutes to express your opinion. Once your 3 minutes have been reached Lynne will notify us by the clang of the cowbell. (Ask Lynne to ring it.) If Lisa feels that the comments are becoming repetitive, she may stop the discussion. Votes taken on Area 40 items will require that we have a quorum of eligible voters. Remember that for an item to pass it must have a two-thirds majority of the votes cast.

At 9:00 tonight, there will be two breakout sessions. One for GSRs here in the Mansfield Room and one for DCMs across the hall in the Russel Room. There are Ask-It Baskets online and in the back of the room. If you have a question you'd like addressed during one of these breakout sessions, please put it

in the basket. These sessions are an excellent opportunity to bring any questions, concerns, or shared experiences regarding general service, the assembly, your home group, district, or other related items.

And what better way to conclude a packed day of AA business than with some fun and fellowship! Anyone who's still awake and wants to hang out can meet in the Trigg room next door.

In closing, I'd like to just encourage each of you to really be an active participant this weekend. Join in the discussion, ask questions, listen to one another, and don't be afraid of the mic. People are suffering and dying from alcoholism right now. The work that we do this weekend is to ensure that what we've found in AA remains available and accessible to all. "When ANYONE, ANYWHERE reaches out, I want the hand of AA to always be there." For that we are responsible.

> Area Chair Report, Lisa C-D

I'm Lisa, I'm an alcoholic. It's been a busy few months serving as your Area 40 Chair and Alternate Delegate. I got to attend the spring roundup in May and the regional forum in August, both in Missoula. I got to hear Kacie deliver her Delegate's Report several times, including once online in July with people from all over the state. I conducted an agenda writing workshop in June, and we fleshed out an idea proposed by Kelly Q., which is now one of the items of business we'll consider and vote on this weekend. In fact, there have been so many events that when I sat down to write this report, I quickly realized that I would need to focus on just a few things in order to fit this into the time allotted.

One of my writing teachers taught me that there is rhetorical power in threes – he was adamant that two is too few, and four is too many. So here are three things from the past few months that I want to share with you.

In June, I got to attend the 3rd Annual Founder's Day campout at a vast and beautiful U of M research forest that we were fortunate enough to call our own for the weekend. On Saturday night at the campout, which was June 10, we had a meeting around the campfire. At some point, the man next to me handed me a Big Book and asked me to read something. I wasn't sure why he was asking me -- I figured maybe he couldn't make out the text in the relative darkness – but I agreed and launched in without even knowing what I was about to read. It was this, from Dr. Bob's Nightmare, describing an encounter with his "new friend," Bill W:

He came and got me home and to bed, gave me a few drinks that night, and one bottle of beer the next morning.

That was June 10, 1935, and that was my last drink. As I write, nearly four years have passed.

The question which might naturally come into your mind would be: "What did the man do or say that was different from what others had done or said?" It must be remembered that I had read a great deal and talked to everyone who knew or thought they knew anything about the subject of alcoholism. But this was a man who had experienced many years of frightful drinking, who had had almost all the drunkard's experiences known to man, but who had been cured by the very means I had been trying to employ, that is to say the spiritual approach. He gave me information about the subject of alcoholism which was undoubtedly helpful. Of far more importance was the fact that he was the first living human with whom I had ever talked, who knew what he was talking about in regard to alcoholism from actual experience. In other words, he talked my language.

By the time I finished reading that passage around the campfire, I had tears in my eyes, a lump in my throat, and goosebumps on my arms. To read those words exactly 88 years later around a campfire with a dozen or so others

"who talked my language" was one of those moments when I really felt how incredibly lucky I am, how lucky we all are, that those two met, and figured this thing out, and cared enough to pass it on in a way that it could reach all of us and so many others.

The second moment I want to share happened in July, when I attended Kacie's delegate report in Bozeman. District 72 hosted a wonderful event with a great turnout and fabulous food. As I caught up with people in attendance, one of them was a man I had worked with on some district-related stuff between 2017 and 2019. I hadn't seen him since before the pandemic. After we hugged, he immediately asked me, "How are your kids?" I was touched that he remembered that my two oldest kids have some health issues, which were just coming to light back when he and I were working together. I told him that it was so kind of him to remember that they've been ill, and he said, "Of course I remember, I pray for them every day." The look in his eyes – such compassion – made me know right away that he was telling the truth. I immediately started crying, which embarrassed both of us, and when I thanked him, he humbly said, "That's just what we do."

As I've thought about that moment in the months since, I've considered that while it's what *some* of us do, it's not what *all* of us do. It's not something that I would have done... but it's what I want to do and it's the way I want to be. And I don't think it's an accident that this person who set that example for me is someone I met doing service in AA. That's not to say that we can't have moments like this one in meetings or during "the meeting after the meeting" or at fellowship events – we can, and I have. But as I've reflected on that moment, it occurs to me that I have more of those moments and meet more of the people who are living demonstrations of how I want to grow spiritually when I do service in AA.

The third and last thing I want to share with you is a moment from just a couple of weeks ago at the West Central Regional Forum in Missoula. We had a fantastic weekend, well attended by people from all over Area 40 and from the other areas in our region – Northern and Southern Minnesota, North and South Dakota, Iowa, Nebraska, and Wyoming. Kacie encouraged everyone from Area 40 to go to the mic at some point during the weekend... her encouragement was gentle at first, and less gentle as the weekend progressed. Many people from our area bravely spoke Friday night and throughout Saturday, undaunted by the 250+ people present and unintimidated by the presence of several staff members from GSO, present and former trustees, and present and former nontrustee directors, who are collectively an impressive and accomplished group of people. In truth, many of the people who spoke at the mic probably were daunted, maybe even a little intimidated, but they spoke anyway. I did not. Not until the final minutes of the final session Sunday morning did I finally make it to the mic. I was so nervous as I spoke that I literally couldn't feel my face.

I wanted to tell you that story, because I want to encourage each and every one of you to do something this weekend that challenges you. Invite someone you don't know to join you for lunch or dinner. During a break, turn to someone you've never met before and introduce yourself. And come to the mic. AA service is a place where we sometimes manage to step well outside our comfort zone and grow – sometimes quickly, sometimes slowly, sometimes with a gentle nudge, sometimes with a mighty shove. Sometimes afterwards I think: "That was not bad." Other times I cringe at my awkwardness, at the fact that my voice audibly shook or that what I meant to say is not at all what came out of my mouth. But the thing is... that's also not bad. Maybe in those moments, maybe my willingness to flail through a challenging moment is what tells others that it's okay to be nervous and it's okay if your point doesn't come out exactly the way you intended. When we do things that scare us, we are relieved of the bondage of self, and that's often when we make new service friends or discover something in AA service that we're passionate about or just help one another overcome whatever is holding us back from being a part of.

Thank you for allowing me to be your trusted servant and to have experiences like these. It truly is an honor.

Delegate Report , Kacie N

In the Fall of 2006, in a room similar to this, 106 miles East of here in Lewistown, Montana, Andrew W. opened an Assembly as the Area Chair and closed the Assembly having been elected the Delegate for the next rotation. At that same Assembly, my friend and fellow home group member Paul W. was serving as Area Secretary, Gerry R. was serving as the Archivist, and Connie was serving as the Public Information chair. Of course, there were so many others there being of service and doing the business of AA in that meeting room, too many to list, but all equally essential. A budget was discussed and passed. Committees met, discussed, and presented items that were passed by the voting body on the Assembly floor. Just exactly like we are doing this weekend in this room.

In that same Fall of 2006, I was 25, over \$30,000 in credit card debt, running short on friends, barely holding a job, and scared to answer my door because men knew where I lived that I don't even remember meeting. I was a year divorced and spent nearly every morning smoking out of a bong with vodka bong water, and every evening getting wasted on \$5 plastic liters of Gordon's vodka trying to work out how I could make suicide by revolver look like an accident.

I was there while you were here. You didn't know me, but you were making a way for me. You were showing up, taking time away from your spouses, partners, children, jobs, and fur babies. You were talking about how to improve AA in Area 40, how to be self-supporting, how to ensure the preservation of this lifesaving program... and you did. You saved my life. I found you. One of you carried some hope to me and let me know it was okay to sit on the furniture even though I didn't even think I was worth the space I took up sitting on the floor. You told me I didn't have to sit in the dark and, more importantly, that I didn't have to sit alone. Eventually, I joined a home group that valued Sponsorship and Step Work, the Traditions, and service. And then.... Then I was invited to my first Assembly. "But I have NO money! Seriously, you guys, I owe soooo much money. I can't afford to go to this thing you're talking about and eat out, sleep in a hotel, pitch in for gas. Impossible!" What was I told? "Get in the car." And not just 'get in the car', but "it's SO much fun, just come, you'll love it. You might get to meet the Grapevine Chair. I got to meet the Grapevine Chair one year when they wore this big grape costume, it was hilarious!" (That's a real conversation.) Not once did anyone say, it's boring, or people argue, or don't do this or that, or you're not sober enough, or experienced enough, or you don't belong. And so, I went. I shared beds, split meals, and clung as tightly as I could to the coattails of my sponsor. And you know what, it was amazing. I don't remember many specifics because as you can imagine it was a whirlwind, but I had been bit by the bug and I was in. You guys were so freaking happy. I wanted what you had more than I could put into words. Was it position or status or prestige that I was enamored with? Nope. It was just you. It was you and your dang hugs and your dang laughter and your overwhelming, undeniable love for one another in Alcoholics Anonymous. Your undeniable love for me.

To get what you have you showed me that I have to do what you do. So, I did – as best I could – a couple more 'get in the cars' and many service positions later, you weirdos elected to be your Delegate, your conduit of information, your spiritual contribution to the General Service Conference of Alcoholics Anonymous. Thank you for that. Since I saw you at our Spring Assembly, I got to participate in the 73rd General Service Conference in Brooklyn, New York. You may not know it, but you all were with me.

How many people in this room use toilet paper? How many of you feel strongly about having toilet paper available to you when you go to the bathroom? Okay, so we're all pretty much on the same page, right? Let me ask you, how many of you believe toilet paper should go over the top when you pull it off the roll? Strongly? How many of you believe it should go under? Do you feel strongly about that? Could you have an argument about it? Ok. So, I go to the General Service Conference, and I've got an Area that believes toilet paper is important, but some believe it should go over and some believe it should go under and both sides believe their way is the right way - with conviction. How does one person vote on behalf of all of you who

don't entirely agree on one topic except that it is important? It's very difficult. But what I can do is listen to you. When you share your opposition with me in a constructive way, I can take that to the Conference and pass on your thoughts and feedback while the conversation is happening. Or when you are strongly in favor of an idea and share with me why you feel so in detail, I can take that to the Conference and share that during the discussion. And when the vote comes up, I can sit quietly, pray, and ask, "Ok, God, what would you have me do?" I can reflect on the sense of the Area in the discussions we've held, consider what is best not just for Montana, but AA as a whole, and vote with faith in you, the process, and our Higher Power. And when I report back to all of you, I can let you know that the toilet paper won't be going over the top this time, even though that's how it should go, but instead, it's going to go under. I will accept the group conscience, even when I'm in the minority opinion, and share with you what led to those results.

Toilet Paper is a fairly benign topic. There is meant to be some humor in this pretty accurate analogy, but I hope you can understand that is what it's like. I care about what each one of you thinks. As does every Delegate who has served before me to represent us at the General Service Conference. There's just no way to vote your way each and every single time on an agenda item and it doesn't mean we're not listening. Please, always be willing to share how you're feeling about something even if you think a decision has already been made. The minority opinions are important.

In this report, I have the opportunity to be accountable to you. You guys spend a lot of money on me. You spend money on me to go to the Conference, to go to West Central Regional events, and to truck around Montana and report back on the Conference to each of your Districts. Things are different than they were in 2006. I have the privilege of being funded to do this service, but I do need to tell you where your money is going. I have had the privilege of delivering my Delegate's Report back on the Conference eight and a half times so far. (Going to Great Falls was amazing! But I didn't give a full conference report back there, so I only feel right about counting it as half a report.) Everywhere I've been invited, the hospitality has been amazing. The food is always delicious. And you are always kind with your open arms and the love that you show me as I share with you the return on your investment in me. I have three more reports scheduled in the upcoming weeks in Laurel, Helena, and Havre. If I have not yet been to your district and you would like me to come and share my report, please reach out and we'll work to get it on the calendar.

In May, I went on vacation to the Oregon Coast with my amazing husband to celebrate our 8 year of being married. (You guys didn't pay for that! We paid for it because I'm no longer \$30,000 in debt. In fact, I have a pretty amazing credit score that I'm quite proud of. A gift of working the steps!) Thank you for teaching me how to be a wife.

In June, I participated in the Agenda Item Writing Workshop hosted by our Area Chair, Lisa. It was lowly attended but not poorly attended and I'm very excited about the outcome of what happened there.

Also in June, I went to Fiddler on the Roof with my mom to celebrate being alive and getting to have a 42nd birthday because I got sober at 25 instead of drinking myself to death or dying by suicide. Thanks to you all, my mom likes me today and enjoys spending time with me.

I attend monthly meetings of the West Central Regional Delegates and am currently serving on a subcommittee of the West Central Region revamping guidelines and the Voice Book for our Regional conferences.

On August 16th, the members of the General Service Conference met together on Zoom to participate in a sharing session as the result of a motion passed in the Spring. We will have two more virtual sharing sessions before we meet at the 74th GSC next April. Those sharing sessions are a result of a frustrating situation producing some silver linings. I wasn't sure what to expect or what it would be like on the 16th. We did have

three sharing sessions prior to the conference this year but they were for the express purpose of addressing the events of the January Board meeting. They were not typical meetings and were a one-time occurrence at that time. The August 16th sharing session was very different. Each of the Trustees gave a summary report of the most recent events from the July Board weekend. There was time for some questions and answers. I was so relieved that we were having the Forum the following weekend because all that information was presented there. My hope and intention for the next two sharing sessions is to schedule an Area 40 Zoom meeting shortly after each session. This will allow me to immediately report back to you all what I learned in the Conference Sharing Session. Please keep an eye on the Area Calendar for those meetings.

I attended the Regional Forum a few weekends ago, which was amazing. I was given the opportunity to be the MC for the CPC workshop planned and executed by our Area CPC Committee Chair, Ty, and his incredible committee. Additionally, I got to moderate a workshop at the Forum titled, "Overcoming Barriers to Participation in AA." I believe this is a really important topic to consider in AA right now. We all get to be here and be sober and somewhere in a dark room somewhere, there's an alcoholic thinking about taking their own life because they can't figure out how to go on with or without drinking. And we're here doing this business so they can find us. It shouldn't have to be hard for them to find us. It's hard enough to get here. There are a lot of barriers we have yet to break so that people will get and stay here. There are barriers that we, here in Montana, might not ever experience. An incredible byproduct of attending the General Service Conference is being able to interact with alcoholics from all walks of life, a cross-section of the US and Canada, speaking different languages but sharing the language of the heart. We had visitors who came from Poland, Central Mexico, and Puerto Rico. One of the members of my Policy and Admissions committee is a French-speaking Canadian so we have a translator with us in the committee the whole time. One of my favorite things I learned is that the word "wordsmith" doesn't translate well from English to French. Instead, the translator says, "dawdling with commas." How appropriate! What an important lesson! Translation is a remarkable thing, but if I had a translator here right now, they would not be translating word for word the things I'm saying. It isn't possible. Sometimes language is a barrier. Did you know there are currently 7,117 known languages in the world? The book Alcoholics Anonymous is translated into just over 70. Should someone be excluded from our membership because they don't speak the right language? I want everyone to get this. I don't want anyone to be left out of the opportunity to receive the gifts I've been blessed with. There are a lot of other ways to get sober these days. We don't have a monopoly, we never have. (We just have the best way, I think.) You know what I need almost more than anything in my sobriety? A newcomer. I need a new person. If I don't have a new person, I've got nothing, really. If I don't have someone to share my experience, strength, and hope with, if I don't have someone to show me that it doesn't work anymore, then what is the point? So, I'd rather have the newcomer walk in and stay with me, than walk in somewhere else and find an option that doesn't include sponsorship, service, steps, and traditions. I'm selfish! I don't want to miss out on what the newcomer has to offer. I want to keep them! So, if we can overcome those barriers to participation, we can make sure there is a chair available, a meeting is open, the phone is answered, the high school has pamphlets, and the professional has resources from us. We're doing so much good work, but there is so much more work to do. That's why we're here this weekend.

I got to get here and stay here. And what it took for me to get here and stay here might not be the same as it is for someone who walks in today. Times and experiences change. I believe it is my responsibility, our responsibility, to be willing to meet the newcomers where they are. What I saw at the Conference that I took so much comfort in, is that there isn't anything decided without reaching Substantial Unanimity. The committee process is inspired and remarkable. There are no sneaky decisions being made under the cloak of darkness in the middle of the night. Thorough discussion is had, minority opinions are heard, and votes only pass if at least 2/3 of the voting members agree. Things do change in Alcoholics Anonymous. I would encourage you to show up, get involved, and ask questions. The information is being shared, but if you're not present to hear it, you may just think someone is trying to pull one over on you. Show up to the business

meetings, ask your GSR questions, show up to the Delegate reports in your District, and ask your DCM and Delegate questions. If you don't like what's going on, vote and share your opinion.

This time next year, we'll be holding elections again. It will be someone else's turn to punch in and take the Delegate shift. Someone else's turn to be Secretary, DCM, GSR, and maybe even Archivist. There is never a time that is too early to start thinking about what you might do next. Consider what you might be interested in doing next rotation, find the person currently doing that job, ask questions, and tag along with them to see how it's done. Read the job description in the Service Manual. Participate and be part of what we have here.

People die from alcoholism. One of my best friends from high school died from Cirrhosis at age 42 this year. Members of our Area have buried family due to death from Cirrhosis. This disease kills people. Suffering from alcoholism wears a lot of different masks. But for as many ways as there are to suffer, there are just as many ways we can work to reach those suffering. Just because one way worked for me, doesn't mean that is the only way that will ever work. This isn't a game. We have Traditions and Concepts as guidelines, but there is no hard-set rule as to the only way for us to reach the suffering alcoholic. We have a lot of different tools, and we can still create new ones. I'm really excited about what is in store for us. I hope we can proceed with open minds, honest hearts, and willing spirits as we do the business of AA. Being always mindful of why it is we're doing what we're doing.

With that, let's get busy doing the work of AA and enjoy the rest of our weekend. Thank you for my sobriety!

District 72 Report

Hi everybody! My name is Betty and I'm an alcoholic. I have the privilege of serving as the DCM for District 72.

Geographically, District 72 includes Gallatin, Park and Madison counties. We offer both open & closed meetings, options for men & women, as well as an option for those who are part of the LGBTQ+ community and friends/allies. Each group determines whether their meeting is online, inperson or hybrid. Hybrid District meetings are held the last Saturday of the month, and we average about 28 attendees/month. 20% of those are visitors!

The AA Preamble states that "Our primary purpose is to stay sober and help other alcoholics to achieve sobriety." That's exactly what we've been doing this year.

Our GSRs report that their meetings are doing well and growing. They are getting newcomers from a variety of sources, including Bridging the Gap, treatment centers & correctional facilities. Once through our doors, newcomers are being offered the opportunity to get involved in AA through service – setting up the room, hosting & chairing meetings, greeting, making coffee – as well as fellowship activities like kickball, BBQs combined with speaker meetings and fun.

Obviously, these things don't happen by accident – they are accomplished through the combined efforts of our dedicated trusted servants at the group, district and area levels. We collaborate with each other and our counterparts in Area 40 to share questions, ideas and approaches on how best to accomplish our primary purpose. For example, under the leadership of our Area Chair, our District CPC chair worked her counterparts in Districts 61 & 81 to put on a hybrid CPC panel before Regional Forum. Judge and Class A trustee, Kerry Meyer spoke about her experience in dealing with alcoholic/addicts in her court, and her view of the efficacy of the AA program. Medical, law, and criminal justice professionals heard how AA supports people in recovering and leading healthy lives. I heard that it was very good and well attended.

We had over 25 members attend West Central Regional Forum. The GSO Staff, Regional Trustees & Delegates talked with and listened to the AAs in attendance. Both presenters & attendees were treated respectfully, enabling an open exchange of information & ideas. I saw that AA's trusted servants, even the ones I don't know, are people who are passionate about A.A. and committed to our primary purpose. I believe that with the help of God and an informed group conscience, A.A. is and will continue to be in good hands forever.

District 72 is financially stable, hovering a little over prudent reserve. Our cabinets are full of literature. Our Technology Committee purchased equipment to support district meetings and special events. We've used it once on the road already without a hitch.

Administratively, we look at our processes and allow ourselves the freedom to consider what we might be able to do better for the Fellowship. We implemented a new standard approach for bringing new business before District. This approach makes it easier for GSRs to share and explain what is being considered to their groups, why, and at what estimated cost. Discussion is much more efficient & effective; more business may be accomplished.

We have a variety of events scheduled between now and yearend: a HOW group speaker event on October 14th. Our Roundup Committee is hosting Fall Assembly the weekend of October 27th. You'll hear more about this event Sunday morning. Flyers & registration forms are available on the table. The Technology Committee is working with the HOW group and the Roundup team to finalize what they might want to make available to online attendees. Stay tuned for more information. We hope to see all of you there!

Hotline/Report & Charter: Xavier Gonzales-Graybill

Chair Report:

Hi my name is Xavier and I am an Alcoholic. I want to first say how grateful I am to be here. Serving as your area 40 hotline has been lifesaving to my sobriety. Since the last assembly I had got married graduated from college then faced the hardest thing I have ever faced in sobriety when I lost my grandma. These were days I didn't know if I could keep going but because of the hand of AA and my service commitment to this area and my sponsor I have been able to stand strong. The biggest thing I learned over the last couple month is that even if I'm thinking about drink and just giving up on life I don't have to because their people out their who actual care about me. I also want to Thank Paul district 41 hotline chair and the hotline alternate chair. He has stepped up when I needed and handle the responsibility of the hotline so thank you. So now let's talk about what I have been going on in area 40 with the hotline.

Before we get started on what I have been doing as your hotline chair I would like to talk about what the hotline is. We are a group of alcoholics that can be the only connection other alcoholics may ever have with AA. It is very important that every district has a hotline committee member or at least 1 male and 1 female who are willing to answer calls. The way that works is everyone who is willing to answer calls would save the hotline number which is 4065405131. This is the only number that a call would come from. Which then if a call is missed I am notified and I reach out to the district that the miss call come from and ask for them to have someone return the call. No one should ever call the hotline to try and find out who called if they missed a call, they should contact me directly if I haven't already contacted them. The answering service only keeps 2 numbers per district to send calls to. These people need to know the number how to answer the calls and information for their district on people to contact and meeting going on. So, it is important to have a couple of people that can be rotated out. Now lets talk about what I been doing.

Since the last assembly the first thing I did was get Paul District 41 hotline chair and the alternate hotline chair signed up and connect with the hotline service and teach him how to communicate with answer service and response to miss calls

Then I started to work on getting our service cancelled with Thryv/DexYp which was a motion that was seconded discussed and passed. This was a task that wasn't easy. They did not want to let us go

and were trying to still charge us until end of the 2024 because they have already started print. Lucky I ddi my research and was able to let them know that there was a lack of communication and the information they had was outdated and which meant we could cancel are service without having to pay any more fee. It did require me filling out a lot of paperwork emails and phone calls but after about 3 months I finally got it done. By doing this we will be saving 1750 a year. So far this year we have spent 942.09 dollar on the hotline.

Next, I was invited by the Area 40 CPC chair Ty to help facilitate a CPC Luncheon during the regional form in which we had A Class A Trustee come and speak. During this luncheon I realized that hotline can be involved in more thing than just the hotline like CPC and/or bridging the gap. Because a professional can give the hotline number to a suffering acholic and if someone coming out of the hospital and is wanting to talk with an acholic they can reach out to the hotline who then could get them connect with bridging the gap.

With that thought in mind I created a card that on one side says Montana Area 40 AA looking to talk with another Alcohlic call the Montana AA Hotline. 833 800 8553. Then on the other side it says looking for a meeting download AA meeting Guide App it has a QR card and the AA-montana.org web address. When a person scans the code, it will allow them to download the meeting guide app the grape vine app and send you to the AA-Montana .org website.

I also attended the regional forum which was not at all what I was expecting but let me honest I didn't know what to expect. I was able to meet a lot of amazing people and connect with people I would never have connected with before. I went to dinner with a class b trustee Cathryn from Canada and talk about how they did they do hotline in Canada as well as just to connect and see that AA is much different in other places they care the message of AA to the still suffering alcoholic. Which I got out of this was event at the end of the weekend was that I know what my 5 year service plan looks like with god willing.

It was my pleasure to present some Area 40 financial highlights this morning. I want to clarify a couple of things from my report.

- Thryv is the new name of Dex YP which we used to publish the hotline number. In fall of 22, we voted to discontinue the use of this service. Xavier diligence got us separated to the tune of approximately \$1,750.
- All the graphs and images displayed were end of August, YTD.

Since the Spring Assembly, I had the pleasure of attending the Forum in Missoula and I would like to compliment the committee on how well executed this event was.

I continue to tinker with the books, keeping Area 40 accounts current and depositing any received contributions. Although I do not mail any acknowledgment to each contributor, I can look up any group's donations by request. I am happy to report, I have not been in contact with any groups who have had contributions returned in the mail. If you have been at Area for the past few years you know this is always an issue but, it is possible, after 2.5 years. We got there, thank you.

Please keep your areas informed. The current address will always be on the Area 40 website. If I accomplish nothing else, I would like all contributions to get deposited. I am sad to report for some, this address will not be changing anytime in the near future.

• Revenue forecast is looking positive, trend looks like we will receive ~\$40,000 which is ~\$5,000 under budget. Given our operating balance, which is 2x our prudent reserve, we continue to draw down slowly. Eventually we need contributions to increase to match our commitment to the Area for the services we provide. But there is no need to ring the cow bell at this time. My hope is that our draw down slows and returns to a healthy balance.

If you are considering this position for the next rotation. The Area 40 Treasurer's job is primarily a quiet existence. I do not interact directly unless there is an issue. It requires some technical knowledge, knowledge about bookkeeping which you can learn on the job, organization skills, and time. No Treasurer has ever died while in the position. Please consider the gifts sobriety has provided and step up to serve where and when you are able. Alcoholics generally thrive when faced with adversity and you will too.

I hope everyone takes the time to review the latest financial reports. They are always posted monthly to the Area 40 website. We continued the trend, light on income compared to expenses for the year to date. However, we are under budget for the year on expenses with a net income of \$1,128.77. Currently our expenses are under budget to the tune of \$6,568.21, this is due to the elimination of directory services for the hotline even with the increase in the cost of travel expenses.

Returning to an in-person assembly will continue take some calibration to ensure we are back on track from a budget and expense perspective. We are current on our annual rent for the archives storage which runs on a rolling 13-month schedule.

Because of inflation, a dollar in the basket today is only worth 61 cents compared to 20 years ago; 47 cents compared to 30 years ago. This is shocking, more so because when I sobered up, a dollar was worth roughly 42% more than a dollar today and you could smoke in meetings. The basket is where money and spirituality mix. So, the question is, what is the monetary value of my sobriety? I participate actively in my home group because of my ability to influence how that money is spent. As I can afford to, I do put in a little extra for those who are unable or for the times I am without cash. My homegroup did have a Venmo account which made our virtual participants able to contribute as well as those who shamefully forgot to bring cash. However, in the return to in-person meetings, this has gone away. If we want A.A. to be here for the next generation, we need to keep supporting our 12ⁿ-Step work at all levels of service.

We are deadly serious about our work but we should not forget the levity in it all. Please take it seriously if you are considering stepping up to serve. We need the best possible option for all levels of service.

Grapevine and La Vina/Policy and Admissions

Chair Report:

Hello Area 40 Spring Round up 2023 participants here and online, My name is Martin NoRunner, I am your Area 40 Grapevine Representative.

The AA Grapevine is a publication within Alcoholics Anonymous (AA) that serves as a forum for members to share their experiences, strength, and hope in recovery from alcoholism. It has played a significant role in the fellowship since its inception. Here is a brief history of the AA Grapevine: Early Years: The AA Grapevine was first published in June 1944, more than nine years after the founding of Alcoholics Anonymous in 1935. The idea for the magazine emerged as a means to facilitate communication and unity among AA members across different geographic locations.

Ruth Hock and the First Issue:

Ruth Hock, an early AA member, was instrumental in the establishment of the Grapevine. She served as the magazine's first editor and handled the initial printing and distribution logistics. The first issue of the AA Grapevine was a four-page, mimeographed newsletter.

Development and Growth:

Over time, the Grapevine evolved and grew in both content and readership. It began to include personal stories of recovery, articles on AA principles and practices, book reviews, and news from AA groups around the world. The magazine expanded from a regional publication to an international one, with translations available in several languages.

Independence and Organization:

Initially, the Grapevine operated under the auspices of the Alcoholic Foundation, which later became the General Service Board of Alcoholics Anonymous. However, in 1948, it became an independent corporation, the AA Grapevine, Inc., governed by a separate board of directors. This independence allowed the Grapevine to maintain its own editorial policy and financial self-sufficiency.

Contributions and Submissions:

The Grapevine's content primarily comes from AA members themselves. Anyone in AA can submit articles, personal stories, poems, artwork, or letters for publication consideration. The magazine aims to represent the collective voice of AA and the experience of its members.

Outreach and Impact:

The AA Grapevine has been influential in carrying the message of recovery to individuals both within and outside the fellowship. It has served as a lifeline for many AA members, offering stories of hope, identification, and inspiration. The magazine has been distributed to prisons, treatment centers, hospitals, and libraries worldwide, contributing to the understanding of alcoholism as a treatable condition.

Digital Age:

With the advent of the internet and digital publishing, the Grapevine has embraced online platforms to reach a broader audience. It maintains a website, and in fall of 2023 will implement an iOS and Android Grapevine Apps allowing members to access articles and subscribe to the magazine digitally. The Grapevine also offers a podcast series featuring personal stories, interviews, and discussions related to recovery.

The AA Grapevine continues to be a invaluable resource within the AA fellowship, providing a platform for members to share their experience, strength, and hope, and fostering unity and connection among those seeking recovery from alcoholism.

ITEM A: Review G.S.O. General Manager's report regarding General Service Conference site selection.

- Where money and spirituality mix melds financial, logistical and spiritual. If there are logistical or financial challenges due to hosting within the regions, it will create spiritual difficulties.
 - The Conference would miss out on Stepping Stones and GSO visits during Conference week. Visiting the office during Conference weeks was one of the reasons the early members chose to meet in NYC.
 - International observers would miss out on the Fellowships history tied to NYC.
 - Similar to international observers, some area delegates would feel left out of the NYC experience and history of the Fellowship.
 - The history of the Conference being held in NYC has been a central part of a long history of unity and comradery among area delegates, trustees, and staff.

Conference Discussions:

In October 1955, the former GSB Policy Committee discussed a suggestion from two delegates, to pursue the "possibility of having alternating sessions of the General Service Conference in cities other than New York." Further, "this would be done in odd years, thereby giving each delegate a chance to visit Headquarters in even years.

The proposal was discussed at the 1956 General Service Conference but was tabled for consideration at "some future date."

ITEM B: Review dates for the 2027 (77th) General Service Conference.

The committee noted that the month of April 2027 weekend dates do not conflict with any significant holidays and allow the Fellowship ample time before the Conference to review and discuss agenda items.

ITEM C: Review progress report on the development of a process using virtual meeting technologies for polling the G.S.C. between meetings.

Excerpts from the January 2023 trustees' General Service Conference meeting: The committee continued their discussion of a draft plan process for polling the GSC between meetings that makes use of virtual meeting technologies and offered several suggestions to the plan and invited participation from delegate chairpersons. The committee agreed that alternate delegates should be invited by the sitting delegate if the Delegate cannot attend. The committee agreed that the Conference Committee on Policy and Admissions would meet prior to the GSC meeting to accept admissions, noting that circumstances involving great emergencies may have their own deadlines. The committee agree to forward the revised draft process plan for polling the GSC between meetings that makes use of virtual meeting technologies to 2023 Conference Committee on Policy and Admissions.

An antiquated process:

Voting Process Conference members may vote by email or by phone. All responses will be made to the email address and phone provided in the original poll. Conference members will be sent a voting form by email. To vote by email, Conference members mark an "X" next to their choice and return it to the email address indicated. The poll document will include a space to indicate yes or no. To vote by phone, Conference members may call the number provided and leave a message with their name, service position and vote.

ITEM D: Discuss report on the Equitable Distribution of Workload process (EDW) Proposed Agend Items (PAI's)

EDW Pilot is a test to see if redistribution works to make conference committee time more effective and balance workloads. In 2021 Advisory Action of the General Service Conference It was recommended that: The Equitable Distribution of Workload Process, as detailed in the Report from the 2020 Trustees' General Service Conference Committee, be implemented for the 72nd General Service Conference (GSC) on a three-year trial basis, with a progress report to be brought to the Conference Committee on Policy and Admissions after each year of the trial.

- 184 PAIs
- Fillable PAI PDF form is cumbersome to use during the overall process. The committee encourages GSO staff to explore and implement an alternative format that streamlines the overall PAI process, including submission, disposition, consideration, and possible translation as Conference background.
- The Conference Agenda Item Routing (CAR) Form is cumbersome to process or use to populate the EDW sandbox tool, which employs the use of a spreadsheet.

Translations Costs: To increase translation capacity, we developed an in-house Language Services Department composed of a translation manager and two translators. This department is expected to have significant savings by reducing the use of outsourced translators.

SECTION 3 - THOUGHTS AND RECOMMENDATIONS FOR YEAR THREE

- Work toward greater clarity and consistency across the trustees' committees regarding points of contact with the conference committee and/or conference committee chairs.
- GSO Staff to consider what the best options are for PAI submission (fillable forms, online forms, or?) and look for opportunities to align new processes with the CAR forms that are completed by the Trustees Committees.
- Consider possible methods to inform and support those submitting PAIs: Video resources? Webinar?
- Shared experience on the value of **robust** group conscience at the local or area level prior to proposing for the GSC?

SECTION 4 – QUESTIONS FOR THE CONFERENCE COMMITTEE ON POLICY AND ADMISSIONS REGARDING PAI FORMS

- How and from who should members gain access to the PAI form?
- What is the role of delegates? Is there a need to prevent PAI forms being used as petitions/suggestion box forms? If so, how might this be achieved?
- What can be done to encourage submission prior to the deadline to prevent everything coming in at once?
- Consider character limits per field, and maximum attachment sizes to ease document management and translation and foster similarity in the amount of content attached.
- Should the PAI form ask specifically whether the idea has been discussed at an area assembly and what the outcome of the vote was?
- How heavily should whether the PAI was supported by group conscience factor into decisions to move items onto the GSC agenda or not?

ITEM E: Review report of the GSB Ad-Hoc Committee on Participation of Online Groups in the U.S./Canada Service Structure.

It was recommended that: The U.S./Canada General Service Structure recognize online groups and encourage their participation by listing groups who request to be listed in Fellowship Connection according to the group's preferred district and area, with the default option being the location of the group's primary contact. This replaces the 1997 Advisory Action that designated online groups as "International Correspondence Meetings." It was recommended that: The General Service Board form a committee to explore future possibilities for the participation of online groups in the U.S./Canada General Service structure.

It might also be helpful to gather shared experience on ways that online groups have used their particular expertise in working with district and area service committees to:

- Bring online meetings to treatment facilities, correctional facilities, nursing homes, and rehabilitation centers
- Reach out and connect with remote communities
- Help members who are homebound or have mobility issues
- Offer more options for the Hard of Hearing, Blind members, and Deaf members
- Use simultaneous interpretation to offer meetings in more languages
- Provide meetings for immunocompromised members
- Offer meetings 24/7 for A.A.s who are shift workers, new parents, or caregivers.

• Make meetings accessible to those who have lost their driving privileges Lastly, it would be helpful to collect shared experiences from districts and areas who are holding assemblies or other events in a hybrid format. What considerations went into the decision to try a hybrid format? What have the challenges been? Has it led to greater participation of online groups? What were the costs? Some survey responses touched on this, but more sharing would be helpful.

Section 8 – The Ongoing Conversation

There are still, as there were with the first progress report, more questions than answers. However, the shape of the questions continues to evolve and change. It is apparent that many conversations are happening at Area, District and Group levels, and that there is a need and an appetite for continued shared experience. There are voices that we continue to need to seek out and hear from in this still-evolving picture and process. It is a remarkable one to be a part of.

> GSR Breakout:

Question: I am the GSR for a small group that meets once a week. I also attend a meeting 5 days a week. Can I hold a position at both?

Answer: Groups can be autonomous on this issue.

A: The GSR pamphlet states it is your only job.

A: One person said they hold both GSR and speaker-finding position.

A: Taking 2 positions is not helping to include more people.

A: 2 homegroups, but one is where you are truly committed, vote, and hold a position.

Question: Why do we have to rotate positions?

Answer: To try something new, and give newcomers a chance to participate.

A: Service keeps you sober and out of your head.

A: To avoid control of one person.

A: I need AA, AA doesn't need me.

There were also plenty of examples given of what not to do.

Question: Is there a required business meeting format?

Answer: Reports first, Roberts Rules, then new/old business. Removing Roberts Rules helped the meeting to run more smoothly.

A: Use the group conscious. The GSR brings information from the district to the group.

A: Having a format helps to maintain order.

A: Invite God in, group conscious is different than a rigid decision making process.

Question: What do we do with members who no longer show up to business meetings that they hold a position in?

Answer: Have group guidelines that specify. For example, if a person misses more than 3 meetings, they will be replaced. Make sure to have the guidelines in place beforehand.

A: Have a group conscious about what do we do with these positions that are not being honored.

A: Remember, just because a position is good for someone, doesn't mean they are good for that position. It isn't personal.

Question: A person asked for experience about Group Inventory.

Answer: Area can provide different formats for groups to then choose from.

A: It was suggested to have food and fellowship along with the inventory. Also, make sure conversation stays open, particularly with the newcomers.

A: One type that was mentioned is survey style resulting in reading the papers in a meeting together.

A: AA Group Inventory has 13 suggested questions.

A: Use an outside of the group member to facilitate the inventory meeting.

> DCM Breakout:

Question: Discussion opened by trying to find a role as DCM rather than let the GSRs run the business of the meeting.

Answer: Thought it was the hardest thing to do as DCM was to let other people take the wheel.

A: This person feels that it is on the right track with motions, etc. Also, sets a good point of order.

A: Shared experience filling in to arbitrate a few times, and pointed out that GSRs look to us for guidance. Also said it is important not to give opinions.

A: Pointed out there is lots of material for helping run the meeting.

A: Said only one of the cities in their district participate in district meetings. It was speculated other cities are holding out. They have also been thinking about building a clubhouse.

A: Suggested attending each group's business meeting in the district and sharing with them the importance of participating in district.

A: Another DCM knew of a group in their district that doesn't go to district meetings in protest.

A: Encourage dark groups to show up to find out what district and area are doing. Also, reach out to other districts for help.

Question: A district has a non-alcoholic wanting to join and hold a service position. Also, one of their chair members is smoking weed.

Answer: Don't take outside contributions. Make sure to ask the question: Do they meet the sobriety requirements?

A: It sorta sorts itself out, and trying to control the situation can be bad.

A: Suggested a policy stating that each position holder needs to have a sponsor, be working the steps, and have a homegroup.

A: Remember that the groups GSRs are just as new and help them in their struggles.

Hi Area 40,

My name is Aryel and I am an alcoholic.

I am the GSR of the Kalispell New Hope Group, I am also the District 91 Intergroup Liason. I am reporting on behalf of the Flathead Valley Intergroup.

I know a lot of you are wondering what Intergroup does. Well Id be happy to tell you. Flathead Valley Intergroup serves more than 15 groups and meetings in Northwest Montana, within district 91. Intergroup offers more than 10 separate service positions, some of which differ from the common district positions, those include an entertainment chair and co-chair, which organize events such as, an annual campout, alcathons, and several holiday and fellowship events, dinners, sobriety birthday meetings. They also have a meeting schedules chair, who is tasked with organizing, editing, printing and distributing paper meeting schedules throughout District 91. We also participate in and contribute to district 91 functions and events, in addition to providing a separate local hotline number and a local website aanwmt.org.

In the last year Flathead Valley Intergroup has held 12 monthly business meetings and 12 monthly sobriety birthday meetings which are on the last Saturday of every month at the North Valley Senior Center in Columbia Falls. We have also received over 60,000 views on the local website.

The local intergroup website provides a variety of services, including a calendar of events, with printable pdf fliers, contact information for all district and intergroup service positions, it also provides a wealth of useful information such as job descriptions, bylaws, and policy and procedures. The website also announces and informs the fellowship of several services, and workshops including, "Into Action", Corrections meetings orientation, in addition to an abundance of family friendly fellowship events and activities, such as the annual New Years Alcathon, Valentines Day party, annual Whitefish Sober Ski, St Patricks Day Dinner and Potluck,

> Forum Report

My name is Greg T., and I'm an alcoholic. Currently serving as the District 12 alternate CM, my home group is the Laurel Home Group.

Since this was just my second Forum, after the event Lisa asked me to share my thoughts to this Assembly. My sponsor trained me never to say no to service opportunities, most especially the ones that may seem uncomfortable. Therefore, without further consideration, I immediately replied "of course." My experience is it often is better not to think about service too much, but to just do it.

In later chatting with Kacie, she said she expected a +500 page extensive report. I don't think this is what you would appreciate so I will try to keep my thoughts brief.

Many years ago, when residing in Ann Arbor, MI I attended my first Forum that occurred in Indianapolis, IN. As I recall, this Indiana Forum was an exciting whirlwind of activity. Like my very first meeting, I recall few details of this weekend other than the New York delegation really impressed me with their knowledge, serenity, and joy. They had something that I wanted, really wanted. Additionally, I also finally got to personally meet Amy Brophy, the then Grapevine editor.

At the time, I was the District Grapevine Rep, which was my first service position outside of my home group. I had just hosted a three-Area Michigan statewide Grapevine Writing Workshop. Preparing for this workshop, on several occasions, I telephoned Amy with numerous questions. She graciously invested a significant amount of her time (and patience) in helping me. Amy also provided extensive GV and La Vina materials for the booths. Amy was my window into New York, and I wanted to thank her in person for all her friendly help. I have never forgotten this very positive interaction and very first real service experience.

When I learned our Montana Area hosts Regional Forums only every 16 years through regular rotation, I realized I needed to take advantage of this infrequent opportunity. Therefore, this August I attended my second Regional Forum. I am so very glad I did! Our recent Missoula Regional Forum was much better than my fondest Midwest first Forum memories!

If you have never attended a Regional Forum, I highly encourage you to do so, even if it requires further less convenient travel to another state in our geographically large and disperse region. You will certainly never regret it!

My sense is our AA adage of "keep coming back" applies particularly well to our Forums. The Forums get better and better the more I attend and become more involved. Please don't wait another sixteen years until the Regional Forum returns to Montana.

For those unfamiliar, Regional Forums are slightly differently structured than our Area Roundups and Assemblies. These Forums rotate between the various Areas of each Region, and by definition are multi-state. These Forums are primarily led by New York-based AA bodies including the AAWS and GV Boards of Trustees, GSO and staff, and participating Area Delegates. The primary objective of Regional Forums is to share information between and with the specific region and New York.

Our West Central Region consists of seven states and eight Areas. Attendees hailed from Montana, Wyoming, Nebraska, North & South Dakota, Iowa, and both Minnesota Areas. Being the local host, Montana attendance and participation dominated.

At this Forum I was pleased to see many Montana friends, and to meet many other very interesting representatives from the other states. The large New York and very well-prepared contingent impressed me most of all. They were a class act well-coordinated team with polished information and content-rich presentations. Their personal and professional qualifications were inspiring.

Their grace, serenity, peace and calm were motivating. During the Q&A sessions, their responses always exhumed grace. Many questions posed by the audience were sensitive, difficult, or at best extremely challenging. They always thanked in a heart-felt manner the person asking the question and seemed very honest and sincere in doing so. I was amazed at how all questions were replied, especially the most pointed ones. Like my first Forum, I came away with the deep feeling that they possessed something I really really wanted.

When I arrived Friday afternoon, after checking in, I went directly to the great room hall which served as the center of most activity. Awaiting me were several large booths filled with literature. I was amazed at the extent that went far beyond the usual generous supply of different literature found at our Area events. One of the most memorable sights greeting me was a table containing Big Book and pamphlet translations in over 70 foreign languages. I awed at the Braille Big Book.

Being raised in Europe, I recognized many different languages of my youth, but also admired Big Books written in uncommon languages from far off exotic countries. I even spotted a copy of the Big Book written in low German, which I spoke as a teen. It is commonly called Plattdeutsch, which I didn't even know existed as a Big Book translation. Low German is a dying dialect spoken in rural areas only along the German border next to the Netherlands, Belgium, and Luxemburg.

The weekend kicked off at 06:00pm sharp with an overview orientation provided by Mike L., our Interim General Service Board Chairman. He supplemented his opening remarks with a very informative video presentation. The rest of Friday evening was filled by various presentations including Bob W., the GSO General Manager, Corporate Board presentations AAWS Trustee Director Carolyn W., and AAGV non-Trustee Director Cindy F.

We also learned about the General Service Board (GSB) and the non-alcoholic Class A and alcoholic Class B different roles through presentations by judge Kerry Meyer and Carolyn W., respectively. Indeed, judge Meyer, one of our non-alcoholic trustee board members, essentially chaired many weekend events.

Saturday morning, the Area Delegates held various complimentary presentations. All held different perspectives reflective of their cohort, geographic region, and background. However, I was extremely impacted by their unity, and common bonds which were immediately apparent in their interactions with each other.

The early morning Delegate Presentations were followed until lunch by our own Gerry R., Appointed Committee Member, presenting on very encouraging developments he champions related to "Opening A.A.'s Doors Wider: Sharing the Indigenous Story." His presentation was fascinating. Gerry was followed by Chris C., the Grapevine Publisher, describing the since launched new AAGV app, and French-Canadian Robert L., Canada Trustee at Large, who shared a PowerPoint and video presentation about his recent trip to Mongolia celebrating their anniversary. It was inspiring and fascinating how our message has spread globally.

Kacie graciously invited 3-4 attendees, including myself, to have a special lunch with judge Meyer. It was indeed a rare opportunity to get to know Kerry as an individual and not just as our non-alcoholic Class A Trustee. It is amazing how much love and caring a non-alcoholic such as Kerry can have for our fellowship. She is indeed a very approachable, warm, and friendly leader.

The Saturday afternoon sessions focused on General Service Office presentations by Bob W., the GM, as well as several members of his staff. Karina C. elaborated particularly well on the Group Services functions, which impact us most. The afternoon sessions concluded with an extensive presentation by Kevin Prior, our non-alcoholic GSB Treasurer. Finances and financial management of our fellowship are very sound and in very capable hands. Kevin even shared his Alanon story.

Saturday evening there were five different workshops to choose from that the Delegates led. The choice was very difficult, but I opted to attend Kacie's workshop about "Overcoming Barries to Participation in AA", because I thought the topic particularly salient to our Area. Kacie was magical in her style, as usual, and the group was very engaging.

However, something unexpected happened earlier Saturday, and repeated it after Kacie's workshop. Let me first explain with a little context.

My District 12 Laurel Home Group has a meeting every other Wednesday evening at the Yellowstone Boys & Girls Ranch. These meetings are usually the high point of our week. YBGR, as we fondly call this Montana institution, is a non-profit institution for adolescents who suffer from alcohol and drugrelated problems. These teenagers are involuntarily sent into YBGR by their parents or the courts for several months, or until their 18th birthday. It is usually their last stop before prison if they were adults. YBGR is a blend between a teen prison and recovery center. The kids' biggest fears surround "graduating YBGR," returning home to their broken dysfunctional families or mis-behaving friends.

Almost one year ago we gave an 8-month token to one of the young girls who was approaching graduation. She also asked for a 12-month token to mail to her big sister, who had recently given birth. She had not seen her sister, except on Zoom, for a year, which is how she met her first

nephew. Of course, we gave her a 12-month token to mail to her sister, adding that her sister must give it back to her when she also celebrates her own 12-month sobriety. The next time we had a meeting in YBGR, this girl had left. Since the kids come from all over the state, we usually never hear what happens to them, but hope and pray for the best.

Saturday midday between events, just before lunch, I briefly saw what I thought was a familiar smile. She said hello and hurried on to wherever she was headed with her friends before I could place the smile. After Kacie's Saturday evening workshop, I spotted this same smile at the rear of the room with her friends. I was amazed to meet this same girl, now a young woman in recovery. She had already received back the twelve-month token from her sister. Both young women were doing well in their recoveries.

Our YBGR graduate was nearing her 18-month anniversary. I reminded her to make sure she receives an 18-month brass "whiner chip" from her home group. (My home group coined the term "whiner chip" for those who were spoiled by monthly aluminum tokens and didn't want to wait a full year for their next brass token...just like me!). She laughed at my explanation, and we parted ways.

Unexpectedly meeting one of the YBGR students, and seeing how they grow and thrive in sobriety, is reassuring. The experience brought tears to my eyes, as it did to several home group members when I recounted this story.

These types of "God-shot" experiences reinforce the feeling that my actions are important. I may be the closest thing to a Big Book someone else meets today. These experiences also remind me that our program works, it truly does.

Sunday events concluded with Ask It Basket questions, first-time Forum attendees sharing, and past trustees sharing. Kerry, Class A Trustee, Bob W, GSO GM, and Mike L., Interim GSB Chair, made final Forum closing comments.

After we closed, Kerry mentioned that only 175 people pre-registered for this Forum but at the last minute, in true AA fashion, 281 actually attended, which represents a typical Forum attendance. Karina C., of the GSO staff, offered to send participants electronic copies of presentation materials if we requested them, which I plan to do to relive this wonderful experience.

I personally have so many fond memories from this Forum. Numerous too many to count unexpected experiences, precious "God shots," and all that I have learned are some of the benefits I gained. Most importantly, however, the refreshed friendships from across our beautiful state and deepened new relationships both from our Area, the Region and now New York, will always remain.

If you ever get the opportunity to attend a fist Forum, please do so. Your sobriety will be deeply impacted. If you are already a frequent attendee, I hope to see you again as our journeys cross.






Many people in AA struggle with trying to approach, let alone understand the 12 Concepts.




...and with good reason. When placed next to the Steps and Traditions, they look and sound more like a legal document.




In their introduction it says they can be used throughout the entire A.A. Service Structure...




...but they primarily address only the relationship between the GSC and the GSB.




They do also touch lightly on AAWS and the Grapevine...



...but only a few of the Concepts mention how the principles found within them apply to the *entire* A.A. service structure. Because of this, A.A. members often think the Concepts don't really apply to them at their level of service.



For many, the esoteric language of the Concepts does more to conceal the basic principles of spiritual balance than it does to reveal and explain them... much like a scientific equation can be confusing for someone who is trying to understand the basic principles of physical balance.



Principles are intended to be guides to a better understanding of obligations and right conduct. To be best understood, they should serve to clarify. It helps if they can be explained with the least amount of intimidating or exclusionary language.



Put simply, the principles of conduct found throughout the 12 Concepts address the balance between Ultimate Authority and Delegated Authority, and the necessary balance that exists between each service position's Rights and Responsibilities.

Basic Principles of Balance

Found throughout the entire Service Structure of Alcoholics Anonymous

This presentation examines how the basic principles found in the Concepts can be guides to understanding the rights and responsibilities of trusted servants across the entire A.A. service structure. They are related through a brief story about one such trusted servant, Joe the Coffee Maker.


Concepts

Final responsibility and ultimate authority for AA world services should always reside in the collective conscience of our fellowship.


Authority, Unity, Communication

*Final responsibility and ultimate authority for AA world services should always reside in the collective conscience of our fellowship.

Each Concept will be presented in its current short form, followed by a short, partial list of basic principles found in it. If applicable, a revised version of the Concept will be offered to better present how these principles can be applied across the entire A.A. service structure. A few, like #1, will remain unchanged as they already address the entire structure.



Concept One speaks to the ultimate authority of the A.A. groups.



They are, after all, at the top of the inverted triangle and are, in fact, the CEO's of A.A. Collectively, they are the ultimate authority and have the final say in all matters.



Concept Two speaks to the very real fact that, to be effective, the groups must delegate authority to their trusted servants at every level of the A.A. service structure, be it the GSB, the GSC, Area, District, or Home Group.

It is impossible for our society to function effectively otherwise.



Delegated authority is nimbler and, therefore, more effective.

Most readily agree that the General Service Conference, and all its related committees do a lot of good and necessary work for A.A., and for the still suffering alcoholic...



...but so does the home group coffee maker. In fact, this one, Joe, goes above and beyond the call to provide his home group with only the best filtered coffee he can make. He is a professional barista after all, and coffee is his life. Indeed, coffee and the Concepts, that's what Joe's life is all about. Joe is a new, but dedicated, trusted servant.

To insure effective leadership, we should endow each element of AA - the Conference, the General Service Board and its service corporations, staffs, committee, and executives - with a traditional "Right of Decision.

Trast, Responsibility, Communication

To insure effective leadership we should endow all our trusted servants with a traditional "Right of Decision."

As a trusted servant, Joe is aware of and enjoys the freedom of choice provided for him by the "Right of Decision" in Concept Three.



Joe uses that right of decision to buy and make only the best coffee that he can find for his group.

Mustachio Pistachio coffee.

However, after a few weeks on the job...



...a few of the group old-timers approached Joe and informed him that they preferred their old coffee, Folgers Classic Roast.



This did not sit well with Joe and

Communication, Trust, Participation

The group decided to have a vote on the matter. Concept Four told them that, since they were all active and responsible members of their group, they all had a voice and a vote.



So, the vote was taken and Joe was encouraged by the strong show of hands in favor of his brand of coffee...



...but then came the vote for the regular brand.

Typically, a trusted servant's Right of Decision is honored in A.A., but when those decisions affect our common welfare in the way our coffee does... well... you can count on someone to write an agenda item.



Though he was disheartened, Joe knew that Concept Five gave him the "Right of Appeal," and boy, did he plan to appeal.




Joe raised his hand high when the secretary asked for "Minority Opinion," and then he laid his heart on the line.




Unfortunately for Joe, no one made a motion to reconsider.

Joe was devastated.



Joe nursed his resentments for a while as he studied Concept Six. In doing so, he realized that the further down the service structure they go, the more trusted servants have a say in service matters.


Joe felt a spiritual awakening come over him. He'd take the matter to District and get them to make his group honor his decision.



Unfortunately, the DCM told him that Tradition 4 gave groups autonomy, so his group could do whatever they wanted with their coffee, but he also mentioned that the district meeting was looking for a new coffee maker.



Soon, Joe was back in business as the new coffee maker for the district meeting.



Unfortunately, Concept Seven ended things. Certain groups in the district protested about the high coffee expenses that were suddenly incurred by their district committee.

The DCM explained to Joe the importance of maintaining balance between the group's "Power of the Purse" and the district's "legal instruments."



It was simple really. The groups provided the district with money to provide services, and they determined that less-expensive, regular coffee was good enough at district meetings. This meant that the district treasurer could write a legally-binding check for expensive coffee if he wanted to but...




...there would be consequences.

Groups would/could withhold Seventh Tradition contributions and the district would/could go broke.

(Of course, the groups would do the responsible thing and let the district know WHY they stopped sending in money, otherwise the Power of the Purse becomes a meaningless drying up of the funds.)



Joe had a hard time dealing with Concept Seven...




...so much so, that he immediately read up on Concept Eight and decided he would stand for DCM at the next district election. His reasoning was that, as DCM, he would be a "principal planner and administrator," meaning (in his mind) that he could make the decisions, and make sure things were done his way.



He figured he could influence the district budget to make it work the way he wanted it to, so he could get his way...



He fancied himself as a leader with a better vision.



Fortunately, the district had a different vision and he didn't get elected. Concept Nine safeguarded the election process and district was able to elect someone else.



They saw that Joe's idea of leadership had nothing to do with the group conscience. He wanted to make it all about him and his choices instead.


In not electing Joe, they actually did him a favor. When you make it all about you in A.A. service work, it can quickly become all about you in a way you don't like.




In A.A., servant leadership is about helping the group (at all levels of service) to achieve their own goals.

It's more about serving the group's vision rather than our personal one. A trusted servant is a facilitator of the Group Conscience, not it's director.


We help the group achieve it's goals, not ours.



As a result of Joe's attempt to take control, both Joe's old home group, and the district, decided to follow the recommendations of Concept Ten and develop a set of guidelines to define the responsibilities and authority of each of their coffee maker positions.



The guidelines were clearly stated and helped everyone understand the duties of a coffee maker much, much better.




The whole predicament served to reinforce Concept Eleven and the need to have competent, qualified, people around our chosen leaders for them to consult with, and to remind them that no one does this for themselves, or by themselves. It turned out to be a great opportunity for spiritual growth for everyone


involved... even Joe.



Good leaders with vision are indeed hard to find and we in A.A. must do all we can to ensure that we chose ours thoughtfully.



Concept Twelve contains the "Six Warranties," which serve as great reminders and are an excellent summary of many of the principles found throughout the Concepts. They provide us all with a clear vision of how we can stay safe and continue to grow as trusted servants, at all levels of service, and as a society.



In the end, these Concepts are about communication and balance. We must strive to maintain clear and consistent communication so that all levels of our service structure are provided both the servants and services they require to maintain the careful balance that is necessary for our inverted triangle to continue to function effectively.
