The conference was held in New York City from April 17th through the 23rd. There were 93 Delegates from North America in attendance. In addition there were staff from the General Service Office, non-Trustee Directors and Trustees of our two Corporate Boards: the Grapevine and Alcoholics Anonymous World Services, and Class A & Class B Trustees.

We met on the common ground of love and tolerance and the examples of those in attendance reflected those spiritual principles. I was honored to be counted amongst their numbers. It was obvious everyone in the room loved Alcoholics Anonymous.

At our Spring Assembly I was given the "levity" to find a Trustee to attend our Fall Assembly to be held in Lewistown on September 17 & 18. That search is over and Linda Chezem, past Class A (non-alcoholic) Trustee will be joining us for the weekend.

Mary D. formerly of the Bitterroot Valley also sends her greetings. Mary now works at the General Service Office in New York, currently assigned to the Literature desk. Mary misses Montana and she wanted me to say Hi to everyone on her behalf. She is doing a great job at the Office and was in attendance at the Conference.

One other item I wanted to mention. Thank you to the groups and individuals who sent cards, letters and faxes to New York. Everyday my message light was blinking in the room and that meant I had mail. One morning, I picked up 16 pieces of mail prior to the start of a committee meeting. Everyone on the committee wanted to see the cards and we may

have started a little late that morning. Thank you again – the communication from home added to the experience in a very special way.

The agenda item to broadcast the flag ceremony at the International Conference in Toronto was approved. There will be ONE password issued for each Area.

The cost of the broadcast will be absorbed by the International Conference. The reason the broadcast is limited is due to a financial decision. The more passwords that are issued the more bandwidth that will be required to send the broadcast over an extranet communication link.

There is the internet for world wide use, there is an intranet that is a closed system used mainly in large offices, and then there is an extranet which is an expansion of an intranet. The broadcast will be on an extranet connection. In addition, the broadcast will be anonymity protected and be encrypted. The encryption will not allow the broadcast to be copied.

Having only one password for Area 40 creates a challenge. Where and who in Montana will get the

As of March 1, 2005 you can call 1-800-655-4069 and reach the District's answering service. This is expected to cost about \$20 per month more than the District is currently paying. The rational behind the 800 number came from comments made by distant groups within the District where newcomers have to dial a long distance number to reach the hotline.

There was a sense

that newcomers in the outlying towns would not as readily call a Bozeman prefix to contact AA from their outlying town also. As part of the District's attention to the answering service, we are planning a 12 step call training event for both AirPage Communication and AA members on the 12 step calling list.

The PI committee has been placing ads in the Bozeman Daily Chronicle over the Christmas holidays and is planning on placing more ads with the toll-free number after the 4th of July, Thanksgiving and Christmas/New Years holidays.

From the Area 40 Archivist

For those of you who are unfamiliar with Archives, I would like give vou a brief description of what I do as the Archivist. The primary job of the Archivist is the collection and preservation of Area 40's history. This includes oral histories via interviews, Area Assembly minutes, District minutes, Area activities such as roundups. We also assist local Archive committees in their effort to preserve our history.

Area 40's repository is located in Great Falls where I live. Because of

an expired lease and an increase in rent we were forced to move the repository to a much smaller room. I am currently looking for a new location. I realize that the repository might be moving in the next two years, but we must still provide for the proper preservation of our records. For future reference. I believe a climate controlled room or building of approximately 500+ square feet is needed currently to store everything and to provide a work area for the Archivist and his or her aides.

Since the last Assembly, I have been busy with the Ad Hoc committee on revising our Policy and Procedures document. I have passed out draft copies to all DCM's and the Area Chairs. It was suggested I do this so people would have a chance to look at what they will be voting on in the fall.

I have also received district minutes from various districts and I thank the District secretaries for their consideration. The storage of district minutes and flyers at the Area Archives provides a backup for those districts with an active Archives committee and a repository for those districts that do not.

I wish to thank those people who have expressed an interest in Archives and who believe, as I do, that Archives is a vital tool in our 12 step work.

The Area committee chairs led eight breakout sessions where we had some thought provoking discussions on the agenda items. I think we had a great turn-out and some good food, as well.

Our District finances are healthy as we enjoy good support from the groups and we finally passed the budget at our March meeting. AA members are regularly speaking in the treatment and mental health center, in the high schools and


are taking several meetings into the correctional facility weekly.

From Your Area Treatment Facilities Chair

We have hit the ground running in treatment this season. A contact list of district treatment chairs has been sent to everyone in the Area. We are lucky enough to have treatment chairs in 9 out of 14 districts so far. We are hoping to hook everyone up to promote communication and make the sharing of experience between the districts easier.

The state has opened a new WATCH East program in Glendive. That program has a capacity of 40 beds and houses all the women sentenced to the WATCH program plus about 15 men at this time. We are helping them replicate the Bridging the Gap (BTG) program for graduates at that facility. Jim H. from District 31 says they are getting a great turnout for the 2 meetings a week.

We have also been in contact with the Mission Mountain School in Condon. A young woman there wrote GSO and they referred her to me. We are talking to them about what type of services we can provide them, probably just literature at this time plus BTG.

Currently we have two additional projects. One is developing a directory of all the facilities in the state. We would like to maintain a list of all the AA contacts, all the facility contacts and the guidelines for taking meetings into each facility. If we do not have a relationship with a facility yet, we hope to work with local AA's to follow up with each facility.

The other related project is to make sure staff at each facility knows about AA and to develop a packet of materials available to anyone leaving the facility. This packet might include flyers, pamphlets and local meetings lists or simply information about the Area 40 website so that staff know where to refer clients to get local AA information. —Lee G.
