### FROM OUR DELEGATE

### What To Do With Rusted Servants?

One of the enjoyable things about being delegate is that you get to correspond with a number of other delegates. Nowadays we do this almost exclusively by e-mail. Recently, John S., a panel 56 delegate for Area 3, Arizona, brought up the topic of past delegate responsibilities and asked all the other delegates, "What does your Area do?" Responses came from twenty-six delegates and the responsibilities of past delegates in different Areas ranged from "no responsibilities at all" to quite extensive responsibilities. I thought it might be interesting to share some of the responses with you, but before I do so, let me assure you that I am not advocating for any change in how Area 40 treats past delegates. Personally, I like the way we do things around here.

In the following, I have include quotes around anything that I have stolen verbatim (though the culprits will remain anonymous for the sake of the quilty).

Quite a few Areas (seven of the twenty-six) do not have any specific responsibilities for past delegates. They "just

put the past delegates out to pasture and call them 'rusted servants'." Or, as another delegate put it, past delegates "sit along the back wall and are expected to shut up and act spiritual." Even in Areas with no specific responsibilities for past delegates, the past delegates are often kept busy in informal ways. Some of these Areas have past delegates chair ad-hoc committees, conduct Traditions, Service Manual, and GSR workshops, or just help out as needed.

In a couple of Areas, the immediate past delegate is "promoted to magazine salesman." In other words, they rotate into the position of Grapevine Chair. There does not seem to be any choice in these Areas, even for rotating delegates that do not want to be Grapevine Chair, though one of the Areas that has this practice has been discussing the possibility of an opt out clause. In our Area, the Grapevine chair has worn an outfit covered in purple balloons to some service events in order to increase awareness of the Grapevine. I'm just picturing the delegates from these other Areas wearing purple balloons.

Many Areas have the immediate past delegate serve on a committee: on the Finance Committee in some Areas: on the State Convention Committee in other Areas: on the Current Practices Committee in one Area; and on the Area Guidelines Review Committee in another. These commitments are for two years in some Areas and four years in other Areas. In some Areas, the past delegate is just a member of the particular committee and in other Areas, the past delegate is chair or cochair of the particular committee.

A number of Areas have the immediate past delegate serve a two-year rotation as Past Delegate Advisor. The responsibilities for this position vary from Area to Area. See the footnote below for the responsibilities of the Area Advisor in Area 40, a position that Scott W. is doing a great job at the moment, and to which I aspire to in the next rotation. The coffee will not run out on my watch.

Six of the twenty-six delegates that responded said past delegates do have a vote at their Area Assemblies. In informal discussions with other delegates, whether or not past delegates have a vote does not seem to affect whether they attend Area Assemblies or not. That's nice

because, as another delegate wrote, "it is just fun to have them around."

So there you have an informal and incomplete survey of what some Areas do with their past delegates. I want to thank all the delegates who responded. Just as each group is autonomous, so is each Area autonomous in how they decide to organize their service structure to best meet the needs of the Area. This

includes how they handle their "rusted servants."

<sup>1</sup>In Area 40, the immediate past delegate serves as Area Advisor for a two-year rotation. This position involves making sure the coffee does not run out at Area Assemblies and, a recently added responsibility, organizing two Service Workshops each year. In addition, two past delegates are

invited and supported to attend each Area Assembly (we have two a year) to share past delegate experience and lead workshops and breakout sessions.



### FROM OUR AREA CHAIR

This year, one of the tasks at hand for the Fall Assembly is providing Area 40's candidate for West Central Regional Trustee. The Trustees make up the twenty-one member General Service Board for the US and Canada. There are seven Class A or nonalcoholic Trustees and fourteen Class B or alcoholic Trustees.

Eight of the Class B Trustees are regional trustees, one Trustee-at-large US, one Trustee-at-large Canada, and four general service trustees. The General Service Board acts very similar to a corporate board. Meetings are held quarterly over weekends as well as during the General Service Conference.

Chuck B. from Iowa is our outgoing West Central Regional Trustee and will be in

attendance at our Fall Assembly. Past Trustees include Fay B. and Bud G. from North Dakota, Ted S. and Joan S. from South Dakota, Carl B. from Wyoming, Dan B. from Iowa, Les L., Don F., James G. from Nebraska, and Don B., Don N. and Don P. from Minnesota.. You should see a trend here. We have yet to put a candidate forward from Area 40 that has been elected West Central Regional Trustee. So, I strongly encourage you to consider who in Area 40 fits the qualifications and would represent Alcoholics Anonymous as a whole.

#### Qualifications:

- 1. Ten years of sobriety is recommended.
- 2. Experience in both Area and local AA service.

- 3. Background and willingness to make decisions on matters of AA policy.
- 4. Recognize that the Trustee serves the entire Fellowship, not just a geographic area.
- 5. Time available to attend Board meetings, Corporate Board (either AA World Services or Grapevine) meetings, and the General Service Conference.

Our Delegate, Andrew, will conduct the election utilizing the Third Legacy procedure. Candidates will provide their service history at the Assembly. Once we have chosen our candidate. Andrew will send their resume to the General Service Office.

In prayer, look around the Area. Visit with Past Delegates and Past Area 40 Committee members. Encourage those interested attend the Assembly and stand for the posi-

## Finance - Curt K.

Consider setting the Area 40 Prudent Reserve at 50% of the budget for "essential services" rather than 50% of the full Area 40 budget. (see attached "Essential Services Budget")

Essential services would include:

The Spring and Fall Assemblies (budgeted to reflect the higher actual costs of the Spring 2007 Assembly)

Regional Service Conference and Forum for the Delegate only

Area 40's share of the Delegate's expenses set at the amount suggested by the General Service Conference (currently \$1,200)

Full funding for the Area Chair travel expenses to Districts and distribution of agendas and background material

Administrative expenses only for the Secretary, Treasurer, and Webmaster

Publication and distribution of the Triangle on a quarterly basis only

Review the financial status of the Area. Recommend the 2008 Area 40 Budget.

## <u>Public Information/Report & Charter – Sean B.</u>

Consider expanding the area 40 website to include dissemination of other materials such as reports from the annual General Service Conference, information coming from the General Service Board throughout the year, and other materials that might continue to improve the communication between all levels of the service structure.


