# OPPORTUNITY FOR SPIRITUAL GROWTH

In 1958, Bill W. spoke about a particular General Service Conference that held hope and was filled with promise because it had trouble and "converted that trouble into an asset, into some growth, and into a great promise." As Bill Sees It, p. 82. Area 40's trusted servants, in this rotation, may well have a similar opportunity to turn trouble into an asset and into growth, and perhaps even into a great promise.

This fall in Lewistown, in addition to reviewing what happened at this year's General Service Conference, we have a bevy of "local" (Area 40) matters. We have questions about where to hold and how to host both a local forum and the 2012 West Central Regional Service Conference. We have agenda items about Area funding our Archives displays at group/district events, changing how we nominate our Area standing committee chairs, standardizing agenda items in a particular format, adding additional duties and qualifying requirements to some of our Area officers' job descriptions, and clarifying how Area funds the costs of our standing committee chairs and officers attending

pre-assemblies. In addition, we have further reports on our Area Hot Line, a report on an inventory of the Triangle's effectiveness and purpose, and the annual job of preparing our budget for next year.

Many of these matters could divide us. We could disagree, in good faith, about what is best for AA in Area 40. We could disagree, vehemently, about what will best serve the still suffering alcoholic. But, to paraphrase what Bill said in 1958, if our Assembly is ruffled, if individual participants are deeply disturbed, that will be fine. Just like the New England town meeting democracy upon which Bill modeled our formal service structure, friction of opposing viewpoints is the very method of operation upon which we proceed.

With the help of our Higher Power, we can arrive at a true group conscience on each of the issues we must decide. We prefer near unanimity, where everyone is comfortable with the outcome even if not all of us are in full agreement. We know that the good can be the enemy of the best, and sometimes it can be better to postpone a decision

instead of adjourning with a very unhappy minority. Here are some tools we might pray to keep in mind:

- Help us to listen instead of engaging in side conversations
- Help us hear with an open mind, before reacting
- Remind us to encourage newer folks to share
- May we speak up and share our concerns and questions – clearly and succinctly
- Let us hear all points of view and encourage any silent minority to speak
- Help us be wary of dominant personalities or powerful advocates and move slowly
- Please keep us from rash or rushed decisions – again, help us slow down
- Give us the strength to avoid pointing fingers
- Grant us the clarity not to take things personally
- Keep in our minds the truth we are all here because we care about AA.

- B. Consider changing Paragraph G10.12 of the Area Policy and Procedures Manual to read "The Triangle Editor must be computer literate with knowledge of word processing software. If necessary, Area 40 will provide the Editor with a computer, printer, scanner and all software necessary to produce the Triangle."
- C. Consider changing the last sentence in paragraph G 11.4 of the Area Policy and Procedures Manual to read "The Secretary must be computer literate with knowledge of word processing software."
- D. Consider adding a guideline to the Area Secretary at G 11 of the Area Policy and Procedures Manual to read "The Secretary will serve as the Area Registrar and be responsible for updating GSO's database, Fellowship New Vision (FNV). As Registrar, the Secretary will update group, district and Area information and work closely with each DCM to assure the Area groups are receiving correspondence from the General Service Office."
- E. Consider adding a guideline to the Area Chair at G 13 of the Area Policy and Procedures Manual to read "Shall work throughout the rotation with the Area Standing Committee Chairs and the Triangle Editor regarding succession planning for the next rotation and with the Chairs and Editor will seek out persons interested and knowledgeable to stand for election in the next rotation.
- F. Consider adding a line item for pre-assemblies to the Area 40 budget, to defray the expenses of Area Officers and Chairs for participation in three (3) pre-assemblies each spring, one in each generalized portion of the Area Eastern, Central and Western Montana either face to face or by teleconference (per the host district's preference for each pre-assembly each year, keeping in mind expenses), with the districts in each portion conferring and deciding whether to hold such a pre-assembly and, if it will be held, which district will host it.
- G. Review the Triangle inventory.



- What does our group accept as "substantial unanimity"?
- Has our group experienced the "tyranny of the majority" or the "tyranny of the minority"?
- Does our group understand the importance of all points of view being heard before a vote is taken?

**Concept VI:** The Conference recognizes that the chief initiative and active responsibility in most world service matters should be exercised by the trustee members of the Conference acting as the General Service Board.

- Are we familiar with how our General Service Board (G.S.B.)
  Class A and Class B trustees serve A.A.? Are we familiar with
  how our other trusted servants serve A.A.?
- Are we clear about the terms, "chief initiative" and "active responsibility"?
