ELECTION ASSEMBLIES

My name is Sharon S. I am an alcoholic and currently serving as your Area Delegate. Two years ago, at the 2012 Fall Assembly, I was elected (by lot, in other words from the hat) to this position. I am grateful for the trust and willingness that put my name in the hat, and grateful that it was the one drawn. These past few months I have been thinking about our election assemblies and the process we use to elect our area delegate, chair/alternate delegate, secretary and treasurer.

In the beginning (1950, quite a few years before my first Area Assembly), a general service assembly was held only to elect committee officers and the delegate to the Conference meeting. Since then, we have used this opportunity to make other decisions about how to best serve the alcoholic who still suffers and as an opportunity for groups and districts to share their experience, strength and hope. Our 2014 Fall Assembly is an election assembly.

Once it was decided to have a General Service Conference, selection of the A.A. members to attend the conference was given much thought and consideration. Our early members wanted to avoid destructive politics and struggles for prestige and glory and, believed that many of these problems were caused by personal nominations and in close elections. Written ballots and no nominations, the two-thirds vote, a way to gradually eliminate lower vote-getters, and a lottery in the case no candidate achieves two-thirds was the solution— our Third Legacy Procedure. I am hoping we will have a good turnout at the Fall Assembly and many will see it in action and that there will be several candidates standing (not running) for Area service positions.

Area 40 Policy and Procedures https://www.aa-montana.org/pdf/area/policyProceduresFall2013.pdf includes service guidelines and qualifications for all Area service positions and the current officers and chairs are available for questions and discussion. Candidates for all Area Service positions are asked to state their sobriety date and service background. The A.A. Service Manual suggests anyone thinking of standing for delegate consider a few questions. With a few minor changes, these are good questions to ask when considering standing for any service position, so I am including them here:

How well did you do in current or past service positions? Did you enjoy the responsibilities? Were you active?

Have you discussed the possibility with your family and employer? Will the time be available for the work required?

Have you read about the position in the Policy & Procedures and Service Manual? Are you familiar with the Twelve Steps, Twelve Traditions, and Twelve Concepts?

Have you talked to others who have held the position to get an idea of the time and effort required?


I really like the first question, as it has that quality of self-appraisal. I was able to look back over my years of service and admit where I did not do a good job and where I did well and acknowledge where I might need help. For example, as Area Secretary I was late getting the minutes out four out of four times! The miracle there was that I didn't quit after the first missed deadline! This was the lesson for me in that position, keep showing up until it's done!

The other experience I have to share is this: eventually, after all my analyzing and worrying and decision making, I let God decide. In other words, if I am able, I stand; God takes care of the rest! And what a fabulous job He does.

Thank you for this experience and I'm excited to hear stories about rotating on to our next service opportunities!
