Our Area has two assemblies every year, one in the Spring and one in the Fall. At the Spring assemblies, we spend a lot of time on the General Service Conference Agenda, and throw in some Area business. At the Fall assemblies we will do an area inventory and have elections, as well as review the GSC agenda and do any other Area business.

Your GSR's and DCM's have a vote at these assemblies. Their job is to get your feedback, and bring it to the assembly. They also serve on committees to bring the business to the Assembly floor. Their participation along with your thoughtful feedback is the top of our upside down service triangle (pg. \$16 in the Service Manual). So as you review the items for which your GSR wants feedback, give them your time and attention, it's what AA is all about.

Why Do We Need a Conference (Assembly)?

The late Bernard B Smith, nonalcoholic, then chairperson of the board of trustees, and one of the architects of the Conference structure, answered that question superbly in his opening talk at the 1954 meeting:

"We may not need a General Service Conference to ensure our own recovery. We do need it to ensure the recovery of the alcoholic who still stumbles in the darkness one short block from this room. We need it to ensure the recovery of a child being born tonight, destined for alcoholism. We need it to provide, in keeping with our Twelfth Step, a permanent haven for all alcoholics who, in the ages ahead, can find in AA that rebirth that brought us back to life.

We need it because we, more than all others, are conscious of the devastating effect of the human urge for power and prestige which we must ensure can never invade AA. We need it to ensure AA against government, while insulating it against anarchy; we need it to protect AA against disintegrations while preventing over integration. We need it so that Alcoholics Anonymous, and Alcoholics Anonymous alone, is the ultimate repository of its Twelve Steps, its Twelve Traditions, and all of its services."

So why do we have an Assembly?.. Because it is our responsibility to take care of our solution to alcoholism and to protect that *permanent haven* that we have been blessed to find.

And because it's a lot of fun and there's usually plenty of chocolate. I'll see you there...
