### Headquarters is coming to Area 40!!!

Summer is indeed upon us in Area 40. Temperatures are hovering around triple digits and there is the slight taste of smoke in the air in some places. This means two things; A.A. Campouts are in full swing (check the aa-Montana.org website for up to date information) and the Fall Area Assembly held at the Great Falls Holiday Inn on September 21—23 is only a few weeks away.

One of the items that we will be deciding on is the top three choices for venues in Area 40 to host the West Central Regional Forum in 2021. We went through this process at the Spring Assembly for hosting the West Central Regional Service Conference. Congratulations to District 11. Districts interested in hosting the Forum will make their presentation to the Corrections Committee where the top three contenders will be chosen and presented to the Assembly during the Corrections Committee report.

A.A. Regional Forums were created in 1975 as a way to improve communication between "Headquarters" (as Bill used to call the General Service Office) and the various eight regions that make up the General Service Conference. The Forums are brought to each region every other year. Members of the General Service Board, staff members from A.A. World Services and the Grapevine also attend. As the A.A. Service Manual says about Forums, "...they provide unique opportunities to share and exchange valuable experience, ask questions and spark new ideas."

At the most recent Forum that I attended, they tried out a new strategy to help the staff from the General Service Office visit with A.A. Members on a more informal basis. This was done by sharing meals with the members of an Area and a member of the staff or board. This was a very special time to spend together. It served as a great way for me to discover that it is not They or Them; It is US. I was able to see and understand that we are all there working to "carry the A.A. Message of love and service."

I would strongly encourage all members to attend a regional forum and to especially consider attending the forum that will be held in Area 40 in 2021. If you are fortunate enough to be a member of a District selected to host the Forum I would also like to encourage you to volunteer for a position on the host committee. #### **Never too young**

After yet another geographic "cure," I was going to AA meetings and making trips to the ladies' room to drink. I sometimes left the meeting drunker than when I arrived. Yet people welcomed me anyway. They shared their experience with drinking and sobriety with me, and told me to keep coming back. Members even helped me get to meetings.

Then one day, in the summer of 1971, I finally realized that I was beyond human aid. I asked the power that enabled these other alcoholics to live sober to help me. I have not had a drink since that day. I was 19 years old.

I began to go to lots of meetings and learn about the Twelve Steps and about growing along spiritual lines. I began to practice these principles in all of my affairs—which also included giving up having affairs!

Greetings Area 40 Members,

Here is the Answer Net Bill and report for July 2018.

There were 20 calls to Answer Net. 19 were legitimate calls for a potential alcoholic looking for help or information. One was a AA Group in Polson asking for name to be changed and meeting information on website. PLEASE contact the Area 40 Webmaster or your DCM to find out how to change that information.

The Area is charged per call, so please don't use the hotline for general AA business. I also will say, this month seven of those calls took 8 or as many as 17 calls to reach a volunteer. In my opinion, that is unacceptable. Please....If you are going to volunteer to be a contact for the Hotline, put accurate information of availability and phone numbers to reach you. Then put the AA Hotline number they call from (406-248-2337) into your contacts, so when a call comes in, you will see on caller ID it is the AA Hotline and know to answer right away or call back ASAP

The bill for July was \$227.50. Under the Area 40 budget of \$250.00 and Area 40 picked up the cost. I did receive a email from the Answer Net Service informing us of a rate increase that could be quite significant, but will wait to discuss this in more detail once I talk to the main manager who has authority over that issue when they return from vacation August 13. So more to come in next few weeks regarding that.

Being the youngest AA in the area at that time, I was asked to chair quite a few meetings and anniversaries. Even TV and newspaper reporters wanted to interview me. That's when older members in our Young People's group explained to me the importance of our Traditions—especially anonymity. Of course, I could do as I chose, but to follow the Traditions, I could either talk about AA anonymously, or not be anonymous and not mention AA. I thought the message of AA was more important than the messenger, so I chose anonymity. I'm grateful for those young members—who were only two or three years sober at the time—who explained this to me.

Most of us in that small Young People's group are still sober today, some since the late 1960s. That group no longer exists, but we do. Our lives have been saved. We get to enjoy a life worth living.

I'm now 65. Over the years, my damaged liver healed, my relationships improved and my faith in a living God grew. Alcoholic drinking restricted my freedom in so many ways. The Third Step increased it. How wonderful!
