Spring Area Assembly Agenda Items

We have a multitude of agenda items from the General Service Conference (GSC) and Area 40. These agenda items are broken into three different categories: review, discuss, and consider. Agenda items listed with "review" and "discuss" primarily are just that, review and discuss and rarely is there a vote taken unless our Area Delegate specifically requests a "sense of the area." Agenda items listed with "consider" are primarily agenda items that will be voted on during our Area Assembly.

Our Area 40 vote doesn't determine the GSC agenda items but does give our Area Delegate a sense of our Area, where as a vote taken on Area 40 agenda items will determine whether that agenda item passes or doesn't.

I have listed below only agenda items with "consider" to save on space. I have left some "review" items due to interest and discussion that was expressed at the West Central Region A.A. Service Conference I attended in Billings February 28 - March 1, 2020.

- Consider voting privileges to be granted to the Archivist, Webmaster, Area Advisor & Bridging the Gap Chair.
- Consider creating a new Area 40 Hotline Chair rotating position that will be separate from the Area 40 PI Chair rotating position.
- Consider rotating Area Assembly between 2 locations by allowing the Area Advisor to select the next location by accepting bids from interested districts.
- Consider implementing an Area Officer Training that will be held in October after elections for the new Area Officers and Area Committee Chairs.

- Consider requests to develop a book on A.A. history from 1955 through the present.

Tradition Two Snip-it

For our group purpose there is but one ultimate authority, a loving God as He may express Himself our group conscience. Our leaders are but trusted servants; they do not govern.

“Sooner or later, every AA comes to depend upon a Power greater than himself. He finds that the God of his understanding is not only a source of strength, but also a source of *positive direction*. Realizing that some fraction of that infinite resource is now available, his life takes on an entirely different complexion. He experiences a new inner security together with such a sense of destiny and purpose as he has never known before. As each day passes, our AA reviews his mistakes and vicissitudes. He learns from daily experience what his remaining character defects are and becomes ever more willing that they be removed. In this fashion he improves his conscious contact with God.

Every AA group follows this same cycle of development. We are coming to realize that each group, as well as each individual, is a special entity, not quite like any other. Though AA groups are basically the same, each group does have its own special atmosphere, its own peculiar state of development. We believe that every AA group has a conscience. It is the collective conscience of its own membership. Daily experience informs and instructs this conscience. The group begins to recognize its own defects of character and, one by one, these are removed or lessened. As this process continues, the group becomes better able to receive right direction for its own affairs. Trial and error produces group experience, and out of corrected experience comes custom. When a customary way of doing things is definitely proved to be best, then that custom forms into AA Tradition. The Greater Power is then working through a clear group conscience.

We humbly hope and believe that our growing AA Tradition will prove to be the will of God for us.”

- Consider amending a sentence in Article 4 of the current Conference Charter.

- Consider a request to change the language of the first sentence of the A.A. Preamble as follows: "Alcoholics Anonymous is a fellowship of people who share..."
- Consider a request to develop an AA Grapevine pamphlet on how the AA Grapevine can be utilized to carry the A.A. message.
- Consider a request to change the name of the General Service Conference Committee on Grapevine to the Conference Committee on Grapevine and La Viña.
- Consider a request for AA Grapevine, Inc. to establish an Instagram account in line with the Twelve Traditions.

Policy & Admissions – GSC

- Consider a proposed process for approving observers to the U.S./Canada General Service Conference.
- Consider implementing electronic voting for trustee elections.
- Consider continuing the review of dates for the General Service Conference with timing and year(s) to review as requested by the general manager.
- Consider a proposed process for how a Conference committee could review, discuss and act on proposed agenda items not forwarded to a Conference committee.
- Consider a proposed process for equitable distribution of Conference committees’ workload.

Why should GSRs and DCMs Attend Area 40’s Spring Assembly?

The Area 40 Spring Assembly is three weeks away. Is your group sending your General Service Representative (GSR) to represent your group? Is the District Committee Member (DCM) of your district planning on attending? Do you know why it is important that your group and district attend Area 40’s Spring Assembly?

Alcoholics Anonymous is an upside-down organization, “because, as the structure chart shows, the groups are on the top and the trustees at the bottom. Bill W. wrote in Concept I: *The A.A. groups today hold ultimate responsibility and final authority for our world services*. Then in Concept II, Bill made it clear that the groups *delegated to the Conference complete authority for the active maintenance of our world services*

Tradition Three Snip-it

The only requirement for A.A. membership is a desire to stop drinking.

“Tradition Three defines the personal liberty of the AA member. It says, in effect, that any alcoholic can be an AA member the moment he says so. Neither can any of us deprive him of that membership, no matter what his behavior. Perhaps no other society has ever staked out such a broad expanse of liberty for the individual as this. Every AA newcomer feels at once that he is wanted and trusted and loved. How well we understand his needs; certainly we have had them ourselves. Seldom has any alcoholic taken unfair advantage of that unlimited charter for freedom. We took this decision for individual freedom years ago. We are glad that we did there has never been any cause for regret.”

“That is why we all judge the newcomer less and less. If alcoholism is an uncontrollable problem *to him* and *he* wishes to do something about it, that is enough for us. We care not whether his case is severe or light, whether his morals are good or bad, whether he has other complications or not. Our A.A. door stands wide open, and if he passes through it and commences to do anything at all about his problem, he is considered a member of Alcoholics Anonymous. He signs nothing, agrees to nothing, promises nothing. We demand nothing. He joins us on his own say-so. Nowadays, in most groups, he doesn’t even have to admit he is an alcoholic. He can join A.A. on the mere suspicion that he may be one, that he may already show the fatal symptoms of our malady.”

Concept Two Bite

When , in 1955, the A.A. groups confirmed the permanent charter for their General Service Conference, they thereby delegated to the Conference complete authority for the active maintenance of our world services and thereby made the Conference—excepting for any change in the Twelve Traditions or in Article 12 of the Conference Charter—the actual voice and the effective conscience for our whole society.

“Exactly as Dr. Bob and I earlier had found it necessary to delegate a large part of our active authority to the Trustees, so have the A.A. groups since found it necessary to delegate these same powers to their General Service Conference. The final say—the ultimate sanction in matters of large importance—has not been given to the Trustees alone. By the Conference Charter, confirmed at St. Louis, this authority is now delegated to the A.A. groups and thence to their Conference, a body which is a representative cross section of our entire fellowship.

Therefore the General Service Conference of A.A.—plus any later formed sections—has become for nearly every practical purpose the active voice and the effective conscience of our whole Society in its world affairs.

In making this momentous transfer, we old-timers deeply hope that we have avoided those pitfalls into which societies have so often fallen because their originators have failed, during their lifetimes, to properly delegate and distribute their own authority, responsibility, and leadership.”

and thereby made the Conference... the actual voice and effective conscience for our whole Society.” But for this to happen—the groups to be the “ultimate responsibility and final authority” and the Conference to be the “actual voice and effective conscience for our whole society”—each group and district need to participate.

Your group’s GSR holds your group’s conscience, and as they weigh and consider the information presented at Area 40’s Spring Assembly, they will represent your group with their vote and with their discussion. The agenda items we will discuss at the Spring Assembly affect Alcoholics Anonymous as a whole, which means all groups, districts, and areas. “Only when the G.S.R. keeps the group informed, and communicates the group conscience, can the Conference truly act for A.A. as a whole.”

Your district’s DCM is “part of the area committee” and “is an essential link between the group G.S.R. and the area delegate to the General Service Conference. As leader of the district committee, made up of all G.S.R.s in the district, the D.C.M. is exposed to the” district’s group conscience. “As a member of the area committee, he or she is able to pass on the district’s thinking to the delegate and the committee.”

A True and High and Constant Purpose

“When I was asked to write a greeting for this Conference, I think I used the word *family* in describing A.A. for perhaps the first time. It occurred to me that we were more than a therapy, more than a group of alcoholics trying to get along in the world. We here in this room are small fragments of a huge and growing family, a fragment collectively designated for the time being as trusted servants for the rest and appointed to a mission which will further our purpose and destiny.”

Why do We Need a General Service Conference?

“The late Bernard B. Smith, non-alcoholic, then chairperson of our board of trustees, and one of the architects of the Conference structure, answered that question superbly in his opening talk at the 1954 meeting: ‘We may not need a General Service Conference to ensure our own recovery. We do need it to ensure the recovery of the alcoholic who still stumbles in the darkness one short block from this room. We need it to ensure the recovery of a child being born tonight, destined for alcoholism. We need it to provide, in keeping with our Twelfth Step, a permanent haven for all alcoholics who, in the ages ahead, can find in A.A. that rebirth that brought us back to life.

We need it because we, more than all others, are conscious of the devastating effect of the human urge for power and prestige which we must ensure can never invade A.A. We need it to ensure A.A. against government, while insulating it against anarchy; we need it to protect A.A. against disintegration while preventing over integration. We need it so that Alcoholics Anonymous, and Alcoholics Anonymous alone, is the ultimate repository of its Twelve Steps, its Twelve Traditions, and all of its services.

We need it to ensure that changes within A.A. come only as a response to the needs and the wants of all A.A., and not of any few. We need it to ensure that the doors of the halls of A.A. never have locks on them, so that all people for all time who have an alcoholic problem may enter these halls unasked and feel welcome. We need it to ensure that Alcoholics Anonymous never asks of anyone who needs us what his or her race is, what his or her creed is, what his or her social position is.” - Reprinted from *The A.A. Send your group's GSR to a Pre-assembly.**Learn More about the Agenda Items - Be Informed**

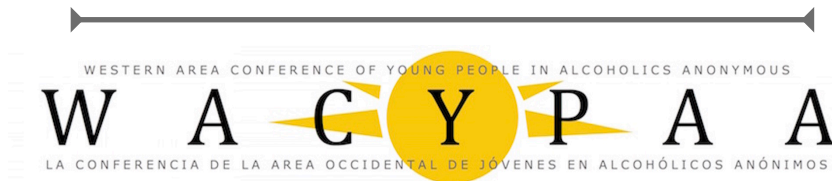
Send your group's General Service Representative (GSR) to a pre-assembly that is located closest to your District. Ask your GSR if they have received the background information on the agenda items. If they haven't, ask them to speak to your District's District Committee Member (DCM). Your GSR will receive more information at the Pre-assembly about the Spring Assembly agenda items and can inform your group. Your GSR can then bring your group's conscience to the Spring Assembly.

The GSRs represent the groups of the Area and in turn our Area Delegate, Paul L., represents our Area (all our groups) at the General Service Conference. Each of us needs to participate to truly have an informed group conscience. Together we uphold Tradition Two.

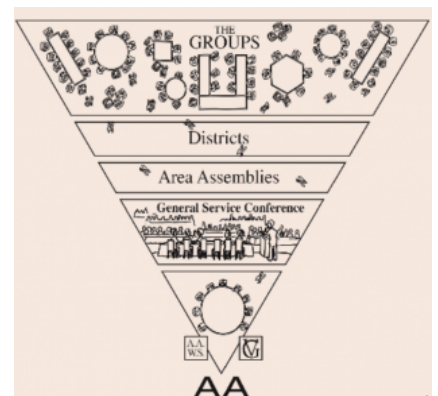
"This 'Right of Decision' should never be made an excuse for failure to render proper reports of all significant actions taken; it ought never be used as a reason for constantly exceeding a clearly defined authority, nor as an excuse for persistently failing to consult those who are entitled to be consulted before an important decision or action is taken.

Our entire A.A. program rests squarely upon the principle of mutual trust. We trust God, we trust A.A., and we trust each other. Therefore we cannot do less than trust our leaders in service. The 'Right of Decision' that we offer them is not only the practical means by which they may act and lead effectively, but it is also the symbol of our implicit confidence."

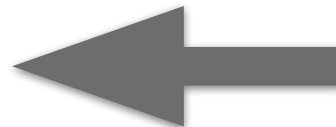
