Old Business

Report on the Joint District Pre-Assembly.

The Pre-Assembly went very well! Eight Area chairs attended with approximately 45 in overall attendance from Districts 11, 12, and 31. Next year Pre- Assembly will be in another District. Thank you to 644 for allowing us to use their space. Lots of good information was passed and discussed. Gas was the only expense that was reimbursed by the District's, but many expenses were avoided through the potluck and housing of Area chairs at local member's homes. The Treasurer has sent out checks to reimburse Area chairs and is receiving contributions from participating Districts. See enclosed financial report.

Review progress on the transfer of the 12 Step phone number to the District owned cell phone. Questions about how the District is able to receive texts and if there is a cut off date to that service. Chair explained that since we are paid up through the end of the year we will continue to receive texts and phone calls, but will not be able to respond via that same number due to Federal regulations. There is a desire to regain the ability to text back with the same number for continuity of service with professionals. Question presented if it is possible to switch to a new phone number and have service available for workshop, and answered it may be possible. Prefer to keep Grasshopper in service until another number is set up to keep service available to professionals. Due date to get a refund is now negotiable or non-existent. Questions about the length of the process of either.

Motion #19: (Aimee S./Nita R.) Motion to move that we start the transition now to a new number and disseminate the information by the Resource Workshop, May 16th.

New Business

Election of District Grapevine Chair position.

Michelle M. willing to stand. She has a home group, has read the Policies and Procedures, is just short on the sobriety guideline of 2 years, her sobriety date is 7-27-2023, and has a heartfelt interest and dedication to the Grapevine. The Grapevine is part of what introduced her to AA before she got sober. She is inexperienced in AA service work, but has lots of experience with

committees and running meetings outside of AA. No one else is willing to stand and no more nominations.

Motion #20: (Pat P.) All in favor of Michelle M. standing for Grapevine chair. 17 for, 0 against, 0 abstain. Motion carries.

Request for group support for service opportunities for the AA: A Resource Workshop.

Group members are needed to help with set up, clean up, registration, name tags, and lunch set up. Please take requests back to groups to gather support for the workshop, then reach out to Mitch A. Recovery Group willing to help with set up. Vince V. volunteered to help with greeting and will get others involved. Erika B. will help with paperwork after the workshop. Mitch A. reminded people that there is no free lunch for AA's that help with the workshop.

Discuss options for Delegate's report.

Prior to three years ago, District 11 and 12 worked together for a joint Delegate report. This year an offer was extended by District 12 to join them on Saturday August 9th at Fireman's Point Campground. District 11 will be required to provide breakfast on Saturday morning. This date corresponds with District meeting time, so District will be at another time. Joint District involvement helps with the Delegate only having to travel to this area one time instead of once for each District. Supplies for breakfast will be an expense to the District. District already has campsites rented with space available for District 11 use. The second option is to schedule our own Delegate report time, including a group to host and possible food.

Motion #21: (Nadine F./Annette R.) Motion to stay at Fireman's Point for the Delegate's report as we have done in the past. 16 for, 0 against, 0 abstain. Motion carries.

District will make use of past supply lists to determine what is needed for this year. Possibly reach out to Intergroup for their participation. Exploring options of when to have District meeting for August.

District in moving forward with filing for non-profit status.

Based on the amount of incoming money and Federal regulations, non-profit status is needed. Pat P., Debbie D., Lynne W., and Claire S. have been meeting. They need to file a non-profit with the state of Montana, file for a tax ID with the IRS, and then file the information return. There is a one time filing fee of \$275. There was discussion of getting outside help, but at this point it seems possible to file, also using the acquired information from other Districts. This status requires yearly filings to stay current, so it will need to be added to our Policies and Procedures so as to not fall off in subsequent years. The current tax ID number at the bank is not recognized with the IRS. If groups have more than \$5,000 of inflow on contributions, they may need to file for non-profit status. Help is available through the experience gained through this situation. Becoming recognized by the IRS does not relieve the Federal requirements with the Grasshopper app.

April CPC Report

Greetings District 11 Trusted Servants,

Here is the April CPC Committee Report:

I again attended the Spring Area 40 Assembly where I had the opportunity to see old friends as well as make some new ones. I participated in the Area CPC Committee meeting where we shared the events and work being done in our respective districts. There are a number of active districts in the area, among which we are counted, as well as some who have recently formed CPC committees or those wanting to. We discussed items and background information on the agenda. One of the items discussed was how to better integrate the neurodivergent population into AA. The November '24 Grapevine theme is regarding this topic. Our committee has been asked by the Area CPC Chair to present information regarding putting on workshops in a sharing session with other districts at a time yet to be determined. As a result of sharing upcoming workshop information with our contacts at RiverStone Health, we have again been asked to present information about AA to their medical staff. While at a downtown coffee shop last month I ran across a group of people with the Angel Initiative who were working with our two professional speakers to get addicted persons the help they need instead of incarceration. We had a brief conversation and exchanged contact information as well as inviting them to participate in our upcoming workshop. I received two reply emails from participants.

Our District CPC committee continues to meet every other Tuesday at City Brew; 1335 Golden Valley Circle. Beginning April 29th, we will meet EVERY Tuesday prior to the workshop. Our second AA speaker has been found and we are asking the groups to help with finding volunteers to help with tasks at the workshop. These jobs would be: 1) Room setup. 2) Room tear down/cleanup. 3) Lunch helpers. 4) Greeters. 5) Registration and money collection. I checked with the library last week and confirmed that we could use space outside of the meeting room to conduct registration. I have been contacted by a few individuals inquiring about the particulars of preregistration and helped them navigate the process. I was also approached bt a member wishing to contribute financially to the workshop. Those funds were forwarded ton our treasurer. We still need to confirm workshop participation by BTG. I have a number of event flyers available if anyone would like some to distribute.

We received one male 12 step request. This was responded to almost immediately; a BIG thank you to our male volunteers! I had a very pleasant conversation with the doctor to had contacted us and invited him to participate in the upcoming workshop. Regarding the transfer of our existing number to the new carrier, it looks as if it is not transferable. Whether this is an absolute fact, or if it is due to some other reason, we cannot be sure. We discussed this at the PI committee meeting a couple of weeks ago, and decide the most prudent course of action was to bring the issue back before the district committee to decide our next course of action. In visiting with the Grasshopper folks, it is unclear whether we will receive a partial refund of our subscription or not.

District 11 Literature Report

Literature:

I attended the Pre-Assembly online and in person, and found them very helpful in preparing for the Area Assembly. I look forward to working with the neighboring District's for the next one. I also attended the Area Assembly in person and was able to participate in the Literature committee business with the new Literature chair Rebecca.

There were 5 voting members in the committee, and topics of consideration included adding the 12 Concepts to the 12×12. The committee was divided on this point, but the sense of the Area was for the change.

Revising Living Sober was supported by the committee and the Area.

Discussion about the updates to the Plain Language Big Book reflected a need to focus on substantive changes by the Fellowship, and to allow editors to make grammatical changes. New service manuals are available with electronic format, and in print.

The second printing of the Plain Language Big Book has 5 editorial revisions and an edit to the Panel number reviewing it.

The new Literature committee workbook and the Plain Language Big Book sold out in the first 2 months and second printings of both are available.

The 5th Edition Big Book is drafting expanded versions of Appendix 3&5 (Medical & Religious Views), and finalizing personal stories selections.

Several pamphlets are being updated, and a 4th Edition Spanish version of the Big Book is selecting new personal stories.

GSO is taking applications for 2 positions in the Literature department to assist with pamphlets.
