Motion #26: (Don M./Jon A.) Motion to change District date for August to the 16th. 20 favor, 0 abstained, 0 against. Motion passed.

Review progress on the District application for Non-Profit status.

Debbie D., Treasurer, has submitted Articles of Incorporation to the State of Montana. She has also spoken with the IRS and was distinctly told not to skip steps in this process, and was provided a list of necessary steps to take. After being set up with the State of Montana, we will file with the IRS for a tax ID number, then we can file that number with the IRS to become a non-profit. Currently, Debbie D. is waiting to hear back from the State. Next month she will provide a progress update.

New Business

Form an ad-hoc committee to update suggested positions and duties for the Area 40 Roundup hosted by District 11.

The prior committee chair suggested that positions be updated in the Policies and Procedures manual. A committee will need to be established in the next 3 months in preparation of the 2027 Roundup. Nadine F. as Archivist, will be part of that ad-hoc committee because she is responsible for updating the Policies and Procedures manual. It is also suggested that people who were part of the prior Roundup take part in this ad-hoc. Please take this information back to the groups for involvement. Mark W. and Debbie D. will be part of the ad-hoc committee.

Motion #27: (Nita R./ Don M.) Motion to approve assembly of ad-hoc committee to research and change District 11 Roundup Policies and Procedures.

19 favor, 0 abstained, 0 against. Motion passed.

<u>Discuss concerns surrounding the sober living houses and their attendees.</u>

Traditions to keep in mind: number 3, the only requirement for membership is the desire to stop drinking, number 5 with each group's primary purpose being to carry the message to the still suffering alcoholic, and Tradition 6 that AA can't lend its name to outside enterprises. Also there is no we in AA, if the sober living attendees have a desire to stop drinking they are part of we. In the past, members of AA have explained to Rimrock and other facilities exactly what AA is and how we work. Possibility of group members meeting separately from the District to express concerns. There is the concern that the large number of sober living attendees are not a reflection of AA, but rather a reflection of treatment centers. Old timers are feeling over run by the numbers in which they appear, 20-30 per meeting. This is Tradition 4 in action, each group

is autonomous except in matters affecting other groups. The decisions made in one group will affect other groups. Numerous suggestions to reach out to sober living operators about what is AA's purpose. GSRs are encouraged to take information back to groups and work together to find resolution.

Agenda Item

At our last group conscience meeting at the 644 group, a lengthy discussion was held regarding concerns surrounding the sober living houses and their attendees. I will briefly list them here:

- 1. The overall number of sober living attendees is fairly large, leaving significantly less chairs available for other regular patrons.
- 2. Group members feel that meetings with such large numbers of sober living attendees are not reflecting an Alcoholics Anonymous program, but rather are more reflective of group treatment sessions. As a result, regular and more long-term attendees do not want to attend meetings at the times this vast number of sober living attendees are typically known to attend.
- 3. The group feels a number of the procedures and requirements of the sober living houses are in direct violation of several of AA traditions, therefore may be affecting AA as a whole.

What I would really appreciate from other GSRs is any feedback surrounding this topic. What is the past experience of other groups? Are other groups having this same experience? What options of solutions have been offered or attempted in the past? What worked? What didn't? Any pertinent thoughts that could be shared?
