Old business:

EIN numbers, steve is out of town so he is not going to be able to be here tonight, TBD next month. Steve is in Florida, District 41 created non-profit for EIN number, Steve recommends district 41 quit letting meetings use EIN number. District 41 created a nonprofit corporation years ago for the purpose of obtaining an Employer Identification Number.

Memo from steve below:

District 41 has allowed individual AA groups to use this number when applying to open their bank accounts. Recently, questions have arisen about this practice. One person's allowing another person to use his Social Security number or Employer Identification Number appears inconsistent with the Bank

Secrecy Act. Therefore, my recommendation is that District 41 should discontinue its practice of allowing AA groups to use its EIN. Because banks will require some documentation of the existence of any depositor, including AA groups, the most proper method to satisfy a bank will be to create a nonprofit corporation or a trust and then apply for an EIN for the corporation or trust. This may be more work and expense than a group wishes to incur and may require some maintenance on an annual basis. It may be possible for a group to obtain an EIN without incorporating or creating a trust, and if it is, it may still be difficult to satisfy a bank of the legitimacy of the group. I would like to work with a treasurer to see what the IRS website permits and then what a bank requires of the group. I am not necessarily recommending it, but another solution may be for a group's treasurer to enter into a short-written agreement with the group obligating himself or herself to handle the group's money appropriately and then open a new bank account in the treasurer's name. If the treasurer accounts for the group's money on a regular basis and is trustworthy, this could work. There are some obvious risks and problems with that approach. One is if the treasurer is not trustworthy. A second arises if and when the treasurer no longer wishes to be the treasurer. Some new arrangement would have to be worked out. Googling this subject on the Internet produced a number of items to read in order to obtain ideas for how to solve this problem. I have enclosed a couple of them. None of the suggestions above is as "easy" as allowing District 41's EIN to be used by a group seeking to open an account. It is my understanding that currently Cathy from the New Beginnings group wants to open an account. If she would like (I know her and her husband well), I could work with her to get an account open for her group. As mentioned above, this will require satisfying both bank and IRS requirements
