DCM: Grant: did not have much time this past month to attend business meetings but hopes to get to more of them this month; plans to create a binder for resources; suggested meeting to discuss budgets for chair positions. During the meeting, Amanda shared that Riverside/Elkhorn Treatment Center is open again (women's corrections) outside of Boulder, MT and at least two women there are asking for meetings. She asked Grant to bring this up to Area contacts to see what can be done.

Old Business:

- Combination lock: Dawn shared concerns, would like combination lock to only go to DCM, Literature, and SYS.
- Suggestion to indicate that RMTC speaker meeting and Angel Room unhoused meetings are not "regular" AA groups/meetings.
 - Reviewed AA guidelines on the types of AA meetings that are held in a treatment facility: 1. Self-supporting group chaired by AA member; and 2. A treatment facility only AA meeting (referred to as beginner's meeting) that is not listed on the meeting list or meeting guide app. The RMTC speaker meeting does not adhere to either of these criteria.
 - Diane made a motion to leave these two meetings on the schedule but have them listed separately from the rest of the meetings; labeled as in cooperation but not in affiliation with AA (i.e. facilities meetings)
 - Amanda minority opinion: feels that these meetings should not be listed on AA meeting schedule at all
 - The motion passed.
