#### **Archives:**

**Greetings District 61:** 

This month was a week of travel and learning for my role as the archive chairperson.

On September 9 I was able to visit our Area Archives in Ennis and meet with our Area Archivist, Rick A. He gave me a brief tour of the facility and as he worked on a display for the area assembly, I familiarized myself with the collection, especially as it related to our district. There I went through an archive box which held District agendas and minutes, and another which had fliers and registration forms for Roundups, Attitudes of Gratitude, Pockets of Enthusiasm, and other events. There were even a few photographs of Carleen and her husband! I also understand there are lots of recordings from our district, but in my brief time there, I wasn't able to find them. At least I have one good reason to go back!

The most exciting find for me was in the Grapevine collection, where we have the earliest mentions of AA forming in Helena. I found a copy of the January 1955 issue that had the story, but our collection did not include the 1946 issue that had the first mention of a group forming in Helena. I photocopied the 1955 article along with some flyers for early Grapefest events so I can put together a small display for the upcoming Grapefest in October.

On September 13 th I attended the Area Assembly to participate in the Archives committee, made a brief report on our archive, and learned about archives in a handful of districts participating in the meeting. One district archive chair is busy with oral histories of long-timers in her areas, others are facing challenges with storage and with access to their archives (no one has a key to the closet), and one district has yet to form an archive.

The official verbiage that ended up being voted on and ultimately passing, reads as follows:

The Committee recommends the BTG Chair guideline "G" on page 31 of the Fall 2024 revision of the Area 40 Policy and Procedures be revised to read: "If the Alt BTG chair position is vacant, the Area BTG Chair selects an Alt BTG chair and presents the candidate for the Area 40 Treatment Committee to review.
