I was lucky enough to meet one of those students who attended an open meeting last week and she told me how much she learned at the presentation, as well as by attending a real meeting. I felt like the work we doing in the community really matters.

Continued working with the Big Sky group to bring a couple of meetings into the 4-day conference the Montana Institute is hosting in Big Sky. Their agenda is very full, and the conference coordinators wanted to ensure that their attendants would be able to keep up with meetings as they have their conference. - Summer meetings outside of Bozeman (June, August, September) groups willing to host - Lenore
 - Lenore has confirmed West Yellowstone in September ok, Brian in Manhattan got back to her, they don't have a location with the internet requirements for Online portion. Do we have any suggestions/volunteers for June hosting?
 - Betty asks if anyone has reached out to Luane in Big Sky, Lenore has reached out to two contacts in Big Sky, not gotten an apparent yes or no. Betty will reach out to Luane T. about June or August.
 - Meghan points out probably can't do June unless someone in room right now can do it for communication sake.
 - Tim reaches out to Chopper and says Ennis is interested in hosting in August
 - Motion: To have September District 72 business meeting in West Yellowstone: In room 23 in favor, 2 online in favor = 25 in favor, 0 opposed, 0 abstain MOTION PASSES
 - Bradley note: Tech committee is able to run hybrid off of a mobile hotspot so it could be possible to host where the WiFi is not available.

11. New Business: 2 MINUTE TIMER FOR QUESTIONS/OPINIONS

- Discuss electing new Answering Service Chairperson.
 - (Note: I don't recall who but I do know it was said that we should give time for groups to know we are electing new Answering Services Chair. It may have been me that said it.)
 - Motion: Lenore motions to elect new answering service chairperson at June D72 Business Meeting.

22 approve in person, 2 online = 24 in favor, 0 opposed, 0 abstain MOTION PASSES

*Please share with groups that we are going to be electing a new Answering Services Chair

- Lenore states current issue is we don't have a list of volunteers for calls, made a list to sign up as she has been getting the calls forwarded to her (pretty sure)
- Tim states as past chair person, we could email out a sign up sheet to be contact for Answering Service Chair to people in District
- Autumn asks does it come up on phone as Hotline? Tim says yes if the Hotline number is in your phone.
- Discussion regarding spending excess funds currently held in the District bank account - Tim K.
 - We have quite a bit of money in our account. Spending plan is ~\$13,000. We are halfway through year and only spent about \$3,000. Purchases of literature are up and sales are down. If District has more than equivalent of Prudent Reserve amount (\$3,283.88) in Operating Balance (\$4,996.57) then we need to decide what to do with excess money. (Note: For clarity, this means that once our Operating Balance exceeds \$3,283.88 then we have to have this conversation). We are over by about \$1,700. GSR's please take back to groups to ask for suggestions unless we decide today (Spoiler: We did not decide today). Tim states A40 is strapped for cash, Area is close to their Prudent Reserve right now, GSO as well. Lenore expenses coming up as well as Tech Committee expenses.
 - Bradley asks what's goal for bringing balance down to? To less than having equivalent of prudent reserve in our operating balance (so less than \$3,283.88).
 - Lenore echoes that Area had to dip into prudent reserve already in recent past.
 - Steven suggests we set a deadline for what to do with excess amount due to past of conversation lasting very long time without action. Based on his experience.
 - David asks about how much Tech committee plans to spend. Bradley states off top of head about \$200, Meghan and Tim state that's in budget and we are discussing excess finances.
 - Amy asks about actual financial status of GSO and Area, Lenore will find out.
 - Tim states even if we suddenly spend a bunch with chairs, it will be ok. We can reach out to groups for more contributions if we dip low. (Note: Our total balance is \$9,583.50. Our Operating Balance is our Balance minus Prudent Reserve, Pink Can Reserve, and Accessibility Reserve).
 - Meghan asks for suggested value to spend. Tim says maybe 1000 to GSO, 2000 to Area.
 - Matthew asks if Lenore hears from A40 Treasurer to let GSR's know quickly
 - Tim suggests getting that info and sending out to groups in general.
 - Betty admits she hasn't spent any of her budget yet but that CPC Committee is quite active. Asks what is needed for chair person
 - Tim clarifies for Betty her budget.
