- 6 identified their gender as female, 8 as male
- 13 matched with a temporary contact, one still to be matched
- 12 from detention center, 2 from treatment facilities communication with the primary counselor at Community, Counseling and Correctional Services in Butte is working well
- Several volunteers have contacted BTG chair to let them know that the volunteers had made contact with their person

BTG volunteers

- District 72 / Area 40 BTG contact databases fully updated
- Livingston volunteers: we have three women and one man, would be ideal to have a couple more men

Update information

- New BTG request form in use
- Email (see appendix) outlining what's involved in being a temporary contact sent to all volunteers for whom we have emails, a few bounced back and no email address for two people, so follow-up work underway to make sure all volunteers receive the guidance
- Guidance includes a request to volunteers let BTG chair know once contact has been made

BTG Outreach Workshop

Outreach Workshop to allow BTG chairs and anyone else who is interested from across Area 40 to meet and share experiences, successes and challenges with participating in the program

Temporary contact guidance (email sent out)

Kia ora e te whānau (hello to you all in this group)

I'm Nelson Husband, the new Bridging the Gap chair for District 72. I'm also from New Zealand, which is why I've greeted you in te reo Māori, NZ's indigenous language we chank you for your willingness to be the hand of AA for people coming out of treatment and/or correctional facilities.

I've enjoyed being in contact with some of you by phone call and others by text. I'm grateful to those of you whom I've already approached to be a temporary contact for your enthusiasm for this service.

Below is an outline of what being a temporary contact for Bridging the Gap involves. For some of you it may be more of a (hopefully) helpful reminder.

- 1. I will ask you by phone call or text if you're available to be a temporary contact. If you are available, I'll then text you the contact information for the person and, if possible, an estimated date of their release from their facility.
- 2. I'll ask you to send a text and email to the person, so that they have your contact details upon their release and can contact you.

- 3. Once you've connected with each other, please arrange to either meet them at a meeting or transport them to a meeting, depending on what works for you and your comfort level around providing transport. If providing transport, please feel free to bring another AA member with you. Please also let me know that you've established contact. Gauging the success of the Bridging the Gap service depends on receiving feedback from the AA volunteers and the people who have requested a temporary contact.
- 4. Your focus is supporting your person into the AA fellowship, which can include attending a few meetings with them, introducing them to other AA members, emphasizing the importance of getting a sponsor, if they don't have one already, and working through the steps, if that's also not something they are doing already. Please make sure your person has a meeting schedule and familiarize them with Conference-approved literature.
- 5. As a temporary contact, you're doing regular 12-step service work. You're not expected to do anything like provide rides to places other than meetings, have them at your home or buy them anything. You're not expected to become their sponsor or be anything other than a "bridge" to the wider fellowship. Your contact with the person with whom you've been matched is intended as a temporary connection, aimed at helping them to get involved with AA in our community. However, if you decide to forge an ongoing, recovery-focused relationship with them, you're entirely welcome to do so.

I look forward to staying in touch with you and I thank you again for helping me to make "bridging the gap" possible for our fellow alcoholics in treatment and detention. Thanks so much again for your service,

I also realized that last year at the December meeting of District 72 we voted to approve some updates to several of the service position job descriptions. I got to attend the West Central Regional AA Service Conference in Casper, WY. We discussed the items on the General Service Conference agenda that our Area 40 Delegate, Lisa C. D. will be attending in NYC this Spring.

The hot topics were mostly about finance and literature. I took notes regarding the agenda items that were discussed that are separate (they should've gone out with this report). If you have any questions, please ask!

It was awesome to see that Area 40 had a lot of people there. I got to see our traditions and Concepts in action with the idea that we can disagree without being disagreeable. Seeing two people come to the mic who feel very strongly (on opposite sides) of certain topics, hug and hang out after was inspiring.

Our Area 40 Delegate Lisa C.D. asked me to share at one of the general sharing sessions on the topic of "Closing the Gap: How do we make the voice of every Group count?". I was terrified, but the 6 minutes went very fast and I only got to say about half of what I wanted to! It was really good practice for me to not be afraid to go to the mic at Area Assemblies and share the voice of our District.

I also attended the online pre-assembly on Saturday 3/8 to discuss the Area 40 Spring Assembly agenda items (this includes Area 40 items and the same General Service Conference items that were discussed at the WCRAASC). We ran out of time, so only the "Consider" items for Hotline/Report and Charter and Literature were discussed.

GSR's, I have some specific things that I heard at the preassembly that were noted as important to discuss at the Group level. I highlighted these items in yellow in my Pre-assembly notes (these also should have been sent out with this report). I would love to get your groups' feedback about these items!

- 1. I received a January "highlights" email about what is going on with AAWS (Alcoholics Anonymous World Service) board. The main thing I noticed was 2 recommendations from the Publishing Committee:
 - a. The Publishing Committee recommended to the AAWS Board to move forward with a \$6 list price for all Committee workbooks as of May 1, 2025.*

- b. The Publishing Committee recommended to the AAWS Board to move forward with a \$5 list price for "The A.A. Service Manual" 2024-2026 Edition as of May 1, 2025.*
 - * Or 90 days from the day of IGCO notification.

I emailed to ask what exactly this means and was told that only Area Chairs will receive a complementary kit. Moving forward, District Chair kits will need to get paid for. I don't know if this is something that the District wants/needs to add to our annual spending plan/budget?

• Elect a new Literature Chair

Meghan read description of Literature Chair position.

Steven willing to stand. March 10 2001 sobriety date. Never been lit chair. Treasurer of first homegroup in Georgia. Was GSR for that group. Treasurer of Reb dogs. Was alt GSR then GSR. Was treasurer for D&@ rotation, Alt-DCM. Amy K states it's a big job, just a heads up. Gotta meet people all the time. He qualifies that he has the time and resources.

Betty motioned to vote him in. 21 in person yes, 3 online yes. 24 yes, 0 no.

Steven R is our new Literature Chair.

Area assembly: sense of the District - Lenore

Wants opinions on some items that will be voted on at Area.

- Asking about removing the word Women from the Concept 4 writing at GSO, used to only be women who worked at GSO. (Lots of in favor)
- Other is striking that "group may decline to hear from GSR" from description. (Lots of in Favor)

- -Consider request to revise pamphlet for Grapevine/La Vina to have updated information. (None opposed)
- Question about changing co-founders writing. Want it to be amended to a supermajority (3/4) instead of just a 2/3 majority. If anyone has time to bring back to groups to ask what even is co-founders writings?
 - Bradley asked is co-founders writing even specified to vote on? Lenore says no.
 - Tim says his group has hangup also on the fact that cofounders writings isn't specified. Worries there is a fear of the people in New York changing writings, concerned about lack of definition of cofounders writing.
 - Pat's group wants to preserve integrity of writing, in favor of supermajority, concern about lack of specificity of co-founders writings.
- Consider that 12 concepts be added to the book 12 and 12, eventually the book may be changed to include 12 concepts as a new book basically.
 - Bradley asks for clarification (I didn't write what that ended up being)
 - Matthew asks if 12 concepts will be removed from service manual? Lisa not certain but asks is group not in favor if then 12 concepts come out of service manual? They don't want them out of service manual yes.
- Pat says what if we just separate them, have 12 steps, a 12 traditions, and a 12 concepts? Maybe a solution.
- Consider request to update Living Sober. Would be a second edition of Living Sober.
 - Pat says his group reads Living Sober, apparently sometimes people end up laughing out loud about how outdated language is.
- A40 Finance. If groups grossing greater than \$5,000, may need to file a thing.
- Contributions this year for Area are down. Please consider contributing more because A40 may need to dip into its prudent reserve. Area needs help with finances, GSRs please talk to group about financial contributions.

District debit card - Meghan
 Machan read reading After

Meghan read motion. After bank, we learned each authorized signer needs a debit card with their own name on it. Figured we may need to amend the original motion if we were to continue with this. We discussed may make most sense to just have the one debit card in Lenore's name since she travels most. Treasurer stills holds onto it. District how do you want us to move forward, should we amend the motion, move forward?

- Bradley asks for clarification. Meghan states we didn't know there needed to be a name on it (debit card). He says does that necessarily change whether we can have 3 people as authorized signers? Meghan says technically we are supposed to have all authorized signers with their names on own cards (according to bank). Bradley says bank can say what they want but it makes sense that we just have one card with one name that others can check out.
- Brian says considering its just one person's name, at end of rotation, would number of the card have to change since name changes? Yes it would, so at end of each rotation we'd have to change everything attached to card.
- Tim says it would have to have Lenore's name attached. It could actually affect her credit (Clarification: it is not a credit card, it is a debit card). Card opens can of worms, Tim likes checks. Wants to strike the motion. Meghan says would it affect her?
- Joanne points out debit card is linked to checking account, it is not a credit card linked to credit, shouldn't necessarily change but check with bank lady. Shouldn't necessarily need to change card number but check with lady at bank cause she's helpful and kind of understands our organization.
- Bradley points out for Zoom yeah we can do ACH payments for Zoom. Clarifies checking account is under District 72 not an individual name. Says Zoom should be ok but other services may need a card for verification purposes. He's ok with keeping it simple with checks but we may need a debit card to sign up with Google Workspaces.
- Lisa says her experience as DCM the bills could be really high, like up to \$1,000 or so high. Could have asked Treasurer for advance but was also embarrassed. Did have times of being financially stressed and would have appreciated a debit card.
- Maurice points out his experience with checks is that they need an actual name on them sometimes to be accepted.
- Betty suggests some issues could be resolved simply between officers (like how Meghan was very on top of getting checks to Betty right away).
 Advances are definitely a thing, a bit more paperwork but are a good option.
- (Crystal attempted to motion, I think for officers to amend original motion to have the individual names but we were running out of time and what I wrote didn't make sense)
- Motion to table by Meghan, seconded by Jax.
- Then we got tired of it at 6:30 and motioned to close.
