Events and planning:

The event with Al-Anon at Kiwanis Club on July 29 moved to the Springs behind Target. Adam J, who came into the program at a very young age was selected as AA speaker to relate to Kiwanis focus on children.

 Nora D has been diligent in trying to reach out to Bozeman Health professionals. Post COVID there have been numerous staffing changes and reaching someone willing to open doors for us has been challenging. We haven't given up; Doreen M is reaching out to the Director Behavioral Health Education and will connect with Catherine J to see what her contacts are.

- We contacted Joe Schumacher, the BRIDGERS outreach coordinator. (In May Dennis S
 attended and reported on the launch of the new misdemeanor DUI Treatment Court.) Joe
 is developing resources for his leadership team at BRIDGERS and is interested in AA
 presenting at one of their meetings, perhaps in the fall. We sent an example agenda and
 outline of the topics to be presented.
- We have been invited to exhibit at the Montana Peer Support and Recovery Services Symposium in Helena September 6. The symposium is funded by Montana Department of Public Health and Human Services. There will be about 200 peer support specialists and administrators attending. District 61 CPC chair, Deborah S is collaborating on the effort. We will be one of only three invited exhibitors there—the Montana Prevention Certification Board (MPCB) non-profit professional credentialing organization which seeks to prevent alcohol, tobacco, and other substance abuse disorders in children, young adults, and adults, and Mountain Pacific Quality Health, a nonprofit organization that connects specialized services, education, training and support to health care systems and communities that seek innovative solutions for optimized health care outcomes.

National PI/CPC Working Group

- Thanks to Literature chair Amy K who is always looking out for anything that might be of interest to the CPC committee. She introduced us to the National PI/CPC working Group. We are amazed at the amount of PI/CPC resources that are available for reference and use and how many participants there are in this community. The working group meets monthly and we are sending information about it to other CPC committees in Montana. One of the activities Doreen M was able to attend is "Nurses for Recovery" which was presented with Al-Anon and focused on the challenges in addressing alcoholism, how nurses can support sobriety, and the AA program of recovery. A serendipitous outcome for her was being connected to a national network of nurses in recovery.
- This National PI/CPC Working Group has been asked to put forward a proposal to add an appendix to the 5th edition of the Big Book titled "Does AA Work", "A Professional's View for the 21st Century" which would feature strong scientific evidence validating the therapeutic effectiveness of the AA program in helping chronic alcoholics achieve and maintain sobriety. This stems from the research study we reported on earlier this year. (See Does Alcoholics Anonymous Work?) Summaries of this work were reported in the September 2020 *Grapevine* and Fall 2021 Box 459.

Co-Founder Writings: Strong sentiment against any changes being made to the basic text of Alcoholics Anonymous. Suggest when change is proposed to use footnotes, pamphlets, Grapevine/La Vina to avoid becoming irrelevant.

How is our 7th Tradition used: Literature on more than 200K tablets in jails & prisons, maintaining the Meeting Guide app, GSO archives, Public service announcements, Corrections Correspondence Service, Literature translations, Accessibility tools, Publishing of service pieces, Cooperation with the Professional Community. Finances: AAWS 2023 Highlights:

- 7th Tradition: \$10.84 million. Up 2.8% from 2022
- 7th Tradition covered 62% of operating expenses
- Operating Expenses: \$17.45 million. Up 9.9% from 2022
- AAWS publishing profits: Up \$6.7 million from 2022
- Individual contribution self-support number: \$6.43
- Group contribution self-support number: \$157.28

Plain Language Translation: The committee recommended that the draft manuscript *Plain Language Big Book: A Tool for Reading Alcoholics Anonymous* be approved with minor changes.
