I was heartened to see so many members of District 91 show up. I forgot the exact numbers, but we filled up a whole row of tables at the assembly and we had at least eight GSR's and alt GSR's attended, which is amazing! Congrats to everyone who made the trip. What's more, I was able to attend group business meetings across the valley when I returned, and it was wonderful to see these same members of AA give detailed reports back to their groups and get them involved. We have a wonderful district. While we didn't have any major hot topic issues at assembly this year, there were still plenty of items to go over and business to discuss. Within Area 40 itself, the area has elected a new Bridging the Gap chair. Sean R. will be the new chair. He was alternate BtG chair previously and will undoubtedly do a good job stepping up. Area 40 also decided that more detailed guideline would be created for our area website. This should make things a little more streamlined and make the website easier to navigate in time. Area 40 also made the decision

to allow districts to fund their own pre-assemblies with guidance from Area 40. As you know, Districts 81, 91, and

93 tried this at our pre-assembly this past month and

that's basically how we will handle pre-assemblies going forward.

On the broader scale, our delegate Lisa C-D asked for a sense of the area on several important topics. This sense of the area gives Lisa an idea on how to vote for certain agenda items at this years General Service Conference. Among the topics discussed: a request that a super majority of voting members at the conference level be needed to amend the founder's writings (The Area was mostly for this), a proposed pilot for a Harmony and Effectiveness session during the General Service Conference that would seek to address any controversial issues or opinions. (The Area was mostly opposed to this), adding the 12 Concepts to the 12 and 12 (The Area was mostly for this), and revising the Living Sober book (The Area was mostly opposed to this).

Finance was also a big topic of discussion. Our Area treasurer Lynne W. basically boiled it down to the suggestion that Area could use more support financially. If you are doing splits this month, consider adding a little more to Area if possible.

I also attended this year's standing corrections meeting hosted by Daniel S., our area corrections chair. There were several corrections chairs from other districts in the meeting and as somebody without much experience in corrections, it was informative. A lot of our time was spent discussing an agenda item that reviewed data from Endovo, a company that, among other things, allows prisoners to access AA literature on tablet devices such as ebooks and audiobooks. It was interesting to learn that more prisoners utilize audiobooks over ebooks. Our committee meeting also went over international committee agenda items. Of note there was an agenda item considering that flags of Sovereign States (i.e. flags of Indigenous nations) be flown as part of the flag ceremony at the International Convention. This was another sense of the area item that the Area was for.

Once again, I thank everyone from District 91 who attended this assembly. Our delegate Lisa is right now in New York at the General Service Convention being of service and passing the opinions and suggestions of Area

40 down the triangle. This is in part, thanks to you the
home groups who have the final say. Thanks all!

Even though our assembly is over, I still plan on attending group business meetings through May to be as available as I can. If you have a business meeting coming up or would like to have me attend a regular meeting for questions, let me know. I could always use a meeting of course.
