There have been two situations this month that were of some concern, first there were words exchanged between a volunteer and an inmate at one of the men's meetings that caused one of our volunteers to be suspended for a month. Secondly, and again at a men's meeting separate from the one already mentioned, one of the inmates got agitated, aggressive, and threatening. Both situations have been resolved for now. However, after speaking to Sgt. Bailey on both accounts, it has been suggested that a better way to call the guards needs to be implemented. More specifically, the guard button at the doorway is too far from the table that the volunteers sit at, and in the case of an emergency where a volunteer may feel threatened by an inmate, it is completely out of reach. Sqt. Bailey and I have discussed a handheld device similar to a key fob for the volunteers to keep at the table where they sit. I will keep you posted on the progress of that development.

As far as the women's meetings are concerned, the calendar has remained filled months in advance. The women have been amazing in their commitment to this service work. There was one instance, however, due to a misunderstanding on my part, of a text sent from a volunteer, where the meeting regrettably had to be cancelled at the last minute.
