# AREA 40 FALL ASSEMBLY 2007 APRIL12 & 13, 2008 AT THE YOGO IN LEWISTOWN, MONTANA

#### Welcome to the Assembly

Carole B.-Alternate Delegate/Area Chair—opened the Assembly promptly at 8:00 am with a reading of Declaration of Unity. After the reading Carole asked for all of us to stand in memory of Robbie Sullivan's love for AA after a moment of silence the assembly prayed the Serenity Prayer. Joe read our 12 Traditions and Katie read the short form of our 12 Concepts. Connie R., Area 40 Secretary, took the roll with 14 of 14 districts represent. There were 114 voting members present and 39 visitors for a total of 153 participants at this Spring 2008 Assembly. Thanks to everyone for coming.

#### Orientation to the Assembly -Andrew W. Area 40 Delegate

My name is Andrew W. and I am an alcoholic. Welcome to the Spring 2008 Assembly of Area 40. I am privileged to serve Area 40 as the delegate for this rotation. We are in the middle of this rotation and it seems like the time is just flying by.

I want to welcome all the new General Service Representatives (GSR) and everyone attending his or her first Area Assembly. Would all the new GSRs please stand up? Would everyone who is attending his or her first Area Assembly please stand up. Just as the newcomer is the lifeblood of an A.A. meeting, so too is the new GSR the lifeblood of the Area Assembly and the A.A. general service structure. Thank you all for your willingness to be of service.

I also want to thank the rest of you for coming back to Lewistown for another assembly. I want to thank all of the past delegates in attendance for continuing to show up and participate in general service.

The first thing that happens following this orientation is that members of the Area Committee will give their reports. This includes the Area officers and committee chairs sitting at the front table as well as all of the district committee members (DCM). In Area 40 we are organized on a committee system based on the committee system used at the General Service Conference. Each DCM serves as a member of one of the Area 40 committees.

After all the reports this morning, we will have all of the standing committee meetings concurrently. Feel free to attend any of the committee meetings or to attend the Workshop that will be held in this room while the standing committees are meeting. The committee meetings are led by the Area Committee chairs except for the Finance Committee, which is led by the Area Treasurer. Each committee discusses the items on the agenda for that committee. Many of the items on our agenda are General Service Conference agenda items. We will not vote on these items but the Committee Chair will often take a sense of the committee on many of these items. Some of the items of we will discuss in committee are Area 40 specific items. The committee will discuss these items and choose to make a recommendation or choose to take no action. When taking a vote in committee, only the members of the committee vote.

This afternoon, I will give my report as your delegate. One of my responsibilities as delegate is to attend the General Service Conference (GSC) in New York. I will be attending my second GSC later this month. The GSC is how A.A. as a whole in the U.S. and Canada get together to make decisions on matters affecting A.A. as a whole. As Concept II states, the GSC, "for all practical purposes, has become the actual voice and effective conscience of our Society." As an Area we are one link in the chain of communication from the groups to the GSC.

Following my report, we will begin our floor assembly where we meet as whole to hear the committee reports. The committee chair will present the committees report on each agenda item and then we will have a chance to discuss the item. Again, we will not vote on the items from the GSC agenda but I will ask the Area Chair for a sense of the Area on many of these items. The purpose of discussing these items and taking a sense of the Area is to help me be well informed when I go to the General Service Conference later this month. For the Area 40 specific agenda items,

if the committee makes a recommendation on the item we will take a vote following the discussion. In order to be a valid vote we must have a quorum (two-thirds of the voting members present).

One piece of advice I have for everyone attending Area Assemblies is to be active participants. Take part in the discussions. I know that it can get somewhat confusing at your first assembly, as we tend to use a lot of jargon. Sometimes it may be unclear as to what we are talking about. Please ask questions if you are unsure. You might find that many others share your confusion. In the interest of saving time, if someone else has already expressed your opinion, it is not necessary to repeat it. If, however, someone else has not expressed your opinion, please go to the mike and share it. Don't be afraid of the mike. It won't bite you.

We ask all of the GSRs to sign in with your District Committee Member (DCM). Your DCM will turn the sign in sheet to the Area Secretary, Connie R. This will enable us to determine how many voting members are present and to determine the number of votes required for a quorum, which is two-thirds of all voting members.

Thank you all for being here. I hope you enjoy your weekend at the assembly.

If you are new here there are a few procedures that we have in place to help allow everyone to participate. I will be timing all the committee reports. Each report has 5 minutes. When the timer goes off, please stop, so that the next report can be given. I also will be timing the discussion during the committee reports and the general sharing. Each of us has 3 minutes to express our thoughts, ideas or opinions. I hope that each of you will go to the microphone at least once.

DCM's please turn in your attendance sheet during the break. We count each voting member and that is what our quorum is based on. It is important as a voting member that you remain for all of the assembly, so we can maintain the quorum. If you are unsure if you are a voting member, ask your DCM or other Area Committee members, we will be happy to answer your questions.

Last fall was a busy assembly. There were many items presented to the assembly from the groups of Area 40. Some of them made it to the floor, some of them became motions and some of them did not make it out of the committee. There was a lot of good discussion. We had 6 made & seconded motions that came to the floor for discussion and were voted on. They were:

Literature Committee recommends considering forwarding to the General Service Conference Secretary a proposal to publish a hardbound edition of the Daily Reflections. This motion was made, seconded, voted on and it was passed.

The Archives/Structure Committee recommends that Area 40 fund the Area Archivist to attend the 2008 National Archives Workshop at Niagara Falls, NY. Funding is not to exceed \$1,500.00.

This motion was made, seconded, voted on and it was passed. A motion to reconsider was made. The motion to

The Archives/Structure Committee recommends that the Area Chair appoint an Ad Hoc committee charged with studying the Pre-Assembly concept currently utilized in Area 40, and that the committee review the purpose of these events, the funding of these events, and the contribution they make to the informed group conscience of Area 40.

A report from the Ad Hoc committee outlining the findings of the committee and suggestions for an Area policy should be given to the Archives/Structure committee no later than the Spring 2008 assembly so that the Archives/Structure Committee can bring forward any policy recommendations needed to guide future Area 40 Pre-Assemblies. This motion was made, seconded, voted on and it was passed

Finance committee recommends that the 2008 Area Budget Proposal be accepted. This motion was made, seconded, voted on and it was passed

Finance Committee recommends that Area 40 reduce prudent reserve to 33 1/3 % (4 months of services). This motion was made, seconded, voted on and it was passed

The PI Committee makes the following recommendation: The PI Committee will determine what is reasonable & prudent to add to the Area 40 website to allow better communication to our fellowship and make a recommendation to the Spring Assembly for consideration and implementation. This motion was made, seconded, voted on and it was passed

It is hard to believe that we are just one assembly away from electing the next rotation of trusted servants. It is important that each of us take an active role in finding members of Alcoholics Anonymous who are willing and able to serve AA as a whole. This weekend gives each of us a chance to talk to people and find out if they are willing to stand for another position. One of my favorite sayings that I have heard in the past is: The Higher Power doesn't chose the prepared; The Higher Power prepares the chosen. I pray each of us is willing to be prepared by our Higher Power.

#### Area 40 Treasurer—Curt K.

Hi everyone, my name is Curt K and I am an alcoholic. Thanks to God, the actions of AA and sponsorship, I have been sober since July 22, 1993 and I am very grateful for that. And I also have the privilege of serving as your Area 40 Treasurer this rotation.

A special welcome to all of you who are attending your first Assembly – thank you for being willing to share your time and talents with AA.

And now about money... The Finance Committee Agenda for the General Service Conference this year has one item that presents a great challenge to our Fellowship. This item, submitted by our very own past Delegate and past Area Treasurer, Loren B., puts in front of us the issue of how our AA 7<sup>th</sup> Tradition is being used at the General Service Office; how big a role, if any, literature sales should play in supporting the work of the General Service Office, and what it means to be truly self-supporting. These are big questions and I look forward to hearing your perspectives and experiences later this weekend. But at the moment, I would like to bring question of self-support closer to home.

There are financial reports on the table outside the door of this room that show our income and expenses for the first three months of 2008 and a full view of 2007. To put our current numbers in context, from 1999 to 2003 we spent about \$15,000 per year on average. Last year our expenses were over \$28,000 and our income was \$23,000, with group contributions making up only \$19,000 of that total. Of course, we can't keep up this pace of spending over the long run unless group contributions rise to meet our budget. We are self-supporting at the moment – groups in our Area contributed all the money we are spending over and above our current year income, but they did so in past years. So the money we are spending is our own 7<sup>th</sup> Tradition, but it's 7<sup>th</sup> Tradition from the past. We won't be able to keep up this pace of spending in the future unless groups give more.

We always have a decision to make as AA members and groups – give more or spend less. The good news is that groups in Area 40 have increased their contributions to the Area significantly in the first quarter of 2008. Of course, we don't know if this pace of giving will continue throughout the year or if it is short-lived.

I will be approaching the Finance Committee about a slightly different budgeting process for the Fall Assembly. I will suggest that I work with the Area Committee Chairs and DCMs to draft budget alternatives that will be sent to groups along with all of the other agenda items for the Fall Assembly. This will give groups a chance to discuss and consider the Area 40 budget as a whole before coming to the Fall Assembly. One of the limitations of our current budget is that it was created piecemeal. Each item we spend our money on was discussed and approved separately and simply added to an already full budget. And as we know, when it is so important to us all that the message of AA get out to more and more alcoholics in need, every idea to help do that looks good. So we approve almost every

new project or budget item that comes forward. So my hope is that we can look at our budget as a whole at the Fall Assembly and make sure it reflects our priorities.

Finally, I would like to encourage each and every one of you to consider standing for an Area position this Fall. I have spoken to a number of well qualified AAs who could all do well for the Area in the Treasurer position. But we should have a slate of candidates five or six deep at each position. Then we have a true group conscience and the best possible servants for our AA work. Concept Nine reads: "Good service leaders, together with sound and appropriate methods of choosing them, are at all levels indispensable for our future functioning and safety." So that is my hope for Area 40 and my hope for each of you as you consider how to share what has been so freely given to you in sobriety.

#### Area 40 Triangle Editor—Raymona C.

Hi, my name is Raymona C. and I am an alcoholic. Welcome everyone to the 2008 Spring Assembly. I am grateful to be here in the company of so many wonderful people. I thank you all for your cooperation and participation with me as your Triangle Editor.

I would like to share with you what my goals for the remainder of my term as Triangle Editor are. First, I hope that everyone is enjoying their publications. I am working harder this year to be prompt and put the Triangle out in a timely fashion. It is also my goal to pass on to the next editor an updated mailing list and some written suggestions for publishing our Area 40 newsletter. As a goal to make sure the mailing list is updated, I encourage those of you who are here to see me and either verify or update any information for your group. I also am in need of information regarding specific groups in the area and will do my best to make contact with people this weekend to seek this information out. I was able to get some updates of info during the pre assemblies in Missoula and at Boulder Hot Springs.

While I was at the pre assemblies, I tried very hard to pay attention to the issues at hand and one of which that caught my interest was the topic of "self supporting through our own contributions" at any level. An area that this seems to be lacking is the Triangle. There are over 230 groups in Montana, all of which receive the Triangle paid or not, due to a past action at a previous assembly. While I agree that each group should indeed receive the Triangle, I would like to see it become more self-supporting. Out of the 230 plus groups, only about 75 – 80 are current in their payments for subscriptions. This is roughly 35%.

Each issue your group receives is marked on the mailing label as to the date the subscription expires or if it is already expired it says "Expired". I included an article to this effect in the last issue of the Triangle. If it is being read, this article reached some people. However, I encourage all of you to check the mailing label on your groups issue and see if you need to update your subscription status. In addition, I understand that there are groups who may be unable to pay for a subscription due to low 7<sup>th</sup> Tradition intake. If you are aware of any such group, and would like to pay for a subscription for them, please feel free to do so. However, if you choose to pay for another group's subscription, please indicate this when sending a payment so that their mailing label will reflect the status of the subscription.

Subscription money for the Triangle may be mailed to the post office box as listed on the subscription form on the back of each issue of the Triangle or to Curt, our Area Treasurer. If you need either address, please see one of us some time this weekend. If every group that is able actually kept their subscription current, money received would go directly to supporting the Triangle as apposed to expenses coming out of the general funds being sent to Area 40. The cost is a mere \$10 per year.

As the result of all this talk about self support, I personally, have made a conscious effort to increase my 7<sup>th</sup> Tradition contribution to \$2.00 each time instead of only \$1.00. The cost of everything is rising and in order to keep up, I am willing to increase what I put in the basket. I challenge all of you to do the same.

I have extra issues of the Triangle available on the table in front of me, if you need one or would like an extra.

On this note, we have been having billing issues with AnswerNet since the hotline went active. Many of you have still not received a bill. Here is what was sent to me this week from AnswerNet:

"The billing for each of the districts has not been totally resolved. We still have some reporting issues to deal with. First of all, we need to track the calls coming in on the toll free and subtract them from each district based on the time and date the call came in. It involves some sorting of data and we are still working on how to best capture that information and then translate that to each district based on previous reporting formats."

It sounds like most of the toll-free calls originate from the Districts that used AnswerNet in the past. These Districts's have been receiving bills. To this end, Helena reported a 50% reduction in cost. It was suggested to me that the Districts who have not received bills have not had much call volume to date. Hopefully the phone book listings will change this. Please provide the 888-607-2000 number as best you can throughout your districts. Thank you for allowing me to be of service,

Hello everyone,

My name is Geoff and I am an Alcoholic.

Since the last Assembly, Beth S, Treatment Chair from District 71, reports that they continue to take meetings into MCDC (Montana Chemical Dependency Center) & Watch West. Meeting times are 6:00pm on Saturday for MCDC and 7:00pm Friday at Watch West. Districts 72 and 61 continue to help support district 71 with both meetings. Good communication between districts has proven to be helpful. BTG (Bridging the Gap) is going well and Beth is in the process of updating the contact list for District 71.Bob H and some volunteers from Dickinson, ND continue to help support District 23 at Watch East in Glendive

Although there have been some changes due to new restrictions placed on the facility and the Parole System, everything is going smoothly. Since the "Family Members" at Watch East cannot be forced to attend AA, the attendance at the Bridging the Gap (BTG) meetings has dropped to about 20 or half of the 40 men and women locked up there. The remainder goes to other programs of their choice. The men and women that do voluntarily attend our meetings seem to be more open to information and ask more questions about AA. We now make sure that all those who fill out cards, for temporary AA contacts upon discharge from the facility, are giving us permission to send their names on to these contacts. It is very helpful, when AA members respond to these requests, to inform them that they got their name from BTG. We have had a few that were quite worried how someone got hold of their name.

We are able to have them start filling out their BTG cards up to 3 months before they leave. This would seem like ample time to get the contacts made but there remains a problem on our end of the system. This has improved over the last couple of years but it is still there. Please, please, please hand out the BTG cards to AA members who will follow through with making contact. It makes it so much easier for the people being released to get to that first AA meeting upon release, if they have had some communication with an AA member who will be there for them.

We have had a change in the meeting format because the facility has agreed to have the "Family Members" view the video "Hope" prior to our coming there on the second Friday of the month. This allows us to get through the BTG part of the meeting early and make an "Introduction to AA" presentation. This helps to prepare them for what they will find when they attend AA on the outside. This has been met with good interest and participation.

I would like to thank the volunteers from Dickinson, ND, who fill in when I can't make it. Due to their willingness we have had a presence there every month for the last two years.

#### **Standing Committee Meetings**

#### Literature—Linda B.

Literature Committee Report

There were sixteen people present for our committee meeting. Thank you, Kyra for your note taking. We updated our district literature contact list, read a letter from the General Service office literature desk, discussed ways to improve and expose our literature on our home fronts. Some suggestions were to each of us take a personal responsibility to share literature, give newcomers pamphlet packets, have displays of literature with other translations, don't let your literature display get old and dusty, have a meeting based on a specific pamphlet, have a listing of all books and pamphlets available, and put literature close to the exit.

We have four agenda items that were thoroughly discussed and an informed consensus was reached. They are as follows:

A. Review manuscript of revised pamphlet "A.A. for the Native North American."

We basically have nothing to review as we don't have a copy of the draft manuscript. It was mailed to committee members only. The Trustee's Literature Committee reviewed the manuscript and recommended to the General Service Board that the manuscript be forwarded to the Conference Committee with one suggested change for their consideration. It is standard practice that draft manuscripts are for committee members only until they are approved.

B. Review progress report from Publications Department on the revision of the pamphlet "A.A. Member-Medications and Other Drugs."

Again, there is nothing for our committee to review. In the background information the Trustee's Literature Committee gave a progress report on the pamphlet. There will be seven stories added to the pamphlet, with all existing stories retained in the pamphlet. New stories will reflect shared experience with drugs and medications. A medical doctor, also an AA member, is reviewing the front matter for changes or updates. The manuscript will be available for review at the August 2008 trustees' literature committee. So, our committee will be seeing this pamphlet again in an upcoming agenda item.

C. Consider a request to change the title of the pamphlet "44 Questions" to "FAQ" subtitled "Frequently Asked Questions about A.A."

This agenda item came from Area 51, North Carolina. Their background information observed that alcoholics seeking help tended not to choose this pamphlet because they were confused by the title. The proposed title is intended to be more descriptive of the contents of the pamphlet, consistent with our literature. Discussion in committee was varied. One district was against it because people don't know what FAQ stands for. Some think the acronym was great. Members have been pretty equally divided on this issue. There was a lot of support for "Frequently Asked Questions about A.A." and leave of the FAQ. Our committee took a sense of the committee on this consideration. The vote was 4-1 to change the title to "FAQ" subtitled "Frequently Asked Questions about A.A," The minority vote was against the consideration, but was in favor of it, if the acronym "FAQ" was left off.

#### Sense of Area -mainly in favor of.

D. Consider a request to reinstate the pamphlet "Letter to a Woman Alcoholic"

A 2006 General Service Conference Advisory Action stated, "It was recommended that the pamphlet "Letter To a Woman Alcoholic" be discontinued. An Area 79, BC/Yukon letter brings forth a consideration to reinstate this pamphlet. They feel that discontinuing this pamphlet leaves a void in the literature. They feel that the pamphlet was discontinued partially because it was written by a non-alcoholic and is not consistent with policy on literature produced by AAWA. There has been varied opinion on this item for consideration. A lot of women like it, a lot of women don't One woman in our meeting spoke very passionately about the huge impact this pamphlet had on her. One comment is "Do we need more pamphlets?" After thoughtful consideration, our committee was unanimously in favor of reinstating this pamphlet.

#### Sense of Area--Split

#### Grapevine/policy and admissions—BilliJo D.

The Grapevine Committee finished ALL of their business this morning. We had nine people in attendance; with seven districts represented.

#### Grapevine:

Items A & B: We reviewed the workbook and reviewed the staff report to explore less expensive formats for the production of the Workbook. We liked the idea of having the workbook available for download on-line; however, we also acknowledged that there are always electronic snafus that happen.

The sense of the committee was to support the staff suggestions of a condensed portable handbook, to update the Grapevine History booklet, and to create an updated version of the workbook available on line.

Item C: To consider publishing 2 CD's of stories from the La Vina. The sense of the committee was to give a thumbs up for the publication.

#### Sense of Area--For

Item D: To reconsider the "gray pages"... the sense of the committee was the same as it was last year. We are against the gray pages. We believe they are a breach of several AA Traditions and would like to send a strong statement against the gray pages. The committee discussed writing a letter to that effect but decided that our beliefs would be in the Secretary's minutes of this assembly.

#### Floor Discussion:

Tim: We need to be friendly with our friends

Carleen: Alarm goes off when states that it is against traditions

Lori: We live in information age, not appropriate in our meeting in print

Larry: It is our meeting in print

Wade: The article about the pill so an alcoholic can drink

Kelly: Bill use to inform the community, in "A vision for You" it states, "we know but a little"

BilliJo: The traditions is 6, Committee felt it was an implied endorsement.

Allan: How are they selected? BilliJo: It is editor's prerogative

Rich: Given the people the benefit of doubt—good intentions, What we don't include says more about us. Bill: meeting in print is it open or closed meeting. The Gray pages are more for us to help inform than to help understand alcoholism.

Peg: Never intention for non-alcoholics to speak at AA meetings.

Sense of Area—More for the gray pages but very close.

Item E: Discuss the AA Grapevine legacy of self-support. We did. We see by the background material that overall, the Grapevine is self-supporting as we think it should be.

Item F: Consider ways to increase awareness of the Grapevine and La Vina's roles . . . BilliJo did not write down any notes on this one. . . but we DID discuss it! I think it boiled down to promotion, attendance at AA happenings around the state, making sure there is a display and Grapevine reps at the displays to talk with people.

Policy & Admissions

Item A: Consider approving a substitute at the General Service Conference.. . the committee says, yes, go ahead.

Item B & E: Approve invitations for two observers and review the current policy. Current policy is to allow two countries to send two visitors to observer the US and Canada General Service Conference. We have requests from Great Britain and Mexico. The sense of the committee is to approve the two requests. In our review, we believe that that the current policy of two counties and two observers is good. We question if more than two counties request to send observers, how does GSO decide which two to pass on to AREAS? Who decides who attends from the requesting country? And is it necessary for someone from a certain country to come to observe every couple of years. One of the requested attendees was our guest for observation of the General Service Conference in 2003, does she really need to be our guest to observe again?

#### Sense of Area on current policy on international guests observing GSO--for

Item C. Review dates for the 2011 General Service Conference, In a divided vote, our committee felt the second choice of Sunday April 10 through Saturday April 16 posed the fewest conflicts of holidays.

Item D: Consider a proposal that the current secondary Conference Archives Committee be established as a standing committee. The sense of the committee was to let it stand as is but we thought we needed more information of what a stand-alone committee could entail in the future.

Gerry: No sense to rush into this. There is time to consider Sense of Area—Against

Item F: Consider delegating to the GSO management the responsibility of Conference site selection. The sense of the committee was yes, GSO management should be delegated the responsibility of site selection.

Rich: GSO maybe moved out of NY Sense of Area—For

Conrad M. called the meeting to order at approximately 10:00 a.m.

#### **Archives**

A. Review contents of workbook.

- ➤ It was noted that all the suggested changes we reviewed last spring have been incorporated into the workbook, including insertion of research forms.
- ➤ Interest was expressed in having the workbook in 3-Ring Binder format. This would facilitate copying of specific pages and forms.
- B. Discuss ideas for making A.A.'s archives and history more readily available to the Fellowship in the future.
  - ➤ Increase on-line access (audio and document downloads). It was noted that there are some recordings and documents already available.
  - ➤ Offer CDs to individuals and groups
  - ➤ Make the GSO Archives digital and searchable

Discussion shifted to making Area 40 Archives available.

- ➤ Archivist Gerry R. mentioned that he would make the archives accessible to the Area 40 fellowship an appointment would be necessary.
- ➤ Other suggestions included inviting the Archivist to bring a display to local events, scan and post items on the Area 40 Website, and implementing the use of webcam technology.
- ➤ It was pointed out that the Area 40 Archivist may be in need of some updated equipment for scanning and digitizing.

#### Area 40 Item for Structure

A. Review the report from the Ad Hoc committee concerning the Pre-Assembly structure currently utilized in Area 40.

Conrad passed out copies of the Ad Hoc Committee's report and read it aloud. The committee accepted the report with gratitude. The conclusion reached by the Ad Hoc Committee was that the Pre-Assemblies are a valuable contribution to the conscience of Area 40 and should continue. It was noted, however, that these events could be more cost-efficient, and funding suggestions were included.

The report was discussed in depth, including many things that were outside the scope of the report (video conferencing, conference phone calls, laptop webcams). The consensus in the room was that all thought the Pre-Assemblies were useful and important, but should be less costly. The Archives/Structure Committee decided to use the report to forge a recommendation for presentation to the 2008 Fall Assembly, and to include the report from the Ad Hoc Committee as background material for the agenda item. Items to keep in mind while writing the recommendation are:

- ➤ Pay attention to wording will this recommendation be clear and understandable in 10 years?
- ➤ Do we need a separate line item in the Area 40 budget for Pre-Assemblies?
- ➤ Who would determine the agenda for Pre-Assemblies and how?
- ➤ Who would be participating in the committee presentations?

The guests decided at this point to leave the meeting to allow the committee to work on the recommendation. The committee was able to make a good start, and Lori F. agreed to type up a draft of the recommendation so far and

email and/or mail/fax to the other members for review and changes with the intent of having a final recommendation ready by July 1, 2008 for placement on the 2008 Fall Assembly agenda.

The Archives/Structure Committee spent the remainder of meeting time available to review the updates and changes to the Area 40 Policy and Procedures Document and Past Actions Document, which were presented by Area 40 Archivist, Gerry R. All the additions and changes were approved. All committee members were given a copy of the Past Actions Document for review and asked to bring any errors or omissions to the attention of the Archivist.

#### Finance - Curt K.

Voting Members Present: Andrew W., Carole B., Curt K., Mike M. for Joe P., Martin D. There were between 10 and 14 additional nonvoting participants in the committee meeting both before and after lunch. Thanks to all who shared of their time and opinions during the discussion. We had full participation of all who attended. And special thanks to Amanda S. for agreeing to take notes of the discussion.

#### **Discussion of General Service Conference Agenda items**

*Item A* – Discuss request that a Finance Kit be developed to assist group, Intergroup/central offices, district and area service workers in carrying the message of our shared responsibility for the Seventh Tradition.

Area 54, Northeast Ohio, sent the item into the GSC Coordinator. Background material lists a number of items suggested for the proposed Kit. The purpose is to further the idea of self-support. Questions from our committee include what financial costs in terms of printing and production would be incurred. How much staff time would this take. If the kit furthers the message that AA members and groups are responsible for funding the budget that we approve through the General Service Conference, then it is a good idea.

One item that should be added to the list is a service piece that shows the value of a dollar today versus the value of a dollar in the early years of AA. A graphic representation of this concept would be helpful – as well as something in plain English, not economic jargon. Inflation has continued for over 70 years of AA's existence, but the convention of giving one dollar each meeting has not changed. Many of us have seen our earning capacity grow exponentially since being sober, yet we still give just one dollar per meeting.

Another piece of information that should be included in the kit is more detail on accounting and legal matters concerning how to form a group and how to apply for tax-exempt status once a group reaches the IRS threshold for registering as a nonprofit organization.

Rather than a special kit, would it be as effective to simply place all of the suggested items for the kit together on the literature order form. Discussion led most to conclude that a kit that is sent to all Area Treasurers and is available to anyone for purchase might more reliably highlight the message of self-support and the 7<sup>th</sup> Tradition.

One useful piece that is included in the proposed kit is the letter from GSO (or is it a Trustee) that describes what our group contributions are used for. It would be useful to have an Area 40 version of this letter as well.

#### Sense of Area--For

*Item B* – Consider the request to "Discuss the benefits and liabilities, both spiritual and practical, of funding the General Service Office of Alcoholics Anonymous solely by the voluntary contributions of AA members and AA groups, that profits from literature sales will no longer be used to fund our General Service Office. Further, consider a procedure for gathering input from the Fellowship as a whole and prepare a report on these discussions for the 2009 Conference."

Our own past Delegate and past Area Treasurer, Loren B., submitted this item to the General Service Conference. The background material shows that Loren is asking the question in order to take the debate out of a philosophical realm and make it real. He pushes us all to decide how AA should go on this topic rather than have it as a subconscious thread through all of our conversations about money and self-support.

The discussion on this topic at the West Central Regional AA Service Conference in Fargo in March was wide ranging. Discussion there included information that AA has been self-supporting without literature sales at least a few years. Loren's article quotes Bill as saying that in only "five of the past fifteen" years has AA been able to support the work of the General Service Office on group contributions. So at least it is possible. Curt has emailed the General Service Office staff asking in how many years in all of AA's history have group contributions met GSO expenses. We are still waiting for a reply.

Participants in our Area 40 committee pointed out that Bill's own writings are inconsistent on the topic. In some places he is clear that absolutely no funding from outside sources should be used to support AA and then in other places he defines literature sales as contributions, even though a significant percentage of literature sales are to entities outside of AA.

Our committee discussed the content of the proposed agenda item enthusiastically, but realized with closer reading that as worded, the agenda item is really only asking if the Fellowship wants to discuss the item further. And by our eager discussion, we proved that "yes", at least the Fellowship in Area 40 would like to discuss the item further. The second part of the agenda item as worded asks for input regarding a procedure for gathering input from the Fellowship. Our committee questioned why we would not simply put the item on the General Service Conference agenda and proceed as with any other agenda item. Once on the GSC agenda, groups, districts, and areas would have an opportunity to discuss the item and come to an informed group conscience. Our committee discussed another option for gathering input, suggesting that groups, districts, and Areas could be surveyed directly rather than through the usual General Service structure.

No matter what the scope of our committee's task concerning this item, several other worthy points were made. Given that gross profits from literature sales make up nearly half of the operating budget of the GSO, the ramifications of any change to how we do business will impact AA in a major way. Many on the committee are intrigued, if not optimistic about the possibilities if the Fellowship would be challenged to support the GSO budget entirely on voluntary contributions. Many of us have seen the amazing personal transformations when individual AAs become self-supporting, especially when making 9<sup>th</sup> step amends. Do we not have confidence that the Fellowship as a whole will benefit from these same principles? The GSO budget is made up of items requested by AA groups through the General Service structure, through the GSC. We may need to step and fund what we have asked for.

A key question in some committee members' minds is whether literature sales should be considered contributions. If so, then we should not be taking contributions from outside sources. Is there a way to separate out profits from sales to outside sources and not apply these proceeds towards GSO expenses?

#### Floor Discussion:

Angela: The definitive on the item is a good idea.

Mary: This has been discussed since Bill W wrote "AA Comes of Age". What would we do with the profits from Literature sales?

Rich: Dumbfounded that GSC doesn't discuss

Gerry: Thought there would be a line for discussion.  $1^{st}$  part like the idea to phase in—weaning of profits.

Lori: It has been discussed. What does other areas think?

Peg: Profits from literature sales—volunteer contributions from AA groups

Tim: 30% of AA profits are from outside sources

Angela: Would profits not go to GSO? Would profits go to the groups?

Curt: No literature prices would be lowered.

Sid: Literature profits are used to bring more people to AA. Peoples contributions would lag Loren: I am the author of the Agenda Item. The intent was to start discussion. He has not heard discussion about supporting GSO with contributions. We need to consider procedure of self support.

Carleen: Going on since 1946. Big book is produced as a throw away. Literature sales could be used to make a better Big Book.

Mark: This is discussed and never goes away. 1987 was the year of the 7<sup>th</sup> tradition challenge. It was the only time we were self supporting.

The committee members each took a turn sharing their thoughts on self support as a general concept, but we decided we had already had a lengthy discussion of this topic in the context of Item B.

#### Discussion of Area 40 Topics Not On The Agenda

*Item 1* – Area 40 IRS Form 990-EZ

Curt presented a draft of the IRS Form 990-EZ that Area 40 is required to submit. By past action of the Assembly, our Treasurer is to submit the form each year that it is required by the IRS. Currently, any tax-exempt, 501(c)(3) organization such as Area 40 must submit a Form 990 return when its gross revenues for the year exceed \$25,000. In 2007, the Area gross revenues were over \$30,000. Curt explained that the Area 40 Pink Can revenue must be included in that total. After presenting the draft Form 990-EZ, the voting members of the Finance Committee unanimously approved its submission to the IRS. There is no cost to submit the Form 990.

*Item 2* – Proposed Change in Area 40 Budget Process

Curt suggested that he work with all the members of the Area Committee – Officers, Committee Chairs, and DCMs – to develop a draft budget to submit as an agenda item by July 1<sup>st</sup>. In this way, groups across the Area can see the budget before the Fall Assembly and have time to discuss it before voting on it. One of the limitations of our current budgeting process is that each new item added to the budget is considered piecemeal, only as it is brought to the Assembly as an action item. And given our Fellowship's enthusiasm to carry the message, new ideas often sound good. But we don't take the time to weigh each new item against the other items we currently fund in our budget. We don't have a chance to consider all the items together and prioritize.

Two suggestions were made regarding the proposed budget process. One was to present two or three alternative budgets for discussion so that the groups could consider how certain scenarios would play out – including the possibility that group contributions might increase enough to fund the whole budget as is. The second suggestion was that the Treasurer should add narrative to each line item to help explain the budget to non-accountants. The explanation could include how each of the scenarios presented would affect the Area's services.

Many thanks again to Amanda S. for her thorough note taking during the Finance Committee sessions. And thanks to all who participated in the discussion.

### Area 40 Standing Committee on Cooperation with the Professional Community: Committee Report to the Floor of the Assembly re Agenda Items, Spring 2008

Your Area 40 CPC Committee met and considered the Agenda items in both CPC and Trustees. I would like to thank the other 3 voting members of my committee who participated B Rich K., DCM, Dist. 11; Richard P., DCM, Dist. 71; and Mark C., Dist. 61 CPC Committee Chair. Thank you also to the other folks who participated in

our discussions and decision-making B Frank, Dist. 72 CPC Chair; Teresa S., GSR, We Care Group (Dist. 61); Rusti L., Trout Creek (Dist. 81); Robin T., Whitefish Group (Dist. 91) and Susie, Hamilton (Dist. 93). All of our Agenda items came from General Service Conference Agenda items.

#### **Cooperation with the Professional Community**

#### A. Consider the draft Video Segments Directed to Professionals.

We wondered how long these 3 short@ streaming videos would be and whether a shorter and longer form might be offered for busier or better informed professionals to cut to the chase, while those with more questions might select the longer version. Andrew W. later addressed this concern, indicating that the streaming videos on the Web site would be under 3 minutes and the CD versions would be about 5 minutes. The other question we had was whether a viewer could pause the streaming video and the answer is yes. We decided to trust our trusted servants to check it out, as we, without the scripts, storyboards and/or videos to review, cannot.

#### B. Review contents of Kit and Workbook.

We know that the Kit and Workbook are essential tools to have for CPC service work. We don=t know about any proposed changes, which we do not have.

#### C. Discuss ways in which A.A. can continue to be a resource to the legal/criminal justice system.

We did. We like workshops (with Continuing Education credits for the professionals, when that can be arranged), taking professionals to lunch, streaming videos, offering panels to professionals and staff folks in various kinds of facilities, coordinating with our own service folks in Corrections, Treatment and PI (instead of being a Lone Rangers@ and riding off in all directions), sponsoring our own professionals as we meet with them as well as professionals we may work with. We like temporary contact and bridging the gap programs and recognize how important it is to follow through and do what we tell the professionals we are going to do, we acknowledge how vital it is to stick with what AA does do and not to do what AA doesn't do, within the guidelines of the facilities into which we carry out message. Let=s not forget telephone, e-mail and personal contacts with professionals, placing literature racks and providing videos and pamphlets, Box 459, About AA, Grapevine subscriptions and ALWAYS ourselves being clear about 2 things:

- 1. What we offer is AA, consistent with the Kit and Workbook materials, the pamphlets and guidelines on providing information and carrying the message to professionals and the drunks with whom they interact; and
- 2. We are not affiliated with the legal/criminal justice system, we are simply offering our AA experience, strength and hope to the suffering alcoholics within the legal/criminal justice system. Whatever that system requires of its professionals and its customers, according to the courts, the legislatures, the governors, wardens, POs and so forth, our message must be presented in the language of the heart, one drunk to another.

We believe it best to conform our nominating procedure and guidelines for the general manager of the General Service Office to our current practice, unless there is something we don=t know that supports the minority view that this position such be governed by strict rotation.

F. Discuss request to revisit the 2007 General Service Conference Advisory Action to consider all eligible Class A and Class B trustees when selecting the Chairperson of the General Service Board.

If there is something new to consider, that was not presented last year, or if there has been a groundswell of disapproval within the Fellowship since the 2007 GSC Advisory Action, then the Conference should consider looking at this Advisory Action anew. Otherwise, let it be.

#### Sense of Area—Against

- G. Bylaws of the General Service Board of Alcoholics Anonymous, Inc., amended in April 2007:
  - 1. Discuss recommendation from the General Service Board that the following language from paragraph three, page 4 of the Bylaws be amended so that it applies only to Class B <u>regional</u> trustees:
    - A. However, when the vacancy being filled is that of a Class B <u>regional</u> trustee, the maximum term of service of such successor member trustee shall be limited to that number of one-year terms which will result in the term of service of the successor member trustee ending at the same time as the term of the replaced member trustee would have ended if no vacancy had occurred and the replaced member trustee had served four consecutive one-year terms.
  - 2. Discuss recommendation from the General Service Board that the following language from paragraph two, page 4 of the Bylaws be amended so that it applies only to Class B <u>regional</u> trustees:
    - A. In the event that any member trustee shall resign, die, retire, be removed, become disqualified, or shall be otherwise unable to serve, the trustees may, at any regular or special meeting of the Board of Trustees, elect a new member trustee to fill such vacancy, or, alternatively, permit such a vacancy to continue until the next annual meeting of the members of the General Service Board. A third alternative, with respect to Class B <u>regional</u> member trustee vacancies occasioned by resignation, death, retirement, removal or disqualification, is to permit the vacancy to remain unfilled for the remainder of the four year commitment, and to allow regional coverage to be provided by the trustee-at-large or the regional trustee from an adjacent region, unless a region decides that a new regional member trustee should be elected.

Both these items simply clarify that the restriction that you may serve only as long as the Class B member trustee you replace could have served applies to Class B regional trustees only.

(G) 3. Discuss recommendation from the General Service Board that the Bylaws be amended to include options for interim changes to member trustee ratio and composition in response to the 2007 Advisory Action which instituted consideration of all eligible Class A and Class B trustees when selecting the Chairperson of the General Service Board.

This item would simply make clear that whenever a trustee remains on the Board beyond his or her normal end of service date because he or she is still serving a term as Chairperson, there will be a new trustee put in the Chairperson=s now vacated trustee position, so now there will be (counting the Chairperson) either a 15<sup>th</sup> alcoholic or an 8<sup>th</sup> non-alcoholic on the Board.

#### **Intergroup Reports**

#### **Report from Park County Intergroup**

Park County Intergroup was formed about four years ago, as a ground swell movement of A. A.'s, because of Bozeman Pass it made it difficult to participate in a lot of the activities there, especially in the winter. It was started to carry the messages and to provide fellowship events for unity of groups in the Park County area. Are charter includes full cooperation with District 72 and Area 40.

Park County Intergroup follows the guidelines of the A.A. Service Manual. As such we maintain a phone information number where we can give callers information on where the next or closest meeting is to them and also maintain a list of people to go out on twelve step calls, if that is what is being called for.

We publish a Park County Meeting list, that also lists a phone number for each meeting. We also publish a pamphlet called Who Me, with blanks to add phone numbers to. This pamphlet was written by two of our members who have long term sobriety

We do several workshops. This year we have already had a workshop on Sponsorship and in April we will have a workshop on Cooperation with the Professional Community/Public Information.

We were poised to take meetings into the jail, and had very good response from the jailer, but the sheriff won't let us in.

We also sponsor fun unity events such as a Valentines's Day event, [this year it was a speaker, with desserts, games, and dance after.] Corn Beef and Cabbage dinner in March, Camp out on a week end in July, Thanksgiving Dinner on Thanksgiving Day, An alcothon on Christmas and a New Year's Eve event.

We sponsor a medallion meeting every first Saturday of the month to give anyone in Park County a chip for their sobriety length. It starts at 7 p.m. And then we have a speaker one month and a call up meeting the next month. Then we serve cake which is donated, followed by our business meeting..

At 8 p.m. Every first Saturday of the month we have an Intergroup business meeting. Since taking over as chair in January I have been going to each meeting and telling them what Intergroup does and asking each group to send an Intergroup representative to our business meetings, so that we can truly represent the groups in Park County.

We purchase literature through District 72. Our financial situation is good. The groups have been generous. We keep a prudent reserve of \$100.00 for the phone.

#### **South Central Montana Intergroup**

South Central Montana Intergroup meets monthly with the IGR's of our groups to get a good feel for the AA Community that we serve & support, we are currently meeting the 2<sup>nd</sup> Saturday of each month @ 1:30 pm. Following the monthly District 11 meeting. A representative of Intergroups Operating Committee attends both the District 11 & 12 meetings on an alternating basis to keep the lines of communication open and be of service when at all possible.

There are currently 29 groups between the 2 Districts, with 166 meetings per week total.

Over the last year one group disbanded, but another group formed to keep the totals static. Integroup maintains the meeting list and prints anywhere from 3000-4000 copies per year. They are distributed by the IGR's and additional copies are kept in the Bookstore.

We publish our monthly Newsletter and distribute copies to all the groups and Districts.

The Newsletter is a convenient forum for any group or District to advise the AA Community of upcoming events by including flyers. The Newsletter routinely includes the minutes of our meetings as well as the Area events Calendar, Service opportunities within Intergroup, as openings become available and any changes to the meeting schedule prior to new meeting lists being printed

The Bookstore is fully stocked with Conference Approved literature, and is staffed every Saturday from 10:00am to 2:00 pm, with volunteers from the groups.

Special Events have allowed us to bring the AA Community together in the spirit of Fellowship and have a joyous time celebrating Recovery, participation in these events has been wonderful and a great time was had by all. Scheduled events that occur annually are Founders Day Celebration, Holiday Party, Cooney Campout (IG), Fireman's Point Campout (Dist12) and Mid-Winter Social (Dist 12).

We are still maintaining an active Hotline number, until such time as the Area Toll Free number takes over.

#### **West Central Regional Forum Report**

Report on the West Central Regional Service Conference (WCRSC) - Tim M. District 61 DCM

How do I paint a picture for you of the WCRSC in five minutes or less and make you feel like you're in it? Well I thought a good place to start is by telling you what the West Central Regional Service Conference (WCRSC) is. It is a gathering of the eight Areas in the West Central region of the United States which, from a geographic standpoint, amounts to Iowa, Northern Minnesota, Southern Minnesota, Montana, Nebraska, North Dakota, South Dakota and Wyoming. The purpose of the conference is to develop greater unity among members, groups, and the Areas of the West Central region; to encourage the exchange of ideas and experience, and to provide an opportunity for members to discuss pertinent aspects of Alcoholics Anonymous.

The event is hosted by the different Areas on a rotating basis and this year the event was held in Fargo North Dakota at the Best Western Doublewood Inn. It began at 7:00pm on Friday February 29<sup>th</sup> and closed on Sunday March 2<sup>nd</sup> at noon. The Theme for this year was "Communication and Participation - The Key to Unity and Self Support". There were 273 registered members in attendance.

The Friday night and Saturday night sessions lasted past 10:00pm on both nights with ice cream and fellowship afterwards. On Saturday and Sunday the day started with a 7:45am and 7:00am meeting respectively. This is not a place where one gets caught up on their sleep.

The agenda consists of General Sessions which are held as a large group where the delegates from each Area get a chance to present the agenda items that were assimilated at GSO that came from individuals, groups, districts and Areas throughout the United States and Canada. This serve's multiple purposes. It not only better informs the members at the conference along with giving them the opportunity to share their opinions, but also gives the delegates a sense of our members feelings on the topics along with a dress rehearsal, if you will, prior to attending the General Service Conference later this Spring in New York city. There were four General Sessions in all each lasting approximately two hours.

Different Area's also have members from their Area's put on presentations to the entire body with this year's topics consisting of; "Self Support" - Northern Minnesota, "Unity" - Nebraska," Communication & Participation" - Wyoming, "Love & Tolerance, Now More Than Ever" - South Dakota.

There are also smaller breakout sessions on; DCM's, Literature, PI/CPC, Delegate/Trustee, Newsletter, GSR's, Archives, Grapevine, Corrections/Treatment and Area Officers that allow members to ask questions and share experience among each other.

The West Central Regional Trustee, Chuck B. was also there to give his last report of his four year rotation along with acting as a facilitator during much of the general sharing and breakout sessions. Dorothy W., trustee at large, was also there to do much of the same along with Jack S. who is a trustee on the General Service board and sits on the Finance committee at GSO. He was also the Saturday night speaker telling his personal story. If you don't know what a Trustee is, think along the lines of - Super Delegate.

That in a nut shell is what the WCRSC is and what went on there from a 10,000 foot level.

To truly appreciate the picture, allow me if you will, to focus it down to what happened to one Alcoholic who attended, me.

I met our Area Finance chair Curt K. at the Helena airport on Friday morning to board our five hour flight. To begin it got out of Helena a hour late. We flew from Helena to Minneapolis where I read the background material along the way in the cramped seating on the plane. I don't know if the gentleman next to me knew much about the background material or AA for that matter but he would have had to have slept the whole flight to not have gotten a look at some of it. They don't feed you anymore on short flights so upon arriving at the Minneapolis airport I set out to find lunch. I settled on a restaurant called Friday's since it was Friday and they were serving fish, which is an outside issue so I won't go into that. I later boarded the hour flight from Minneapolis to Fargo and took my seat in the next to the last row of the plane. The cabin crew was just about to close the door to leave and I was sitting there all delighted that no one was sitting next to me and I could lay out the background material on the next seat and finish my reading when a gentleman in a dark blue pinstripe suit came down the aisle and preceded to take over the empty seat beside me. I greeted him as warmly as I could but was thinking one more minute and the door would have been closed and my seat/desk would have been mine to finish up my review of the agenda material. We shared a few general comments and he then looked at me and asked, "You're not by any chance headed to the West Central conference are you"? I smiled and said yes at which time he said he was also and that his name was Jack. As it turned out this Jack was the Jack I mentioned above in the section on Trustee's who is on the General Service board on the Finance committee and a former director of the Grapevine. He was flying in from Washington DC and almost missed his last connection. What a way to get reminded that my first inclination to perceive a situation as bad is often not the case at all. I now had a walking talking encyclopedia next to me of the agenda items I had remaining to cover. What a deal.

We arrived at Fargo and I retrieved my luggage and waited for my cab with the district 72 DCM Lori F. who just arrived as well. What's Fargo like in February, its cold, It's windy, and it is all so flat but I was very happy to be there! In the cab on the way to the hotel I met another member of our fellowship from Nebraska.

That night I had supper at the hotel with our Area delegate, our past delegate another delegate from somewhere, Curt our Finance chair, and Jack from the plane who needed no introduction. Throughout dinner I couldn't help but keep thinking how does a drunk from Anaconda Montana end up in Fargo North Dakota having dinner with the high caliber of people such as these in a fancy hotel?

I did not sleep much Friday night or Saturday night for that matter, not only because the hours available were short, but also because my excitement about being a part of this were so high.

Things that come to mind about what I heard and experienced there were; The level that people care about, and are willing to do for our fellowship tops the list, Bill W.'s litmus test on if we should do something in AA, Is it Spiritual, Is it Necessary, Contributions are up the last two years, 7.5% last year and approximately 13% in 2006.

I also learned that many people do not share the same thoughts on matters as I and when it comes to the grey pages in the Grapevine this was almost painfully true but I had fun sharing on the topic none the less and I can still respect and even like them if they don't have the same opinions as me.

The thing that concerned me the most was a story a young Mexican fellow told from the mike in the General sharing session during the discussion on funding other countries to come to the general service conference. He said that in Mexico there are two GSO's and that one of them is notorious. He said they will have newcomers stand on one foot for 24 hour in an attempt to break their will and people have died during this process. I don't know about you, but it left me with little doubt if we should fund this effort.

This fall we will be voting in new members to the 2009-2010 rotation. So if you are currently just mulling over the idea or perhaps the idea doesn't even exist about standing for a position I would like to close with this. A question in the Ask-It-Basket of a service workshop I was a participating in asked if service work in A.A. has benefited me in my career. I hope my report has better answered this question than the short time I had available then that it has not only benefited me from a career standpoint, but in every area of my life.
