## > Assembly Welcome, Saturday Morning- Kacie N

Good morning, everyone! My name is Kacie and I'm an alcoholic. I have the privilege of serving as your Area 40 Montana Delegate. Thank you all so much for being here today.

Would all of you who are attending Assembly for the first time, please stand? Those of you online attending for the first time, please raise your virtual hand.

Welcome! We are so glad to have you here. Look around at the people who are still seated or whose hands are not raised. At one point it was also their first assembly ever. They've been where you are and would be happy to answer any questions you may have. Those of you still seated or without your hand raised, please take time during the weekend to reach out, welcome, and offer your experience to any of our first-time attendees. Please have a seat and lower your hands.

Will all DCMs stand, please? Thank you for your service and for taking on such an important leadership and communication role in the service triangle. I am so grateful you are there to help me communicate from the General Service Office, Board, and Conference at the bottom of the triangle back up to the GSRs and groups at the top of the triangle. After our secretary, Lynne does roll call, we will ask DCMs to complete the sign-in sheet for their districts. Those voting members who are attending virtually should let Alex M know that they are voting members. GSRs and DCMs are the only voting members of the district. Alternate GSRs will only have a vote if their GSR is not present virtually or in person. Alternate DCMs will only have a vote if their DCM is not present virtually or in person. DCMs, please identify your District Reps who have been appointed to be a member of one of the Area Standing Committees. These appointed District Reps are voting members of the Area Standing Committee only and do not have a vote on the floor of the general assembly unless they are also a GSR.

The DCMs will return their sign-in sheets to Lynne by the first break. The information necessary to establish a quorum, which is two-thirds of the eligible voters, is gathered from these sign-in sheets. With very few exceptions, votes taken this weekend are decided by "substantial unanimity." What that means is that as long as we have a quorum (two-thirds of the registered voters) any item we vote on must receive two-thirds of the counted vote in order to pass. Lisa will explain this in more detail as it comes up.

Will all Past Delegates stand, please? Will all past Trustees please stand? Thank you for taking your turn in each service position you've held. Thank you for the sacrifice and service you've given to Area 40 and the AA fellowship as a Delegate and as a Trustee. Thank you for being present and leading by example.

Our responsibility this weekend is to establish and gather the informed group conscience of Area 40 regarding the items on our agenda. Lisa, our Area Chair and Alternate Delegate, will be facilitating the assembly according to a loose interpretation of Robert's Rule of Order, an interpretation that she will explain as she goes, and of which, she has the final say. In other words, when it comes time to decide if we're done talking about something, "Lisa makes the call."

Lisa has prepared this weekend's agenda and has decided the order in which we will conduct our business. Soon we will start to hear reports from our Area Officers, Area Chairs, and DCMs. At 9:15 we will stop the reports, take a short break, and convene Standing Committee meetings in their respective breakout rooms. Anyone can attend the committee meetings, but remember, only the Committee Chair, appointed DCMs, and District Reps are eligible to vote in committee. If you choose not to attend a committee meeting, Past Delegates Mark S. and Andrew W. will be conducting workshops here in this main room. After the committee breakouts and workshop conclude, we will break for lunch.

We have a lot of Area 40 business to discuss and vote on this weekend. If during their discussions, a committee decides to bring an item to the floor to be voted on by the entire Assembly, it will come to the floor in the form of a Recommendation, which is considered a made and seconded motion. Lisa will facilitate discussion on all items. There will be 3 microphones: two here on the assembly floor and the 3<sup>rd</sup> for virtual comments. If you wish to speak, please get in line behind the mic or raise your hand. You will have 3 minutes to express your opinion. Once your 3 minutes have been reached Lynne will notify us by the clang of the cowbell. (Ask Lynne to ring it.) If Lisa feels that the comments are becoming repetitive, she may stop the discussion. Votes taken on Area 40 items will require that we have a quorum of eligible voters. Remember that for an item to pass it must have a two-thirds majority of the votes cast.

When we are discussing General Service Conference Agenda items, no votes are cast to take action on those items. Instead, a sense of the Area will be requested. This will allow me to see by a show of hands whether our Area is in favor of or opposed to an item. When a sense of the Area is requested, ALL attendees are invited to participate – voting member or not.

At 9:00 tonight, there will be two breakout sessions. One for GSRs here in the Mansfield Room and one for DCMs across the hall in the Russel Room. There are Ask-It Baskets online and in the back of the room. If you have a question you'd like addressed during one of these breakout sessions, please put it in the basket. These sessions are an excellent opportunity to bring any questions, concerns, or shared experiences regarding general service, the assembly, your home group, district, or other related items.

And what better way to conclude a packed day of AA business than with some fun and

fellowship! Anyone who's still awake and wants to hang out can meet in the Trigg room next door.

In closing, I'd like to just encourage each of you to really be an active participant this weekend. Join in the discussion, ask questions, listen to one another, and don't be afraid of the mic. People are suffering and dying from alcoholism right now. The work that we do this weekend is to ensure that what we've found in AA remains available and accessible to all. "When ANYONE, ANYWHERE reaches out, I want the hand of AA to always be there." For that we are responsible.

#### A Preview for Fall Elections

#### **Nomination Procedure:**

Our Service Manual explains that a Regional Trustee is selected for their service experience and familiarity with A.A. principles. While no trustee can be said to "represent" a geographical section – because all trustees represent only the Fellowship as a whole – regional trustees bring to the General Service Board's discussions a regional A.A. point of view and experience that is invaluable. The West Central Regional Trustee acts as the point of contact for the eight West Central Regional Delegates and provides them with frequent updates on Board activities.

All eligible and willing candidates will be posted on the screen All voting members will cast a written ballot, one choice per ballot The tally is posted on the board screen

The first candidate with two-thirds wins

--If a candidate does not win on the first ballot I will continue to explain the Third Legacy procedure as we proceed.

If no candidate has two-thirds after the 2nd ballot then the candidates with less than one-fifth of the total vote will be withdrawn, except the top two candidates must remain (all tied runners-up remain as candidates)

If no candidate has two-thirds after the 3rd ballot then the candidates with less than one-third of the total vote will be withdrawn, except the top two candidates must remain (all tied runners-up remain as candidates)

If after the 4th ballot no candidate has two-thirds of the total vote the top two candidates remain and the chairperson asks for a motion (with a second and simple majority by show of hands) to conduct a fifth and final ballot

If this motion does not occur or is defeated then the balloting is over and the choice is made by lot —"going to the hat"— immediately

If there is a 5th ballot and no candidate has two-thirds of the total vote the choice is made by 4 lot —"going to the hat" — immediately

## > Secretary Report, Lynne W

Hi ya'll, I'm Lynne and I'm an alcoholic. I have the privilege to serve as your Area 40 Secretary and Registrar. I have laid out the dashboard information, district # cheat sheets, and a

new, redesigned, some would say "correct" map of the Area. Please throw away any old versions of the map you might have. They were, well, wrong is a good word for it. This updated map has Malta in District 51, where it belongs. People have asked why this map isn't on the website and this is the reason why, right there—it is not an official map, it is one I created to help know where everyone was from. I hope you find it useful, but it may be flawed so please let me know if I have any of your district lines wrong on this map.

I will be focusing on my duties as Registrar this year, so DCMs, if you would prefer I email you the printed spreadsheet in your folder, let me know. Everyone: DCMs, GSRs, Committee Members and interested parties, please allow me a moment to explain the project. GSO is trying to keep records of the homegroups in our anonymous organization. They keep records of people through email. If you want to be the GSR on file with GSO, we need your email. Consider revising the Area Advisor job description to make the Venue Liaison duties applicable for the four assemblies of the Advisor's rotation (currently, the Venue Liaison duties are for the last two Area Assemblies of the Advisor's rotation and the first two Area Assemblies of the following rotation).

**Motion**: Recommendations Passed by simple majority, the change is as follows:

G15.4 Will serve as Venue Liaison. In this position they are provided the authority to represent Area 40 in the process of evaluating, negotiating, selecting and making commitments for the sites during the four Area Assemblies of their rotation. The outgoing Area Advisor will set the dates for the following year and communicate with the incoming Area Advisor.

Since the Fall Assembly, my life's been a whirlwind of balancing accounts, depositing contributions, and sending out monthly finance reports. And while I don't send out thank-you notes for every contribution (because let's be real, my handwriting is atrocious), I'm more than happy to look up any contributions if you're feeling curious. While I may not always be at the forefront like Lisa or Kacie, the responsibilities are nonetheless vital. Maintaining the financial health of Area 40 demands a blend of technical proficiency, meticulous attention to detail, loosely organized organizational skills, and a little bit of time. It's a role that requires a deep appreciation for the gifts of sobriety and a willingness to step up and serve whenever the need arises. And let's face it, if there's one thing alcoholics excel at, it's thriving in the face of adversity. So if you've been waiting your whole life for this oppotunity, consider this your chance to shine.

Now, onto the nitty-gritty: I trust everyone has had a chance to review the latest financial reports,

posted on our website each month. While we've managed to steer clear of the dreaded deficit territory thus far, impending expenses such as the Assembly, Archives rent, and our Delegate's attendance at the Conference will soon come knocking at our door.

Speaking of rent, our annual archives storage fee is due next month, following its predictable 13-month rotation. Fear not, though, for our expenses remain within budget year-to-date, thanks in no small part to the unwavering generosity of our groups. And just to put any anxious minds at ease, let me assure you that we have a healthy cushion of cash on hand – no need to sound the alarm bells despite the latest rumblings from GSO.

In the spirit of progress, I've implemented a few changes to our financial procedures this year. Contributions are now reported more accurately to reflect when they hit our books, and I've migrated our accounting software to the cloud for added flexibility and ease of transition between Treasurers. In addition, our recurring expenses are now on autopay, ensuring timely payments and sparing us the headache of lost emails or checks in the mail.

But hey, let's not get too caught up in the value of dollars past and present. Instead, let's ponder the truly deep questions in life, like: What's the going rate for sobriety these days? Is it a buy-one-get-one-free deal, or more of a 'limited time offer' situation? Let's not forget the noble art of 12th-Step work. Sure, we're deadly serious about our recovery, but let's not forget the levity. After all, laughter is the best medicine, even if it's not covered by insurance. Keep in the forefront of the work we do that our primary purpose remains to carry the message to the still sick and suffering alcoholic.

I participate actively in my home group both because of my ability as a member to influence how that money is used and because it is a vital part of how AA functions. As I can afford to, I do put in a little extra for those who are unable or for the times I am without. If we want A.A. to be here for the next generation, we need to keep supporting our 12<sup>th</sup>-Step work at all levels of service. GSO very recently was fully self-supporting and we are now in a crunch. We'll get through this but we need to stick together. We got this.

So, if you're thinking of stepping up to serve, remember: We offer on-the-job training, a supportive community, and the occasional chuckle. Because in the end, we're all just trying to navigate this crazy

journey of sobriety with a little grace and dignity. We need the best possible option at all levels of service. Please reach out if you are interested, I am always open to sharing my experience.

In conclusion, if anyone figures out the exact monetary value of sobriety, please let us know. Until then, we'll be over here trying to find the balance between our wallets and hearts.

## > Area Chair Report, Lisa C-D

Good morning Area 40! I'm Lisa, an alcoholic, and your Area Chair and Alternate Delegate.

I'm amazed to find that we're more than halfway through this service rotation, with less than nine months to go before Area 40 will have a new panel of trusted servants. It has made me reflect on what I still hope to accomplish in my position before December. My first goal is to hold another online workshop for How to Write Agenda Items in June. When Area 40 meets for its fall assemblies, we don't have a GSC agenda before us full of items to discuss and review, making fall an ideal time to focus instead on unmet needs within Area 40, ideas for improving how we reach out to the still suffering, and any items Area 40 might want the 75th GSC to consider next spring. At an Agenda Item Workshop last June, a member of District 41 suggested that AA create a pamphlet specifically addressing the unhoused alcoholic. We used our workshop time to develop that item into a proposal, which was then presented to a group, a district, and to Area 40 itself. All of those bodies passed the proposal with substantial unanimity, and now it will be considered by the Cooperation with the Professional Community Committee at the General Service Conference in NYC later this month. For this AA nerd, it has been a thrill to see something progress from one member's great idea to something that is under discussion across the Fellowship. If that sounds fun to you, start thinking now about the unmet needs you see or the improvements you would like to make within our fellowship, and bring those ideas to the Agenda Item Workshop in June!

Another goal of mine is to have an online session for the Area on the subject of service sponsorship — an aspect of sponsorship that some begin hearing about almost as soon as they get sober, but that others may hear about for the first time when they begin attending area assemblies. For me, I have had two traditional sponsors who have taken me through the steps, and while both of them have encouraged/insisted on my participation in service at the group level, neither of them shares my passion for General Service. If you have served — or are considering serving — at the District or Area level, you may find a service sponsor helpful. I have one now, but I didn't for many years, and there are things I wrestled with and flailed my way through that would have been much easier, I think, if I'd had a service sponsor backing me up. When I ask myself why I didn't have one for so long, a few things come to mind. The first is that I didn't really know what it was, and I thought I probably should know, so it became something I was afraid to ask about. The second is that I didn't want to hurt my regular sponsor's feelings. These and other things that come up around this topic will be, I hope, the subject of an online meeting for our Area later this year.

My third goal in the remaining months of this rotation is to visit some of you for your district business meetings and at your summer events. It's an element of the Area Chair and Delegate job descriptions to, between the two of them, try to visit every district at least once during their two-year term of office. I've made it to five of our fourteen districts so far, and I'm ready to roadtrip, so I hope I'll get to see a lot of you this summer at meetings and special events in your districts.

I had the privilege in January of speaking at a Service Workshop in District 72 called "How Service Preserves Us." It was a wonderful event, very well attended and with a "comfort food" buffet, which

I'd never heard of before and which I thought was brilliant. After I spoke, one of the attendees told me something that she'd heard years before at a Regional Service Conference. When considering whether to accept a service position, we should consider whether we have the ODAT to do that position. ODAT is, of course, an acronym for "one day at a time," but in this context, the acronym stands for "Opportunity, Desire, Ability, and Time." It's become a new way for me to think about willingness to stand, and I wanted to share it with all of you as we move towards the elections we'll conduct the next time we gather for an assembly.

As I reflected on what I wanted to say during the service talk I gave in January, I was struck by how often service positions have come to me seemingly by accident or happenstance. When I was newly sober, I became a GSR only because no one else in my new home group wanted the job. A few years later, I was drawn into my District's CPC committee because they were wrestling with an issue that I happened to know something about because of my day job. A few years after that, I boldly declared that I was willing to serve as a DCM only because there were already two far more qualified candidates standing, and I was sure one of them would be elected. But then one of them withdrew, and the other announced that he planned to vote for me, so I suddenly found myself with a terrifying new job that I knew very little about. Being a DCM brought me to Area, which I loved instantly, but I never would have thought of serving at Area had I not been encouraged to do so by people who were already serving. That led to two more terrifying positions that I knew very little about, including my current one. But I heard something at my first Area Assembly – and I've heard it several times since – and I can say through personal experience that it is the absolute truth: God doesn't choose the qualified. God qualifies the chosen. We find what we need to do the jobs we're entrusted with in AA.

Of course, that doesn't mean we become perfect. We make plenty of mistakes along the way. For example, at the start of our online pre-assembly a few weeks ago, I suddenly got really nervous when it was time to start. So instead of asking the group assembled to start our five-hour Zoom meeting with a moment of *silence* for the still suffering alcoholic, I asked instead if we could have a moment of *suffering*. It was not a great moment for me, but fortunately, this program teaches me how to laugh at myself and even to welcome the moments like that one that keep me humble.

In the months remaining in this rotation, I hope all of you will set and achieve goals that will be of service to your groups, districts, and Area 40, and to the still suffering among us. And I hope as you consider whether to stand in the next rotation, you'll make some room for serendipity to guide you to your next jobs. If you have the Opportunity, Desire, Ability, and Time, I hope you won't allow fear to hold you back from accepting new challenges.

Good afternoon! My name is Kacie, I am an alcoholic currently serving as your Area 40 Montana Panel 73 Delegate.

Here's what I've been up to since I last saw you at our Fall Assembly in September. I was invited to share my Delegate's report at the Fireman's Point Campout in Columbus the weekend after the Assembly. The next weekend I had the opportunity to share my report at the Grapefest in Helena. And the weekend after that, I got to share it at the Havre Mini Conference. That was a VERY busy and extremely rewarding string of weekends! Thank you districts 12, 61, and 51 for the loving invitations to share my report. And a special thanks to my co-pilot, Susan, who is always up for an

AA adventure and not only gets in the car but drives it too! It is getting to be that Delegate report-back time again. Area 40 invests a lot of time and financial support in our Delegates. One of the best ways to ensure you, your groups, and districts are yielding a return on that investment is to provide me the opportunity to visit you some time after I return from Conference so that I may share with you what I saw, heard, and felt while participating as a member of the General Service Conference. This provides the opportunity for me to report on the results of agenda item votes and current A.A. finances. It is also an opportunity to report back on the experience shared with me from other Areas in our service structure. It's easy not to know or simply forget that the work we do, the votes taken, and the conversations had affect more of the A.A. Fellowship than just our little corner of the world her in Montana. The Remote Communities Meeting, Area Highlights, and General Sharing sessions provide expansive insight into the challenges and successes of other Areas. And I can't wait to return and share those experiences with all of you. So, it's never too early to get in touch with me so we can schedule a time for me to visit you with my report.

In the Fall, I also had an opportunity to share information about what A.A is and is not as well as provide resources for more information to the Rotary Club in Kalispell. I got to study up on CPC material and refresh my memory on how to talk to "normal" people in as anonymous of a way as possible. There were no cameras, news articles, publications, or postings of the event. It was a great opportunity to remember that we are Alcoholics Anonymous not Alcoholics Invisible.

I had the privilege of serving on the Conference ad-hoc committee tasked with developing questions and a plan for the GSC Inventory that will be conducted during the week of Conference in 2025. We met seven times before the close of 2023 and our work will now be forwarded to the Agenda Conference Committee this month.

The members of the General Service Conference had two virtual sharing sessions, one in late Fall and the other in February. I've also attended three Delegate's Only virtual meetings with the 92 other delegates to prepare for conference and a monthly WCR Delegate's meeting with the delegates and alternate delegates of the West Central Region and our Area point person, Class A Trustee, Kerry Meyer.

The first weekend in March I flew to Minot, North Dakota for the West Central Region AA Service Conference. I won't steal Susan's thunder by sharing too many details, you'll get to hear that tomorrow. But there are a few questions I'd like to invite our Area 40 fellowship to noodle on a bit. Is the West Central Regional AA Service Conference a necessary service? If so, what are some of the barriers to participation in this event? How can we work to remove them? Are there opportunities for our Area and the other seven Areas in our Region to support this service more? What, if any, is our financial obligation as an Area to maintain this service? The WCR delegates met together in Minot, reviewed financials for the year and found that financial support through registration fees only may not be a sustainable option. We agreed to go back to our Areas and start a conversation. If you have feedback or questions for me on this topic, please let me know.

I must share that while I arrived in Minot by plane, I returned home by train, this was not planned. I won't go into all of the details but I must share with you how incredible Area 40 is. After more than five hours of delays, taxing back and forth on the runway, and almost taking off, my return flight home was cancelled. Dang snowstorm! This is happening at the end of a long, full, rewarding, and exhausting weekend. As I deboarded the plane in the snowy darkness and made my way to baggage claim, I could feel my spiritual fitness draining. I quickly realized I needed to

ask for help. There was a group of Area 40 nutballs still in Minot scheduled to leave by train in the morning. The next available flight wasn't until the day after that. I called one of those nutballs and defeatedly said, "My brain is broken. My spirit isn't too far behind. I'm tired, I can't think, and I need help." The comforting voice, as I recall it, said, "We got you. Hang tight." Some time later the van arrived at the airport, friends poured out, scooped up my luggage, and put me in the front seat. They had me laughing in no time. A room at the hotel had already been booked, a seat on the train had already been reserved, and lots of hugs were given. I didn't have to do a dang thing except surrender and accept help. I share all of this to say that if there was ever a time I was feeling kind of trudgy — I think that was it. I whispered a plea for help and Area 40 delivered. Don't tell any of the other Areas, but you guys, we really do have the very best one.

The third Saturday of every month I hop on Zoom and participate in a deep dive Concept Study with other Area 40 members across Montana. Last month was pretty monumental because we just finished our first full time through! I'm very excited to announce that this Concept Study will continue and is set to start over at the beginning with the Conference Charter next month! Anyone and everyone is invited to participate. The Concepts are such a valuable tool and understanding them seems to come so much easier when studying them with each other. There are flyers on the back table with the meeting info. This is not a secret meeting, the more the merrier! There are no prerequisites to join. You don't have to have a service position. You don't even need to know what a Concept is! If you are interested in learning, have a heart for service, and a passion for A.A., this study is for you!

This year the General Service Board, General Service Office Staff, and the Conference Improvement Committee have made a significant effort to cut costs for the conference. This includes conducting some of the pre-conference meetings virtually instead of in person in Brooklyn before Conference week begins. I have already attended the Remote Communities Meeting, the 1728 Meeting, and one of two sharing sessions on the topic of the Founders Writings. These were all held virtually but are considered part of the Conference. So, I will report back on these meetings after the entire Conference has concluded.

I closed out 2023 and started 2024 by hosting three different virtual sharing sessions to review some financial information and to discuss questions regarding the Founders Writings. I was pleased to see a wide variety of participants in these sessions and grateful for all of the feedback shared. This experience really drove home for me that conversations with one another are vital. That communication is an essential key for successful service work. And that these important conversations are most effective when founded in accurate information sharing, personal experience, strength, and hope, and a shared passion to fulfill the primary purpose of Alcoholics Anonymous. When we can start a conversation from a place where agreement on our primary purpose is the foundation, we are then more likely to have ears open to hear each other out when we might not agree with one another on certain topics. More often than not, it seems we all agree that we are here to stay sober and to help the still suffering alcoholic find us, achieve sobriety, maintain it, and hopefully stay. We may disagree on a lot of other things, but if we can agree on that, I believe it keeps our hearts open and allows a loving Higher Power to work through the collective group conscience and serve the good of AA.

I'm sure I've forgotten to include something, but I hope to convey that the privilege and honor of being allowed a turn as your Delegate is a responsibility I do not take lightly. Talking with you at events, getting your emails, letters, and phone calls, receiving text messages with daily reading

screenshots and quotes – all of these interactions and conversations are moments I'll carry with me to the conference in New York. Your voices truly do guide me when I cast my vote on each item. I share those voices with the conference from the mic and in my committee. You may not be taking up physical space there, but you are all absolutely there with me.

Thank you for loving AA as much as I do. Thank you for being an Area that embodies the Responsibility Statement. Thank you for answering the phone, responding to the email, taking the jail meeting, talking with the professional, buying a Grapevine Subscription for the treatment center, downloading and subscribing to the Grapevine app!... Thank you for being of service to your fellows and for showing up even when it isn't fun. I love you guys so freaking much and I'm beyond grateful for each and every one of you.

#### o Archivist Report:

Good Morning Area 40,

My name is Earl Fink and I am an alcoholic. I am also serving as the Area 40 Archivist. I am happy to report that our archives collection is safe and secure, the climate in the repository stays around 50\* to 70\* and the humidity stays a consistent 25% to 35%, sometimes drier in the winter. We have sufficient room, shelving, and storage containers for our current collection. I try to keep old records and books in acid free archival boxes as much as possible. Our repository serves us well at this time, but I have received a letter that our rent will increase from \$420 to \$460 / month at renewal. I have forwarded that correspondence to Jake. I have been doing a lot of thinking about the expense associated

with maintaining our Archives and how we are utilizing them. I believe that we need to have an open and honest dialog about some of the items that we are keeping along with evaluating our practices and our Archival Policy. Our history is very wonderful and fascinating, but it needs to be utilized and shared.

The methods of collection and storage have changed significantly since I became the Archivist. When I started we were corresponding by letters and hard copy documents that has now shifted to digital media for the most part. Distribution of Background Information was at one time making copies of 900 to 1000 pages and delivering them personally to having a complete set available on a Dashboard. Hard copy storage has turned into hard drives and the cloud. I have become a member of a few online archival groups that share articles about our founders and early members of Alcoholics Anonymous, as well as having become a regular visitor of several historical websites. There is an abundance of information and history about Alcoholics Anonymous on many reputable sites.

I was able to attend the 2023 Fall Round-up in Bozeman last Halloween. It was a lot of fun visiting with folks. The winter blast slowed attendance somewhat, but it was a great event anyway. The winter was not very conducive to traveling a lot, but I was able to utilize online events for our concept study, an Ad-hoc committee on Policy and Procedures, The West Central Regional Service Conference and the Area 40 Pre Assembly. I couple of weekends ago I was able to attend the South Central Intergroup Founders Day Event in Billings with a display and a short history presentation. The following day I was able to go visit with one of our Past Delegates, Bob H., our Panel 42 representative to the General Service Conference. He is well and living in a care facility in Billings. While at Founders Day, Terri T., a friend, former standing committee chair and former "Triangle" editor presented me with a couple of old Dictionary's. One was published in 1941 and is on the display table with the Big Book display and the other is suspected to be a 1938, though that needs to be researched further. I have been looking for one from that time period and now we have one. On the way home, I stopped at a meeting of the Laurel Home Group. I was invited to stay for the District 12 District meeting, but I chose to get on the road instead. I have been invited to attend the 2024 Spring Round-up in Billings in May and have been asked to have a display at the National Bridging the Gap Workshop this fall in Missoula and at the National AA Archives Workshop in Iowa in late September. I have not committed to that event yet but will let them know soon.

I asked that the Area start searching for a new Archivist at the assembly last fall. I have spoken with a few who have expressed interest but have not heard anything more. If you think you might be interested in serving in this capacity, please don't hesitate to ask about any questions you might have. We have two Past Archivist: Tom W. and Gerry R. as well as myself, who could provide information about this position. I have decided that I will rotate at the end of this year, therefore, a new Archivist should be elected at the 2024 Fall Assembly.

Group highlighted the need to adapt to changing times and the impact of the Inflation Reduction Act on paper materials. Rebecca emphasized the importance of the Grapevine as a valuable resource for AA members, while Libba provided information on current pricing and distribution. The group discussed reducing the number of printed and concentrating on digital distribution. Brandon and Lance B. (Miles City) also provided their

differing but equally valuable thoughts on the topic. Later, the group discussed ways to enhance the efficiency and inclusivity of the upcoming AA conference, including having a well-rounded delegation and using virtual meetings. The Group discussed the dates for the 2027& 2028 General Service Conferences.

#### **Action Items**

- Promote online Grapevine/La Viña access over print to reduce costs.
- Bring laptops/phones to show groups instant Grapevine app access.
- Consider reducing print issues and shifting focus to online platforms.
- Explore adding translation tab to app for La Viña.

- They suggest pooling old copies to offer to local jails or distribution centers, as the content is relatable and simple to read.
- Grapevine Libraries: Take a Grapevine, leave a Grapevine.

#### AA grapevine app and its features.

- Malcom expressed gratitude for free access to information and updated subscription.
- Martin suggests using past editions of the AA Grapevine as a fun way to get people involved with the app and familiar with its content.
- Martin emphasizes importance of attending AA meetings and provides app for locating in-person meetings.

#### AA meeting materials and recommendations.

- Guidelines emphasize that "consider" and "review" have different meanings: "consider" implies a wider-ranging discussion, while "review" focuses on a specific item with a higher likelihood of a recommendation.
- The committee may take no action, make a recommendation to reverse, modify, or supplement a prior advisory action when using "reconsider".
- Martin reviews AA Grapevine workbook, updates content, and makes it easier to use.
- Guidelines emphasize the importance of prayer and meditation in AA.

#### Cost-effectiveness and sustainability of printing Lavinia.

- Martin discusses the impact of the Inflation Reduction Act on consumerism and production, including the shift towards digital products.
- Martin expresses concern about financial losses due to printing and distribution of materials, suggesting a need for more fiscal responsibility in the future.
- Martin highlights the importance of cutting back on printing and trimming the fat on operations to continue passing the message efficiently and sustainably.

#### The financial struggles of the Grapevine magazine.

- Reviewed La Viña Magazine circulation, revenue, and budget over six years, highlighting significant drops in circulation during COVID-19 pandemic.
- Discussed the history of Grapevine's Spanish edition, including the need for a bimonthly publication at first.
- Reflected on the challenges faced by Grapevine, including operating at a loss and the importance of reaching a large population in Mexico and Canada.
- Group expresses concerns about financial sustainability of AA's magazine, Lavina.

#### Magazine distribution and technology.

- Libba expressed frustration with the lack of change in the magazine's subscription prices, suggesting it's irresponsible to continue the status quo.
- Rebecca proposed the idea of conducting a subscription survey or drive to determine why members are not purchasing the magazine, and to find a solution to increase support.
- Martin mentions that the organization is struggling to provide adequate support to alcoholics in Canada and Mexico due to subscription demand and economic constraints.
- Maritn suggests using real-time translation technology to make educational materials more accessible.

#### Sustainability of printing Lavinia magazine.

- Group mentioned that the organization is losing money on printing and distributing literature, and that they will need to make a decision about how to proceed.
- Group agrees that the organization cannot continue operating at a loss and it was suggested writing an agenda item to address the issue for suggestion.
- Group highlights financial struggles of Lavinia, suggesting cutting back on print services to fund digital publishing.

#### Funding and services for Asian and Asian American alcoholics.

- Group suggests implementing real-time translation feature in the app to make it more accessible. Various languages.
- Group emphasizes the importance of carrying the message of Alcoholics Anonymous effectively.

#### Literature distribution and inclusivity in a recovery program.

- Group discussed the racial tension during the COVID-19 pandemic, particularly against Asian individuals, with instances of verbal and physical assault on the streets.
- The speaker's sponsor advises them to proactively greet others in a professional setting to break the ice and build connections, even for new female colleagues.
- Group highlights similarities between Westerners and Asian Americans in recovery, emphasizing the importance of literature distribution.
- Group discussed pamphlets, profit margins, and inclusivity.

#### Conference site selection and cost.

• Group highlights the environmental cost of producing pamphlets for a conference, mentioning a paradigm shift in economics.

#### Conference dates and workload distribution.

- Alternative locations for a conference included Akron/Cleveland.
- Group reviewed proposed dates for General Service Conference 2027 & 2028, considering holidays and venue availability.
- Group reviewed dates for upcoming events, including Memorial Day and Victoria Day.

#### **EDW Pilot.**

- EDW focuses on the importance of efficiency in committee work, rather than being sidetracked by non-essential discussions.
- EDW helps to create well-rounded delegates in decision-making.

#### Virtual meetings and online participation in AA.

- Committee discusses participation of online groups in US-Canada service structure, with a focus on efficiency and fun.
- Group discussed potential expansion of Alcoholics Anonymous to include virtual meetings and digital representation.
- Group brainstorms ways to increase fiscal engagement for virtual meetings.

#### Electing delegates and conference committee chairs.

- Group seeks clarification on proposed item to revise procedures for electing conference committee chairpersons and their alternates.
- The delegate chair is selected by lot, not by service position, and has increased authority and responsibility in recent years.
- The minority has the spiritual opportunity to participate at each level of the upsidedown spiritual triangle, including the area delegates and delegate chair.

#### Agenda item for upcoming conference.

- Group suggests coordinating with Casey and past delegates before the Spring 2024 GSC to become informed on how to be of maximum service to create unity while practicing the principles in all our affairs.

Daniel – whoever stands is voted "in". Membership is not willing to take service positions. Open service positions get filled as time passes. Frustrated with how to get people excited for service at the district level. Has found people who are willing to serve show up.

Steve – Fell into a home group that has a history of being involved in service. Goal is to have elections before Fall Area Assembly so they can go to Assembly and learn before taking the new service role. District has adopted this same strategy.

Brandy – coming to Area has helped her as a new DCM helped her get a better understanding and get excited about her new role

Susan – came to Assembly the first time because someone was funded and now that she is funded and asked someone else to come. Taking people with you generate more excited. We have an obligation and a privilege to come. Take someone along.

#### > Intergroup Report

Good morning, extended family, Area 40, My name is Aryel and I am an alcoholic. District 91 Liason New Hope GSR Flathead Valley Intergroup events chair

I am reporting on behalf of the Flathead Valley Intergroup. I'm here to inform you of the purpose and function of intergroup. Intergroup is the local A.A. service office for the Flathead Valley responsible for providing all our A.A. groups and members with

information needed to carry the message to anyone in the community who may have a problem with alcohol. In other parts of the country, intergroups are called central offices, but these are actually one and the same organization. The A.A. intergroup helps carry the message by publishing a meeting directory, managing the local Web site and supporting any activity that meets the need of helping the newcomer find Alcoholics Anonymous. Flathead Valley Intergroup serves more than 15 groups and meetings in Northwest Montana, within district 91. Intergroup offers more than 10 separate service positions, some of which differ from the common district positions, those include an entertainment chair and co-chair, which organize events such as, an annual campout, alcathons, and several holiday and fellowship events, dinners, sobriety birthday meetings. They also have a meeting schedules chair, who is tasked with organizing, editing, printing and distributing paper meeting schedules throughout District 91. We also participate in and contribute to district 91 functions and events, a local website aanwmt.org, we have recently

discontinued our independent hotline and redirected any of those calls to the area 40 hotline.

In the last year Flathead Valley Intergroup has held 12 monthly business meetings and 12 monthly sobriety birthday meetings which are on the last Saturday of every month at the North Valley Senior Center in Columbia Falls. We have also received over 60,000 views on the local website.

The local intergroup website provides a variety of services, including a calendar of events, with printable pdf fliers, contact information for all district and intergroup service positions, it also provides a wealth of useful information such as job descriptions, bylaws, as well as policy and procedures. The website also announces and informs the fellowship of several services, and workshops including, "Into Action", Corrections meetings orientation, in addition to an abundance of family friendly fellowship events and activities, such as the annual New Years Alcathon, Valentines Day party, annual Whitefish Sober Ski, St Patricks Day Dinner and Potluck, Spring Fling Barbecue, annual EZ-Duz It Golf Tournament, Founders Day Campout, Great Northern Hike, Annual Intergroup Emery Bay Campout, Halloween Party, Thanksgiving Dinner and Potluck, Eureka White Elephant gift exchange and Christmas Party, and the Annual Christmas Alcathon.

I am honored and privileged to be an active participant in the service structure of Alcoholics Anonymous, District, Intergroup, and group level. I cannot accurately express the amount of gratitude that I have for the life that God and Alcoholics Anonymous have given me, therefore the closest I can come is to take every opportunity I am presented to suit up and show up, by being of service in Alcoholics Anonymous, and to carry the message to the still suffering alcoholic.

#### General Service Conference Report

Hi! I am Susan, Alcoholic. I am the D91 Corrections Chair. I have been asked to speak on my experience as a first-time attendee of the West Central Regional AA Service conference that was held in March in Minot, ND.

The excitement of the conference happened long before the conference even began. 15 of us from Missoula, Bitterroot, Flathead, Great Falls and Havre all began plotting and planning the 14-hour train ride to Minot. These were DCMs, Area committee Chairs, District chairs, several new GSR's and some newcomers who joined in just to see what we were all about. The train ride was a hoot and the perfect kick-off to the conference ahead!

The conference began Friday with a First Timer orientation where the purpose of the Conference was explained. We were there to <u>develop Unity</u>, exchange new ideas, and share experiences! Woo hoo. I'm in!

The theme was connecting with Love, Unity, and Service. There was a plethora of intros, welcomes, opening ceremonies and lots of AA business conducted over the 3-day weekend. I will highlight a few that stood out to me. First was the General session about "Overcoming barriers to participation" ...which I figured was basically "some people just don't want to do it, that's why they don't participate". But I quickly learned about real barriers that other members had experienced that I would never have considered. Barriers like language, age, remote communities,

transportation, folks who can't read or write, feelings of inadequacy. These were not MY experiences and were not on my radar at all. But these were <u>very real barriers</u> to other members, and I began to realize the scope and depth of other AA issues that need to be addressed.

We got to meet the Delegates, which was great, and enabled us to put names with faces and get to know the delegates from other Areas.

We went through the entire 74<sup>th</sup> General Service Conference Agenda items over the weekend and that made for some very interesting, passionate, thought provoking, emotional and sometimes heated discussions. This was my favorite part of the conference, and I was on the edge of my seat as these issues were unpacked by the fellowship <u>at great length</u>. Here are a few of the more notable topics I took interest in.

The first was when we were considering a request to develop a pamphlet on the unhoused alcoholic in AA. There were lots of folks sharing what they thought, until one guy got up and he had practical, hands-on experience working with the unhoused. And his commentary was the one that in my view seemed to be the most credible as he was coming from a place with real knowledge of the subject.

I was also very interested in the conversations regarding the paid placement of PSA videos on streaming platforms, and the whole conversation of attraction versus promotion and how this all pertains to our traditions. Loved it, it was fascinating.

As the district corrections chair. I have been following closely the draft manuscript of the translation of the book Alcoholics Anonymous into plain and simple language. Here I was really shocked at the misinformation and wildly misunderstood nature of this manuscript in general. Clarification was given several times and folks either couldn't or wouldn't comprehend the meaning of "translation". This is where the heated part came in.

Then there was discussion about the cost effectiveness and sustainability of continuing to print La Vina. Here we were clearly losing money and I thought the conversation would be short and revolve around the dollars and cents of the matter. There was plenty of talk of money and lack of finances and just when the group was almost talked out about money...a small group of Spanish speaking members came to the mic, one with a translator. And they gave an emotional appeal about how important the La Vina publication was to the Spanish speaking membership and what it meant to them. They explained how the subscriptions were passed around in their small groups, person to person, one member to another. And sometimes up to 50 people would read the same subscription. They explained why the subscriptions were down drastically due to COVID and the lockdowns closing their meeting. They explained passionately that this publication was vital to them, and at that point I had a huge lump in my throat and tears were streaming down my face. And at that moment his sobriety and the sobriety of all our Spanish AA community had come down to a balance sheet, and I was almost ashamed of some of the previous conversation. I was moved by their compassion for one another and the heartfelt plea to keep this publication available to their membership!

One thing was made crystal clear to me. No matter where you stood on a topic, no matter the subject. Everyone in that room clearly loves AA. They love the book, they love the fellowship, they love the service, and they will rally united in that.

There was also plenty of lightheartedness and laughs, to be sure. And some very heartfelt sharing by Vera F (AAWS non trustee Director) and Mike L. (beloved West Central Region Trustee) They both shared some personal stories, and it got real, and they got personal, and it was honest and it was vulnerable, and it was sincere. And I felt it. And I felt connected to them, and I felt connected to the fellowship of AA.

At this conference I learned a lot, experienced and felt a lot. And I know for certain. This is what I want to do. This is where I want to be, and these are the people I want to be with. At the start of the conference, it was stated "the purpose was to develop unity, exchange ideas and share experiences". Well, they delivered that "in spades". Thank you for the opportunity to share with

#### Mark S, Panel 44

30 years ago was my first GSC. No email, all snail mail. No internet, communication was much slower. There was a lot more suspicion about what "They" are up to. I was chair of my committee that conference, and I hung out with the trustees and found out they are alcoholics who disagree just like we do. They're just trying to get along and stay sober, there's no big conspiracy. There is no, "Us vs Them", we're all in the same damn boat, we're all just sober alcoholics.

The 2 delegates before me came back bittered from the experience. Mine were both great, but they all have a completely different flavor. It changes, the members change. Items change, they go away and then they come back. We are never really done with a few things. Money is always one of the things that we struggle with. We've never had too much money. We've been flush a couple times, but there are lots of districts in this Area who are not flush. Now that we have zoom the districts who can't afford the travel can now participate, we just have to let them know that the option is here.

Next Assembly we will be electing a new Area Committee. One of you in this room is probably our next delegate, and someone else is the next delegate after that. While you are doing service work & throughout events like this, pay attention to who is doing the work. Not everyone who stand for a position wants to do the work. There are those who want to stand up here on this stage and look good. Sometimes ppl get elected who don't show up. They stand for the election then fizzle out when there's work to be done so be careful who we pick because our servants can do a lot for us.

We have had some terrific servants this rotation. There are some of you just starting your service careers, and since Kacy and Mark were both born on the same day, June 20<sup>th</sup> is a good day to be born if you want to be a delegate. You will be forever changed once you are a delegate. You will have a much deeper understanding that our fellowship is much deeper than we first understand. A lot happens there that we can't prepare for, you just have to show up and experience it. The room itself isn't much bigger than this one, and just like in this room the work is done by the people who show up.

There's a group of people we are not reaching somehow, and the General Service Conference is always looking for ideas on how to reach them. You in this room can help us reach them. If you have that idea, please speak up. I have a lot of confidence in you because you are here. I hope you develop the love of service that I have. Service doesn't immune you from drinking, but it is an excellent addition to your recovery.

This is a pretty good group, I'm proud to be apart of it and grateful you trusted me enough to send me out there a couple of times. Thank you.



In this case, the GSC Chair resigned and there wasn't a whole lot of info. The fellowship said, "If you don't want to give us info then we will provide it ourselves."

Kacy called me, she didn't know what to do. I told her to get more information. What happened was, the board was trying to be respectful, but it was being read as secrecy by the fellowship. If you leave an information void it will get filled. The first tradition comes to mind, and I have to ask: Are we moving toward unity? Kacy was a big part of the delegates asking for more information, and we as a fellowship were given it as a result.

This past March, I felt a pull to go to the Pacific Regional Assembly process (maybe because it was San Franciso as opposed to Minot). One reason was my first former sponsor was going to be there. I had the opportunity to disagree with 2 people with 50 plus years, and was respectful while doing it. I asked what they thought we should do moving forward, and I didn't agree with their answers but I still talked to them.

There were other people who were still feeling some trust issues with the board. For me, the principle it goes back to is, "Love and tolerance is our code." We do not add, "Until you do something that pisses me off." We get upset at people, and we form sides. That is not the way to do it. I had to disagreed with two people I love and respect, and was polite about it. I can see they think what they are doing is best for AA. Even as Delegates and Trustees we can make mistakes, personalities get involved, and we have to work on things. That is why we have the traditions. Personalities can overtake the principles so we need the traditions to pull us back in.

We are not perfect at practicing the traditions, but as long as we are willing to work toward them they keep us in check and guide us back to get on track.







# Income & Expense vs. Budget (FY 2023)




# Income & Expense vs. Budget (2024 YTD)







# Respecting Money By Bill

HERE IN THE STATES it is Thanksgiving time. The whole of AA takes its cue from this occasion and we rejoice world-wide in gratitude for the blessings that our fellowship has bestowed upon us. It is traditional, too, that this is the season for taking stock of our progress as a fellowship. We look at our society and ask "How are we doing?"

AA's Twelve Traditions are the measuring rods that we use. "How well are we sticking to the Twelve Traditions" is the prime question of each Thanksgiving week. Every year we see more clearly that adherence to our hard won traditional principles is the basis for our unity and the effective carrying of our message; that indifference, lack of understanding, or rebellion against these principles could result in widespread dissensions and maybe ruin. We keenly realize that the practice of the Twelve Traditions is quite

as vital to the life of AA as a whole as is the practice of the Twelve Steps to the life and sobriety of each member.

The Grapevine has asked me to write about the Traditions in this issue. Accordingly I've selected those which deal with the often misunderstood and sometimes unpopular topic of money-its use and its misuse. About this, our Traditions make two short and simple declarations. In Tradition Seven we read that Every AA Group ought to be fully self-supporting, declining outside contributions. Tradition Eight states, Alcoholics Anonymous should remain forever non-professional, but our service centers may employ special workers.



#### Area 40 Policies and Procedures – Area Treasurer

- Any Area Committee member, or ad hoc committee chairperson who is not reimbursed in the capacity of G.S.R. or D.C.M. shall be reimbursed for all miles driven on Area 40 business, at a rate of \$0.05 per mile, as well as actual spent monies of food, gas and lodging. No money will be paid without proper receipts. The use of the Area Committee Expense Form is suggested.
- The Area will fund the Area Delegate to attend Spring and Fall Roundups.
- The Area will also pay the expenses of two past delegates to attend Area Assembly. This does not include the immediate past delegate whose expenses are also paid by the Area.
- The Area will fund the Area Delegate, at the GSO suggested level of Area contribution for expenses, to attend the General Service Conference each spring.
- The Area will fund the Area Delegate and Alternate Delegate/Area Chair for expenses to attend the annual meeting of the West Central Region.
- The Area will fund the Area Assembly biannually. Arrangements and negotiations for meeting space and coffee will be the responsibility of the Area Advisor.
- The Area Treasurer is allowed to advance funds for approved travel and lodging expenses to events for Area 40 Representatives.

## Appendix 2

## Plain Language Big Bookthe Journey So Far

## Some history...

Discussion at the 66th General Service Conference in 2016 resulted in an additional committee consideration\* that:

"the need for 'plain-language' recovery literature be explored by the Trustees' Literature Committee as a way to make the life-saving message of Alcoholics Anonymous more accessible."

(\*An item that was discussed by a Conference committee, but with no action taken or recommendation made to the Conference as a whole. Serves as a suggestion to the corresponding trustees' committee.)

► That exploration led to the creation of subcommittees for *Researching Issues, Possible Tools and Access to the Book*, known as RIPTAB-I and RIPTAB-II.

- In RIPTAB-I, they looked at established literacy levels to guide discussions of what language comprehension skills a reader a prospective member would need to comprehend the book, Alcoholics Anonymous.
- And they reviewed what other simplified "recovery" materials were being used by members to meet those needs.

- ► The subcommittee concluded that literacy concerns indeed reflected potential accessibility barriers and it learned how this can be related to factors such as education, ethnicity, English as first language, reading disabilities, brain injuries and incarceration.
- ► At the 70<sup>th</sup> General Service Conference in 2020, the Conference Literature Committee requested the trustees make available the RIPTAB presentation. A video of that presentation was produced and distributed with a request for feedback.

- ► RIPTAB-II was tasked with continuing the work which involved gathering further information about issues related to fellowship requests regarding the language of the Big Book.
- ▶ A progress report was then forwarded to the 2021 Conference Literature Committee focused on accessibility and relatability of the Big Book in terms of reaching a wider demographic of alcoholics.
- The idea of a new book was not meant to change or replace the Big Book, but rather to overcome barriers so the AA message might reach more suffering alcoholics.

- ► At the 71st General Service Conference in April 2021, there was a Conference Advisory Action which recommended:
- "that a draft version of the book, Alcoholics Anonymous, be translated into plain and simple language and be developed in a way that is accessible and relatable to as wide of an audience as possible and that a progress report or draft be brought back to the 2022 Conference Literature Committee."

## A quick translation detour...

## Post 71<sup>st</sup> General Service Conference...

▶ In July 2021, at the meeting of the Trustees Literature Committee, a subcommittee was created to track the development of the Plain Language Big Book. Noting the Conference Committee's request that the book be "developed in a way that is accessible and relatable to as wide of an audience as possible." ► The subcommittee adopted the name "TABB" (Tools to Access the Big Book) and worked with the AAWS Publishing Department to review potential writers for the project.

► A formal "Request for Information" was sent out to vendors.

It was focused on writers with experience in the fields of health, spirituality, self-help, or education.

## From the RFI...

- ▶ Goals/Outcomes:
- "We seek a full plain language translation of an abridged Alcoholics Anonymous. The final work product must be accessible to readers at a fifthgrade reading level."

"The translation as a whole must capture the welcoming and inclusive spirit of Alcoholics Anonymous and inspire a sense of belonging and hope in the alcoholic seeking help."

## The response...

- ► There were 16 affirmative responses.
- Of those, some were individuals, some were partnerships, some were firms. Some were AA members.
- ➤ The TABB subcommittee plus three members from AAWS Publishing (all AA members) selected six vendors which were then hired to translate Chapter 5 and, if possible, a few select passages.
- The samples were independently read and ranked by TABB and the Publishing team members and a writer was chosen.

- ► While the selection of the writer was finalized in January 2022, further negotiations lead to the contract being signed in May 2022.
- ► The subcommittee recommended that providing anonymity to the writer was in everyone's best interest.
- ► The writer asked not to be given specific coaching on certain passages until the review process. They didn't want to be over-guided and as a result, get stifled.
- The subcommittee established a regular ongoing review process of the writer's work.

## Heading towards the 72<sup>nd</sup> GSC...

▶ In a break with previous practice, and to obtain early feedback, the TABB subcommittee recommended sharing unedited samples from the writer's first attempt to translate the text with the Conference Literature Committee.

► The Trustees Literature Committee recommended that the samples be shared with all Conference members.

## After the 72<sup>nd</sup> Conference...

- ▶ I joined the subcommittee in 2022. We met several times. Some of those meetings were joint meetings with Publishing and with the writer.
- As chapters came in, we reviewed and provided suggestions for changes, with an expectation of additional rounds of refinements to ensure the tone and tenor was faithful to the guidance and the Big Book.

## Heading towards the 73<sup>rd</sup> GSC...

- ► Trustees Literature Committee recommended that all Conference members should have access to the completed Chapters 1 through 6.
- ▶ Given the fellowship's strong interest in this project, the subcommittee gave much consideration to how the need for maintaining confidentiality could be balanced with the need for unity and transparency.

## The Reading Room...

- ► To ensure confidentiality in the process it was decided to create a controlled environment: a designated room; with no cellphones or recording devices allowed; and monitored by members of the Trustees Literature Committee.
- We worked with the Trustees Conference Committee to schedule hours for each Conference member during Conference week.
- ► Afterwards, a sharing session was held, and Conference members gave their impressions and suggestions on the first 6 chapters.

## Post 73<sup>rd</sup> General Service Conference...

► Feedback from the Conference members provided to the writer and working to incorporate in the translation.

► The subcommittee has reviewed Chapter 11, Dr. Bob's Nightmare, and the Appendices and provided comments to the writer.

► Another reading room with the full draft is planned for the 74<sup>th</sup> General Service Conference in April 2024.

## In closing...

Comments from the Conference members:

- ▶ I could read and understand this without a sponsor and heard the message of hope.
- Was against it but I have evolved, struck by how beautiful and respectful it was. This is the most loving thing we have done for the still suffering alcoholics.
- Lots of fear in my area, thank you for all the work to make this week possible, I think this tool will save lives please make it available in as many formats as possible as soon as possible.
