## From Your Area Advisor

### Non-alcoholic (Class A) Trustees

AA's debt to those who do not share our disease but willingly share our problems is immense, going back to the beginning. Bill W. wrote: "In the days when AA was unknown, it was the non-alcoholic trustees who held up our hands before the general public. They supplied us with ideas...they voluntarily spent hours on end, working side by side with us and among the grubbiest of details. They gave freely of their professional and financial wisdom. Now and then, they helpfully mediated our difficulties." Written in 1966, those words hold true today. Non-alcoholic trustees remain a rich source of wisdom and perspective, and since they need not maintain anonymity, they are available to appear in public on behalf of AA.

Board members make an effort to choose Class A trustees from a variety of professional backgrounds, and the board has included doctors, lawyers, clergy, sociologists, business people and financial experts among its members. Whatever their backgrounds, the bylaws make one key provision for non-alcoholic trustees: they "shall be persons who are not and have not been afflicted by the disease of alcoholism and who express a profound faith in the recovery program upon which the Fellowship of Alcoholics Anonymous is founded." (pg S60, The AA Service Manual)

Due to a scheduling conflict our Regional Trustee is unable to attend our Fall Area 40 Assembly. In his absence, a past Class A Trustee, Linda Chezem, has graciously accepted our invitation and will be there for the weekend to visit and share her experience, strength and hope. Linda served on the General Service Board from 1997 to 2003, and exemplified the de-

scription of a Class A trustee given above. She is a graduate of Indiana University School of Law and a former Judge, Court of Appeals of Indiana. She started the first certified court alcohol and drug program in Indiana and has conducted seminars and written articles on such subjects as DWI, family and addiction. She is a professor at Purdue University and has a part-time appointment at the Indiana School of Medicine. Linda served on various committees during her six years on the Board including Nominating, Correctional Facilities, Archives, International Conventions/Regional Forums, Conference and Finance. She also presented the Keynote Address at the 53<sup>rd</sup> General Service Conference.

Following are some quotes from presentations that Linda gave at different Conferences:

*"I want to share back with you what you have taught me. You the members of the Fellowship have befriended me and taught me with unselfish hearts. Safeguarding unity comes about as each member grows in the understanding that the good of the group and the good of Alcoholics Anonymous as a whole comes first: that what we may personally feel, may not be a good thing for AA as a whole, and that we need to keep an open and loving mind and trust the process. We need to repeatedly surrender our personal ambitions and wishes for the greater good." Further, "I define humility as acting with the conviction that the common good is more important than individual self-interests or convenience." (pg 22, 49<sup>th</sup> Final Conference Report)*

*"It is funny how when I try to determine where my fault or failure lies before doing anything else, my understanding of the situation changes. If I*

*try to figure out what I can do to correct myself, the whole situation becomes easier. Disagreements and critics seem to be part of the universal human condition. For AA to have people who criticize or hold different views...is indicative of the fact that we are a part of humanity. How we treat our critics...is critical to the ability of the Fellowship to hold the hand of recovery out to the alcoholic. Petty bickering or large infighting will hurt or prevent the recovery of those who engage in the pettiness, as well as discourage a newcomer." She further stated, "Respectfulness to a critic, yes, refusal to let go of something that we disagree with, no. We cannot afford to chew the same cabbage forever." (pg 39, 51<sup>st</sup> Final Conference Report)*

*"I do not attempt to speak for AA ever. But when given the opportunity to share with my professional community the value of cooperating with AA, I am grateful to share the story. Sharing about AA, not preaching, not promoting. I hope to be supportive of my AA friends who carry the message that might save a life. Cooperation is not an outside influence." (pg 21, 52<sup>nd</sup> Final conference Report)*

I believe that we are in for a great opportunity to get to know a trusted servant and a great friend of AA a little better. Please join me in welcoming Linda to Montana and to our Area 40 Fall Assembly. — Earl F.

Consider whether Area 40, through its Public Information Chair, will encourage and assist (as requested) our districts and inter-groups to list their answering service/hot line numbers and/or addresses in the Western US Directory, to provide another contact source for persons seeking AA meetings and information through the directory.

### Archives/Structure – Dennis O.

- Archives
  1. Discuss the recommendation that the current Policy and Procedures Document be made available to the Area on the Area Website and that updates and revisions will be the responsibility of the Archives Committee after each assembly. Corrections to the Policy and Procedures document need to be submitted to the Area Chair for furtherance to the Archives Committee in accordance with Area Timelines to be included under the committee's agenda.
  2. Discuss the recommendation that the Policy and Procedure Document be reproduced and distributed by the Archives Committee at the first Area Assembly of the New Rotation. Cost of the reproduction to be paid out of the General Fund. It is suggested that the number of copies be deter-

mined by the average Area Assembly attendance during the previous rotation plus 10%.

3. Consider the recommendation that the Archives Committee conduct, with the Area Archivist, an update of the Past Actions Document to insure the applicability of any Past Actions and to insure the historical position of certain Past Actions. This review will be conducted during the second year of each rotation.
4. Consider the recommendation that the Area 40 Archives-Structure Committee bring forward a recommendation to the Fall 2005 Assembly facilitating Area Workshops beginning in 2006.

### Finance – Sid Godolphin

1. Consider the proposal that Area 40 submit the following Agenda Item to the 2006 General Service Conference:

*"Consider the addition of a reference to the publications A.A. Guidelines: Finance and The A.A. Group Treasurer in the pamphlet, Self-Support: Where Money and Spirituality Mix."*
2. Discuss the financial impact of Area 40 facilitating Area Workshops beginning in 2006.
3. Consider the proposal that Area 40 institute a mileage reimbursement policy for area officers, area committee chairs, area advisor, and special invitees of the Area Chair at a rate of \$0.30 per mile for all miles driven on behalf of Area 40. This mileage reimbursement would supersede all other mileage and gas reimbursement previously adopted by Area 40.
4. Consider the proposal that Area 40 pay the expenses of the Area 40 Delegate to attend the General Service Conference based on the following formula: To the extent that excess funds are available over and above the prudent reserve as of December 31<sup>st</sup> of each year, we will pay the full cost of our delegate according to the

full cost estimate of the previous year's GSC (that includes both "direct" and "indirect" costs).

### Grapevine/Policy & Admissions – Gail M.

  1. Discuss ways the Area 40 Grapevine Committee can encourage submission of articles to the Grapevine.
- Policy & Admissions
  1. Consider the recommendation that the Area adopt the new Policy and Procedures Document dated 4/10/2005.
  2. Consider a proposal for Area 40 to submit the following Agenda Item to the 2006 General Service Conference:

"As a matter of policy, Alcoholics Anony-

mous should be mindful to balance the number of odd and even panel Delegates, watching for future addition of Delegate Areas and current Delegate Areas that may switch to opposite panel elections to better achieve balance within their Regions."

### Literature – Louise M

1. Consider the proposal that Area 40 submit the following Agenda Item to the 2006 General Service Conference: "Consider the elimination of the freight charge of 10% for literature orders under \$250.00, which was instituted effective July 1, 2005."
2. Consider the proposal that Area 40 submit the following Agenda Item to the 2006 General Service Conference: "Consider the elimination of volume discounts on literature orders."

## Just What is a Regional Forum?

Regional Forums originated in 1975 at the suggestion of the late Chair Emeritus of the General Service Board of Trustees, Dr. Jack Norris. They are weekend sharing sessions designed to improve communication and participation among A.A. service workers in a region, the General Service Board, A.A. World Services, Inc., the Grapevine Corporation Board, the Grapevine Staff, and the General Service Office Staff.

At the invitation of a region, four Regional Forums are held each year. Since the U.S./Canada service structure is composed of eight regions, a Regional Forum may be held in alternate years in a particular region on a rotating basis.

The location and agenda for a Regional Forum are decided jointly by the Regional Trustee, Area Delegates and G.S.O. The respon-

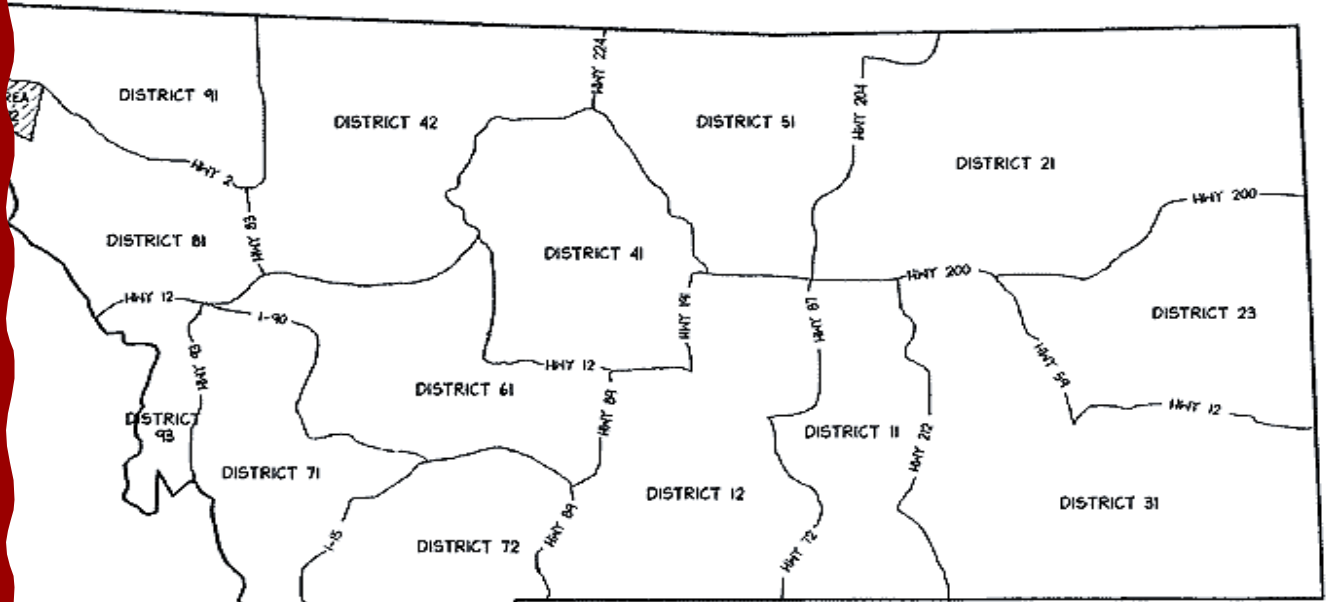
sibility for direct contact with the hotel is assumed by a local A.A. Host Contact working with the Regional Forums Coordinator and Regional Trustee. The Regional Forums Coordinator at G.S.O. distributes registration forms and invitations to groups and service workers through the region and, working with the Host Contact and Regional Trustee, coordinates the details of the Forum.

A region may request a Special Forum which has fewer participants from the boards and staff over shorter time periods. Special Forums require the approval of the trustees' Committee on International Conventions/Regional Forums. They may be designed for remote, sparsely populated or urban areas. The Regional Forums Coordinator works closely with the Regional Trustee and Host Contact to tailor each agenda to local needs.

There is no registration fee for a Regional or Special Forum. The General Service Board covers the expenses of meeting rooms, transportation and hotel rooms for its board and staff personnel. In many places, area committees, districts and groups cover or defray the transportation and lodging expenses of the trusted servants representing them at a forum.

Forums are intended to be sharing sessions, thus no formal actions result. Forums provide unique opportunities to share valuable experience, ask questions and spark new ideas. Regional and Special Forums carry the A.A. message through service.

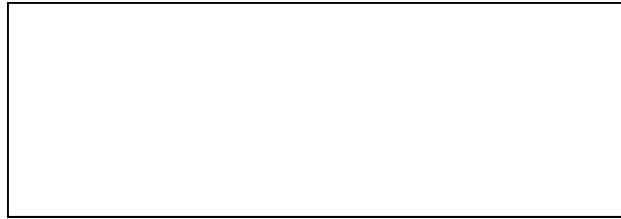
