If It Ain't Broke ...

"If it ain't broke, don't fix it" was a comment frequently heard around the state as Area Officers conducted listening sessions. Members attending the listening sessions communicated their sense that we should not limit the amount of literature profits used to fund services, although there was not a consensus or clear majority. The "if it ain't broke" mind-set reflected caution about taking radical action rather than a full endorsement of the status quo. It was generally agreed that we should work toward increasing 7th Tradition contributions.

There were great discussions at the listening sessions, with a wide range of views expressed and questions asked. Members had an opportunity to gain a new awareness of how money and spirituality mix, to become better informed about how 7th Tradition funds are used and to learn some history about funding GSO functional expenses.

In addition to "if it ain't broke", comments shared include:

- We hope that all literature being sold ultimately reaches the hands of an alcoholic or those afflicted by the disease of alcoholism.
- Using literature profits to help support GSO is in line with Bill W.'s original vision for the Big Book and literature profits as discussed in *A.A. Comes of Age*.
- Raising literature prices is like an unfair tax on groups.
- Leave it the way it is, but let's work harder to increase contributions.
- The ideal is self support, but it's always been and always will be a battle.
- I can't spend more than I earn. My group can't spend more than it receives in the 7th Tradition.
- Let's not make voluntary contributions into dues.
- Bill W. wrote on both sides of this issue.

What Kind of Unity?

As the Fellowship discussed the issue of self-support and the use of Literature profits to fund services, it was obvious that we do not all agree. How do we get through these times of dissent and focus on our primary purpose?

The closing comments at the 2009 West Central Regional Forum by Class A (Non Alcoholic) Trustee and General Service Board Chairperson, Ward Ewing, state how these conver-

sations and discussions can help A.A. flourish and grow:

"...If we can stay focused on our primary purpose and reach out to the suffering alcoholic, then I am absolutely convinced that our membership will grow.

I have also learned, over the course of this weekend, how the Three Legacies are connected, through service, to our primary purpose. Regarding the Legacy of Unity we have heard a lot about divisions

among us. And despite this conversation around differences, we have an incredibly deep commonality—our love for the Fellowship. We have to be united in carrying the message because there are millions of people who need to hear it. So our unity needs to be the kind that's based on varying our differences. Our unity requires us to express our views, so listen to one another carefully and find ways to move forward.

Finance Survey Results Are In

Approximately 65 responses to the Finance Survey have been tallied and will be included in background material for the 60th General Service Conference in April.

The yes/no answers indicate that people completing the survey feel well-informed about GSO's services and their groups' contributions, think A.A. should continue funding those services using literature profits as necessary, and would participate in a 7th Tradition Workshop.

The detailed survey responses to the yes/no questions are reflected in the table entitled "Finance Survey Yes/No" on this page.

The second part of the survey included discussion questions. Again, respondents were very positive and generally thought their groups were doing a good job. Here are some highlights (see the background information for the Conference for the complete list of responses):

1. Does my group believe the 7th Tradition is a principle of participation in carrying the message to the still suffering alcoholic?
 - It is giving back.
 - Money in the basket is ultimately about carrying the message.
2. How does my group utilize our 7th Tradition Contributions? What can my group do to increase self-support?
 - We do well in all areas of contributions.
 - We could help members of the group be well informed about the 7th Tradition and how is it used.
 - We buy books for new comers and give some to District.
 - We could bring the 7th Tradition up as a topic or have a workshop.
 - We contribute to all service work.
 - We now contribute \$2-\$5 each as we realized we were not self-supporting at District, Area, and GSO levels.
 - We buy coffee, pay rent, buy literature and send some to District, Area and GSO.
 - We have a yearly speaker event; pay for supplies and rent for meetings; we give scholarships to newcomers for A.A. events. We can ALL put more than one dollar in the basket at each meeting.
 - We could get rid of the pink can.
3. Does my group have good communications about 7th Tradition Contributions received and how that money is spent?
 - Good, but posters or announcements could improve it.
 - Group Treasurers give reports at monthly or quarterly group business meetings with paper copies available.
4. How is the relationship between spirituality and the 7th Tradition expressed in my group?
 - Actual contributions say it all.
 - Actions indicate that we give it away to keep it with both time and money.
 - We do not hoard money, we pass it along.
 - We have regular service rotation and participate at all levels of service and business.
 - We talk about the needs of the group first, making for great unity within the group.
 - Our group is approaching 30 years; makes regular contributions; stays active in service, unity, and recovery; has a yearly group inventory; looks for ways to better carry the message.

Speaking of Self Support

Speaking of self-support. How is Area 40 doing?

Area 40 started 2009 with a balance of \$21,115.28. Thanks to the generosity of Area groups, the Area ended the year in good shape with \$24,735.57 in the checkbook. The operating reserve was \$12,641.17 with a Prudent Reserve of \$10,303 and \$1,791.40 in the Archivist Account.

The total income from group contributions, districts, roundups, 7th Tradition collected at Area Assemblies, and Triangle subscriptions was \$31,684.75. Total expenses for the year were \$30,080.40, 97% of the \$30,939 budgeted.

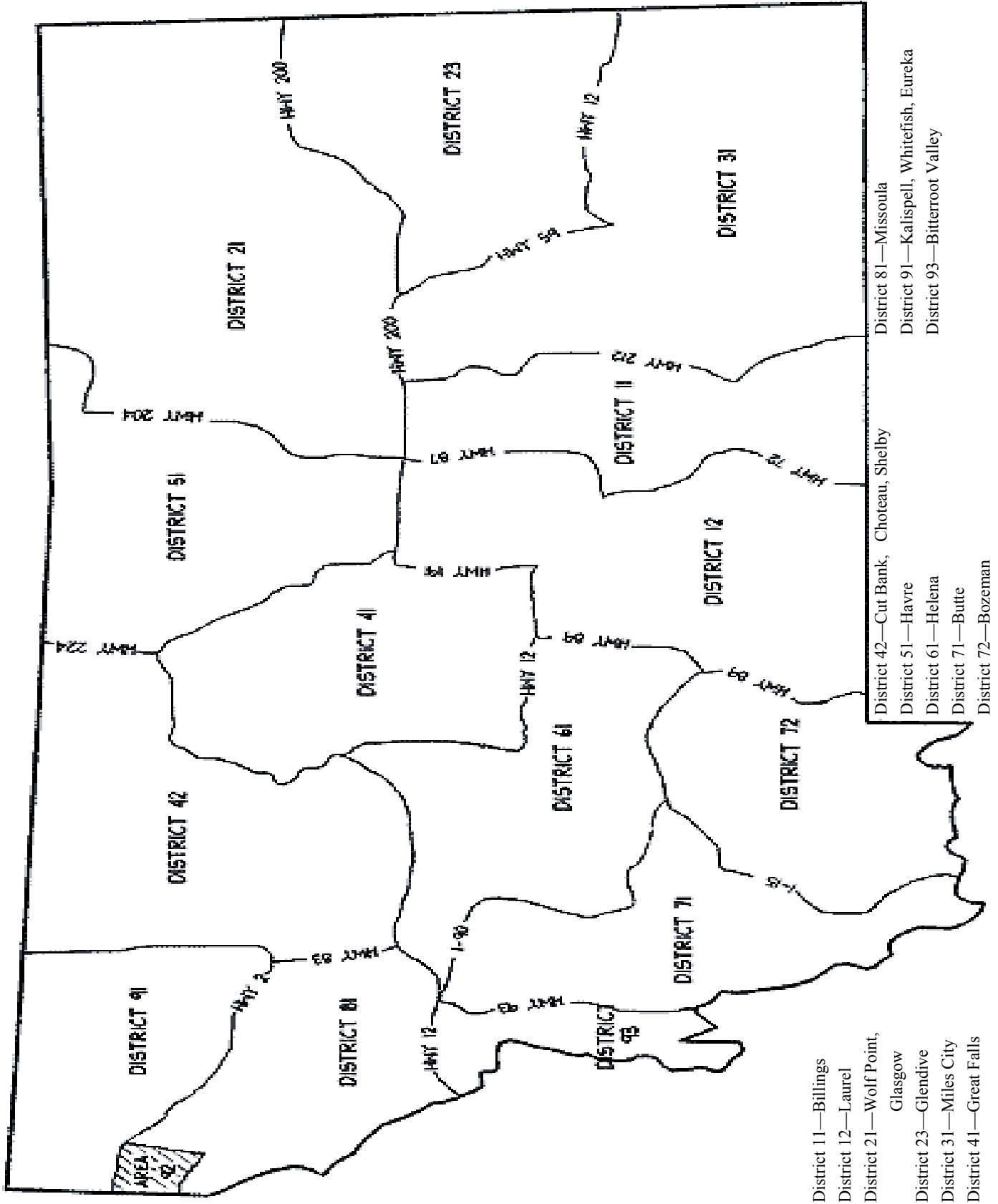

Some of the questions offered for further consideration and reflection:

- Does money contributed to “can funds” take away from the 7th Tradition basket?
- How much money is enough? How much of a spiritual principle is enough?
- Do we match consistency and prudence in money spent and money received?
- Could outside entities buying books influence later editions of the Big Book?
- How can we convince A.A. members to put more than a buck in the basket?
- Can we be impacted by a change in buying practices by big purchasers?

The listening sessions were conducted in response to the 59th General Service Conference Advisory Action from the trustees' Finance Committee to “gather input from the fellowship on the following for review by the 2010 Conference Committee on Finance:

- 1) If we continue to use literature profits to partially fund services, should there be a limit?
- 2) If there is a limit how do we continue to pay for services if there is a shortfall in contributions?”

Our Delegate, Carole B.; Area Chair/Alternate Delegate, Terry S.; Treasurer, Linda B.; and past Delegate, Andrew W., visited Districts 11, 41, 51, 61, 72, 81, 91, and 93 to conduction the sessions. The detailed notes from the sessions have been forwarded for inclusion as background material for the 2010 General Service Conference.

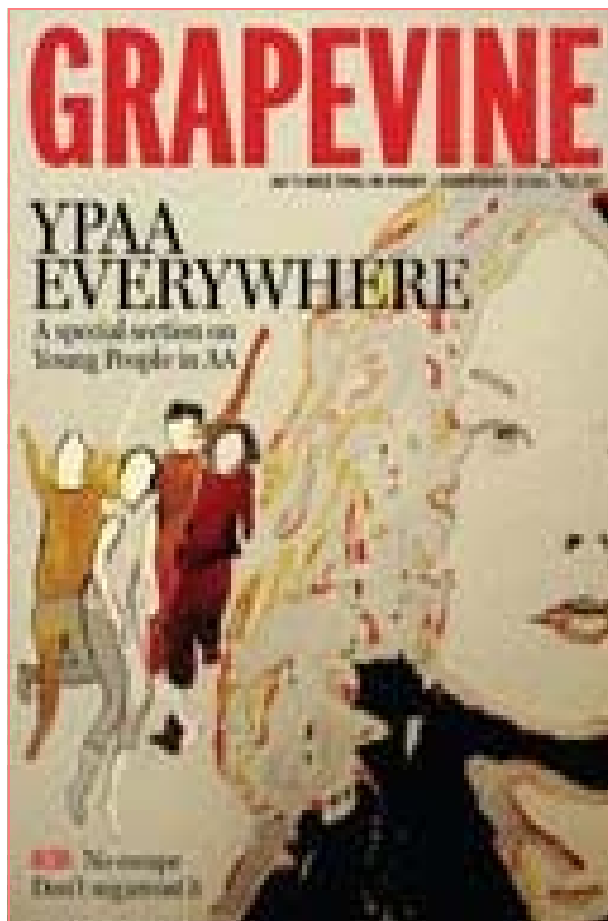
But in order for A.A. to run itself, we have a system for finding out how A.A. as a whole feels about its world affairs, and how it wants to operate.

(Of course, neither the Conference, the General Service Board, nor any A.A. committee or office has any power to govern anyone in A.A. “Our leaders are but trusted servants; they do not govern.”)

You and I may not need a General Service Conference today, to insure our own recovery. But what about the millions of sick alcoholics still stumbling out there in the dark?

When they come trying to find us, we want each of them to get the same loving help we all had. The Conference—and the whole general service system—has that responsibility: **to keep A.A. alive and well for those yet to come.”**
